# **Hazardous Materials Code**

#### 2019 Edition

This edition of NFPA 400, *Hazardous Materials Code*, was prepared by the Technical Committee on Hazardous Chemicals. It was acted on by NFPA at its June Association Technical Meeting held June 11-14, 2018, in Las Vegas, NV. It was issued by the Standards Council on August 14, 2018, with an effective date of September 3, 2018, and supersedes all previous editions.

This document has been amended by one or more Tentative Interim Amendments (TIAs) and/or Errata. See "Codes & Standards" at www.nfpa.org for more information.

This edition of NFPA 400 was approved as an American National Standard on September 3, 2018.

#### Origin and Development of NFPA 400

For the first edition of NFPA 400, four separate documents — NFPA 430, NFPA 432, NFPA 434, and NFPA 490 — were withdrawn in 2010 and included in their entirety in NFPA 400. This edition covered hazardous material categories found in building and fire codes such as corrosives, flammable solids, pyrophoric substances, toxic and highly toxic materials, unstable materials, and water-reactive materials. NFPA 400 also included compressed gases and cryogenic fluids by extracting NFPA 55, Compressed Gases and Cryogenic Fuels Code, into Chapter 21.

The code established the need for additional fire protection based on quantity limits for various occupancies using the maximum allowable quantity (MAQ) concept.

In the 2013 edition, the MAQ tables in Chapter 5 were updated to be consistent with changes in fire and building codes and coordinated with requirements for industrial and medical gases based on changes to NFPA 55. The Committee updated the table establishing MAQ values for hazardous materials stored or used in outdoor control areas. The results of the Fire Protection Research Foundation (FPRF) project "Oxidizer Classification Research Project: Tests and Criteria" were used to establish an alternative method for assigning classifications to oxidizing solids. To accomplish that, the committee modified definitions for Class 1, Class 2, and Class 3 oxidizers based on the test protocol and criteria presented in the completely revised Annex G.

The oxidizer table in Annex G was updated for specific oxidizer solids based on the test results. The Committee also incorporated edits consistent with the *Manual of Style for NFPA Technical Committee Documents*.

The 2016 edition incorporated a number of significant changes to the requirements for ammonium nitrate in Chapter 11. Highlights included the addition of sprinkler requirements for existing buildings of combustible construction and content, the requirement for new buildings and storage bins to be of noncombustible construction, and emergency planning and public notification/alert systems for both new and existing facilities.

Additional changes further protected ammonium nitrate from becoming contaminated or from becoming molten and confined, conditions that can lead to an explosion during fires involving ammonium nitrate. Clear guidance for emergency responders on the conditions under which ammonium nitrate can explode, when to fight such fires, and when to evacuate were added to Annex E, which also included information on the properties and uses of ammonium nitrate. A number of oxidizers were reclassified in Annex G based on work performed under the auspices of the Fire Protection Research Foundation (FPRF). In Annex F, the tables were revised based on new test data provided by the Organic Peroxide Producers' Safety Division (OPPSD) of the Society of the Plastics Industry (SPI). Terminology and content throughout the document have been modified to correlate with OSHA's revised *Hazard Communication Standard*. A new annex, Annex J, Hazardous Material Definitions Comparison Table, compared the hazardous materials definitions in the new OSHA standard with those in NFPA 400. Finally, the MAQ tables in Chapter 5 were modified to reflect a change in typical container sizes from 50 lb to 55 lb (22.7 kg to 24.9 kg).

In the 2019 edition, multiple terms relating to aisles have been revised for consistent use throughout the code. A major revision has been made to the MAQ tables in Chapter 5 that deletes most of the occupancy-specific tables in an effort to consolidate information and reduce repetition. MAQ values for assembly, educational, day care, health care, ambulatory health care, detention and correctional, certain residential, and business occupancies have been consolidated, and annex material has been added to provide clarification on amounts needed to be stored within and outside of cabinets when allowed to have increases based on the table footnotes. A new table has also been added to the code to extract common path of travel distance limits from NFPA 5000®, Building Construction and Safety Code®.

Further revisions have been made to the requirements for ammonium nitrate in Chapter 11. Text has been added to clarify which sections apply retroactively, and language has been revised to clarify that molten ammonium nitrate needs to be able to flow away from storage areas to open, unconfined areas free from incompatible materials. Revisions have been made to the fire protection system requirements so that automatic fire sprinkler systems are not required in Type I or Type II construction buildings unless they also have combustible content. Requirements for ammonium nitrate storage in railcars have been added to cover non–transportation-regulated storage.

Class II organic peroxides have been divided into Class IIA and Class IIB based on small-scale burn rate data and alignment with international classifications. Definitions have been added, MAQ tables have been updated to include these two classes, and some of the assignments of organic peroxide formulation classifications in Annex F have been changed accordingly. Changes have been made to the requirements for fire protection systems, and to remove MAQs for segregated storage and cutoff storage, since these are addressed through the protection level and control area concepts.

Finally, new annex material has been added to show an example of a storage layout in a typical sprinklered warehouse storing Class 1 oxidizers.

The 2019 edition of NFPA 400 is dedicated to the memory of Nancy Pearce, who served as Staff Liaison to the Technical Committee on Hazardous Chemicals since the 2013 edition of the code. Nancy passed away on September 5, 2017, after a long and courageous battle with breast cancer — although that did not stop her from sharing her joy and passion with all who had the pleasure of working with her. Nancy worked at NFPA for 6 years, and spent the previous 23 years as an Industrial Hygienist for the Massachusetts Department of Labor Standards, Occupational Safety and Health Program. Often with a smile, she could pull teams of people together with a common mission, never minimizing their important work for making the world a safer place to work and live. Nancy will be remembered and missed for her professionalism, incredible work ethic, and kindness.

#### Chapter 1 Administration

# 1.1 Scope.

- 1.1.1\* Applicability. This code shall apply to the storage, use, and handling of the following hazardous materials in all occupancies and facilities:
  - (1) Ammonium nitrate solids and liquids
- (2) Corrosive solids and liquids
- (3) Flammable solids
- (4) Organic peroxide formulations
- (5) Oxidizer solids and liquids
- (6) Pyrophoric solids and liquids
- (7) Toxic and highly toxic solids and liquids
- (8) Unstable (reactive) solids and liquids
- (9) Water-reactive solids and liquids
- (10)\* Compressed gases and cryogenic fluids as included within the context of NFPA 55

**1.1.1.1 Occupancies.** Unless otherwise specified in this code, all occupancy definitions and classifications shall be in accordance with the building code.

**1.1.1.2 Multiple Hazards.** Hazardous materials that are classified in more than one hazard category, as set forth in Section 4.1, shall conform to the code requirements for each hazard category.

#### 1.1.2 Exemptions.

**1.1.2.1** The quantity and arrangement limits in this code shall not apply to facilities that use ammonium perchlorate in the commercial manufacture of large-scale rocket motors.

# **1.1.2.2** This code shall not apply to the following:

- (1) Storage or use of hazardous materials for individual use on the premises of one- and two-family dwellings
- (2) Explosives or blasting agents, which are regulated by NFPA 495, and fireworks
- (3) Refrigerants and refrigerant oil contained within closedcycle refrigeration systems complying with the fire code and the mechanical code adopted by the jurisdiction
- (4) High-hazard contents stored or used in farm buildings or similar occupancies and in remote locations for onpremises agricultural use
- (5) Corrosive materials in stationary batteries utilized for facility emergency power or uninterrupted power supply, or similar purposes, in accordance with NFPA 1
- (6) Aerosols complying with NFPA 30B
- (7) Corrosive materials displayed in original packaging in mercantile occupancies and intended for personal or household use or as building materials
- (8) Flammable and combustible liquids having no other physical or health hazard properties covered by this code
- (9) Organic peroxide formulations that are capable of detonation as manufactured or when unpackaged or in authorized shipping containers under conditions of fire exposure, when stored, manufactured, or used in accordance with NFPA 495
- (10) Combustible metals, as defined in NFPA 484
- (11) LP-Gas complying with NFPA 58 or NFPA 59
- (12) Where approved, materials that have been satisfactorily demonstrated not to present a potential danger to public health, safety, or welfare, based upon the quantity or condition of storage
- (13) The off-site transportation of hazardous materials when in accordance with Department of Transportation (DOT) regulations
- (14) Cellulose nitrate film complying with NFPA 40
- **1.2\* Purpose.** The purpose of this code shall be to provide fundamental safeguards for the storage, use, and handling of hazardous materials as listed in 1.1.1.
- **1.3 Application.** Administrative, operational, and maintenance provisions of this code shall apply to the following:
- Conditions and operations arising after the adoption of the code
- (2) Existing conditions and operations

# 1.3.1 Conflicts.

**1.3.1.1** Where requirements between this code and a referenced NFPA document differ, the requirements of this code shall apply.

- **1.3.1.2** Where a conflict between a general requirement of this code and a specific requirement of this code exists, the specific requirement shall apply.
- **1.3.2 Multiple Occupancies.** Where two or more classes of occupancy occur in the same building or structure and are so intermingled that separate safeguards are impracticable, means of egress facilities, construction, protection, and other safeguards shall comply with the most restrictive fire safety requirements of the occupancies involved.
- **1.3.3 Vehicles and Marine Vessels.** Vehicles, marine vessels, or other similar conveyances, where in fixed locations and occupied as buildings, as described by Section 11.6 of NFPA *101* shall be treated as buildings and comply with this code.

#### 1.3.4 Buildings.

- **1.3.4.1** Buildings permitted for construction after the adoption of this code shall comply with the provisions stated herein for new buildings.
- **1.3.4.2** Repairs, renovations, alterations, reconstruction, change of occupancy, and additions to buildings shall conform with NFPA *101* and the building code.
- **1.3.4.3** Newly introduced equipment, materials, and operations regulated by this code shall comply with the requirements for new construction or processes.
- **1.3.5 Severability.** If any provision of this code or the application thereof to any person or circumstance is held invalid, the remainder of the code and the application of such provision to other persons or circumstances shall not be affected thereby.
- **1.4 Retroactivity.** The provisions of this code reflect a consensus of what is necessary to provide an acceptable degree of protection from the hazards addressed in this code at the time the code was issued.
- **1.4.1** Unless otherwise specified, the provisions of this code shall not apply to facilities, equipment, structures, or installations that existed or were approved for construction or installation prior to the effective date of the code. Where specified, the provisions of this code shall be retroactive.
- **1.4.2** In those cases where the authority having jurisdiction (AHJ) determines that the existing condition presents an unacceptable degree of risk, the AHJ shall be permitted to apply retroactively any portions of this code deemed appropriate.
- **1.4.3** The retroactive requirements of this code shall be permitted to be modified if their application would be impractical in the judgment of the AHJ, and only where it is evident that a reasonable degree of safety is provided.
- **1.5 Equivalency.** Nothing in this code is intended to prevent the use of systems, methods, or devices of equivalent or superior quality, strength, fire resistance, effectiveness, durability, and safety over those prescribed by this code.
- **1.5.1** Technical documentation shall be submitted to the AHJ to demonstrate equivalency.
- **1.5.2** The system, method, or device shall be approved for the intended purpose by the AHJ.
- **1.5.3 Alternatives.** The specific requirements of this code shall be permitted to be altered by the AHJ to permit alternative methods that will secure equivalent fire safety, but in no case shall the alternative afford less fire safety than, in the judg-

- ment of the AHJ, that which would be provided by compliance with the provisions contained in this code.
- **1.5.4 Modifications.** The AHJ shall be authorized to modify any of the provisions of this code upon application in writing by the owner, a lessee, or a duly authorized representative where there are practical difficulties in carrying out the provisions of the code, provided that the intent of the code is met, public safety is secured, and substantial justice is done.
- **1.5.5** Buildings with equivalency, alternatives, or modifications approved by the AHJ shall be considered as conforming with this code.
- **1.5.6** Each application for an alternative fire protection feature shall be filed with the AHJ and shall be accompanied by such evidence, letters, statements, results of tests, or other supporting information as required to justify the request.
- **1.5.7** The AHJ shall keep a record of the actions on the applications specified in 1.5.6, and a signed copy of the AHJ's decision shall be provided for the applicant.
- **1.5.8 Approval.** The AHJ shall approve alternative construction systems, materials, or methods of design when it is substantiated that the proposed alternative provides an equivalent level of protection of this code.

#### 1.5.9 Tests.

- **1.5.9.1** Where there is insufficient evidence of compliance with the requirements of this code, or where there is evidence that any material or method of construction does not conform to the requirements of this code, or where there is insufficient evidence to substantiate claims for alternative construction systems, materials, or methods of construction, the AHJ shall be permitted to require tests for proof of compliance at the expense of the owner or the owner's agent.
- **1.5.9.2** Test methods shall be as specified by this code for the material in question.
- **1.5.9.3** If no appropriate test methods are specified in this code, the AHJ shall be authorized to accept an applicable test procedure from another recognized source.
- **1.5.9.4** Copies of the results of all tests specified in 1.5.9.2 and 1.5.9.3 shall be retained in accordance with local AHJ guidance.

#### 1.6 Units and Formulas.

- **1.6.1** The units of measure in this code are presented first in U.S. customary units (inch-pound units), followed by International System (SI) of Units in parentheses.
- **1.6.2** Either system of units shall be acceptable for satisfying the requirements in the code.
- **1.6.3** Users of this code shall apply one system of units consistently and shall not alternate between units.
- **1.6.4** The values presented for measurements in this code are expressed with a degree of precision appropriate for practical application and enforcement. It is not intended that the application or enforcement of these values be more precise than the precision expressed.
- **1.6.5** Where extracted text contains values expressed in only one system of units, the values in the extracted text have been retained without conversion to preserve the values established

by the responsible technical committee in the source document.

- 1.7 Enforcement. This code shall be administered and enforced by the AHJ designated by the governing authority. See Annex K for sample wording for enabling legislation.
- 1.8\* Permits. Permits and the permit process shall comply with the requirements of NFPA 1.

# 1.8.1 Plans and Specifications.

- 1.8.1.1 The AHJ shall have the authority to require plans and specifications to ensure compliance with applicable codes and
- 1.8.1.2 Information that is identified by the owner as confidential shall not be made part of the public record.

#### 1.8.2 Stop Work or Evacuation.

- **1.8.2.1** The AHJ shall have the authority to order an operation or use stopped and the immediate evacuation of any occupied building or area when such building or area has hazardous conditions that present imminent danger.
- 1.8.2.2 Whenever any work is being done contrary to provisions of this code, the AHJ is hereby authorized to order such work stopped.
- **1.8.2.3** The work specified in 1.8.2.2 shall immediately stop until authorized by the AHJ to proceed.

#### 1.9 Facility Closure.

- **1.9.1** Where required by the AHJ, no facility storing hazardous materials listed in 1.1.1 shall close or abandon an entire storage facility without notifying the AHI at least 30 days prior to the scheduled closing.
- 1.9.2 The AHJ shall be permitted to reduce the 30-day period specified in 1.9.1 when there are special circumstances requiring such reduction.

#### 1.9.3 Facilities Out of Service.

- 1.9.3.1 Facilities Temporarily Out of Service. Facilities that are temporarily out of service shall continue to maintain a permit and be monitored and inspected.
- 1.9.3.2 Facilities Permanently Out of Service. Facilities for which a permit is not kept current or that are not monitored and inspected on a regular basis shall be deemed to be permanently out of service and shall be closed in accordance with 1.9.4.1 through 1.9.4.2.

#### 1.9.4 Closure Plan.

- 1.9.4.1 Where required by the AHJ, the permit holder or applicant shall submit a closure plan to the fire department to terminate storage, dispensing, handling, or use of hazardous materials at least 30 days prior to facility closure.
- 1.9.4.2 The plan shall demonstrate that hazardous materials that were stored, dispensed, handled, or used in the facility have been transported, disposed of, or reused in a manner that eliminates the need for further maintenance and any threat to public health and safety.

#### 1.10 Emergency Planning.

1.10.1 Emergency Action Plan. An emergency action plan, consistent with the available equipment and personnel, shall be

established to respond to fire and other emergencies in accordance with requirements set forth in NFPA 1.

**1.10.2 Activation.** The facility responsible for an unauthorized release shall activate the emergency action element of the Hazardous Materials Management Plan.

#### 1.11 Hazardous Materials Management Plan (HMMP).

- 1.11.1\* When required by the AHJ, new or existing facilities that store, use, or handle hazardous materials covered by this code in amounts above the MAQ specified in 5.2.1.2 through 5.2.1.5 and 5.4.1.2 shall submit a hazardous materials management plan (HMMP) to the AHJ.
- 1.11.2 The HMMP shall be reviewed and updated as follows:
- When the facility is modified (2)
- When hazardous materials representing a new hazard category not previously addressed are stored, used, or handled in the facility
- 1.11.3 The HMMP shall comply with the requirements of Chapter 6.

#### 1.12\* Hazardous Materials Inventory Statement (HMIS).

- 1.12.1 When required by the AHJ, a hazardous materials inventory statement (HMIS) shall be completed and submitted to the AHJ.
- 1.12.2 The HMIS shall comply with the requirements in NFPA 1.

#### 1.13 Plan Review.

- 1.13.1 Where required by the AHJ for new construction, modification, or rehabilitation, construction documents and shop drawings shall be submitted, reviewed, and approved prior to the start of such work as provided in Section 1.13.
- 1.13.2 The applicant shall be responsible for ensuring that the following conditions are met:
- The construction documents include all of the fire protection requirements.
- The shop drawings are correct and in compliance with the applicable codes and standards.
- The contractor maintains an approved set of construction documents on-site.
- 1.13.3 It shall be the responsibility of the AHJ to promulgate rules that cover the following:
- Criteria to meet the requirements of Section 1.13
- Review of documents and construction documents within established time frames for the purpose of acceptance or providing reasons for nonacceptance
- 1.13.4 Review and approval by the AHI shall not relieve the applicant of the responsibility of compliance with this code.
- 1.13.5 When required by the AHJ, revised construction documents or shop drawings shall be prepared and submitted for review and approval to illustrate corrections or modifications necessitated by field conditions or other revisions to approved plans.

# 1.14 Technical Assistance.

1.14.1 The AHJ shall be permitted, upon prior written notification to the applicant, building owner, or owner's agent, to require a review by an independent third party with expertise in the matter to be reviewed at the submitter's expense.

- **1.14.2** The independent reviewer shall provide an evaluation and recommend necessary changes to the proposed design, operation, process, or new technology to the AHJ.
- **1.14.3** The AHJ shall be authorized to require design submittals to bear the stamp of a professional engineer.
- **1.14.4** The AHJ shall make the final determination as to whether the provisions of this code have been met.

# **Chapter 3 Definitions**

**3.1\* General.** The definitions contained in this chapter shall apply to the terms used in this code. Where terms are not defined in this chapter or within another chapter, they shall be defined using their ordinarily accepted meanings within the context in which they are used. *Merriam-Webster's Collegiate Dictionary*, 11th edition, shall be the source for the ordinarily accepted meaning.

#### 3.2 NFPA Official Definitions.

- **3.2.1\* Approved.** Acceptable to the authority having jurisdiction.
- **3.2.2\* Authority Having Jurisdiction (AHJ).** An organization, office, or individual responsible for enforcing the requirements of a code or standard, or for approving equipment, materials, an installation, or a procedure.
- **3.2.3\* Code.** A standard that is an extensive compilation of provisions covering broad subject matter or that is suitable for adoption into law independently of other codes and standards.

- **3.2.4 Labeled.** Equipment or materials to which has been attached a label, symbol, or other identifying mark of an organization that is acceptable to the authority having jurisdiction and concerned with product evaluation, that maintains periodic inspection of production of labeled equipment or materials, and by whose labeling the manufacturer indicates compliance with appropriate standards or performance in a specified manner.
- **3.2.5\*** Listed. Equipment, materials, or services included in a list published by an organization that is acceptable to the authority having jurisdiction and concerned with evaluation of products or services, that maintains periodic inspection of production of listed equipment or materials or periodic evaluation of services, and whose listing states that either the equipment, material, or service meets appropriate designated standards or has been tested and found suitable for a specified purpose.
- 3.2.6 Shall. Indicates a mandatory requirement.
- **3.2.7 Should.** Indicates a recommendation or that which is advised but not required.
- 3.3 General Definitions.
- **3.3.1\* Absolute Pressure** [**Gas**]. Pressure based on a zero reference point, the perfect vacuum. [55, 2016]
- **N** 3.3.2\* Access Aisle. Limited-width spaces used to move between storage piles.
- **N** 3.3.3\* **Aisle.** A clear area between the faces of two storage piles or the faces of two storage racks providing access to the storage with material-handling equipment.

# 3.3.4 Area.

- **3.3.4.1** *Control Area.* A building or portion of a building or outdoor area within which hazardous materials are allowed to be stored, dispensed, used, or handled in quantities not exceeding the MAQ.
- **3.3.4.2** *Indoor Area [Gas].* An area that is within a building or structure having overhead cover, other than a structure qualifying as "weather protection" in accordance with Section 6.6 of NFPA 55. [**55**, 2016] (*See also 3.3.4.4*, *Outdoor Area.*)
- **3.3.4.3** *Organic Peroxide Storage Area.* An area used for the storage of organic peroxide formulations.
- **3.3.4.4** *Outdoor Area [Gas].* An area that is not an indoor area. [55, 2016]
- **3.3.4.5** *Outdoor Control Area.* An outdoor area within which hazardous materials are allowed to be stored, dispensed, used, or handled in quantities not exceeding the MAQ.
- **3.3.5 ASME.** American Society of Mechanical Engineers. [58, 2017]
- **3.3.6 ASTM [Gas].** American Society for Testing and Materials, now known as "ASTM International." [55, 2016]
- **3.3.7 Basement.** Any story of a building wholly or partly below grade plane that is not considered the first story above grade plane. [5000, 2018].
- **3.3.8 Building.** Any structure used or intended for supporting or sheltering any use or occupancy. [101, 2018]

- **3.3.9 Building Code.** The building or construction code adopted by the jurisdiction.
- **3.3.10 Bulk Ammonium Nitrate.** Large quantities of ammonium nitrate solids in the form of a pile, not divided into parts or packaged into separate units.
- **3.3.11\* Bulk Hydrogen Compressed Gas System.** A gaseous hydrogen  $(GH_2)$  system with a storage capacity of more than 5000 scf  $(141.6 \text{ Nm}^3)$  of compressed hydrogen gas. [55, 2016]
- **3.3.12\* Bulk Inert Gas System.** An assembly of equipment, that consists of, but is not limited to, storage containers, pressure regulators, pressure relief devices, vaporizers, manifolds, and piping, with a storage capacity of more than 20,000 scf (566 m<sup>3</sup>) of inert gas, including unconnected reserves on hand at the site, and that terminates at the source valve. [55, 2016]
- **3.3.13\* Bulk Liquefied Hydrogen System [Gas].** A liquefied hydrogen  $(LH_2)$  system with a storage capacity of more than 39.7 gal (150 L) of liquefied hydrogen. [55, 2016]
- **3.3.14\* Bulk Oxygen System.** An assembly of equipment, such as oxygen storage containers, pressure regulators, pressure relief devices, vaporizers, manifolds, and interconnecting piping, that has a storage capacity of more than 20,000 scf (566 m<sup>3</sup>) of oxygen and that terminates at the source valve. [55, 2016]
- **3.3.15 CFR.** The Code of Federal Regulations of the United States Government. [1, 2018]
- **3.3.16 CGA [Gas].** Compressed Gas Association. [1, 2018]
- **3.3.17 Combustible.** A substance that will burn.
- Δ 3.3.18\* Combustible Dust. A finely divided combustible particulate solid that presents a flash-fire hazard or explosion hazard when suspended in air or the process-specific oxidizing medium over a range of concentrations. [652, 2019]
  - **3.3.19** Combustible Liquid. Any liquid that has a closed-cup flash point at or above 100°F (37.8°C), as determined by the test procedures and apparatus set forth in NFPA 30. Combustible liquids are classified in accordance with the following: (1) Class II Liquid any liquid that has a flash point at or above 100°F (37.8°C) and below 140°F (60°C); (2) Class III Liquid any liquid that has a flash point at or above 140°F (60°C); (a) Class IIIA Liquid any liquid that has a flash point at or above 140°F (60°C), but below 200°F (93°C); and (b) Class IIIB Liquid any liquid that has a flash point at or above 200°F (93°C). [30, 2018]
  - **3.3.20\* Compressed Gas System.** An assembly of equipment designed to contain, distribute, or transport compressed gases. [318, 2018]
  - **3.3.21 Container.** A containment device including, but not limited to, cylinders, tanks, intermediate bulk containers, pressure vessels, drums, carboys, cans, bottles, boxes, bags, bins, and portable tanks that vary in shape, size, and material of construction and are used for holding, storing, and transporting hazardous materials covered by this code.
    - **3.3.21.1** *ASME Container:* A container constructed in accordance with the ASME *Boiler and Pressure Vessel Code.*
    - **3.3.21.2\*** *Container [Flammable and Combustible Liquid].* Any vessel of 119 gal (450 L) or less capacity used for transporting or storing liquids. [30, 2018]

- **3.3.21.3** Closed Container [Flammable and Combustible Liquid]. A container as herein defined, so sealed by means of a lid or other device that neither liquid nor vapor will escape from it at ordinary temperatures. [30, 2018]
- **3.3.21.4** *Combustible Containers.* Containers that include paper bags, fiber drums, plastic containers, and wooden or fiber boxes or barrels, as well as noncombustible containers having removable combustible liners or packing, and noncombustible containers having combustible overpacks.
- **3.3.21.5** *Noncombustible Containers.* Containers constructed of glass or metal that can be coated with a polymeric material no more than  $\frac{1}{2}$  in. (2 mils) in thickness.
- **3.3.21.6\*** *Nonmetallic Container [Solid, Flammable, and Combustible Liquid].* A container as defined in 3.3.21 constructed of glass, plastic, fiber, or a material other than metal. [30, 2018]
- **3.3.21.7** *Overpack Container.* A closed container intended to encapsulate and contain a leaking or damaged liquid or solid material container thereby preventing the release of liquids, solids, or vapors and is made of the same material or similarly protective material as the leaking or damaged container.
- 3.3.21.8 Cylinder Containment Vessel [Gas]. See 3.3.27.
- **3.3.21.9** Storage Tank [Flammable and Combustible Liquid]. Any vessel having a liquid capacity that exceeds 60 gal (230 L), is intended for fixed installation, and is not used for processing. [30, 2018]
- **3.3.21.9.1\*** *Stationary Tank [Gas].* A packaging designed primarily for stationary installations not intended for loading, unloading, or attachment to a transport vehicle as part of its normal operation in the process of use. [55, 2016]
- **3.3.21.10** Aboveground Tank [Flammable and Combustible Liquid]. A storage tank that is installed above grade, at grade, or below grade without backfill. [30, 2018]
- **3.3.21.10.1\*** Atmospheric Tank [Flammable and Combustible Liquid]. A storage tank that has been designed to operate at pressures from atmospheric through a gauge pressure of 1.0 psi (6.9 kPa) (i.e., 760 mm Hg through 812 mm Hg) measured at the top of the tank. [30, 2018]
- **3.3.21.10.2** Secondary Containment Tank [Flammable and Combustible Liquid]. A tank that has an inner and outer wall with an interstitial space (annulus) between the walls and which has a means of monitoring the interstitial space for a leak. [30, 2018]
- **3.3.21.11\*** *Portable Tank [Flammable and Combustible Liquid].* Any vessel having a liquid capacity over 60 gals (230 L) intended for storing liquids and not intended for fixed installation. [30, 2018]
- **3.3.21.11.1\*** *Portable Tank [Gas].* Any packaging over 60 U.S gal (227.1 L) capacity designed primarily to be loaded into or on, or temporarily attached to, a transport vehicle or ship and equipped with skids, mountings, or accessories to facilitate handling of the tank by mechanical means. [55, 2016]
- 3.3.21.11.2\* Nonmetallic Portable Tank [Flammable and Combustible Liquid]. A portable tank as herein defined

constructed of plastic, fiber, or a material other than metal. [30, 2018]

- **3.3.21.12\*** *Pressure Vessel.* A container, process vessel, or other component designed in accordance with the ASME *Boiler and Pressure Vessel Code*, DOT, or other approved standards.
- **3.3.21.13** Cylinder [Gas]. See 3.3.25.
- 3.3.21.13.1 Cylinder Pack [Gas] See 3.3.28.
- **3.3.21.14** *Compressed Gas Container (Gas).* A pressure vessel designed to hold compressed gas at an absolute pressure greater than 1 atmosphere at 68°F (20°C) that includes cylinders, containers, and tanks. [55, 2016]
- **3.3.21.14.1\*** *Tube Trailer [Gas].* See 3.3.87.
- **3.3.21.15\*** *ISO Module.* A single unit or unit assembly of containers, IBCs, portable tanks, or cylinders permanently mounted in a frame conforming to International Organization for Standardization (ISO) requirements.
- **3.3.21.16\*** *Safety Can [Liquid].* A listed container of not more than 5.3 gal (20 L) capacity having a screen or strainer in each fill and pour opening and having a spring closing lid and spout cover designed to safely relieve internal pressure when exposed to fire. [30, 2018]
- **3.3.21.17** *Aerosol Container [Liquid]*. A metal can or plastic container up to a maximum size of 33.8 fl oz (1000 ml) or a glass, stone, or metal bottle up to a maximum size of 4 fl oz (118 ml) that is designed and intended to dispense an aerosol. [30B, 2019]
- **3.3.22 Continuous Gas Detection System [Gas].** A gas detection system in which the instrument is maintained in continuous operation and the interval between sampling of any point does not exceed 30 minutes. [55, 2016]
- **3.3.23 Court.** An open, uncovered, unoccupied space, unobstructed to the sky, bounded on three or more sides by exterior building walls. [101, 2018]
  - **3.3.23.1** *Enclosed Court.* A court bounded on all sides by the exterior walls of a building or by the exterior walls and lot lines on which walls are permitted. [5000, 2018]
- **3.3.24 Cryogenic Fluid [Gas].** A fluid with a boiling point lower than  $-130^{\circ}F$  ( $-90^{\circ}C$ ) at an absolute pressure of 14.7 psi (101.325 kPa). [55, 2016]
  - **3.3.24.1** *Flammable Cryogenic Fluid.* A cryogenic fluid that forms flammable mixture in air when in its vapor state. [55, 2016]
  - **3.3.24.2** *Inert Cryogenic Fluid.* A cryogenic fluid that vaporizes to produce an inert gas when in its vapor state. [55, 2016]
  - **3.3.24.3** *Oxidizing Cryogenic Fluid.* An oxidizing gas in the cryogenic state. [55, 2016]
- **3.3.25\* Cylinder [Gas].** A pressure vessel designed for pressures higher than absolute pressure of 40 psi (276 kPa) and having a circular cross-section.
- **3.3.26 Cylinder Containment System [Gas].** A gastight recovery system comprising equipment or devices that can be placed over a leak in a compressed gas container, thereby stopping or

- controlling the escape of gas from the leaking container. [55, 2016]
- **3.3.27 Cylinder Containment Vessel [Gas].** A gastight recovery vessel designed so that a leaking compressed gas container can be placed within its confines, thereby encapsulating the leaking container. [55, 2016]
- **3.3.28\* Cylinder Pack [Gas].** An arrangement of cylinders into a cluster where the cylinders are confined into a grouping or arrangement with a strapping or frame system and connections are made to a common manifold. The frame system is allowed to be on skids or wheels to permit movement. **[55,** 2016]
- **3.3.29 Deflagration.** Propagation of a combustion zone at a velocity that is less than the speed of sound in the unreacted medium. [68, 2018]
- **3.3.30 Detached Building.** A separate building that is separated from other structures or uses as required by *NFPA 5000* for a freestanding structure. [5000, 2018]
- **3.3.31 Detonation.** Propagation of a combustion zone at a velocity greater than the speed of sound in the unreacted medium. [68, 2018]
- **3.3.32 Distributor [Gas].** A business engaged in the sale or resale, or both, of compressed gases or cryogenic fluids, or both. [55, 2016]
- **3.3.33 DOT.** U.S. Department of Transportation. [52, 2016]
- **3.3.34 Emergency Response.** Emergency response or responding to emergencies means a response effort by employees from outside the immediate release area or by other designated responders including, but not limited to, private sector emergency responders, mutual aid groups, local fire departments, or other qualified parties to an occurrence that results, or is likely to result, in an uncontrolled release of a hazardous material.
- **3.3.35 Emergency Response Liaison.** A person designated to act as a liaison for emergency response as defined by the emergency plan.
- **3.3.36 Emergency Shutoff Valve [Gas].** A designated valve designed to shut off the flow of gases or liquids. [55, 2016]
  - **3.3.36.1** Automatic Emergency Shutoff Valve [Gas]. A designated fail-safe automatic closing valve designed to shut off the flow of gases or liquids that is initiated by a control system where the control system is activated by either manual or automatic means. [55, 2016]
  - **3.3.36.2** *Manual Emergency Shutoff Valve [Gas].* A designated valve designed to shut off the flow of gases or liquids that is manually operated. [55, 2016]
- **3.3.37 Excess Flow Control [Gas].** A fail-safe system or approved means designed to shut off flow due to a rupture in pressurized piping systems. [55, 2016]
- **3.3.38\* Exhausted Enclosure [Gas].** An appliance or piece of equipment that consists of a top, a back, and two sides that provides a means of local exhaust for capturing gases, fumes, vapors, and mists. [55, 2016]
- **3.3.39\* Explosion Control [Gas].** A means of either preventing an explosion through the use of explosion suppression, fuel reduction, or oxidant reduction systems or a means to

- prevent the structural collapse of a building in the event of an explosion through the use of deflagration venting, barricades, or related construction methods. [55, 2016]
- △ 3.3.40 Explosion Vent. An opening in an enclosure to relieve the developing pressure from a deflagration.
  - **3.3.41\* Explosive.** Any chemical compound, mixture, or device, the primary or common purpose of which is to function by explosion. [495, 2018]
  - **3.3.42\* Explosive Decomposition.** Rapid chemical reaction resulting in a large, almost instantaneous, release of energy.
  - **3.3.43\* Explosive Reaction.** A reaction, which includes both deflagration and detonation, producing a sudden rise in pressure with potentially destructive results.
  - **3.3.44 Fire Prevention Code.** The fire prevention code adopted by the jurisdiction.
  - **3.3.45 Fire Protection System.** Any fire alarm device or system or fire extinguishing device or system, or a combination thereof, that is designed and installed for detecting, controlling, or extinguishing a fire or otherwise alerting occupants, or the fire department, or both, that a fire has occurred. [1, 2018]
  - **3.3.46\* Flammable Liquid (Class I).** Any liquid having a closed-cup flash point below 100°F (37.8°C).
  - **3.3.47\* Flammable Solid.** A solid substance, other than a substance defined as a blasting agent or explosive, that is liable to cause fire resulting from friction or retained heat from manufacture, that has an ignition temperature below 212°F (100°C), or that burns so vigorously or persistently when ignited that it creates a serious hazard.
  - **3.3.48 Gallon [Gas].** A standard U.S. gallon. [55, 2016]

#### 3.3.49 Gas.

- **3.3.49.1\*** *Compressed Gas [Gas]*. A material, or mixture of materials, that (1) is a gas at 68°F (20°C) or less at an absolute pressure of 14.7 psi (101.325 kPa) and (2) that has a boiling point of 68°F (20°C) or less at an absolute pressure of 14.7 psi (101.325 kPa) and that is liquefied, nonliquefied, or in solution, except those gases that have no other health or physical hazard properties are not considered to be compressed gases until the pressure in the packaging exceeds an absolute pressure of 40.6 psi (280 kPa) at 68°F (20°C). [55, 2016]
- **3.3.49.2** *Corrosive Gas [Gas].* A gas that causes visible destruction of or irreversible alterations in living tissue by chemical action at the site of contact. [55, 2016]
- **3.3.49.3** *Flammable Gas [Gas]*. A material that is a gas at 68°F (20°C) or less at an absolute pressure of 14.7 psi (101.325 kPa), that is ignitable at an absolute pressure of 14.7 psi (101.325 kPa) when in a mixture of 13 percent or less by volume with air, or that has a flammable range at an absolute pressure of 14.7 psia (101.325 kPa) with air of at least 12 percent, regardless of the lower limit. [55, 2016]
- **3.3.49.4** *Flammable Liquefied Gas [Gas].* A liquefied compressed gas that, when under a charged pressure, is partially liquid at a temperature of 68°F (20°C) and is flammable. [55, 2016]
- **3.3.49.5** *Highly Toxic Gas [Gas].* A chemical that has a median lethal concentration ( $LC_{50}$ ) in air of 200 ppm by

volume or less of gas or vapor, or 2 mg/L or less of mist, fume, or dust, when administered by continuous inhalation for 1 hour (or less if death occurs within 1 hour) to albino rats weighing between 0.44 lb and 0.66 lb (200 g and 300 g) each. [55, 2016]

- **3.3.49.6** *Inert Gas [Gas].* A nonreactive, nonflammable, noncorrosive gas such as argon, helium, krypton, neon, nitrogen, and xenon. [55, 2016]
- **3.3.49.7\*** *Irritant Gas [Gas].* A chemical that is not corrosive, but that causes a reversible inflammatory effect on living tissue by chemical action at the site of contact.
- **3.3.49.8** *Nonflammable Gas [Gas].* A gas that does not meet the definition of a flammable gas. [55, 2016]
- **3.3.49.9\*** *Other Gas [Gas]*. A gas that is not a corrosive gas, flammable gas, highly toxic gas, oxidizing gas, pyrophoric gas, toxic gas, or unstable reactive gas with a hazard rating of Class 2, Class 3, or Class 4 gas. [55, 2016]
- **3.3.49.10** *Oxidizing Gas [Gas]*. A gas that can support and accelerate combustion of other materials more than air does. [55, 2016]
- **3.3.49.11** *Pyrophoric Gas [Gas].* A gas with an autoignition temperature in air at or below  $130^{\circ}$ F ( $54.4^{\circ}$ C). [**55**, 2016]
- **3.3.49.12** *Toxic Gas [Gas].* A gas with a median lethal concentration ( $LC_{50}$ ) in air of more than 200 ppm, but not more than 2000 ppm by volume of gas or vapor, or more than 2 mg/L, but not more than 20 mg/L of mist, fume, or dust, when administered by continuous inhalation for 1 hour (or less if death occurs within 1 hour) to albino rats weighing between 0.44 lb and 0.66 lb (200 g and 300 g) each. [55, 2016]
- **3.3.49.13\*** *Unstable Reactive Gas [Gas].* A gas that, in the pure state or as commercially produced, will vigorously polymerize, decompose, or condense, become self-reactive, or otherwise undergo a violent chemical change under conditions of shock, pressure, or temperature. [55, 2016]
- **3.3.49.13.1** Class 2 Unstable Reactive Gas [Gas]. Materials that readily undergo violent chemical change at elevated temperatures and pressures. [55, 2016]
- **3.3.49.13.2** Class 3 Unstable Reactive Gas [Gas]. Materials that in themselves are capable of detonation or explosive decomposition or explosive reaction, but that require a strong initiating source or that must be heated under confinement before initiation. [55, 2016]
- **3.3.49.13.3** *Class 4 Unstable Reactive Gas [Gas]*. Materials that in themselves are readily capable of detonation or explosive decomposition or explosive reaction at normal temperatures and pressures. [55, 2016]
- **3.3.50\* Gas Cabinet [Gas].** A fully enclosed, noncombustible enclosure used to provide an isolated environment for compressed gas cylinders in storage or use. [55, 2016]
- **3.3.51 Gas Manufacturer/Producer [Gas].** A business that produces compressed gases or cryogenic fluids, or both, or fills portable or stationary gas cylinders, containers, or tanks. [55, 9016]
- **3.3.52\* Gas Room** [Gas]. A separately ventilated, fully enclosed room in which only compressed gases, cryogenic

fluids, associated equipment and supplies are stored or used. [55, 2016]

- **3.3.53\* Gaseous Hydrogen (GH<sub>2</sub>) System.** An assembly of equipment that consists of, but is not limited to, storage containers, pressure regulators, pressure relief devices, compressors, manifolds, and piping and that terminates at the source valve. [55, 2016]
- **3.3.54 Handling.** The deliberate movement of material by any means to a point of storage or use. [1, 2018]
- **3.3.55 Hazardous Materials Storage Cabinet.** A metal cabinet complying with the conditions set forth in 6.1.18.
- 3.3.56 High-Hazard Level Contents.
  - **3.3.56.1** *High-Hazard Level 1 Contents.* For definition and examples see 4.2.1.2.1.
  - **3.3.56.2** *High-Hazard Level 2 Contents.* For definition and examples see 4.2.1.2.2.
  - **3.3.56.3** *High-Hazard Level 3 Contents.* For definition and examples see 4.2.1.2.3.
  - **3.3.56.4** *High-Hazard Level 4 Contents.* For definition and examples see 4.2.1.2.4.
- **3.3.57\*** Immediately Dangerous to Life and Health (IDLH) [Gas]. A concentration of airborne contaminants, normally expressed in parts per million (ppm) or milligrams per cubic meter, that represents the maximum level from which one could escape within 30 minutes without any escape-impairing symptoms or irreversible health effects. [55, 2016]
- **3.3.58\* ISO Module [Gas].** An assembly of tanks or tubular cylinders permanently mounted in a frame conforming to International Organization for Standardization (ISO) requirements. [55, 2016]
- 3.3.59 Limit.
  - **3.3.59.1** *Ceiling Limit.* The maximum concentration of an airborne contaminant to which a person can be exposed.
  - **3.3.59.2\*** *Permissible Exposure Limit (PEL) [Gas].* The maximum permitted 8-hour, time-weighted average concentration of an airborne contaminant. [55, 2016]
  - **3.3.59.3\*** Short-Term Exposure Limit (STEL) [Gas]. The concentration to which it is believed that workers can be exposed continuously for a short period of time without suffering from irritation, chronic or irreversible tissue damage, or narcosis of a degree sufficient to increase the likelihood of accidental injury, impairment of self-rescue, or the material reduction of work efficiency, without exceeding the daily permissible exposure limit (PEL). [55, 2016]
- **3.3.60 Liquefied Hydrogen (LH<sub>2</sub>) System.** An assembly of equipment that consists of, but is not limited to, storage containers, pressure regulators, pressure relief devices, compressors, manifolds, and piping and that terminates at the source valve. [55, 2016]
- **3.3.61 Manufacturing Plants.** Those facilities where hazardous materials are produced by chemical means or where hazardous materials are pelletized, ground, dissolved, packaged, mixed, or blended.

#### 3.3.62 Material.

- **3.3.62.1** *Combustible (Material).* A material that, in the form in which it is used and under the conditions anticipated, will ignite and burn; a material that does not meet the definition of noncombustible or limited-combustible. [5000, 2018]
- **3.3.62.2\*** *Corrosive Material.* A chemical that causes visible destruction of, or irreversible alterations in, living tissue by chemical action at the site of contact.

#### 3.3.62.3 Hazard Material.

- **3.3.62.3.1** *Health Hazard Material.* A chemical or substance classified as a toxic, highly toxic, or corrosive material in accordance with definitions set forth in this code.
- **3.3.62.3.2** *Physical Hazard Material.* A chemical or substance classified as a combustible liquid, explosive, flammable cryogen, flammable gas, flammable liquid, flammable solid, organic peroxide, oxidizer, oxidizing cryogen, pyrophoric, unstable (reactive), or water-reactive material.
- **3.3.62.4\*** *Hazardous Material.* A chemical or substance that is classified as a physical hazard material or a health hazard material, whether the chemical or substance is in usable or waste condition. (See also 3.3.62.3.1, Health Hazard Material, and 3.3.62.3.2, Physical Hazard Material.)
- **3.3.62.5\*** *Incompatible Material.* Materials that, when in contact with each other, have the potential to react in a manner that generates heat, fumes, gases, or by-products that are hazardous to life or property.
- 3.3.62.6 Limited-Combustible (Material). See 4.6.2.
- 3.3.62.7\* Noncombustible Material. See 4.6.1.
- **3.3.62.8** *Pyrophoric Material.* A chemical with an autoignition temperature in air at or below 130°F (54.4°C).
- 3.3.62.9\* Toxic Material. A material that produces a lethal dose or a lethal concentration within any of the following categories: (1) a chemical or substance that has a median lethal dose (LD<sub>50</sub>) of more than 50 mg/kg but not more than 500 mg/kg of body weight when administered orally to albino rats weighing between 200 g and 300 g each; (2) a chemical or substance that has a median lethal dose (LD<sub>50</sub>) of more than 200 mg/kg but not more than 1000 mg/kg of body weight when administered by continuous contact for 24 hours, or less if death occurs within 24 hours, with the bare skin of albino rabbits weighing between 2 kg and 3 kg each; (3) a chemical or substance that has a median lethal concentration (LC<sub>50</sub>) in air of more than 200 parts per million but not more than 2000 parts per million by volume of gas or vapor, or more than 2 mg/L but not more than 20 mg/L, of mist, fume, or dust when administered by continuous inhalation for 1 hour, or less if death occurs within 1 hour, to albino rats weighing between 200 g and 300 g each.
- **3.3.62.9.1\*** *Highly Toxic Material.* A material that produces a lethal dose or lethal concentration that falls within any of the following categories: (1) a chemical that has a median lethal dose ( $LD_{50}$ ) of 50 mg/kg or less of body weight when administered orally to albino rats weighing between 200 g and 300 g each; (2) a chemical that has a median lethal dose ( $LD_{50}$ ) of 200 mg/kg or less of body weight when

- administered by continuous contact for 24 hours, or less if death occurs within 24 hours, with the bare skin of albino rabbits weighing between 2 kg and 3 kg each or albino rats weighing 200 g and 300 g each; (3) a chemical that has a median lethal concentration (LC<sub>50</sub>) in air of 200 parts per million by volume or less of gas or vapor, or 2 mg/L or less of mist, fume, or dust, when administered by continuous inhalation for 1 hour, or less if death occurs within 1 hour, to albino rats weighing between 200 g and 300 g each.
- **3.3.62.10\*** *Unstable (Reactive) Material.* A material that, in the pure state or as commercially produced, will vigorously polymerize, decompose or condense, become self-reactive, or otherwise undergo a violent chemical change under conditions of shock, pressure, or temperature.
- **3.3.62.10.1\*** *Class 1 Unstable (Reactive)*. Materials that in themselves are normally stable, but that can become unstable at elevated temperatures and pressures.
- **3.3.62.10.2\*** *Class 2 Unstable (Reactive)*. Materials that readily undergo violent chemical change at elevated temperatures and pressures.
- **3.3.62.10.3\*** *Class 3 Unstable (Reactive)*. Materials that in themselves are capable of detonation or explosive decomposition or explosive reaction, but that require a strong initiating source or that must be heated under confinement before initiation.
- **3.3.62.10.4\*** *Class 4 Unstable (Reactive)*. Materials that in themselves are readily capable of detonation or explosive decomposition or explosive reaction at normal temperatures and pressures.
- **3.3.62.11\*** *Water-Reactive Material.* A material that explodes, violently reacts, produces flammable, toxic, or other hazardous gases; or evolves enough heat to cause selfignition or ignition of nearby combustibles upon exposure to water or moisture.
- **3.3.63\* Maximum Allowable Quantity Per Control Area** (MAQ). A threshold quantity of hazardous material in a specific hazard class that once exceeded, requires the application of additional administrative procedures, construction features, or engineering controls.
- **3.3.64 Mechanical Code [Gas].** The mechanical or mechanical construction code adopted by the jurisdiction. [55, 2016]
- **3.3.65\* Mobile Supply Unit [Gas].** Any supply source that is equipped with wheels so it is able to be moved around. [55, 2016]
- **3.3.66\* Nesting** [Gas]. A method of securing cylinders upright in a tight mass using a contiguous three-point contact system whereby all cylinders in a group have a minimum of three contact points with other cylinders or a solid support structure (e.g., a wall or railing). [55, 2016]
- **3.3.67\* Nonbulk Flammable Gas System.** A system consisting of cylinders or other storage systems, with each individual cylinder and each individual set of connected cylinders having less than 5000 scf (141.6 Nm<sup>3</sup>). [**55**, 2016]
- **3.3.68\* Normal Temperature and Pressure (NTP) [Gas].** A temperature of 70°F (21°C) at an absolute pressure of 14.7 psi (101.325 kPa). [55, 2016]

**DEFINITIONS** 400-17

- **3.3.69 Occupancy.** The purpose for which a building or other structure, or part thereof, is used or intended to be used. [ASCE/SEI 7:1.2]
  - 3.3.69.1\* Assembly Occupancy. An occupancy (1) used for a gathering of 50 or more persons for deliberation, worship, entertainment, eating, drinking, amusement, awaiting transportation, or similar uses: or (2) used as a special amusement building, regardless of occupant load. [101, 2018]
  - 3.3.69.2\* Business Occupancy. An occupancy used for the transaction of business other than mercantile. [5000, 2018]
  - 3.3.69.3\* Day-Care Occupancy. An occupancy in which four or more clients receive care, maintenance, and supervision, by other than their relatives or legal guardians, for less than 24 hours per day. [5000, 2018]
  - 3.3.69.4\* Detention and Correctional Occupancy. An occupancy used to house one or more persons under varied degrees of restraint or security where such occupants are mostly incapable of self-preservation because of security measures not under the occupants' control. [5000, 2018]
  - 3.3.69.5\* Educational Occupancy. An occupancy used for educational purposes through the twelfth grade by six or more persons for 4 or more hours per day or more than 12 hours per week. [5000, 2018]
  - 3.3.69.6\* Health Care Occupancy. An occupancy used to provide medical or other treatment or care simultaneously to four or more patients, on an inpatient basis, where such patients are mostly incapable of self-preservation due to age, physical or mental disability, or because of security measures not under the occupants' control. [5000, 2018]
  - 3.3.69.6.1\* Ambulatory Health Care Occupancy. An occupancy used to provide services or treatment simultaneously to four or more patients that provides, on an outpatient basis, one or more of the following: (1) treatment for patients that renders the patients incapable of taking action for self-preservation under emergency conditions without the assistance of others; (2) anesthesia that renders the patients incapable of taking action for self-preservation under emergency conditions without the assistance of others; (3) treatment for patients who, due to the nature of their injury or illness, are incapable of taking action for selfpreservation under emergency conditions without the assistance of others. [101, 2018]
  - 3.3.69.7\* Industrial Occupancy. An occupancy in which products are manufactured or in which processing, assembling, mixing, packaging, finishing, decorating, or repair operations are conducted. [5000, 2018]
  - 3.3.69.8\* Mercantile Occupancy. An occupancy used for the display and sale of merchandise. [5000, 2018]
  - 3.3.69.9 Multiple Occupancy. A building or structure in which two or more classes of occupancy exist. [5000, 2018]
  - 3.3.69.10\* Residential Board and Care Occupancy. An occupancy used for lodging and boarding of four or more residents, not related by blood or marriage to the owners or operators, for the purpose of providing personal care services. [5000, 2018]

3.3.69.11\* Residential Occupancy. An occupancy that provides sleeping accommodations for purposes other than health care or detention and correctional. [5000, 2018]

- **3.3.69.12\*** *Storage Occupancy.* An occupancy used primarily for the storage or sheltering of goods, merchandise, products, or vehicles. [5000, 2018]
- 3.3.70 Organic Peroxide. Any organic compound having a double oxygen or peroxy (-O-O-) group in its chemical struc-
- **3.3.71 Organic Peroxide Formulation.** A pure or technically pure organic peroxide or a mixture of organic peroxides with an active oxygen (aO) concentration greater than 1 percent alone or in combination with one or more materials. The transport type for organic peroxide formulations is determined by the UN Manual of Tests and Criteria, Part II. Terms such as accelerator, catalyst, initiator, and curing agent are sometimes used to describe organic peroxide formulations and are misleading because they can also refer to materials that are not or do not contain organic peroxides, some of which might present increased hazard when mixed with organic peroxides.
  - 3.3.71.1 Class 1 Organic Peroxide. Describes organic peroxide formulations that are more severe than a Class II but do not detonate and that are characterized as "explosive in package" or by a very fast burning rate. Includes those characterized for transport as Type B, those characterized for transport as Type C with a large-scale burning rate equal to or greater than 300 kg/min, and those characterized for transport as Type C with a small-scale burning rate greater than 9.0 kg/min × m<sup>2</sup> unless the large-scale burning rate is less than 300 kg/min.
  - 3.3.71.2 Class II Organic Peroxide.
- 3.3.71.2.1 Class IIA Organic Peroxide. Describes organic peroxide formulations characterized for transport as Type C with a large-scale burning rate greater than 140 kg/min but less than 300 kg/min. Includes those characterized as Type C, Type D, and Type E if the small-scale burning rate is greater than  $2.2 \text{ kg/min} \times \text{m}^2$ .
- 3.3.71.2.2 Class IIB Organic Peroxide. Describes organic peroxide formulations characterized for transport as Type C with a large-scale burning rate of greater than 60 kg/min but less than 140 kg/min. Includes those characterized for transport as Type D with a large-scale burning rate greater than 60 kg/min, those characterized for transport as Type E with a large-scale burning rate greater than 60 kg/min, and those characterized as Type C, Type D, and Type E if the small-scale burning rate is greater than  $0.9 \text{ kg/min} \times \text{m}^2$ .
- 3.3.71.3 Class III Organic Peroxide. Describes organic peroxide formulations that burn rapidly and present a moderate reactivity hazard. Includes those characterized for transport as Type D with a large-scale burning rate equal to or greater than 10 kg/min but less than 60 kg/min, those characterized for transport as Type E with a large-scale burning rate equal to or greater than 10 kg/min but less than 60 kg/min, those characterized for transport as Type F with a large-scale burning rate equal to or greater than 10 kg/min, and those characterized as Type D, Type E, and Type F if the smallscale burning rate is less than  $0.9 \text{ kg/min} \times \text{m}^2$ .
- 3.3.71.4 Class IV Organic Peroxide. Describes organic peroxide formulations that burn in the same manner as ordinary

- combustibles and present a minimal reactivity hazard. Includes those characterized for transport as Type E or Type F with a large-scale burning rate less than 10 kg/min.
- Δ 3.3.71.5 Class V Organic Peroxide. Describes organic peroxide formulations that burn with less intensity than ordinary combustibles or those that do not sustain combustion and present no reactivity hazard, and those characterized for transport as Type G without additional subsidiary risks.
  - **3.3.72 OSHA [Gas].** The Occupational Safety and Health Administration of the U.S. Department of Labor. [55, 2016]
  - **3.3.73\* Oxidizer.** Any solid or liquid material that readily yields oxygen or other oxidizing gas or that readily reacts to promote or initiate combustion of combustible materials and that can, under some circumstances, undergo a vigorous self-sustained decomposition due to contamination or heat exposure.
    - **3.3.73.1** *Class 1.* An oxidizer that does not moderately increase the burning rate of combustible materials with which it comes into contact or a solid oxidizer classified as Class 1 when tested in accordance with the test protocol set forth in Section G.1.
    - **3.3.73.2** *Class* **2.** An oxidizer that causes a moderate increase in the burning rate of combustible materials with which it comes into contact or a solid oxidizer classified as Class 2 when tested in accordance with the test protocol set forth in Section G.1.
    - **3.3.73.3** *Class 3.* An oxidizer that causes a severe increase in the burning rate of combustible materials with which it comes into contact or a solid oxidizer classified as Class 3 when tested in accordance with the test protocol set forth in Section G.1.
    - **3.3.73.4** Class 4. An oxidizer that can undergo an explosive reaction due to contamination or exposure to thermal or physical shock and that causes a severe increase in the burning rate of combustible materials with which it comes into contact.
  - **3.3.74 Pile.** Material in a single contiguous storage area, including any material not properly separated by appropriate distance.
  - **3.3.75\* Protection Level.** A term used to describe a tier of building safety that exceeds the construction requirements for control areas to accommodate quantities of hazardous materials in excess of those permitted using the control area concept. (See Section 5.3.)
  - **3.3.76 Remotely Located, Manually Activated Shutdown Control [Gas].** A control system that is designed to initiate shutdown of the flow of gas or liquid that is manually activated from a point located some distance from the delivery system. **[55, 2016]**
  - **3.3.77\* Safety Data Sheet (SDS).** The document that describes composition of a material, hazardous properties and hazard mitigation, and disposal information.
  - **3.3.78\* Secondary Containment.** That level of containment that is external to and separate from primary containment.
  - **3.3.79 Spill Control.** A method for the control of a hazardous materials spill.

- **3.3.80 Standard Cubic Foot (scf) of Gas [Gas].** An amount of gas that occupies one cubic foot at an absolute pressure of 14.7 psi (101 kPa) and a temperature of 70°F (21°C). [55, 2016]
- **3.3.81 Storage, Compressed Gases or Cryogenic Fluids [Gas].** An inventory of compressed gases or cryogenic fluids in containers that are not in the process of being examined, serviced, refilled, loaded, or unloaded.
  - **3.3.81.1** *Bulk Solid Storage.* The storage of more than 6000 lb (2722 kg) in a single container.
  - **3.3.81.2** *Detached Storage.* Storage in a separate building or in an outside area located away from all structures. [1, 2018]
  - **3.3.81.2.1** *Detached Building.* A separate single-story building, without a basement or crawl space, used for the storage or use of hazardous materials and located an approved distance from all other structures.
  - **3.3.81.2.2** *Detached Storage (Oxidizers).* Storage in either an open outside area or in a separate building containing no incompatible materials and located away from all other structures.
  - **3.3.81.3** *Segregated Storage*. Storage in the same room or inside area but physically separated by distance, noncombustible partitions, cabinets, or enclosures from incompatible materials.
- **3.3.82\* Storage (Hazardous Material).** Hazardous material in the act of being stored as a supply reserved for future use or disposal including, but not limited to, any of the following: (1) hazardous material packaged in individual containers, without active connections, that can be handled, stacked, arranged or transported on site; (2) unconnected mobile equipment or over-the-road transport vehicles containing hazardous materials awaiting transportation; (3) mobile equipment including over-the-road transport vehicles containing hazardous materials when connected and serving as a source of supply; (4) stationary tanks containing hazardous materials, including tanks connected and serving as a source of supply.
- **3.3.83 Storage Height.** The height from the finished floor to the top of the highest container or a pile's peak.
- 3.3.84\* Tank.
  - **3.3.84.1** *Container Tank.* Any vessel of 119 gal (450 L), 1000 lb (454 kg) or less water capacity used for transporting or storing hazardous chemicals.
  - **3.3.84.2\*** *Portable Tank.* A container designed primarily to be loaded into or on or temporarily attached to a transport vehicle or ship and equipped with skids, mountings, or accessories to facilitate handling of the tank by mechanical means and not intended for fixed installation.
  - **3.3.84.3\*** *Stationary Tank.* A vessel used for storing hazardous materials designed for stationary installations not intended for loading, unloading, or attachment to a transport vehicle or ship as part of its normal operation in the process of use.
- **3.3.85 TC [Gas].** Transport Canada. [**55**, 2016]
- **3.3.86 Treatment System [Gas].** An assembly of equipment capable of processing a hazardous gas or vapor and reducing

- the gas concentration to a predetermined level at the point of discharge from the system to the atmosphere.
- **3.3.87\* Tube Trailer [Gas].** A truck or semitrailer on which a number of very long compressed gas tubular cylinders have been mounted and manifolded into a common piping system. **[55,** 2016]
- **3.3.88\* Use.** To place a material, including solids, liquids, and gases, into action.
  - **3.3.88.1\*** *Closed System Use.* Use of a solid or liquid hazardous material in a closed vessel or system that remains closed during normal operations where vapors emitted by the product are not liberated outside of the vessel or system and the product is not exposed to the atmosphere during normal operations and all uses of compressed gases.
  - **3.3.88.2\*** *Open System Use.* Use of a solid or liquid hazardous material in a vessel or system that is continuously open to the atmosphere during normal operations and where vapors are liberated or the product is exposed to the atmosphere during normal operations.
- **3.3.89 Valve Outlet Cap or Plug [Gas].** A removable device that forms a gastight seal on the outlet to the control valve that is provided on a source containing a compressed gas or cryogenic fluid. [55, 2016]
- **3.3.90 Valve Protection Cap [Gas].** A rigid, removable cover provided for container valve protection during handling, transportation, and storage. [55, 2016]
- **3.3.91 Valve Protection Device [Gas].** A device attached to the neck ring or body of a cylinder for the purpose of protecting the cylinder valve from being struck or from being damaged by the impact resulting from a fall or an object striking the cylinder. [1, 2018]
- **3.3.92 Waste.** Hazardous materials that have been determined by the user to be beyond their useful life and that are awaiting disposal or processing by either public or private means.
- 3.4 Special Performance-Based Definitions.
- 3.4.1 Analysis.
  - **3.4.1.1** *Sensitivity Analysis.* An analysis performed to determine the degree to which a predicted output will vary given a specified change in an input parameter, usually in relation to models. [5000, 2018]
  - **3.4.1.2** *Uncertainty Analysis.* An analysis performed to determine the degree to which a predicted value will vary. [5000, 2018]
- **3.4.2 Data Conversion.** The process of developing the input data set for the assessment method of choice. [*101*, 2018]
- **3.4.3 Design Fire Scenario.** See 3.4.8.1.
- $\textbf{3.4.4 Design Specification.} \ \ See \ 3.4.18.1.$
- **3.4.5 Design Team.** A group of stakeholders including, but not limited to, representatives of the architect, client, and any pertinent engineers and other designers. [101, 2018]
- **3.4.6\* Exposure Fire.** A fire that starts at a location that is remote from the area being protected and grows to expose that which is being protected. [101, 2018]

- **3.4.7\* Fire Model.** A structured approach to predicting one or more effects of a fire. [101, 2018]
- **3.4.8\* Fire Scenario.** A set of conditions that defines the development of fire, the spread of combustion products throughout a building or portion of a building, the reactions of people to fire, and the effects of combustion products. [101, 2018]
  - **3.4.8.1** *Design Fire Scenario.* A fire scenario selected for evaluation of a proposed design. [914, 2015]
- **3.4.9\* Fuel Load.** The total quantity of combustible contents of a building, space, or fire area.  $[5000, \overline{2018}]$
- 3.4.10 Input Data Specification. See 3.4.18.2.
- **3.4.11 Occupant Characteristics.** The abilities or behaviors of people before and during a fire. [101, 2018]
- **3.4.12\* Performance Criteria.** Threshold values on measurement scales that are based on quantified performance objectives. [101, 2018]
- **3.4.13\* Proposed Design.** A design developed by a design team and submitted to the authority having jurisdiction for approval. [101, 2018]
- **3.4.14 Safe Location.** A location remote or separated from the effects of a fire so that such effects no longer pose a threat. [*101*, 2018]
- **3.4.15 Safety Factor.** A factor applied to a predicted value to ensure that a sufficient safety margin is maintained. [101, 2018]
- **3.4.16 Safety Margin.** The difference between a predicted value and the actual value where a fault condition is expected. [101, 2018]
- **3.4.17 Sensitivity Analysis.** See 3.4.1.1.
- 3.4.18 Specification.
  - **3.4.18.1** *Design Specification.* A building characteristic and other conditions that are under the control of the design team. [5000, 2018]
  - **3.4.18.2** *Input Data Specification*. Information required by the verification method. [101, 2018]
- **3.4.19 Stakeholder.** An individual, or representative of same, having an interest in the successful completion of a project. [101, 2018]
- **3.4.20 Uncertainty Analysis.** See 3.4.1.2.
- **3.4.21 Verification Method.** A procedure or process used to demonstrate or confirm that the proposed design meets the specified criteria. [101, 2018]

# Chapter 4 Classification of Materials, Wastes, and Hazard of Contents

- **4.1\* Hazardous Material Classification.** Materials shall be classified into one or more of the following categories of hazardous materials, based on the definitions found in Chapter 3:
- (1) Corrosive solids, liquids, or gases
- (2) Flammable solids
- (3) Flammable gases

- (4) Flammable cryogenic fluids
- (5) Inert cryogenic fluids
- (6) Inert gases
- (7) Organic peroxide formulations
- (8) Oxidizer solids or liquids
- (9) Oxidizing gases
- (10) Oxidizing cryogenic fluids
- (11) Pyrophoric solids, liquids, or gases
- (12) Toxic or highly toxic solids, liquids, or gases
- (13) Unstable (reactive) solids, liquids, or gases
- (14) Water-reactive solids or liquids

#### 4.2 Classification of High-Hazard Contents.

#### 4.2.1 General.

- **4.2.1.1** High-hazard contents shall include materials defined as hazardous material in Chapter 3, whether stored, used, or handled.
- **4.2.1.2** High-hazard contents shall include those materials defined as hazardous material solids, liquids, or gases limited to the hazard categories specified in 1.1.1 and classified in accordance with 4.2.1.2.1 through 4.2.1.2.4 whether stored, used, or handled.
- **4.2.1.2.1 High-Hazard Level 1 Contents.** High-hazard Level 1 contents shall include materials that present a detonation hazard, including, but not limited to, the following hazard categories:
- (1) Class 4 oxidizers
- (2) Detonable pyrophoric solids or liquids
- (3) Class 3 detonable and Class 4 unstable (reactive) solids, liquids, or gases
- (4) Detonable organic peroxides
- **4.2.1.2.2 High-Hazard Level 2 Contents.** High-hazard Level 2 contents shall include materials that present a deflagration hazard or a hazard from accelerated burning, including, but not limited to, the following hazard categories:
- Combustible dusts that are stored, used, or generated in a manner that creates a severe fire or explosion hazard
- (2) Class I organic peroxides
- (3) Class 3 solid or liquid oxidizers that are used or stored in normally open containers or systems or in closed containers or systems at gauge pressures of more than 15 psi (103.4 kPa)
- (4) Flammable gases
- (5) Flammable cryogenic fluids
- (6) Nondetonable pyrophoric solids, liquids, or gases
- (7) Class 3 nondetonable unstable (reactive) solids, liquids, or gases
- (8) Class 3 water-reactive solids and liquids
- **4.2.1.2.3 High-Hazard Level 3 Contents.** High-hazard Level 3 contents shall include materials that readily support combustion or present a physical hazard, including, but not limited to, the following hazard categories:
- (1) Flammable solids, other than dusts classified as highhazard Level 2, that are stored, used, or generated in a manner that creates a high fire hazard
- (2) Class II and Class III organic peroxides
- (3) Class 2 solid or liquid oxidizers
- (4) Class 3 solid or liquid oxidizers that are used or stored in normally closed containers or systems at gauge pressures of less than 15 psi (103.4 kPa)

- (5) Class 2 unstable (reactive) materials
- (6) Class 2 water-reactive solids, liquids, or gases
- (7) Oxidizing gases
- (8) Oxidizing cryogenic fluids
- **4.2.1.2.4 High-Hazard Level 4 Contents.** High-hazard Level 4 contents shall include materials that are acute health hazards, including, but not limited to the following hazard categories:
- (1) Corrosive solids, liquids, or gases
- (2) Highly toxic solids, liquids, or gases
- (3) Toxic solids, liquids, or gases
- **4.3 Mixtures.** Mixtures shall be classified in accordance with the hazards of the mixture as a whole by an approved, qualified organization, individual, or testing laboratory.
- **4.4\* Multiple Hazards.** Hazardous materials that have multiple hazards shall conform to the code requirements for each applicable hazard category.
- **4.5\* Classification of Waste.** Waste comprised of or containing hazardous materials shall be classified in accordance with Sections 4.1 through 4.4 as applicable.
- **4.5.1\*** Waste classified in accordance with Sections 4.1 through 4.4 shall comply with the requirements of Chapters 1 through 9 and the material-specific requirements of Chapters 11 through 21 as applicable.
- 4.6 Combustibility of Materials.
- 4.6.1\* Noncombustible Material.
- **4.6.1.1** A material that complies with any one of the following shall be considered a noncombustible material:
- (1)\* The material, in the form in which it is used and under the conditions anticipated, will not ignite, burn, support combustion, or release flammable vapors when subjected to fire or heat.
- (2) The material is reported as passing ASTM E136, Standard Test Method for Behavior of Materials in a Vertical Tube Furnace at 750°C.
- (3) The material is reported as complying with the pass/fail criteria of ASTM E136 when tested in accordance with the test method and procedure in ASTM E2652, Standard Test Method for Behavior of Materials in a Tube Furnace with a Cone-Shaped Airflow Stabilizer, at 750 °C.

[**5000:**7.1.4.1.1]

- **4.6.1.2** Where the term *limited-combustible* is used in this code, it shall also include the term *noncombustible*. [**5000:**7.1.4.1.2]
- $\Delta$  4.6.2\* Limited-Combustible Material. A material shall be considered a limited-combustible material where both of the following conditions of 4.6.2(1) and 4.6.2(2), and the conditions of either 4.6.2.1 or 4.6.2.2 are met:
  - (1) The material does not comply with the requirements for a noncombustible material in accordance with 4.6.1.
  - (2) The material, in the form in which it is used, exhibits a potential heat value not exceeding 3500 Btu/lb (8141 kJ/kg) when tested in accordance with NFPA 259.
    [5000:7.4.1.2]
  - **4.6.2.1** The material shall have a structural base of noncombustible material with a surfacing not exceeding a thickness of  $\frac{1}{8}$  in. (3.2 mm) where the surfacing exhibits a flame spread index not greater than 50 when tested in accordance with ASTM E84, Standard Test Method for Surface Burning Characteris-

tics of Building Materials, or ANSI/UL 723, Standard for Test for Surface Burning Characteristics of Building Materials.

- **4.6.2.2** The material shall be composed of materials that, in the form and thickness used, neither exhibit a flame spread index greater than 25 nor evidence of continued progressive combustion when tested in accordance with ASTM E84 or ANSI/UL 723 and are of such composition that all surfaces that would be exposed by cutting through the material on any plane would neither exhibit a flame spread index greater than 25 nor exhibit evidence of continued progressive combustion when tested in accordance with ASTM E84 or ANSI/UL 723. [5000:7.4.1.2.2]
- **4.6.2.3** Where the term *limited-combustible* is used in this code, it shall also include the term *noncombustible*. [5000:7.4.1.2.4]

#### Chapter 5 Permissible Storage and Use Locations

#### 5.1\* General.

- **5.1.1 Control Areas or Special Protection Required.** Hazardous materials shall be stored and used in any of the following:
- (1) In control areas complying with Section 5.2
- (2) In occupancies complying with requirements for Protection Level 1, Protection Level 2, Protection Level 3, or Protection Level 4 in accordance with Section 5.3
- (3) In outdoor areas complying with Section 5.4
- **5.1.2 Weather Protection Structures.** Weather protection, when provided, shall comply with 6.2.7.2.
- **5.1.3 High-Hazard Contents.** Occupancies in which high-hazard contents are stored, used, or handled shall also comply with Chapter 6.

#### 5.2 Control Areas.

**5.2.1** Hazardous materials shall be permitted to be stored and used in control areas in accordance with 5.2.1 and 5.2.2.

#### 5.2.1.1 General.

- **5.2.1.1.1** All occupancies shall be permitted to have one or more control areas in accordance with Section 5.2.
- Δ 5.2.1.1.2\* The quantity of hazardous materials in an individual control area shall not exceed the MAQ set forth in Table 5.2.1.1.3, except as modified by 5.2.1.2 through 5.2.1.5, which establish additional quantity limits or increases based on occupancy.
- **N 5.2.1.1.2.1** The quantity of hazardous materials in an individual control area in laboratories classified as business occupancies shall not exceed the MAQ set forth in Table 5.2.1.1.3.
- Δ 5.2.1.1.3\* The MAQ of hazardous materials per control area shall be as specified in Table 5.2.1.1.3 except as modified by 5.2.1.2 through 5.2.1.5. Ammonium nitrate shall also comply with Chapter 11.

# 5.2.1.2 Quantity Limits for Occupancies Other than Mercantile, Storage, or Industrial Occupancies.

**N 5.2.1.2.1** The MAQ of hazardous materials per control area in occupancies other than mercantile, storage, or industrial occupancies shall be as specified in Table 5.2.1.2.1.

- **N** 5.2.1.2.2 The MAQ set forth in Table 5.2.1.2.1 shall be the maximum aggregate quantity allowed in storage and use.
- **5.2.1.3 Industrial Occupancies.** The MAQ of hazardous materials per control area in industrial occupancies shall be as specified in Table 5.2.1.1.3, with increased quantities permitted where storage areas comply with 5.2.1.5.
- **5.2.1.4 Storage Occupancies.** The MAQ of hazardous materials per control area in storage occupancies shall be as specified in Table 5.2.1.1.3, with increased quantities permitted where storage areas comply with 5.2.1.5.

# 5.2.1.5 Special Quantity Limits for Mercantile, Industrial, and Storage Occupancies.

- **5.2.1.5.1 General.** Where storage in mercantile, industrial, and storage occupancies is in compliance with all of the special controls set forth in 5.2.1.5.2, the MAQ of selected hazardous materials shall be permitted to be increased in accordance with 5.2.1.5.3.
- **5.2.1.5.2 Special Controls Required for Increased Quantities.** Where quantities of hazardous materials are increased in accordance with 5.2.1.5.3, such materials shall be stored in accordance with the following limitations:
- Storage and display of solids shall not exceed 200 lb/ft² (976.4 kg/m²) of floor area actually occupied by solid merchandise.
- (2) Storage and display of liquids shall not exceed 20 gal/ft<sup>2</sup> (76 L/m<sup>2</sup>) of floor area actually occupied by liquid merchandise.
- (3) Storage and display height shall not exceed 6 ft (1.8 m) above the finished floor.
- (4) Individual containers less than 5 gal (19 L) or less than 25 lb (11 kg) shall be stored or displayed on pallets, racks, or shelves.
- (5) Racks and shelves used for storage or display shall be in accordance with 6.1.13.
- (6) Containers shall be listed or approved for the intended use.
- (7) Individual containers shall not exceed 100 lb (45.4 kg) capacity for solids or a 10 gal (38 L) capacity for liquids.
- (8) Incompatible materials shall be separated in accordance with 6.1.12.
- (9) Except for surfacing, floors shall be of noncombustible construction.
- (10) Aisles 4 ft (1.2 m) in width shall be maintained on three sides of the storage or display area.
- (11) Hazard identification signs shall be provided in accordance with 6.1.8.
- △ 5.2.1.5.3\* Special Maximum Allowable Quantity Increases for Storage in Mercantile, Storage, and Industrial Occupancies. The aggregate quantity of nonflammable solid and nonflammable or noncombustible liquid hazardous materials permitted within a single control area of a mercantile, storage, or industrial occupancy shall be permitted to exceed the MAQ specified in Table 5.2.1.1.3, without complying with Protection Level 2, Protection Level 3, or Protection Level 4, provided that the quantities comply with Table 5.2.1.5.3(a) and Table 5.2.1.5.3(b) and that materials are displayed and stored in accordance with the special limitations in 5.2.1.5.2.

- **5.2.2.2** Where only one control area is present in a building, no special construction provisions shall be required.
- **5.2.2.3** Where more than one control area is present in a building, control areas shall be separated from each other by fire barriers in accordance with Table 5.2.2.1.

#### 5.3 Protection Levels.

- **5.3.1** Where the quantity of hazardous materials in storage or use exceeds the MAQ for indoor control areas as set forth in Section 5.2, the occupancy shall comply with the requirements for Protection Level 1, Protection Level 2, Protection Level 3, or Protection Level 4, as required for the material in storage or use as defined in 6.2.2 through 6.2.5.
- **5.3.2** Protection level 5 shall apply to semiconductor fabrication facilities where required by the building code.

#### 5.3.3 Protection Level 1.

- **5.3.3.1** Buildings containing quantities of hazardous materials exceeding the MAQ of high-hazard level 1 contents permitted in control areas shall comply with applicable regulations for Protection Level 1, as set forth in the applicable sections of Chapter 6, Chapters 11 through 21, and the building code.
- **5.3.3.2** High-hazard level 1 contents shall include materials that present a detonation hazard as defined in 4.2.1.2.1.

## 5.3.4 Protection Level 2.

- **5.3.4.1** Buildings, and portions thereof, containing quantities of hazardous materials exceeding the MAQ of high-hazard level 2 contents permitted in control areas shall comply with applicable regulations for Protection Level 2, as set forth in the applicable sections of Chapter 6, Chapters 11 through 21, and the building code.
- **5.3.4.2** High-hazard level 2 contents shall include materials that present a deflagration hazard or a hazard from accelerated burning as defined in 4.2.1.2.2.

**5.3.5.2** High-hazard level 3 contents shall include materials that readily support combustion or present a physical hazard as defined in 4.2.1.2.3.

# 5.3.6 Protection Level 4.

**5.3.6.1** Buildings, and portions thereof, containing quantities of hazardous materials exceeding the MAQ of high-hazard level 4 contents permitted in control areas shall comply with applicable regulations for Protection Level 4, as set forth in the applicable sections of Chapter 6, Chapters 11 through 21, and the building code.

**5.3.6.2** High-hazard level 4 contents shall include materials that are acute health hazards as defined in 4.2.1.2.4.

#### Chapter 6 Fundamental Requirements

#### 6.1 General Requirements.

- **6.1.1 Applicability.** Storage, use, and handling of hazardous materials in any quantity shall comply with Section 6.1.
- **6.1.1.1\*** Storage of hazardous materials in quantities exceeding the MAQ set forth in Chapter 5 shall comply with Section 6.2 and the applicable material specific requirements in Chapters 11 through 21.
- **6.1.1.2\*** The use, dispensing, and handling of hazardous materials in quantities exceeding the MAQ set forth in Chapter 5 shall comply with Section 6.3 and the applicable material specific requirements in Chapters 11 through 21.
- **6.1.2\* Safety Data Sheets (SDS).** Safety data sheets (SDS) shall be available on the premises for hazardous materials regulated by this code. When approved, SDSs shall be permitted to be retrievable by electronic access.

#### 6.1.3 Release of Hazardous Materials.

- **6.1.3.1 Prohibited Releases.** Hazardous materials shall not be released into a sewer, storm drain, ditch, drainage canal, lake, river, or tidal waterway; upon the ground, a sidewalk, a street, or a highway; or into the atmosphere, unless such release is permitted by the following:
- (1) Federal, state, or local governing regulations
- (2) Permits of the jurisdictional air quality management board
- (3) National Pollutant Discharge Elimination System permit
- (4) Waste discharge requirements established by the jurisdictional water quality control board
- Sewer pretreatment requirements for publicly or privately owned treatment works
- **6.1.3.2 Control and Mitigation of Unauthorized Releases.** Provisions shall be made for controlling and mitigating unauthorized releases.
- **6.1.3.3 Records of Unauthorized Releases.** Accurate records of the unauthorized release of hazardous materials shall be kept by the permittee.
- **6.1.3.4\* Notification of Unauthorized Releases.** The fire department shall be notified immediately or in accordance with approved emergency procedures when an unauthorized release becomes reportable under state, federal, or local regulations.
- **6.1.3.5 Container Failure.** When an unauthorized release due to primary container failure is discovered, the involved primary container shall be repaired or removed from service.
- **6.1.3.6 Overpack Containers.** Overpack containers shall be permitted to be used as a means to provide protection for primary containers to be transported for repair or removal from service.

# 6.1.3.7 Responsibility for Cleanup of Unauthorized Releases.

- **6.1.3.7.1** The person, firm, or corporation responsible for an unauthorized release shall institute and complete all actions necessary to remedy the effects of such unauthorized release, whether sudden or gradual, at no cost to the AHJ.
- **6.1.3.7.2** When deemed necessary by the AHJ, cleanup of an unauthorized release shall be permitted to be initiated by the

- fire department or by an authorized individual or firm, and costs associated with such cleanup shall be borne by the owner, operator, or other person responsible for the unauthorized release.
- **6.1.4\* Personnel Training.** Persons in areas where hazardous materials are stored, dispensed, handled, or used shall be trained in the hazards of the materials employed and actions required by the emergency plan. The level of training to be conducted shall be consistent with the responsibilities of the persons to be trained in accordance with 6.1.4.1 through 6.1.4.5.
- **6.1.4.1 Awareness.** The training provided for persons designated in 6.1.4 shall include awareness training in accordance with 6.1.4.1.1 through 6.1.4.1.3.
- **6.1.4.1.1 Completion.** Initial training shall be completed prior to beginning work in the work area.
- **6.1.4.1.2 Hazard Communications.** Training shall be provided prior to beginning work in the work area to enable personnel to recognize and identify hazardous materials stored, dispensed, handled, or used on site and where to find safety information pertaining to the hazards of the materials employed.
- **6.1.4.1.3 Emergency Plan.** Training shall be provided prior to beginning work in the work area to enable personnel to implement the emergency plan.
- **6.1.4.2 Operations Personnel.** Persons engaged in storing, using, or handling hazardous materials shall be designated as operations personnel and shall be trained in accordance with 6.1.4.1 and 6.1.4.2.1 through 6.1.4.2.6.
- **6.1.4.2.1 Physical and Health Hazard Properties.** Operations personnel shall be trained in the chemical nature of the materials, including their physical hazards and the symptoms of acute or chronic exposure as provided by the safety data sheet (SDS) furnished by the manufacturer or other authoritative sources.
- **6.1.4.2.2 Dispensing, Using, and Processing.** Operations personnel shall be trained in the use of specific safeguards applicable to the dispensing, processing, or use of the materials and equipment employed.
- **6.1.4.2.3 Storage.** Operations personnel shall be trained in the application of storage arrangements and site-specific limitations on storage for the materials employed.
- **6.1.4.2.4 Transport** (Handling). Operations personnel involved in materials handling shall be trained in the requirements for on-site transport of the materials employed.
- **6.1.4.2.5 Actions in an Emergency.** Operations personnel shall be trained in the necessary actions to take in the event of an emergency, including the operation and activation of emergency controls prior to evacuation.
- **6.1.4.2.6 Changes.** Training shall be provided whenever a new hazardous material is introduced into the work area that presents a new physical or health hazard, or when new information is obtained pertaining to physical or health hazards of an existing hazardous material that has not been included in previous training, and when there are changes in any of the following:
- (1) Equipment

- (2) Operations
- (3) Hazardous materials

#### 6.1.4.3 Emergency Response Liaison.

- **6.1.4.3.1** Responsible persons shall be designated and trained to be emergency response (ER) liaison personnel.
- **6.1.4.3.2** Emergency response liaison personnel shall do the following:
- Aid emergency responders in pre-planning responses to emergencies
- (2) Identify locations where hazardous materials are located
- (3) Have access to safety data sheets
- (4) Be knowledgeable in the site emergency response procedures
- **6.1.4.4\* Emergency Responders.** Emergency responders shall be trained to be competent in the actions to be taken in an emergency event.
- **6.1.4.4.1\* Emergency Response Team Leader.** Persons acting as ER team leaders shall be trained under the Incident Command System concept or equivalent.
- **6.1.4.4.2\* Response to Incipient Events.** Responses to incidental releases of hazardous materials where the material can be absorbed, neutralized, or otherwise controlled at the time of release by employees in the immediate release area, or by maintenance personnel, shall not be considered emergency responses as defined within the scope of this code.
- **6.1.4.4.3\* On-Site Emergency Response Team.** When an onsite emergency response team is provided, emergency responders shall be trained in accordance with the requirements of the specific site emergency plan or as required by federal, state, or local governmental agencies.
- **6.1.4.5 Training Mandated by Other Agencies.** Training required by federal, state, or local regulations that is required based on the quantity or type of hazardous materials stored, dispensed, handled, or used shall be conducted in accordance with the requirements of and under the jurisdiction of the governing agency.
- **6.1.4.6 Documentation.** Training shall be documented and the documentation made available to the AHJ upon written request.

#### 6.1.5 Ignition Source Controls.

- **6.1.5.1 Smoking.** Smoking shall be prohibited in the following locations:
- (1) Within 25 ft (7.6 m) of outdoor storage areas, dispensing areas, or open use areas
- (2) In rooms or areas where hazardous materials are stored or dispensed or used in open systems in amounts requiring a permit in accordance with Section 1.8
- **6.1.5.2 Open Flames and High-Temperature Devices.** Open flames and high-temperature devices shall not be used in a manner that creates a hazardous condition.
- **6.1.5.3 Energy-Consuming Equipment.** Energy-consuming equipment with the potential to serve as a source of ignition shall be listed or approved for use with the hazardous materials stored or used.

- **6.1.5.3.1\* Powered Industrial Trucks.** Powered industrial trucks shall be operated and maintained in accordance with NFPA 505. [1:10.18]
- **6.1.6 Systems, Equipment, and Processes.** Processes, methods, specifications, equipment testing and maintenance, design standards, performance, installation, equipment design and construction, and other pertinent criteria shall be in accordance with this section.
- **6.1.6.1 Design and Construction of Containers and Tanks.** Containers, cylinders, and tanks shall be designed and constructed in accordance with approved standards. Containers, cylinders, tanks, and other means used for containment of hazardous materials shall be of an approved type.
- △ 6.1.6.2 Piping, Tubing, Valves, and Fittings. Piping, tubing, valves, fittings, and related components used for hazardous materials shall be in accordance with the following:
  - (1) Piping, tubing, valves, fittings, and related components shall be designed and fabricated from materials compatible with the material to be contained and shall be of a strength and durability to withstand the pressure, structural and seismic stress, and exposure to which they are subject.
  - (2) Piping and tubing shall be identified in accordance with ASME A13.1, Scheme for the Identification of Piping Systems, to indicate the material conveyed.
  - (3) Accessible manual valves, or fail-safe emergency shutoff valves operated by a remotely located manually or automatically activated shutdown control, shall be installed on supply piping and tubing at the following locations:
    - (a) Point of use
    - (b) Tank or bulk source
  - (4) Manual emergency shutoff valves and remotely located manually activated shutdown controls for emergency shutoff valves shall be identified, and the location shall be clearly visible, accessible, and indicated by means of a sign.
  - (5) Backflow prevention or check valves shall be provided when the backflow of hazardous materials could create a hazardous condition or cause the unauthorized discharge of hazardous materials.
  - (6) Liquids classified in accordance with NFPA 704 shall be carried in pressurized piping above a gauge pressure of 15 psi (103 kPa) having a hazard ranking as follows:
    - (a) Health hazard Class 3 or Class 4
    - (b) Flammability Class 4
    - (c) Instability Class 3 or Class 4
  - (7) The pressurized piping specified in 6.1.6.2(6) shall be provided with an approved means of leak detection and emergency shutoff or excess flow control in accordance with the following:
    - (a) Where the piping originates from within a hazardous material storage room or area, the excess flow control shall be located within the storage room or area.
    - (b) Where the piping originates from a bulk source, the excess flow control shall be located at the bulk source.
    - (c) Piping for inlet connections designed to prevent backflow shall not be required to be equipped with excess flow control.

- **6.1.6.3** Additional Regulations for Supply Piping for Health Hazard Materials. Supply piping and tubing for liquids or solids having a health hazard ranking of Class 3 or Class 4 in accordance with NFPA 704 shall be in accordance with ASME B31.3, *Process Piping*, and the following:
- (1) Piping and tubing utilized for the transmission of highly toxic, toxic, or highly volatile corrosive liquids shall have welded, threaded, or flanged connections throughout, except for connections located within a ventilated enclosure, or an approved method of drainage or containment.
- (2) Piping and tubing shall not be located within corridors, within any portion of a means of egress required to be enclosed in fire resistance–rated construction, or in concealed spaces in areas not classified as Protection Level 1 through Protection Level 4 occupancies.
- **6.1.6.4 Equipment, Machinery, and Alarms.** Equipment, machinery, and required detection and alarm systems associated with the use, storage, or handling of hazardous materials shall be listed or approved.
- **6.1.7 Empty Containers and Tanks.** Empty containers and tanks previously used for the storage of hazardous materials shall be free from residual material and vapor as defined by DOT, the *Resource Conservation and Recovery Act (RCRA)*, or other regulating authority or shall be maintained as specified for the storage of hazardous material.

# 6.1.8 Signs.

#### 6.1.8.1 General.

- **6.1.8.1.1 Design and Construction.** Signs shall be durable, and the size, color, and lettering of signs shall be in accordance with nationally recognized standards.
- **6.1.8.1.2 Language.** Signs shall be in English as the primary language or in symbols permitted by this code.
- **6.1.8.1.3 Maintenance.** Signs shall meet the following criteria:
- (1) They shall not be obscured.
- (2) They shall be maintained in a legible condition.
- (3) They shall not be removed, unless for replacement.

#### 6.1.8.2 Hazardous Materials Identification.

- **6.1.8.2.1 NFPA 704 Placard.** Visible hazard identification signs in accordance with NFPA 704 shall be placed at the following locations, except where the AHJ has received a hazardous materials management plan and a hazardous materials inventory statement in accordance with Sections 1.11 and 1.12 and has determined that omission of such signs is consistent with safety:
- (1) On stationary aboveground tanks
- (2) On stationary aboveground containers
- (3) At entrances to locations where hazardous materials are stored, dispensed, used, or handled in quantities requiring a permit
- (4) At other entrances and locations designated by the AHJ
- **6.1.8.2.2 Identification of Containers, Cartons, and Packages.** Individual containers, cartons, or packages shall be conspicuously marked or labeled in accordance with nationally recognized standards.

- **6.1.8.3** No Smoking Signs. Where "no smoking" is not applicable to an entire site or building, signs shall be provided as follows:
- (1) In rooms or areas where hazardous materials are stored or dispensed or used in open systems in amounts requiring a permit in accordance with Section 1.8
- (2) Within 25 ft (7.6 m) of outdoor storage, dispensing, or open-use areas

#### 6.1.9 Protection from Vehicles.

- **6.1.9.1** Guard posts or other approved means shall be provided to protect the following where subject to vehicular damage:
- (1) Storage tanks and connected piping, valves, and fittings
- (2) Storage areas containing tanks or portable containers except where the exposing vehicles are powered industrial trucks used for transporting the hazardous materials
- (3) Use areas
- **6.1.9.2** Where guard posts are installed, the posts shall meet the following criteria:
- (1) They shall be constructed of steel not less than 4 in. (102 mm) in diameter and concrete filled.
- (2) They shall be spaced not more than 4 ft (1.2 m) between posts on center.
- (3) They shall be set not less than 3 ft (0.9 m) deep in a concrete footing of not less than a 15 in. (381 mm) diameter
- (4) They shall be set with the top of the posts not less than 3 ft (0.9 m) above ground.
- (5) They shall be located not less than 3 ft (0.9 m) from the tank

# 6.1.10 Electrical Wiring and Equipment.

- **6.1.10.1 General.** Electrical wiring and equipment shall be installed in accordance with *NFPA 70*.
- **6.1.10.2 Static Accumulation.** When processes or use conditions exist where flammable gases, dusts, or vapors can be ignited by static electricity, means shall be provided to prevent the accumulation of a static charge and to dissipate the static charge to ground.
- **6.1.11 Protection from Light.** Materials that are sensitive to light shall be stored in containers designed to protect them from such exposure.

# 6.1.12 Separation of Incompatible Materials.

- **6.1.12.1** Incompatible materials in storage and storage of materials incompatible with materials in use shall be separated when the stored materials are in containers having a capacity of more than 5 lb (2.268 kg) or  $\frac{1}{2}$  gal (1.89 L).
- $\pmb{6.1.12.2}$  Separation shall be accomplished by one of the following methods:
- (1) Segregating incompatible materials storage by a distance of not less than 20 ft (6.1 m)
- (2) Isolating incompatible materials storage by a noncombustible partition extending not less than 18 in. (457 mm) above and to the sides of the stored material or by a noncombustible partition that interrupts the line of sight between the incompatible materials

- (3) Storing liquid and solid materials in hazardous materials storage cabinets complying with 6.1.18
- (4) Storing compressed gases in gas cabinets or exhausted enclosures complying with Chapter 21
- **6.1.12.3** Materials that are incompatible shall not be stored within the same cabinet or enclosure.

#### 6.1.13 General Storage.

- **6.1.13.1 Storage.** The storage arrangement of materials shall be in accordance with this chapter and the material specific requirements of Chapters 11 through 21 as applicable.
- **6.1.13.2 Shelf Storage.** Shelving shall be constructed to carry the design loads and shall be braced and anchored in accordance with the seismic design requirements of the applicable building code.

#### 6.1.13.2.1 Shelf Construction.

- **6.1.13.2.1.1** Shelving shall be treated, coated, or constructed of materials that are compatible with the hazardous materials stored.
- **6.1.13.2.1.2** Shelves shall be provided with a lip or guard where used for the storage of individual containers, except under either of the following conditions:
- Where storage is located in hazardous materials storage cabinets or laboratory furniture specifically designed for such use
- (2) Where amounts of hazardous materials in storage do not exceed the quantity threshold for requiring a permit in accordance with Section 1.8
- **6.1.13.2.2** Shelf storage of hazardous materials shall be maintained in an orderly manner.
- **6.1.14\* Seismic Protection.** Machinery and equipment utilizing hazardous materials in areas subject to seismic activity shall be seismically anchored in accordance with the building code.
- **6.1.14.1 Shock Padding.** Materials that are shock sensitive shall be padded, suspended, or otherwise protected against accidental dislodgement and dislodgement during seismic activity.
- **6.1.15** Outdoor Storage and Use Areas. Outdoor storage and use areas for hazardous materials shall comply with the following:
- Outdoor storage and use areas shall be kept free of weeds, debris, and common combustible materials not necessary to the storage or use of hazardous materials.
- (2) The area surrounding an outdoor storage and use area shall be kept clear of weeds, debris, and common combustible materials not necessary to the storage or use of hazardous materials for a minimum distance of 15 ft (4.5 m).
- (3) Outdoor storage and use areas for hazardous materials shall be located not closer than 20 ft (6.1 m) from a property line that can be built upon, a street, an alley, or a public way, except that a 2-hour fire barrier wall, without openings and extending not less than 30 in. (762 mm) above and to the sides of the storage area, shall be permitted in lieu of such distance.

#### 6.1.16 Maintenance Required.

- **6.1.16.1\*** Equipment, machinery, and required detection and alarm systems associated with hazardous materials shall be maintained in an operable condition.
- **6.1.16.2** Stationary tanks not used for a period of 90 days shall be safeguarded or removed in an approved manner.
- **6.1.16.2.1** The tanks specified in 6.1.16.2 shall have the fill line, gauge opening, and pump connection secured against tampering.
- **6.1.16.2.2** Vent lines shall be maintained.
- **6.1.16.2.3\*** Tanks that are to be placed back in service shall be tested in an approved manner.
- **6.1.16.3** The following shall apply to defective containers, cylinders, and tanks:
- They shall be removed from service, repaired, or disposed of in an approved manner.
- (2) Overpack containers shall be permitted to be used as a means to provide protection for primary containers that are transported for repair or removal from service.
- **6.1.16.4** Defective equipment or machinery shall be removed from service and repaired or replaced.
- **6.1.16.5** Required detection and alarm systems that are defective shall be replaced or repaired.

# **6.1.17** Testing.

- **6.1.17.1** The equipment, devices, and systems listed in 6.1.17.2.1 shall be tested at one of the intervals listed in 6.1.17.2.2. Written records of the tests conducted or maintenance performed shall be maintained.
- **6.1.17.2** Testing shall not be required under the following conditions:
- (1) Where approved written documentation is provided that testing will damage the equipment, device, or system and the equipment, device, or system is maintained as specified by the manufacturer
- (2) Where equipment, devices, and systems fail in a fail-safe manner
- (3) Where equipment, devices, and systems self-diagnose and report trouble, with records of the self-diagnosis and trouble reporting made available to the AHI
- (4) Where system activation occurs during the required test cycle for the components activated during the test cycle
- (5) Where approved maintenance in accordance with 6.1.16.1 is performed not less than annually or in accordance with an approved schedule, in which case the testing requirements set forth in 6.1.17.2.1 and 6.1.17.2.2 are permitted to apply.
- **6.1.17.2.1 Equipment, Devices, and Systems Requiring Testing.** The following equipment, devices, and systems shall be tested in accordance with 6.1.17 and 6.1.17.2.2:
- (1) Limit control systems for liquid level, temperature, and pressure required by 6.2.1.7 and 6.3.1.2
- (2) Monitoring and supervisory systems required by 6.2.1.1 and 6.3.2.1.1

- **6.1.17.2.2 Testing Frequency.** The equipment, systems, and devices listed in 6.1.17.2.1 shall be tested at one of the following frequencies:
- (1) Not less than annually
- (2) In accordance with the approved manufacturer's requirements
- In accordance with approved recognized industry standards
- (4) In accordance with an approved schedule
- **6.1.18 Hazardous Materials Storage Cabinets.** When storage cabinets are used to increase MAQ per control area or to otherwise comply with a specific provision in Chapter 6, such cabinets shall be in accordance with the following:
- (1) Cabinets shall be constructed of metal.
- (2) The interior of cabinets shall be treated, coated, or constructed of materials that are nonreactive with the hazardous material stored, and such treatment, coating, or construction shall include the entire interior of the cabinet.
- (3) Cabinets shall be either listed as suitable for the intended storage or constructed in accordance with the following:
  - (a) Cabinets shall be of steel having a thickness of not less than 0.044 in. (1.12 mm) (18 gauge).
  - (b) The cabinet, including the door, shall be doublewalled with 1½ in. (38.1 mm) airspace between the walls.
  - (c) Joints shall be riveted or welded and shall be tightfitting.
  - (d) Doors shall be well fitted, self-closing, and equipped with a self-latching device.
  - (e) The bottoms of cabinets utilized for the storage of liquids shall be liquidtight to a minimum height of 2 in. (51 mm).
  - (f) For requirements regarding electrical equipment and devices within cabinets used for the storage of hazardous liquids, compressed gases, or cryogenic fluids, see NFPA 70.
- (4) Cabinets shall be marked in conspicuous lettering that reads as follows: HAZARDOUS — KEEP FIRE AWAY
- **6.1.19 Installation of Tanks.** Installation of tanks shall be in accordance with 6.1.19.1 through 6.1.19.2.

#### 6.1.19.1 Underground Tanks.

- **6.1.19.1.1** Underground tanks used for the storage of liquid hazardous materials shall be provided with secondary containment.
- **6.1.19.1.2** In lieu of providing secondary containment for an underground tank, an aboveground tank in an underground vault complying with NFPA 30 shall be permitted.
- **6.1.19.2 Aboveground Tanks.** Aboveground stationary tanks installed outdoors and used for the storage of hazardous materials shall be located and protected in accordance with the requirements for outdoor storage of the particular material involved and in accordance with the requirements of Chapters 11 through 21.
- **6.1.19.2.1** Aboveground tanks that are installed in vaults complying with NFPA 30 shall not be required to comply with location and protection requirements for outdoor storage.
- **6.1.19.2.2** Aboveground tanks that are installed inside buildings and used for the storage of hazardous materials shall be

- located and protected in accordance with the requirements for indoor storage of the particular material involved.
- **6.1.19.2.3 Marking.** Aboveground stationary tanks shall be marked as required by 6.1.8.2.1.
- **6.1.20** When required, fire alarm systems and smoke detection systems shall be installed in accordance with *NFPA 72*.
- 6.2 Requirements for Occupancies Storing Quantities of Hazardous Materials Exceeding the Maximum Allowable Quantities per Control Area for High-Hazard Contents.
- **6.2.1 Indoor Storage General Requirements.** The requirements set forth in 6.2.1 shall apply to buildings, or portions thereof, that are required to comply with Protection Level 1 through Protection Level [4] where required by Section 5.3. [5000:34.3.2]
- **6.2.1.1 Fire Protection Systems.** Buildings, or portions thereof, required to comply with Protection Level 1 through Protection Level [4] shall be protected by an approved automatic fire sprinkler system complying with Section 55.3 of *NFPA 5000.* [5000:34.3.2.1]
- **6.2.1.1.1** The design of the sprinkler system shall be not less than ordinary hazard group 2 in accordance with NFPA 13 except as follows:
- (1) Where different requirements are specified in Chapters 11 through 21 of this code
- (2) Where the materials or storage arrangement requires a higher level of sprinkler system protection in accordance with nationally recognized standards
- (3) Where approved alternative automatic fire extinguishing systems are permitted
- **6.2.1.1.2** Electronic supervision of supervisory signals shall be provided in accordance with 55.3.2.1 of *NFPA 5000*. [**5000**:34.3.2.1.1]
- **6.2.1.1.3** Waterflow alarms shall be monitored in accordance with 55.3.2.2 of *NFPA 5000.* [**5000:**34.3.2.1.2]
- **6.2.1.1.4** Rooms or areas that are of noncombustible construction with wholly noncombustible contents shall not be required to comply with 6.2.1.1. [**5000**:34.3.2.1.3]
- **6.2.1.2 Building Height Exception.** The height of a one-story building, or portion thereof, containing only tanks or industrial process equipment shall not be limited based on the type of construction. [5000:34.3.2.2]
- **6.2.1.3 Separation of Occupancies Having High Hazards.** The separation of areas containing high-hazard contents from each other and from other use areas shall be as required by Table 6.2.1.3 and shall not be permitted to be reduced with the installation of fire protection systems as required by 6.2.1.1. [5000:34.3.2.3]
- **6.2.1.4 Egress.** Egress from areas required to comply with Protection Level 1, Protection Level 2, Protection Level 3, or Protection Level 4 shall comply with 34.3.2.4 of *NFPA 5000* and with 6.2.1.4 of this code. [**5000**:34.3.2.4]
- **6.2.1.4.1 Travel Distance Limit.** Travel distance to an exit from areas required to comply with Protection Level 1 through Protection Level [4] shall not exceed the distance given in Table 6.2.1.4.1, measured as required in 11.6.3 of *NFPA 5000*. [5000:34.3.2.4.1]

- **6.2.1.4.2 Capacity of Means of Egress.** Egress capacity for high-hazard content areas shall be based on 0.7 in. (18 mm) per person for stairs or 0.4 in. (10 mm) per person for level components and ramps in accordance with 11.3.3.1 of *NFPA 5000.* [**5000:**34.3.2.4.2]
- **6.2.1.4.3 Number of Means of Egress.** Not less than two means of egress shall be provided from each building, or portion thereof, required to comply with Section 6.2, unless rooms or spaces do not exceed 200 ft<sup>2</sup> (18.6 m<sup>2</sup>), have an occupant load not exceeding three persons, and have a travel distance to the room door not exceeding 25 ft (7.6 m). [5000:34.3.2.4.3]

- **6.2.1.5.1** Solids and liquids stored in closed containers shall not be required to comply with 6.2.1.5.
- **6.2.1.5.2** Mechanical exhaust systems shall comply with the *Uniform Mechanical Code* as referenced in Chapter 50 of NFPA 5000. [5000:34.3.2.5.2]
- **6.2.1.5.3** Mechanical ventilation shall be at a rate of not less than 1  $\rm ft^3/min/ft^2$  (5.1 L/s/m²) of floor area over areas required to comply with Protection Level 1 through Protection Level [4]. [5000:34.3.2.5.3]
- **6.2.1.5.4** Ventilation requirements shall be determined by calculations based on anticipated fugitive emissions or by sampling of the actual vapor concentration levels under normal operating conditions. [5000:34.3.2.5.5]
- **6.2.1.5.5** Make-up air shall be provided, and provision shall be made for locating make-up air openings to avoid short-circuiting the ventilation. [5000:34.3.2.5.6]
- **6.2.1.5.6** Ducts conveying explosives or flammable vapors, fumes, or dusts shall extend directly to the exterior of the building without entering other spaces. [5000:34.3.2.5.7]
- **6.2.1.5.6.1** Exhaust ducts shall not extend into or through ducts and plenums. [5000:34.3.2.5.7.1]
- **6.2.1.5.6.2** Ducts conveying vapor or fumes having flammable constituents less than 25 percent of their lower flammability limit shall be permitted to pass through other spaces. [5000:34.3.2.5.7.2]
- **6.2.1.5.7** Emissions generated by workstations shall be removed from the areas in which they are generated by means of local exhaust installed in accordance with the mechanical code.
- **6.2.1.5.8** The location of supply and exhaust openings shall be in accordance with the *Uniform Mechanical Code* as referenced in Chapter 50 of *NFPA 5000*. [**5000:**34.3.2.5.9]
- **6.2.1.5.9** Systems shall operate continuously unless alternate designs are approved. [5000:34.3.2.5.11]
- **6.2.1.5.10** A manual shutoff control for ventilation equipment required by 6.2.1.5 shall be provided outside the room adjacent to the principal access door to the room. [5000:34.3.2.5.12]
- **6.2.1.5.11** The shutoff control described in 6.2.1.5.10 shall be of the break-glass type and shall be labeled as follows:

- **6.2.1.5.12** Exhaust ventilation shall be arranged to consider the density of the potential fumes or vapors released. [5000:34.3.2.5.14]
- **6.2.1.5.12.1** For fumes or vapors that are lighter than air, exhaust shall be taken from a point within 12 in. (305 mm) of the high point of the room or area in which they are generated
- **6.2.1.5.12.2** For fumes or vapors that are heavier than air, exhaust shall be taken from a point within 12 in. (305 mm) of the floor. [5000:34.3.2.5.14.1]

- **6.2.1.5.12.3** The location of both the exhaust and inlet air openings shall be arranged to provide air movement across all portions of the floor or room to prevent the accumulation of vapors. [5000:34.3.2.5.14.2]
- **6.2.1.5.12.4** Exhaust ventilation shall not be recirculated within the room or building if the materials stored are capable of emitting hazardous vapors. [5000:34.3.2.5.14.3]
- **6.2.1.5.12.5** Recirculation shall be permitted where it is monitored continuously using a fail-safe system that is designed to automatically sound an alarm, stop recirculation, and provide full exhaust to the outside in the event that vapor–air mixtures in concentrations over one-fourth of the lower flammable limit are detected. [5000:34.3.2.5.14.4]
- **6.2.1.5.12.6** Air contaminated with explosive or flammable vapors, fumes, or dusts, or with radioactive materials, shall not be recirculated.
- **6.2.1.6\* Explosion Control.** Buildings, or portions thereof, required to comply with Protection Level 1 through Protection Level 3 and containing materials shown in Table 6.2.1.6 shall be provided with a means of explosion control. [**5000**:34.3.2.6]

- **6.2.1.7 Limit Controls.** Limit controls shall be provided in accordance with 6.2.1.7.1 and 6.2.1.7.2.
- **6.2.1.7.1 Temperature Control.** Materials that must be kept at temperatures other than normal ambient temperatures to prevent a hazardous reaction shall be provided with an approved means to maintain the temperature within a safe range.
- **6.2.1.7.1.1** Redundant temperature control equipment that will operate on failure of the primary temperature control system shall be provided.
- **6.2.1.7.1.2** The use of alternative means that prevent a hazardous reaction shall be permitted subject to the approval of the AHJ.

#### 6.2.1.7.2 Pressure Control.

- **6.2.1.7.2.1** Stationary tanks and equipment containing hazardous material liquids that can generate pressures exceeding design limits due to exposure fires or internal reaction shall have some form of construction or other approved means that will relieve excessive internal pressure.
- **6.2.1.7.2.2** The termination point for piped vent systems used for the purpose of operational or emergency venting shall be located to prevent impingement exposure on the system served and to minimize the effects of high-temperature thermal radiation or the effects of contact with the material being vented from the escaping plume on the supply system, personnel, adjacent structures, and ignition sources.

## 6.2.1.8 Standby and Emergency Power.

- **6.2.1.8.1** Where mechanical ventilation, treatment systems, temperature control, alarm, detection, or other electrically operated safety systems are required by this code, NFPA 1, or NFPA 5000, such systems shall be provided with standby power or emergency power as required by 6.2.1.8. [**5000**:34.3.2.7.1]
- **6.2.1.8.2** Standby power for mechanical ventilation, exhaust treatment, and temperature control systems shall not be required where such systems are engineered and approved as fail-safe. [5000:34.3.2.7.2]
- **6.2.1.8.3** The secondary source of power shall be an approved means of legally required standby power in accordance with *NFPA 70*.
- 6.2.1.9 Spill Control and Secondary Containment for Hazardous Materials Liquids and Solids.
- **6.2.1.9.1 General.** Buildings, or portions thereof, required to comply with Protection Level 1 through Protection Level 4 shall be provided with spill control and secondary containment in accordance with 6.2.1.9.2 and 6.2.1.9.3, except for outdoor storage on containment pallets complying with 6.2.7.3.3.

## 6.2.1.9.2 Spill Control.

- **6.2.1.9.2.1** Buildings, or portions thereof, used for storage of hazardous materials liquids in individual containers having a capacity of more than 55 gal (208.2 L) shall be provided with spill control to prevent the flow of liquids to adjoining areas.
- **6.2.1.9.2.2** Where spill control is required, floors in indoor locations and similar surfaces in outdoor locations shall be constructed to contain a spill from the largest single vessel by one of the following methods:

- (1) Liquidtight sloped or recessed floors in indoor locations or similar areas in outdoor locations
- Liquidtight floors in indoor locations or similar areas in outdoor locations provided with liquidtight raised or recessed sills or dikes
- Sumps and collection systems [**5000:**34.3.2.8.2.2]
- **6.2.1.9.2.3** Except for surfacing, the floors, sills, dikes, sumps, and collection systems shall be constructed of noncombustible material, and the liquidtight seal shall be compatible with the material stored. [5000:34.3.2.8.2.3]
- **6.2.1.9.2.4** Where liquidtight sills or dikes are provided, they shall not be required at perimeter openings that are provided with an open-grate trench across the opening that connects to an approved collection system. [5000:34.3.2.8.2.4]

#### 6.2.1.9.3 Secondary Containment.

- **6.2.1.9.3.1** Buildings, or portions thereof, used for any of the following shall be provided with secondary containment:
- Storage of liquids where the capacity of an individual vessel exceeds 55 gal (208.2 L) or the aggregate capacity of multiple vessels exceeds 1000 gal (3785 L)
- Storage of solids where the capacity of an individual vessel exceeds 550 lb (248.8 kg) or the aggregate capacity of multiple vessels exceeds 10,000 lb (4524.8 kg)
- 6.2.1.9.3.2 Buildings, or portions thereof, containing only hazardous materials in listed secondary containment tanks or systems shall not be required to comply with 6.2.1.9.3.1.
- 6.2.1.9.3.3 Buildings, or portions thereof, containing only ammonium nitrate solids, organic peroxide solids, flammable solids, pyrophoric solids, or corrosive solids shall not be required to comply with 6.2.1.9.3.1.
- **6.2.1.9.3.4** The building, room, or area shall contain or drain the hazardous materials and fire protection water through the use of one of the following methods:
- Liquidtight sloped or recessed floors in indoor locations or similar areas in outdoor locations
- Liquidtight floors in indoor locations or similar areas in outdoor locations provided with liquidtight raised or recessed sills or dikes
- Sumps and collection systems
- Drainage systems leading to an approved location
- **6.2.1.9.3.5** Where incompatible materials are present in open containers or systems, such materials shall be separated from each other in the secondary containment system.
- 6.2.1.9.3.6 Secondary containment for indoor storage areas shall be designed to contain a spill from the largest vessel plus the design flow volume of fire protection water calculated to discharge from the fire-extinguishing system over the minimum required system design area, or area of the room or area in which the storage is located, whichever is smaller, for a period of 20 minutes.
- **6.2.1.9.3.7** A monitoring method shall be provided to detect hazardous materials in the secondary containment system.
- **6.2.1.9.3.8** The monitoring method specified in 6.2.1.9.3.7 shall be permitted to be visual inspection of the primary or secondary containment or other approved means.

- 6.2.1.9.3.9 Where secondary containment is subject to the intrusion of water, a monitoring method for detecting water shall be provided.
- **6.2.1.9.3.10** Where monitoring devices are provided, they shall be connected to distinct visual or audible alarms.
- **6.2.1.9.3.11** Where remote containment systems are provided, drainage systems shall be in accordance with the plumbing code, as referenced in Chapter 2, and the following provisions also shall be met:
- The slope of floors in indoor locations to drains or similar areas in outdoor locations shall be not less than 1 percent.
- Drains from indoor storage areas shall be sized to carry the volume of the fire protection water, as determined by the design density discharged from the automatic fireextinguishing system over the minimum required system design area, or area of the room or area in which the storage is located, whichever is smaller.
- Materials of construction for drainage systems shall be compatible with the materials stored.
- Separate drainage systems shall be provided to avoid mixing incompatible materials where such materials are present in an open-use condition.
- Drains shall terminate in an approved location away from buildings, valves, means of egress, fire access roadways, adjoining property, and storm drains.
- **6.2.1.10 Floors in Storage Rooms.** Floors in storage areas for ammonium nitrate, organic peroxides, oxidizers, pyrophoric materials, unstable (reactive) materials, water-reactive solids and liquids, corrosive materials, and toxic and highly toxic materials shall be of liquidtight, noncombustible construction.
- 6.2.1.11 Supervision of Alarm, Detection, and Automatic Fire-Extinguishing Systems. Alarm, detection, and automatic fireextinguishing systems required by Chapter 6 or other chapters of this code regulating hazardous materials shall be supervised by an approved central, proprietary, or remote station service or shall initiate audible and visual signals at a constantly attended on-site location.

## 6.2.2 Protection Level 1.

6.2.2.1 General. Buildings, or portions thereof, required to comply with Protection Level 1 shall comply with 6.2.2 and the building code.

## 6.2.2.2 Detached Building Required.

- **6.2.2.2.1\*** Buildings required to comply with Protection Level 1 shall be used for no other purpose, shall not exceed one story in height, and shall be without basements, crawl spaces, or other under-floor spaces. [5000:34.3.3.2.1]
- 6.2.2.2.2 Roofs of buildings described in 6.2.2.2.1 shall be of lightweight construction with suitable thermal insulation to prevent sensitive material from reaching its decomposition temperature. [5000:34.3.3.2.2]
- **6.2.2.2.3** Buildings required to comply with both Protection Level 1 and Protection Level 4 shall comply with the most requirements for both restrictive protection [**5000:**34.3.3.2.3]
- △ 6.2.2.3 Minimum Distance to Property Lines or Horizontal Separation. Buildings required to comply with Protection Level 1 shall be set back from property lines, or be provided

with a horizontal separation in accordance with *NFPA 5000* by a distance of not less than 75 ft (23 m) and of not less than that required by Table 6.2.2.3. [5000:34.3.3.3]

- **6.2.2.3.1** Explosives that are in accordance with NFPA 495 shall not be required to comply with 6.2.2.3. [5000:34.3.3.3.1]
- **6.2.2.3.2** Distances shall be measured from the perimeter wall to property lines, including those on a public way. [5000:34.3.3.3.2]
- **6.2.2.3.3** Quantities of explosives used in applying Table 6.2.2.3 shall be based on equivalent pounds (kilograms) of TNT. [5000:34.3.3.3.3]
- **6.2.2.4 Frangible Building.** Frangible buildings complying with 7.4.1.4.5.3 of *NFPA 5000* shall not be required to be protected with an automatic sprinkler system. [**5000**:34.3.3.4]

#### 6.2.3 Protection Level 2.

**6.2.3.1 General.** Buildings, or portions thereof, required to comply with Protection Level 2 shall comply with 6.2.1 and 6.2.3.2 through 6.2.3.5.2. [5000:34.3.4.1]

## 6.2.3.2 Exterior Wall Required.

- **6.2.3.2.1** Buildings, or portions thereof, required to comply with Protection Level 2 shall be located on property such that not less than 25 percent of the perimeter wall is an exterior wall. [5000:34.3.4.2.1]
- **6.2.3.2.2** Rooms utilized for the use, dispensing, mixing, and storage of flammable and combustible liquids having a floor area of not more than 500 ft<sup>2</sup> (46.5 m<sup>2</sup>) shall not be required to be located on the outer perimeter of the building where such rooms comply with NFPA 30. [5000:34.3.4.2.2]

## 6.2.3.3 Minimum Distance to Property Lines or Horizontal Separation.

- **6.2.3.3.1** Buildings, or portions thereof, required to comply with Protection Level 2 shall be set back from property lines, or be provided with a horizontal separation in accordance with 7.3.4.2 of *NFPA 5000* at any of the following distances:
- (1) Not less than 30 ft (9.1 m) where the area of the occupancy exceeds 1000 ft² (93 m²) and a detached building is not required
- (2) Not less than 50 ft (15 m) where a detached building is required by Table 5.3.7
- (3) Not less than the distances required by Table 6.2.2.3 for buildings containing materials with explosive characteristics

[**5000:**34.3.4.3.1]

**6.2.3.3.2** Distances shall be measured from the walls enclosing the Protection Level 2 area to property lines, including those on a public way, or in accordance with 7.3.4.2 of *NFPA 5000* for buildings on the same lot. [**5000:**34.3.4.3.2]

## 6.2.3.4 Detached Building Required.

**6.2.3.4.1\*** Buildings required to comply with Protection Level 2 and containing quantities of high-hazard contents exceeding the quantity limits set forth in Table 5.3.7 shall be used for manufacturing, processing, dispensing, use, or storage of hazardous materials and no other purpose, shall not exceed one story in height, and shall be without basements, crawl spaces, or other under-floor spaces. [5000:34.3.4.4.1]

- **6.2.3.4.2** Buildings that contain high-hazard level 2 contents also shall be permitted to contain high-hazard level 3 or high-hazard level 4 contents, provided that incompatible materials are separated as otherwise required by the provisions of this code, NFPA 1, and *NFPA 5000*. [**5000:**34.3.4.4.2]
- **6.2.3.4.3** The roofs of buildings specified in 6.2.3.4.1 shall be of lightweight construction.

#### 6.2.3.5 Water-Reactive Materials.

- **6.2.3.5.1** Rooms or areas containing Class 2 or Class 3 water-reactive materials shall be resistant to water penetration. [5000:34.3.4.5.1]
- **6.2.3.5.2** Piping for conveying water, other than fire protection piping, shall not route over or through areas containing Class 2 or Class 3 water-reactive materials, unless isolated by approved liquidight construction. [**5000**:34.3.4.5.2]

#### 6.2.4 Protection Level 3.

**6.2.4.1 General.** Buildings, or portions thereof, required to comply with Protection Level 3 shall comply with 6.2.1 and 6.2.4.2 through 6.2.4.7.2. [**5000**:34.3.5.1]

## 6.2.4.2 Exterior Wall Required.

- **6.2.4.2.1** Buildings, or portions thereof, required to comply with Protection Level 3 shall be located on property such that not less than 25 percent of the perimeter wall is an exterior wall. [5000:34.3.5.2.1]
- **6.2.4.2.2** Rooms utilized for the use, dispensing, mixing, and storage of flammable and combustible liquids having a floor area of not more than 500 ft<sup>2</sup> (46.5 m<sup>2</sup>) shall not be required to be located on the outer perimeter of the building where such rooms are in accordance with NFPA 30. [5000:34.3.5.2.2]

## **6.2.4.3** Minimum Distance to Property Lines or Horizontal Separation.

- **6.2.4.3.1** Buildings, or portions thereof, required to comply with Protection Level 3 shall be set back from property lines, or be provided with a horizontal separation in accordance with 7.3.4.2 of *NFPA 5000* at any of the following distances:
- (1) Not less than 30 ft (9.1 m) where the area of the occupancy exceeds 1000 ft² (93 m²) and a detached building is not required
- (2) Not less than 50 ft (15 m) where a detached building is required by Table 5.3.7
- (3) Not less than the distances required by Table 34.3.3.3 of NFPA 5000 for buildings containing materials with explosive characteristics

[**5000:**34.3.5.3.1]

**6.2.4.3.2** Distances shall be measured from the walls enclosing the Protection Level 3 area to property lines, including those on a public way, or in accordance with 7.3.4.2 of *NFPA 5000* for buildings on the same lot. [**5000:**34.3.5.3.2]

## 6.2.4.4 Detached Building Required.

**6.2.4.4.1\*** Buildings required to comply with Protection Level 3 and containing quantities of high-hazard contents exceeding the quantity limits set forth in Table 5.3.7 shall be used for manufacturing, processing, dispensing, use, or storage of hazardous materials and no other purpose, shall not exceed one story in height, and shall be without basements, crawl spaces, or other under-floor spaces. [5000:34.3.5.4.1]

## Explanatory Notes Essential to the Application of the American Table of Distances.

<sup>1</sup>"Explosive materials" means explosives, blasting agents, and detonators.

Explosives" means any chemical compound, mixture, or device, the primary or common purpose of which is to function by explosion. A list of explosives determined to be within the coverage of 18 USC 40, "Importation, Manufacture, Distribution and Storage of Explosive Materials," is issued at least annually by the Director of the Bureau of Alcohol, Tobacco, and Firearms of the Department of the Treasury. For quantity and distance purposes, detonating cord of 50 grains per foot should be calculated as equivalent to 8 lb (3.7 kg) of high explosives per 1000 ft (305 m). Heavier or lighter core loads should be rated proportionately.

Blasting agents" means any material or mixture consisting of fuel and oxidizer, intended for blasting, and not otherwise defined as an explosive, provided that the finished product, as mixed for use or shipment, cannot be detonated by means of a No. 8 test blasting cap where unconfined.

"Detonator" means any device containing any initiating or primary explosive that is used for initiating detonation. A detonator may not be permitted to contain more than 10 g of total explosives by weight, excluding ignition or delay charges. The term includes, but is not limited to, electric blasting caps of instantaneous and delay types, blasting caps for use with safety fuses, detonating cord delay connectors, and nonelectric instantaneous and delay blasting caps that use detonating cord, shock tube, or any other replacement for electric leg wires. All types of detonators in strengths through No. 8 cap should be rated at 1½ lb (0.7 kg) of explosives per 1000 caps.

<sup>5</sup>For strengths higher than No. 8 cap, the manufacturer should be consulted.

"Magazine" means any building, structure, or container, other than an explosives manufacturing building, approved for the storage of explosive materials.

"Natural barricade" means natural features of the ground, such as hills, or timber of sufficient density that the surrounding exposures that need protection cannot be seen from the magazine when the trees are bare of leaves.

8"Artificial barricade" means an artificial mound or revetted wall of earth of a minimum thickness of 3 ft (0.9 m).

<sup>9</sup>"Barricaded" means the effective screening of a building containing explosive materials from the magazine or another building, a railway, or a highway by a natural or an artificial barrier. A straight line from the top of any sidewall of the building containing explosive materials to the eave line of any magazine or other building or to a point 12 ft (3.7 m) above the center of a railway or highway shall pass through such barrier.

<sup>10</sup>"Inhabited building" means a building regularly occupied in whole or part as a habitation for human beings, or any church, schoolhouse, railroad station, store, or other structure where people are accustomed to assemble, but does not include any building or structure occupied in connection with the manufacture, transportation, storage, or use of explosive materials.

"Railway" means any steam, electric, or other railroad or railway that carries passengers for hire.

<sup>12</sup>"Public highway" means any road, street, or way, whether on public or private property, open to public travel.

<sup>18</sup>Where two or more storage magazines are located on the same property, each magazine shall comply with the minimum distances specified from inhabited buildings, railways, and highways, and, in addition, they should be separated from each other by not less than the distances shown for "separation of magazines," except that the quantity of explosive materials contained in detonator magazines shall govern with regard to the spacing of said detonator magazines from magazines containing other explosive materials. If any two or more magazines are separated from each other by less than the specified "separation of magazines" distances, such magazines, as a group, shall be considered as one magazine, and the total quantity of explosive materials stored in such group shall be treated as if stored in a single magazine located on the site of any magazine of the group, and shall comply with the minimum specified distances from other magazines, inhabited buildings, railways, and highways.

<sup>14</sup>Storage in excess of 300,000 lb (136,200 kg) of explosive materials in one magazine generally is not necessary for commercial enterprises.

<sup>15</sup>This table applies only to the manufacture and permanent storage of commercial explosive materials. It is not applicable to the transportation of explosives or any handling or temporary storage necessary or incident thereto. It is not intended to apply to bombs, projectiles, or other heavily encased explosives.

<sup>16</sup>Where a manufacturing building on an explosive materials plant site is designed to contain explosive materials, the building shall be located at a distance from inhabited buildings, public highways, and passenger railways in accordance with the American Table of Distances based on the maximum quantity of explosive materials permitted to be in the building at one time.

- **6.2.4.4.2** Buildings that contain high-hazard level 3 contents also shall be permitted to contain high-hazard level 2 or high-hazard level 4 contents, provided that incompatible materials are separated as otherwise required by the provisions of this code and NFPA 1. [5000:34.3.5.4.2]
- **6.2.4.5 Detached Unprotected Building.** Where acceptable to the AHJ, based on a determination that a protected building is not practical and an assessment of acceptable risk, storage buildings required to comply with Protection Level 3 shall be permitted without fire protection systems, provided that the following provisions are met:
- (1) The building, or portions thereof, shall have a horizontal separation of at least 200 ft (61 m) from exposed business, industrial, mercantile, and storage occupancies on the same lot and from any property line that is or can be built upon. Where protection for exposures is provided in accordance with 6.2.4.5(6)(c), the horizontal separation shall be at least 100 ft (30.5 m).
- (2) The building, or portions thereof, shall have a horizontal separation of at least 1000 ft (305 m) from exposed occupancies other than business, industrial, mercantile, and storage occupancies on the same lot and from any property line that is or can be built upon. Where protection for exposures is provided in accordance with 6.2.4.5(6)(c), the horizontal separation shall be at least 500 ft (150 m).
- (3) The building shall not exceed one story in height.
- (4) The building shall not have basements, crawl spaces, or other under-floor accessible spaces.
- (5) Egress from the building shall not exceed 50 percent of the distances listed in Table 6.2.1.4.1, measured as required in 11.6.2 of NFPA 5000, and in compliance with 34.3.2.4.2 through 34.3.2.4.5 of NFPA 5000.
- (6) The building shall comply with the requirements of the following:
  - (a) 34.3.2.2 of NFPA 5000 for building height
  - (b) 6.2.1.5 for ventilation
  - (c) 6.2.1.6 for explosion control
  - (d) 6.2.1.8 for standby and emergency power
  - (e) 6.2.1.10 for floor construction
  - (f) 34.3.2.10 of NFPA 5000 for unprotected vertical openings
- (7) Spill control shall comply with 6.2.1.9.
- (8) Secondary containment shall comply with 6.2.1.9.3, except that containment for fire protection water shall not be required if the building is not provided with a fire protection sprinkler system.
- (9) Where credit is taken for protection for exposures in accordance with 34.3.5.5(1) and 34.3.5.5(2) of NFPA 5000, protection of exposures shall consist of fire protection for structures on property adjacent to the storage building that is provided by (1) a public fire department or (2) a private fire brigade maintained on the property adjacent to the storage building, either of which shall be capable of providing cooling water streams to protect the property adjacent to the storage building.

**6.2.4.6 Roofs.** The roofs of buildings specified in 6.2.4.4.1 shall be of lightweight construction.

#### 6.2.4.7 Water-Reactive Materials.

- **6.2.4.7.1** Rooms or areas containing Class 2 or Class 3 water-reactive materials shall be resistant to water penetration. [5000:34.3.5.7.1]
- **6.2.4.7.2** Piping for conveying water, other than fire protection piping, shall not route over or through areas containing Class 2 or Class 3 water-reactive materials, unless isolated by approved liquidight construction. [**5000**:34.3.5.7.2]

#### 6.2.5 Protection Level 4.

- **6.2.5.1** Buildings, or portions thereof, required to comply with Protection Level 4 shall comply with 6.2.1, 6.2.5.2, and 6.2.5.3. [5000:34.3.6]
- **6.2.5.2 Highly Toxic Solids and Liquids.** Highly toxic solids and liquids not stored in approved hazardous materials storage cabinets shall be isolated from other hazardous materials storage by a 1-hour fire barrier. [5000:34.3.6.2]
- **6.2.5.3 Gas Rooms.** Exhaust ventilation for gas rooms shall be designed to operate at a negative pressure in relation to the surrounding areas and shall direct the exhaust ventilation to an exhaust system. [**5000:**34.3.6.1]
- **6.2.6 Protection Level 5.** Buildings, and portions thereof, required to comply with Protection Level 5 shall comply with *NFPA 5000*, NFPA 1, and NFPA 318.
- **6.2.7 Outdoor Storage.** Outdoor storage areas shall be in accordance with the requirements of Chapters 11 through 21, as applicable.
- $\Delta$  6.2.7.1 Clearance from Combustibles. Clearance from combustibles shall comply with 6.1.15(2).
  - **6.2.7.2 Weather Protection.** Where weather protection is provided for sheltering outside hazardous material storage or use areas, such storage or use areas shall be considered outside storage or use areas, provided that all of the following conditions are met: [5000:34.2.6]
  - (1) The overhead structure shall be approved noncombustible construction with a maximum area of 1500 ft<sup>2</sup> (140 m<sup>2</sup>) except that area increases based on location or fire protection systems under the requirements of the building code shall be allowed.
  - (2) Supports and walls shall not obstruct more than one side or more than 25 percent of the perimeter of the storage area. [5000:34.2.6]
  - (3) The distance from the structure and the structural supports to buildings, lot lines, or public egress to a public way shall not be less than the distance required by Chapters 11 through 21 for an outside hazardous material storage area without weather protection.
  - (4) Weather-protection structures containing storage of explosive or detonable materials shall be considered indoor storage.

## 6.2.7.3 Secondary Containment.

- **6.2.7.3.1 General.** Where secondary containment is required, it shall be in accordance with 6.2.1.9.3.
- **6.2.7.3.2** Where Required. Where required by Table 6.2.7.3.2, outdoor storage areas used for hazardous materials solids or liquids shall be provided with secondary containment in accordance with 6.2.1.9.3.

- **6.2.7.3.3 Containment Pallets.** Where used as a substitute for spill control and secondary containment for outdoor storage in accordance with 6.2.1.9.1, containment pallets shall comply with the following:
- A liquidtight sump accessible for visual inspection shall be provided.
- (2) The sump shall be designed to contain not less than 66 gal (249.8 L).
- (3) Exposed surfaces shall be compatible with the material stored.
- (4) Containment pallets shall be protected to prevent collection of rainwater within the sump.
- 6.3 Requirements for Use, Dispensing, and Handling of Hazardous Materials in Amounts Exceeding Maximum Allowable Quantities.
- **6.3.1\* General.** The following shall apply to aggregate quantities of hazardous materials used, dispensed, or handled:
- (1) Where the aggregate quantity of hazardous materials used, dispensed, or handled exceeds the MAQ, the requirements set forth in Section 6.3 shall apply, except as specified in 6.3.1.1.

- (2) Where the aggregate quantity of hazardous materials used, dispensed, or handled does not exceed the MAQ, Section 6.3 shall not apply.
- **6.3.1.1 Uses Not Required to Comply.** The following use conditions shall not be required to comply with Section 6.3:
- (1) Corrosives used in stationary lead-acid battery systems used for standby power, emergency power, or uninterrupted power supply complying with Chapter 52 of NFPA 1
- (2) Application and release of pesticide products and materials intended for use in weed abatement, erosion control, soil amendment or similar applications, where applied in accordance with the manufacturer's instructions and label directions

#### 6.3.1.2 Limit Controls.

- **6.3.1.2.1 General.** Limit controls shall be provided in accordance with 6.3.1.2.1 through 6.3.1.2.4.2.
- **6.3.1.2.2 Temperature Control.** Process tanks and equipment, which involve temperature control of the material to prevent a hazardous reaction, shall be provided with limit controls to maintain the temperature within a safe range.

#### 6.3.1.2.3 Pressure Control.

- **6.3.1.2.3.1** Stationary tanks and equipment containing hazardous materials liquids that can generate pressures exceeding design limits due to exposure fires or internal reaction shall have a form of construction or other approved means that relieves excessive internal pressure.
- **6.3.1.2.3.2** The means of pressure relief shall vent to an approved location.
- **6.3.1.2.3.3** Where required by Chapter 21, the means of pressure relief shall vent to an exhaust scrubber or treatment system.

## 6.3.1.2.4 Liquid Level.

- **6.3.1.2.4.1 High Level.** Open tanks in which hazardous materials are used shall be equipped with a liquid level limit control or other means to prevent overfilling of the tank.
- **6.3.1.2.4.2** Low Level. Open tanks and containers in which hazardous materials are heated shall be equipped with approved automatic shutoff controls, which will sense low liquid levels and shut off the source of heat.
- **6.3.1.3 Standby and Emergency Power.** Where mechanical ventilation, treatment systems, temperature control, alarm, detection, or other electrically operated safety systems are required by this code, NFPA 1, or *NFPA 5000*, such systems shall be provided with standby power or emergency power as required by 6.3.1.3. [**5000**:34.3.2.7.1]
- **6.3.1.3.1** Standby power for mechanical ventilation, exhaust treatment, and temperature control systems shall not be required where such systems are engineered and approved as fail-safe. [5000:34.3.2.7.2]
- **6.3.1.3.2** The secondary source of power shall be an approved means of legally required standby power in accordance with *NFPA 70*, except for areas containing highly toxic or toxic gases, where a legally required emergency power system in accordance with Chapter 52 of *NFPA 5000* and NFPA 55 shall be provided to operate safety systems required by this code, NFPA 1, and *NFPA 5000*. [**5000:**34.3.2.7.3]

- 6.3.1.4 Spill Control and Secondary Containment for Hazardous Materials Liquids.
- **6.3.1.4.1 Spill Control.** Where spill control is specifically required in 6.3.2 or 6.3.3, such systems shall be in accordance with 6.3.1.4.1.1 through 6.3.1.4.1.3.
- **6.3.1.4.1.1 General.** Where spill control is required, floors in indoor locations and similar surfaces in outdoor locations shall be constructed to contain a spill from the largest single vessel by one of the following methods:
- Liquidtight sloped or recessed floors in indoor locations or similar areas in outdoor locations
- (2) Liquidtight floors in indoor locations or similar areas in outdoor locations provided with liquidtight raised or recessed sills or dikes
- (3) Sumps and collection systems [5000:34.3.2.8.2.2]
- **6.3.1.4.1.2** Except for surfacing, the floors, sills, dikes, sumps, and collection systems shall be constructed of noncombustible material, and the liquidtight seal shall be compatible with the material stored. [5000:34.3.2.8.2.3]
- **6.3.1.4.1.3** Where liquidtight sills or dikes are provided, they shall not be required at perimeter openings that are provided with an open-grate trench across the opening that connects to an approved collection system. [**5000**:34.3.2.8.2.4]
- **6.3.1.4.2 Secondary Containment.** Where secondary containment is specifically required in 6.3.2 or 6.3.3, such systems shall be in accordance with 6.3.1.4.2.1 through 6.3.1.4.2.10.
- **6.3.1.4.2.1** Buildings, or portions thereof, containing only hazardous materials in listed secondary containment tanks or systems shall not be required to comply with 6.3.1.4.2. [5000:34.3.2.8.3.2]
- **6.3.1.4.2.2** Secondary containment shall be achieved by means of drainage control where required by NFPA 30. [5000:34.3.2.8.3.4]
- **6.3.1.4.2.3** The building, room, or area shall contain or drain the hazardous materials and fire protection water through the use of one of the following methods:
- Liquidtight sloped or recessed floors in indoor locations or similar areas in outdoor locations
- (2) Liquidtight floors in indoor locations or similar areas in outdoor locations provided with liquidtight raised or recessed sills or dikes
- (3) Sumps and collection systems
- (4) Drainage systems leading to an approved location [5000:34.3.2.8.3.5]
- **6.3.1.4.2.4** Where incompatible materials are present in open containers or systems, such materials shall be separated from each other in the secondary containment system. [5000:34.3.2.8.3.6]
- **6.3.1.4.2.5** Secondary containment for indoor storage areas shall be designed to contain a spill from the largest vessel plus the design flow volume of fire protection water calculated to discharge from the fire-extinguishing system over the minimum required system design area, or area of the room or area in which the storage is located, whichever is smaller, for a period of 20 minutes. [5000:34.3.2.8.3.7]

- **6.3.1.4.2.6** A monitoring method shall be provided to detect hazardous materials in the secondary containment system. [5000:34.3.2.8.3.8]
- **6.3.1.4.2.7** The monitoring method shall be permitted to be visual inspection of the primary or secondary containment, or other approved means. [**5000:**34.3.2.8.3.9]
- **6.3.1.4.2.8** Where secondary containment is subject to the intrusion of water, a monitoring method for detecting water shall be provided. [**5000**:34.3.2.8.3.10]
- **6.3.1.4.2.9** Where monitoring devices are provided, they shall be connected to distinct visual or audible alarms. [5000:34.3.2.8.3.11]
- **6.3.1.4.2.10** Where remote containment systems are provided, drainage systems shall be in accordance with the *Uniform Mechanical Code*, and the following provisions also shall be met:
- (1) The slope of floors in indoor locations to drains or similar areas in outdoor locations shall be not less than 1 percent.
- (2) Drains from indoor storage areas shall be sized to carry the volume of the fire protection water, as determined by the design density discharged from the automatic fireextinguishing system over the minimum required system design area, or area of the room or area in which the storage is located, whichever is smaller.
- (3) Materials of construction for drainage systems shall be compatible with the materials stored.
- (4) Separate drainage systems shall be provided to avoid mixing incompatible materials where such materials are present in an open-use condition.
- (5) Drains shall terminate in an approved location away from buildings, valves, means of egress, fire access roadways, adjoining property, and storm drains.
- **6.3.1.5 Lighting.** Lighting by natural or artificial means shall be provided, and artificial lighting, where provided, shall be in accordance with nationally recognized standards.

## 6.3.1.6 System Design.

- **6.3.1.6.1** Systems shall be suitable for the use intended and shall be designed by persons competent in such design.
- **6.3.1.6.2** Where nationally recognized good practices or standards have been established for the processes employed, they shall be followed in the design.
- **6.3.1.6.3** Controls shall be designed to prevent materials from entering or leaving process or reaction systems at other than the intended time, rate, or path.
- **6.3.1.6.4** Where automatic controls are provided, they shall be designed to be fail-safe.

#### 6.3.1.7 Liquid Transfer.

- **6.3.1.7.1** Approved containers shall be used where liquids are dispensed from containers.
- **6.3.1.7.2** Liquids having a hazard ranking of 3 when exceeding 5.3 gal (20 L), or liquids having a hazard ranking of 4 when exceeding 1.1 gal (4 L), shall be transferred by one of the following methods:
- (1) From safety cans
- (2) Through an approved closed-piping system

- (3) From containers or tanks by an approved pump taking suction through an opening in the top of the container or tank
- (4) For other than highly toxic liquids, from containers or tanks by gravity through an approved self-closing or automatic-closing valve where the container or tank and dispensing operations are provided with spill control and secondary containment complying with 6.3.1.4.1 through 6.3.1.4.2.10
- (5) By the use of approved engineered liquid transfer systems
- **6.3.1.8** Supervision of Alarm, Detection, and Automatic Fire-Extinguishing Systems. Alarm, detection, and automatic fire-extinguishing systems required by Section 6.3 shall be supervised by an approved central, proprietary, or remote station service or shall initiate an audible and visual signal at a constantly attended on-site location.
- 6.3.2 Indoor Dispensing and Use.
- 6.3.2.1 General Indoor Requirements.
- 6.3.2.1.1 Fire Protection Systems.
- **6.3.2.1.1.1 General.** Indoor dispensing and use areas shall be provided with approved fire protection systems in accordance with 6.2.1.1.
- **6.3.2.1.1.2** Fire-Extinguishing System for Laboratory Fume Hoods and Spray Booths. In addition to the requirements of 6.2.1.1, laboratory fume hoods and spray booths where flammable materials are dispensed or used shall be protected by an automatic fire-extinguishing system.
- **6.3.2.1.2 Protection Level 1 through Protection Level 4.** Buildings and structures required to comply with Protection Level 1, Protection Level 2, Protection Level 3, or Protection Level 4 controls shall be constructed in accordance with the specific protection level controls of Section 6.2 and the requirements of *NFPA 5000*.
- **6.3.2.1.2.1 Building Height Exception.** The height of a one-story building, or portion thereof, containing only tanks or industrial process equipment shall not be limited based on the type of construction. [5000:34.3.2.2]
- **6.3.2.1.2.2 Separation of Occupancies Having High Hazards.** The separation of areas containing high-hazard contents from each other and from other use areas shall be as required by Table 6.2.1.3 and shall not be permitted to be reduced with the installation of fire protection systems as required by 6.3.2.1.1. [5000:34.3.2.3]
- **6.3.2.1.2.3 Egress.** Egress from areas required to comply with Protection Level 1, Protection Level 2, Protection Level 3, or Protection Level 4 shall comply with 6.2.1.4 and Chapter 14 of NFPA 1.
- 6.3.2.1.3 Ventilation.
- **6.3.2.1.3.1 General.** Indoor dispensing and use areas shall be provided with exhaust ventilation in accordance with 6.2.1.5. [**5000:**34.3.2.5]
- **6.3.2.1.3.2 Exceptions to Ventilation Requirement.** Exhaust ventilation required by 6.3.2.1.3.1 shall not be required for dispensing and use of flammable solids other than those with finely divided particles.

- **6.3.2.1.3.3 Standby and Emergency Power.** Standby or emergency power shall be provided in accordance with 6.2.1.8.
- 6.3.2.1.4 Explosion Control.
- **6.3.2.1.4.1 General.** Explosion control shall be provided in accordance with 6.2.1.6 where an explosive environment can occur because of the characteristics or nature of the hazardous materials dispensed or used, or as a result of the dispensing or use process, unless process vessels comply with 6.3.2.1.4.2.
- **6.3.2.1.4.2 Process Vessels.** Additional explosion control shall not be required for materials and processes that are located in process vessels designed to fully contain or vent the worst-case explosion anticipated within the vessel under process conditions considering the most likely failure. When deflagration venting from process vessels is provided, the discharge from venting systems shall be in accordance with NFPA 68 and arranged so that overpressures produced will not endanger personnel or damage the building, structure, or surrounding buildings or structures in which the process is located.
- 6.3.2.2 Indoor Open Systems.
- **6.3.2.2.1 General.** Dispensing and use of hazardous materials in open containers or systems in amounts exceeding the MAQ specified in Section 5.2 shall be in accordance with 6.3.2.2.2 through 6.3.2.2.4.2.
- **6.3.2.2.2 Ventilation.** In addition to the requirements of 6.3.2.1.3, where liquids or solids having a health, instability, or flammability hazard ranking of Class 3 or Class 4 in accordance with NFPA 704 are dispensed or used, mechanical exhaust ventilation shall be provided to capture fumes, mists, or vapors at the point of generation, unless such liquids or solids can be demonstrated as not creating harmful fumes, mists, or vapors.
- **6.3.2.2.3 Floor Construction.** Except for surfacing, floors of areas where liquid or solid hazardous materials are dispensed or used in open systems shall be of noncombustible, liquidtight construction.
- 6.3.2.2.4 Spill Control and Secondary Containment for Hazardous Materials Liquids.
- **6.3.2.2.4.1 Spill Control.** Buildings, or portions thereof, used for any of the following shall be provided with spill control in accordance with 6.3.1.4.1 to prevent the flow of liquids to adjoining areas:
- (1) Dispensing of hazardous materials liquids into vessels exceeding a 1.1 gal (4 L) capacity
- (2) Open use of hazardous materials liquids in vessels or systems exceeding a 5.3 gal (20 L) capacity

## 6.3.2.2.4.2 Secondary Containment.

- △ (A) Where required by Table 6.3.2.2.4.2(A), buildings, or portions thereof, used for either of the following shall be provided with secondary containment in accordance with 6.3.1.4.2.1 through 6.3.1.4.2.10:
  - (1) Open use of liquids where the capacity of an individual vessel or system exceeds 1.1 gal (4 L)
  - (2) Open use of liquids where the capacity of multiple vessels or systems exceeds 5.3 gal (20 L)
- △ (B) Buildings, or portions thereof, containing only hazardous materials in listed secondary containment tanks or systems shall not be required to comply with 6.3.2.2.4.2(A).

### 6.3.2.3 Indoor — Closed Systems.

**6.3.2.3.1 General.** Dispensing and use of hazardous materials in closed containers or systems in amounts exceeding the MAQ specified in Chapter 5 shall be in accordance with 6.3.2.3.1 through 6.3.2.3.3.2.

**6.3.2.3.2 Ventilation.** If closed systems are designed to be opened as part of normal operations, ventilation shall be provided in accordance with 6.3.2.1.3.1.

## 6.3.2.3.3 Spill Control and Secondary Containment for Hazardous Materials Liquids.

Δ 6.3.2.3.3.1 Spill Control. Buildings, or portions thereof, where hazardous materials liquids are used in individual closed vessels exceeding a 55 gal (208.2 L) capacity shall be provided with spill control in accordance with 6.3.1.4.1 through 6.3.1.4.1.3 to prevent the flow of liquids to adjoining areas.

**6.3.2.3.3.2 Secondary Containment.** Where required by Table 6.3.2.2.4.2(A), buildings, or portions thereof, used for either of the following shall be provided with secondary containment in accordance with 6.3.1.4.2.1 through 6.3.1.4.2.10:

- (1) Closed-use capacity of an individual vessel or system exceeds 55 gal (208 L)
- (2) Closed-use aggregate capacity of multiple vessels or systems exceeds 1000 gal (3785 L)

## 6.3.3 Outdoor Dispensing and Use.

## 6.3.3.1 General.

**6.3.3.1.1 Location.** Outdoor dispensing and use areas shall be located as required for outdoor storage of hazardous materials in quantities exceeding the MAQ.

△ 6.3.3.1.2 Clearance from Combustibles. Clearance from combustibles shall be in accordance with 6.1.15(2).

**6.3.3.1.3 Weather Protection.** Weather protection, when provided, shall comply with 6.2.7.2.

## 6.3.3.2 Outdoor — Open Systems.

**6.3.3.2.1 General.** In addition to the requirements set forth in 6.3.3.1 through 6.3.3.1.3, dispensing and use of hazardous materials in open containers or systems in amounts exceeding the MAQ specified in Chapter 5 shall be in accordance with 6.3.3.2.1 through 6.3.3.2.2.2.

## 6.3.3.2.2 Spill Control and Secondary Containment for Hazardous Materials Liquids.

**6.3.3.2.2.1 Spill Control.** Outdoor areas used for either of the following shall be provided with spill control in accordance with 6.3.1.4.1 through 6.3.1.4.1.3 to prevent the flow of liquids to adjoining areas:

- (1) Dispensing of hazardous materials liquids into vessels exceeding a 1.1 gal (4 L) capacity
- (2) Open use of hazardous materials liquids in vessels or systems exceeding a 5.3 gal (20 L) capacity

#### 6.3.3.2.2.2 Secondary Containment.

- **(A) Where Required.** Where required by Table 6.3.2.2.4.2(A), outdoor areas used for either of the following shall be provided with secondary containment in accordance with 6.3.1.4.2.1 through 6.3.1.4.2.10:
- Open use of liquids where the capacity of an individual vessel or system exceeds 1.1 gal (4 L)
- (2) Open use of liquids where the capacity of multiple vessels or systems exceeds 5.3 gal (20 L)
- △ (B) Incompatible Materials. Incompatible materials used in open systems shall be separated from each other in the secondary containment system.

#### 6.3.3.3 Outdoor — Closed Systems.

**6.3.3.3.1 General.** In addition to the requirements set forth in 6.3.3.1 through 6.3.3.1.3, dispensing and use of hazardous materials in closed containers or systems in amounts exceeding the MAQ specified in Chapter 5 shall be in accordance with 6.3.3.3.1 through 6.3.3.3.2.2.

## 6.3.3.3.2 Spill Control and Secondary Containment for Hazardous Materials Liquids.

**6.3.3.3.2.1 Spill Control.** Outdoor areas where hazardous materials liquids are used in individual closed vessels exceeding a 55 gal (208 L) capacity shall be provided with spill control in accordance with 6.3.1.4.1 through 6.3.1.4.1.3 to prevent the flow of liquids to adjoining areas.

**6.3.3.3.2.2 Secondary Containment.** Where required by Table 6.3.2.2.4.2(A), outdoor areas used for either of the following shall be provided with secondary containment in accordance with 6.3.1.4.2.1 through 6.3.1.4.2.10:

- (1) Closed-use capacity of an individual vessel or system exceeds 55 gal (208 L)
- (2) Closed-use aggregate capacity of multiple vessels or systems exceeds 1000 gal (3785 L)

## 6.3.4 Handling.

- **6.3.4.1 General.** The handling and transportation of hazardous materials in exit access corridors or exit enclosures shall be in accordance with 6.3.4.2 through 6.3.4.4.2.
- **6.3.4.2 Carts and Trucks Required.** Liquids in containers exceeding 5 gal (19 L) in an exit access corridor or exit enclosure shall be transported on a cart or truck.
- **6.3.4.2.1** Containers of hazardous materials having a hazard ranking of 3 or 4 in accordance with NFPA 704 and transported within corridors or exit enclosures shall be on a cart or truck.
- **6.3.4.2.2** Where carts and trucks are required for transporting hazardous materials, they shall be in accordance with 6.3.4.3, except for the following:
- Two hazardous material liquid containers that are hand carried in safety carriers
- (2) Not more than four drums not exceeding 55 gal (208 L) each that are transported by drum trucks
- (3) Solid hazardous materials not exceeding 100 lb (45 kg) that are transported by hand trucks
- (4) Single container not exceeding 50 lb (23 kg) that is hand carried
- **6.3.4.3 Carts and Trucks.** Carts and trucks required by 6.3.4.2 to be used to transport hazardous materials shall be in accordance with 6.3.4.3.1 through 6.3.4.3.6.
- **6.3.4.3.1 Design.** Carts and trucks used to transport hazardous materials shall be designed to provide a stable base for the commodities to be transported and shall have a means of restraining containers to prevent accidental dislodgement.
- **6.3.4.3.2 Speed-Control Devices.** Carts and trucks shall be provided with a device that will enable the operator to control movement safely by providing stops or speed-reduction devices.
- **6.3.4.3.3 Construction.** Construction materials for hazardous material carts or trucks shall be compatible with the material transported.
- **6.3.4.3.4 Spill Control.** Carts and trucks transporting liquids shall be capable of containing a spill from the largest single container transported.
- **6.3.4.3.5 Attendance.** Carts and trucks used to transport materials shall not obstruct or be left unattended within any part of a means of egress.
- **6.3.4.3.6** Incompatible Materials. Incompatible materials shall not be transported on the same cart or truck.
- 6.3.4.4 Emergency Alarm for Transportation of Hazardous Materials in Corridors or Exit Enclosures.
- **6.3.4.4.1** When hazardous materials having a hazard ranking of 3 or 4 in accordance with NFPA 704 are transported through corridors or exit enclosures, there shall be an emergency telephone system, a local manual alarm station, or an approved alarm-initiating device at not more than 150 ft (46 m) intervals and at each exit throughout the transport route.
- **6.3.4.4.2** The signal shall be relayed to an approved central, proprietary, or remote station service or constantly attended on-site location and shall also initiate a local audible alarm.

## Chapter 7 Emergency Planning, Fire Risk Control, and Chemical Hazard Requirements for Industrial Processes

- **7.1\* General.** This chapter shall apply to emergency planning, fire risk control, and chemical hazard requirements associated with industrial processes consisting of interconnected equipment or vessels when required by 7.1.1.
- **7.1.1 Applicability.** Except as provided in 7.1.2, the requirements of this chapter shall be applicable to facilities with the following materials, where the quantities of materials in use in an industrial process require compliance with Protection Level 1, Protection Level 2, Protection Level 3, or Protection Level 4:
- Unpackaged organic peroxide formulations that are capable of explosive decomposition in their unpackaged state
- (2) Oxidizer Class 3 and Class 4: solids and liquids
- (3) Pyrophoric solids, liquids, and gases
- (4) Únstable reactive Class 3 and Class 4: solids, liquids, and gases
- (5) Highly toxic solids, liquids, and gases
- (6) Water-reactive liquids, Class 3

## 7.1.2 Analysis of Upset Conditions.

- **7.1.2.1** Chapter 7 shall not apply when a qualified design professional documents that the unmitigated consequences of a process upset condition will not result in the following:
- (1) Explosion with blast overpressure exceeding 1 psi (6.9 kPa) at 60 ft (20 m) or at the property line, whichever is less
- (2) Fire with radiant energy exceeding 1500 Btu/hr/ft<sup>2</sup> (4.73 kW/m<sup>2</sup>) over 15 seconds duration at 60 ft (20 m) (flux value) or at the property line, whichever is less
- (3)\* Maximum airborne concentration from a release of material that, with a 1-hour exposure, would cause irreversible or other serious health effects or symptoms that could impair an individual's ability to take protective action at a distance of 60 ft (20 m) from the process or at the property line, whichever is less
- **7.1.2.2** Mitigation to reduce the potential risk of an unintended upset to levels below those specified in 7.1.2.1(1) through 7.1.2.1(3) shall be subject to approval by the AHJ in accordance with 7.1.3.
- **7.1.3 Substantiating Documentation.** When required by the AHJ, a technical report substantiating a determination by the process engineer or process designer to not apply Chapter 7 shall be submitted to the AHJ for review and approval in accordance with Section 1.14.

#### 7.2 Process Review and Plan Preparation.

**7.2.1\* General.** Industrial processes shall be reviewed and written plans prepared by qualified personnel to ensure that fire and explosion and chemical hazards resulting from loss of containment or potential chemical interaction are prevented.

### 7.2.2 Fire Risk Controls.

- **7.2.2.1** The extent of fire risk controls provided shall be determined by means of an evaluation of the process and application of fire protection and process engineering principles.
- **7.2.2.2** The evaluation specified in 7.2.2.1 shall include, but shall not be limited to, an analysis of the following:

- Fire and chemical hazards of the process relevant to the chemicals and conditions being used
- (2) Emergency relief from process vessels relevant to the properties of the materials used and the fire protection and control measures taken
- (3) Effluent-handling systems for emergency relief venting
- (4) Facility and equipment design, handling, and transfer requirements specified in Chapter 6 and Chapters 11 through 21, as applicable
- (5) Emergency response capabilities of the local emergency services
- (6) Local conditions, such as exposure to and from adjacent properties and exposure to floods, earthquakes, and severe weather conditions

#### 7.2.3 Emergency Action Planning.

- **7.2.3.1** Written Emergency Action Plan. A written emergency action plan that is consistent with the personnel and equipment employed shall be developed and implemented.
- **7.2.3.2 Provisions Within the Emergency Action Plan.** The emergency action plan shall include the following procedures in the event of a chemical emergency, fire, or explosion:
- (1) Procedures for sounding the alarm
- (2) Procedures for notifying and coordinating with the fire department, governmental agencies, or other emergency responders or contacts, as required
- (3) Procedures for evacuating and accounting for personnel, as applicable
- (4) Procedures for establishing requirements for rescue and medical duties for those requiring or performing these duties
- (5) Procedures and schedules for conducting drills
- (6) Procedures for shutting down and isolating equipment under emergency conditions to include the assignment of personnel responsible for maintaining critical plant functions or for shutdown of process operations
- (7) Appointment and training of personnel to carry out assigned duties, including steps to be taken at the time of initial assignment, as responsibilities or response actions change, and at the time anticipated duties change
- (8) Alternative measures for occupant safety, when applicable
- (9) Aisles designated as necessary for movement of personnel and emergency response
- (10) Maintenance of fire protection equipment
- (11) Safe procedures for startup to be taken following the abatement of an emergency
- **7.2.3.2.1** When an on-site emergency response team is provided in accordance with 6.1.4.4.3, the emergency action plan shall include the following in addition to the requirements of 7.2.3.2:
- (1) Procedures for controlling fire, explosion, or chemical hazards resulting from loss of containment
- (2) Procedures for mitigating unintended chemical interactions
- **7.2.3.3 Plan Access.** Emergency action plans shall be kept on site and accessible to affected personnel.
- **7.2.3.4 Plan Review.** The emergency action plan shall be reviewed at least annually.

- **7.2.3.5 Plan Updating.** The emergency action plan and related procedures shall be updated and communicated to affected personnel when conditions involving the process(es) or facilities affecting the process(es) are modified or changed in a manner that affects the plan.
- 7.3 Operating and Maintenance Procedures.

## 7.3.1 Operating Procedures.

#### 7.3.1.1 General.

- **7.3.1.1.1** Operating procedures shall be developed for processes regulated by this chapter and implemented in accordance with Section 7.3.
- **7.3.1.1.2** Operating procedures shall be authorized and approved by personnel designated by the process owner/operator.
- **7.3.1.2\* Contents.** Operating procedures shall address the following:
- Each operating phase including, but not limited to, startup, operation, shutdown, and startup after unscheduled shutdown
- (2) Operating limits
- (3) Safety and health controls
- (4) Safety systems
- **7.3.1.3 Review.** The operating procedures shall be reviewed annually by the authorized individual per 7.3.1.1 and updated as necessary to ensure that the information is accurate and represents the manner in which the process is operated.

#### 7.3.2 Maintenance Procedures.

- **7.3.2.1 General.** Maintenance procedures shall be developed and implemented in accordance with Section 7.3.
- **7.3.2.2\* Contents.** Maintenance procedures shall address a schedule for inspecting and testing alarms, interlocks, and controls in accordance with one of the following frequencies:
- (1) At least annually
- (2) In accordance with the manufacturer's requirements
- (3) In accordance with approved recognized industry standards
- (4) In accordance with an approved schedule
- **7.4\* Safety Reviews.** When there are changes in chemicals, equipment, processes, or procedures, the hazards of the process shall be evaluated in accordance with the requirements of 7.2.2 prior to startup of the modified equipment or process.

#### 7.5 Incident Investigation Plan.

- **7.5.1\* General.** An investigation of a chemical incident regulated by Chapter 7 shall be conducted when the following occurs:
- (1) An incident results in a fire, explosion, or unintended
- (2) An event does not result in a fire, explosion, or unintended release but has the potential to do so.
- **7.5.2 Documentation.** The results of the investigation shall be documented and made available to the AHJ upon written request.
- **7.6 Document Retention.** Documentation required by this chapter shall be retained for a period of not less than 5 years.

## Chapter 8 Reserved

## Chapter 9 Security for Hazardous Materials

- **9.1 General.** The storage, dispensing, use, and handling areas shall be secured against unauthorized entry and safeguarded with such protective facilities as public safety requires.
- **9.1.1 Applicability.** The requirements of 9.1.2 shall apply to facilities with the following materials where the quantities of materials in use in an industrial process require compliance with Protection Level 1, Protection Level 2, Protection Level 3, or Protection Level 4:
- Unpackaged organic peroxide formulations that are capable of explosive decomposition in their unpackaged state
- (2) Oxidizer Class 3 and Class 4: solids and liquids
- (3) Pyrophoric solids, liquids, and gases
- (4) Unstable reactive Class 3 and Class 4: solids, liquids, and gases
- (5) Highly toxic solids, liquids, and gases
- (6) Water-reactive liquids, Class 3
- **9.1.2\* Security Plan.** Where required by the AHJ, a security plan to restrict unauthorized access to facilities subject to Section 9.1 shall be developed.

#### Chapter 10 Performance-Based Option

#### 10.1\* General.

- **10.1.1\* Application.** The requirements of this chapter shall apply to facilities designed to the performance-based option permitted by Chapter 4 of NFPA 1.
- **10.1.2\* Goals and Objectives.** The performance-based design shall meet the goals and objectives of this code in accordance with Chapter 4 of NFPA 1.
- **10.1.3\* Approved Qualifications.** The performance-based design shall be prepared by a person with qualifications acceptable to the AHJ.
- **10.1.4\* Plan Submittal Documentation.** When a performance-based design is submitted to the AHJ for review and approval, the owner shall document, in an approved format, each performance objective and applicable scenario, including any calculation methods or models used in establishing the proposed design's fire and life safety performance.
- **10.1.5\* Independent Review.** The AHJ shall be permitted to require an approved, independent third party to review the proposed design and provide an evaluation of the design to the AHJ at the expense of the owner.
- **10.1.6 Sources of Data.** Data sources shall be identified and documented for each input data requirement that is required to be met using a source other than a required design scenario, an assumption, or a facility design specification.
- **10.1.6.1** The degree of conservatism reflected in such data shall be specified, and a justification for the source shall be provided.
- **10.1.6.2** Copies of all references relied upon by the performance-based design to support assumptions, design features, or any other part of the design shall be made available to the AHJ if requested.

- **10.1.7 Final Determination.** The AHJ shall make the final determination as to whether the performance objectives have been met.
- 10.1.8\* Operations and Maintenance (O&M) Manual. An approved operations and maintenance manual shall be provided by the owner to the AHJ and the fire department for review, and shall be maintained at the facility in an approved location.
- **10.1.9\* Information Transfer to the Fire Service.** Where a performance-based design is approved and used, the designer shall ensure that information regarding the operating procedures of the performance-based designed fire protection system is transferred to the owner and to the local fire service for inclusion in the prefire plan.

## 10.1.10\* Design Feature Maintenance.

- **10.1.10.1** The design features required for the facility to meet the performance goals and objectives shall be maintained by the owner and be readily accessible to the AHJ for the life of the facility.
- **10.1.10.2** The facility shall be maintained in accordance with all documented assumptions and design specifications.
- **10.1.10.2.1** Any proposed changes or variations from the approved design shall be approved by the AHJ prior to the actual change.
- **10.1.10.2.2** Any approved changes to the original design shall be maintained in the same manner as the original design.
- 10.1.11\* Annual Certification. Where a performance-based design is approved and used, the property owner shall annually certify that the design features and systems have been maintained in accordance with the approved original performance-based design and assumptions and any subsequent approved changes or modifications to the original performance-based design.

## 10.1.12 Hazardous Materials.

- 10.1.12.1 Performance-based designs for facilities containing high-hazard contents shall identify the properties of hazardous materials to be stored, used, or handled and shall provide adequate and reliable safeguards to accomplish the following objectives, considering both normal operations and possible abnormal conditions:
  - Minimize the potential occurrence of unwanted releases, fire, or other emergency incidents resulting from the storage, use, or handling of hazardous materials
  - (2) Minimize the potential failure of buildings, equipment, or processes involving hazardous materials by ensuring that such buildings, equipment, or processes are reliably designed and are suitable for the hazards present
  - (3) Minimize the potential exposure of people or property to unsafe conditions or events involving an unintended reaction or release of hazardous materials
  - (4) Minimize the potential for an unintentional reaction that results in a fire, explosion, or other dangerous condition
  - (5) Provide a means to contain, treat, neutralize, or otherwise handle plausible releases of hazardous materials to minimize the potential for adverse impacts to persons or property outside of the immediate area of a release

- (6) Provide appropriate safeguards to minimize the risk of and limit damage and injury that might result from an explosion involving hazardous materials that present explosion hazards
- (7) Detect hazardous levels of gases or vapors that are dangerous to health and alert appropriate persons or mitigate the hazard when the physiological warning properties for such gases or vapors are inadequate to warn of danger prior to personal injury
- (8) Maintain power to provide for continued operation of safeguards and important systems that are relied upon to prevent or control an emergency condition involving hazardous materials
- (9) Maintain ventilation where ventilation is relied upon to minimize the risk of emergency conditions involving hazardous materials
- (10) Minimize the potential for exposing combustible hazardous materials to unintended sources of ignition and for exposing any hazardous material to fire or physical damage that can lead to endangerment of people or property
- 10.1.12.2 A process hazard analysis and off-site consequence analysis shall be conducted when required by the AHJ to ensure that people and property are satisfactorily protected from potentially dangerous conditions involving hazardous materials. The results of such analyses shall be considered when determining active and passive mitigation measures used in accomplishing the objectives of NFPA 101 and the applicable fire prevention code.
- **10.1.12.3** Written procedures for pre-startup safety reviews, normal and emergency operations, management of change, emergency response, and accident investigation shall be developed prior to beginning operations at a facility. Such procedures shall be developed with the participation of employees.
- **10.1.13 Special Definitions.** A list of special terms used in this chapter shall be as follows:
- (1) Design Fire Scenario (See 3.4.8.1.)
- (2) Design Specifications (See 3.4.4.)
- (3) Design Team (See 3.4.5.)
- (4) Exposure Fire (See 3.4.6.)
- (5) Fire Model (*See 3.4.7.*)
- (6) Fire Scenario (See 3.4.8.)
- (7) Fuel Load (See 3.4.9.)
- (8) Input Data Specification (See 3.4.10.)
- (9) Occupant Characteristics (See 3.4.11.)
- (10) Performance Criteria (See 3.4.12.)
- (11) Proposed Design (See 3.4.13.)
- (12) Safety Factor (See 3.4.15.)
- (13) Safety Margin (See 3.4.16.)
- (14) Sensitivity Analysis (See 3.4.1.1.)
- (15) Stakeholder (See 3.4.19.)
- (16) Uncertainty Analysis (See 3.4.1.2.)
- (17) Verification Method (See 3.4.21.) [1:5.1.13]

## 10.2 Performance Criteria.

**10.2.1 General.** A design shall meet the objectives specified in Section 10.1 if, for each required design scenario, assumption, and design specification, the performance criteria of 10.2.2 are met.

## 10.2.2\* Specific Performance Criteria.

- **10.2.2.1\* Fire Conditions.** No occupant who is not intimate with ignition shall be exposed to instantaneous or cumulative untenable conditions.
- **10.2.2.2\* Explosion Conditions.** The facility design shall provide an acceptable level of safety for occupants and for individuals immediately adjacent to the property from the effects of unintentional detonation or deflagration.
- 10.2.2.3\* Hazardous Materials Exposure. The facility design shall provide an acceptable level of safety for occupants and for individuals immediately adjacent to the property from the effects of an unauthorized release of hazardous materials or the unintentional reaction of hazardous materials.
- **10.2.2.4\* Property Protection.** The facility design shall limit the effects of all required design scenarios from causing an unacceptable level of property damage.
- **10.2.2.5\* Public Welfare.** For facilities that serve a public welfare role, the facility design shall limit the effects of all required design scenarios from causing an unacceptable interruption of the facility's mission.
- **10.2.2.6 Occupant Protection from Untenable Conditions.** Means shall be provided to evacuate, relocate, or defend in place occupants not intimate with ignition for sufficient time so that they are not exposed to instantaneous or cumulative untenable conditions from smoke, heat, or flames.
- **10.2.2.7 Emergency Responder Protection.** Buildings shall be designed and constructed to reasonably prevent structural failure under fire conditions for sufficient time to enable fire fighters and emergency responders to conduct search and rescue operations.
- **10.2.2.8 Occupant Protection from Structural Failure.** Buildings shall be designed and constructed to reasonably prevent structural failure under fire conditions for sufficient time to protect the occupants.

#### 10.3 Retained Prescriptive Requirements.

- **10.3.1 Systems and Features.** All fire protection systems and features of the building shall comply with applicable NFPA standards or the fire prevention code for those systems and features.
- **10.3.2\* Electrical Systems.** Electrical systems shall comply with applicable NFPA standards for those systems.
- **10.3.3 General.** The design shall comply with the following requirements in addition to the performance criteria of Section 10.2 and the methods of Sections 10.4 through 10.7 or the fire prevention code:
  - (1) Fundamental requirements
  - (2) Fire drills
  - (3) Smoking
- (4) Open outdoor fires, incinerators, and outdoor fireplaces
- (5) Fire department access
- (6) Access to structures
- (7) Fire protection markings
- (8) Vacant buildings and premises
- (9) Combustible vegetation
- (10) Safeguards during building construction, alteration, and demolition operations

- **10.3.4\* Means of Egress.** The design shall comply with the following NFPA *101* requirements in addition to the performance criteria of Section 10.2 and the methods of Sections 10.4 through 10.7:
- (1) Changes in level in means of egress: 7.1.7 of NFPA 101
- (2) Guards: 7.1.8 of NFPA 101
- (3) Doors: 7.2.1 of NFPA 101
- (4) Stairs: 7.2.2 of NFPA 101

Exception: The provisions of 7.2.2.5.1, 7.2.2.5.2, 7.2.2.6.2, 7.2.2.6.3, and 7.2.2.6.4 of NFPA 101 shall be exempted.

- (5) Ramps: 7.2.5 of NFPA 101
  - Exception: The provisions of 7.2.5.3.1, 7.2.5.5, and 7.2.5.6.1 of NFPA 101 shall be exempted.
- (6) Fire escape ladders: 7.2.9 of NFPA 101
- (7) Alternating tread devices: 7.2.11 of NFPA 101
- (8) Capacity of means of egress: Section 7.3 of NFPA 101
  - Exception: The provisions of 7.3.3 and 7.3.4 of NFPA 101 shall be exempted.
- (9) Impediments to egress: 7.5.2 of NFPA 101
- (10) Illumination of means of egress: Section 7.8 of NFPA 101
- (11) Emergency lighting: Section 7.9 of NFPA 101
- (12) Marking of means of egress: Section 7.10 of NFPA 101
- **10.3.5 Equivalency.** Equivalent designs for the features covered in the retained prescriptive requirements mandated by 10.3.1 through 10.3.4 shall be addressed in accordance with the equivalency provisions of Section 1.5.

#### 10.4\* Design Scenarios.

#### 10.4.1 General.

- **10.4.1.1** The proposed design shall be considered to meet the goals and objectives if it achieves the performance criteria for each required design scenario. The AHJ shall approve the parameters involved with required design scenarios.
- **10.4.1.2\*** Design scenarios shall be evaluated for each required scenario using a method acceptable to the AHJ and appropriate for the conditions. Each scenario shall be as challenging and realistic as any that could realistically occur in the building.
- **10.4.1.3\*** Scenarios selected as design scenarios shall include, but not be limited to, those specified in 10.4.2 through 10.4.5.
- **10.4.1.3.1** Design fire scenarios demonstrated by the design team to the satisfaction of the AHJ as inappropriate for the building use and conditions shall not be required to be evaluated fully.
- **10.4.1.3.2** Fire Design Scenario 8 (see 10.4.2.8) shall not be required to be applied to fire protection systems or features for which both the level of reliability and the design performance in the absence of the system or feature are acceptable to the AHJ.
- **10.4.1.4** Each design scenario used in the performance-based design proposal shall be translated into input data specifications, as appropriate for the calculation method or model.
- 10.4.1.5 Any design scenario specifications that the design analyses do not explicitly address or incorporate and that are, therefore, omitted from input data specifications shall be identified, and a sensitivity analysis of the consequences of that omission shall be performed.

- **10.4.1.6** Any design scenario specifications modified in input data specifications, because of limitations in test methods or other data generation procedures, shall be identified, and a sensitivity analysis of the consequences of the modification shall be performed.
- 10.4.2 Required Design Scenarios Fire.
- **10.4.2.1\* Fire Design Scenario 1.** Fire Design Scenario 1 involves an occupancy-specific design scenario representative of a typical fire for the occupancy.
- **10.4.2.1.1** This design scenario shall explicitly account for the following:
- (1) Occupant activities
- (2) Number and location
- (3) Room size
- (4) Furnishings and contents
- (5) Fuel properties and ignition sources
- (6) Ventilation conditions
- **10.4.2.1.2** The first item ignited and its location shall be explicitly defined.
- **10.4.2.2\* Fire Design Scenario 2.** Fire Design Scenario 2 involves an ultrafast-developing fire in the primary means of egress with interior doors open at the start of the fire. This design scenario shall address the concern regarding a reduction in the number of available means of egress.
- 10.4.2.3\* Fire Design Scenario 3. Fire Design Scenario 3 involves a fire that starts in a normally unoccupied room that can potentially endanger a large number of occupants in a large room or other area. This design scenario shall address the concern regarding a fire starting in a normally unoccupied room and migrating into the space that can, potentially, hold the greatest number of occupants in the building.
- 10.4.2.4\* Fire Design Scenario 4. Fire Design Scenario 4 involves a fire that originates in a concealed wall- or ceiling-space adjacent to a large occupied room. This design scenario shall address the concern regarding a fire originating in a concealed space that does not have either a detection system or suppression system and then spreading into the room within the building that can, potentially, hold the greatest number of occupants.
- **10.4.2.5\* Fire Design Scenario 5.** Fire Design Scenario 5 involves a slowly developing fire, shielded from fire protection systems, in close proximity to a high occupancy area. This design scenario shall address the concern regarding a relatively small ignition source causing a significant fire.
- **10.4.2.6\* Fire Design Scenario 6.** Fire Design Scenario 6 involves the most severe fire resulting from the largest possible fuel load characteristic of the normal operation of the building. This design scenario shall address the concern regarding a rapidly developing fire with occupants present.
- **10.4.2.7\* Fire Design Scenario 7.** Fire Design Scenario 7 involves an outside exposure fire. This design scenario shall address the concern regarding a fire starting at a location remote from the area of concern and either spreading into the area, blocking escape from the area, or developing untenable conditions within the area.
- **10.4.2.8\* Fire Design Scenario 8.** Fire Design Scenario 8 involves a fire originating in ordinary combustibles in a room or area with each passive or active fire protection system or

feature independently rendered ineffective. This set of design scenarios shall address concerns regarding each fire protection system or fire protection feature, considered individually, being unreliable or becoming unavailable. This scenario shall not be required to be applied to fire protection systems or features for which both the level of reliability and the design performance in the absence of the system are acceptable to the AHJ.

#### 10.4.3 Required Design Scenarios — Explosion.

#### 10.4.3.1\* Explosion Design Scenario 1.

- **10.4.3.1.1** Explosion Design Scenario 1 is the detonation or deflagration of explosive materials being manufactured, stored, handled, or used in a facility.
- **10.4.3.1.2** Explosion Design Scenario 1 shall address the concern regarding safety of individuals not intimate with the explosion and property protection of adjacent properties and buildings.

## 10.4.4\* Required Design Scenarios — Hazardous Materials.

- **10.4.4.1 Hazardous Materials Design Scenario 1.** Hazardous Materials Design Scenario 1 involves an unauthorized release of hazardous materials from a single control area. This design scenario shall address the concern regarding the spread of hazardous conditions from the point of release.
- **10.4.4.2 Hazardous Materials Design Scenario 2.** Hazardous Materials Design Scenario 2 involves an exposure fire on a location where hazardous materials are stored, used, handled, or dispensed. This design scenario shall address the concern regarding how a fire in a facility affects the safe storage, handling, or use of hazardous materials.
- **10.4.4.3 Hazardous Materials Design Scenario 3.** Hazardous Materials Design Scenario 3 involves the application of an external factor to the hazardous material that is likely to result in a fire, explosion, toxic release, or other unsafe condition. This design scenario shall address the concern regarding the initiation of a hazardous materials event by the application of heat, shock, impact, or water onto a hazardous material being stored, used, handled, or dispensed in the facility.

## 10.4.4.4 Hazardous Materials Design Scenario 4.

- **10.4.4.4.1** Hazardous Materials Design Scenario 4 involves an unauthorized discharge with each protection system independently rendered ineffective. This set of design hazardous materials scenarios shall address concern regarding each protection system or protection feature, considered individually, being unreliable or becoming unavailable.
- **10.4.4.4.2\*** Hazardous Materials Design Scenario 4 shall not be required to be applied to protection systems or features for which both the level of reliability and the design performance in the absence of the system are acceptable to the AHJ.

## 10.4.5 Required Design Scenarios — Safety During Building Use.

**10.4.5.1\* Building Use Design Scenario 1.** Building Use Design Scenario 1 involves an event in which the maximum occupant load is in the assembly building and an emergency event occurs, blocking the principal exit/entrance to the building. This design scenario shall address the concern of occupants having to take alternative exit routes under crowded conditions.

**10.4.5.2** Building Use Design Scenario 2. Building Use Design Scenario 2 involves a fire in an area of a building undergoing construction or demolition while the remainder of the building is occupied. The normal fire suppression system in the area undergoing construction or demolition has been taken out of service. This design scenario shall address the concern regarding the inoperability of certain building fire safety features during construction and demolition in a partially occupied building.

## 10.5 Evaluation of Proposed Designs.

#### 10.5.1 General.

- **10.5.1.1** A proposed design's performance shall be assessed relative to each performance objective in the fire prevention code and each applicable scenario in Section 10.4, with the assessment conducted through the use of appropriate calculation methods.
- 10.5.1.2 The choice of assessment methods shall require the approval of the AHJ.
- **10.5.2 Use.** The design professional shall use the assessment methods to demonstrate that the proposed design will achieve the goals and objectives, as measured by the performance criteria in light of the safety margins and uncertainty analysis, for each scenario, given the assumptions.

#### 10.5.3 Input Data.

#### 10.5.3.1 Data.

- **10.5.3.1.1** Input data for computer fire models shall be obtained in accordance with ASTM E1591, *Standard Guide for Obtaining Data for Deterministic Fire Models*.
- 10.5.3.1.2 Data for use in analytical models that are not computer-based fire models shall be obtained using appropriate measurement, recording, and storage techniques to ensure the applicability of the data to the analytical method being used.
- **10.5.3.2 Data Requirements.** A complete listing of input data requirements for all models, engineering methods, and other calculation or verification methods required or proposed as part of the performance-based design shall be provided.
- **10.5.3.3 Uncertainty and Conservatism of Data.** Uncertainty in input data shall be analyzed and, as determined appropriate by the AHJ, addressed through the use of conservative values.
- **10.5.4 Output Data.** The assessment methods used shall accurately and appropriately produce the required output data from input data based on the design specifications, assumptions, and scenarios.
- **10.5.5 Validity.** Evidence shall be provided confirming that the assessment methods are valid and appropriate for the proposed facility, use, and conditions.
- **10.6\* Safety Factors.** Approved safety factors shall be included in the design methods and calculations to reflect uncertainty in the assumptions, data, and other factors associated with the performance-based design.

## 10.7 Documentation Requirements.

#### 10.7.1\* General.

- **10.7.1.1** All aspects of the design, including those described in 10.7.2 through 10.7.14, shall be documented.
- **10.7.1.2** The format and content of the documentation shall be acceptable to the AHJ.

## 10.7.2\* Technical References and Resources.

- **10.7.2.1** The AHJ shall be provided with sufficient documentation to support the validity, accuracy, relevance, and precision of the proposed methods.
- **10.7.2.2** The engineering standards, calculation methods, and other forms of scientific information provided shall be appropriate for the particular application and methodologies used.
- **10.7.3 Facility Design Specifications.** All details of the proposed facility design that affect the ability of the facility to meet the stated goals and objectives shall be documented.
- **10.7.4 Performance Criteria.** Performance criteria, with sources, shall be documented.
- **10.7.5 Occupant Characteristics.** Assumptions about occupant characteristics shall be documented.
- **10.7.6 Design Scenarios.** Descriptions of design hazards scenarios shall be documented.
- **10.7.7 Input Data.** Input data to models and assessment methods, including sensitivity analysis, shall be documented.
- **10.7.8 Output Data.** Output data from models and assessment methods, including sensitivity analysis, shall be documented.
- 10.7.9 Safety Factors. Safety factors utilized shall be documented.
- **10.7.10 Prescriptive Requirements.** Retained prescriptive requirements shall be documented.

## 10.7.11\* Modeling Features.

- **10.7.11.1** Assumptions made by the model user, and descriptions of models and methods used, including known limitations, shall be documented.
- **10.7.11.2** Documentation shall be provided that the assessment methods have been used validly and appropriately to address the design specifications, assumptions, and scenarios.
- **10.7.12** Evidence of Modeler Capability. The design team's relevant experience with the models, test methods, databases, and other assessment methods used in the performance-based design proposal shall be documented.
- **10.7.13 Performance Evaluation.** The performance evaluation summary shall be documented.
- **10.7.14** Use of Performance-Based Design Option. Design proposals shall include documentation that provides anyone involved in ownership or management of the facility with all of the following notification:
- (1) The facility was approved as a performance-based design with certain specified design criteria and assumptions.
- (2) Any remodeling, modification, renovation, change in use, or change in the established assumptions will require a re-evaluation and re-approval.

## Chapter 11 Ammonium Nitrate Solids and Liquids

#### 11.1 General. See also Annex E.

- 11.1.1\* Scope. The requirements of this chapter shall apply to the storage, use, and handling of solid or liquid ammonium nitrate in quantities greater than 1,000 lb.
- **11.1.1.** The storage, use, and handling of ammonium nitrate shall comply with the requirements of Chapters 1 and 4.
- 11.1.1.1.1 Chapters 6 through 10 shall apply unless otherwise indicated in this chapter.
- 11.1.1.2 This chapter shall apply to solid ammonium nitrate in the form of crystals, flakes, grains or prills, including fertilizer grade and industrial grade or other mixtures containing 60 percent or more by weight of ammonium nitrate.
- **11.1.1.3** This chapter shall apply to liquid ammonium nitrate solutions containing 70 percent or more by weight of ammonium nitrate.
- **11.1.1.4** This chapter shall not apply to liquid ammonium nitrate solutions used as fertilizers unless classified as a hazardous material by the U.S. Department of Transportation (DOT).
- 11.1.1.5\* This chapter shall not apply to ammonium nitrate and ammonium nitrate mixtures that are DOT Hazard Class 1 explosives.
- **11.1.1.6\*** The agricultural application of ammonium nitrate and ammonium nitrate—based fertilizers in outdoor agricultural uses is not regulated by this code.
- **11.1.1.7** Where Chapter 11 is applicable, Chapter 15 and Chapter 19 shall not apply.
- **11.1.2 Sources of Ignition.** Open flames and smoking shall be prohibited in buildings that store, use, and handle ammonium nitrate.
- 11.1.3 General Requirements for Storage. The quantity and arrangement limits in this chapter shall not apply to the transient storage of ammonium nitrate in process areas at plants where ammonium nitrate is manufactured.
- **11.1.4 Construction Requirements.** Buildings, or portions thereof, in which ammonium nitrate is stored, used, or handled shall be constructed in accordance with the building code.
- 11.1.4.1 Buildings used for the storage and handling of ammonium nitrate in bulk, bags, or other combustible containers shall be of noncombustible (Type I or II) construction.
- **11.1.4.2** Bins or compartments used for the storage of bulk ammonium nitrate shall be constructed of noncombustible materials that are compatible with ammonium nitrate. (See 11.3.2.3.2.)
- 11.1.4.3 Storage buildings shall not have basements unless the basements are open on at least one side.
- 11.1.4.3.1 Buildings over one story in height shall not be used for storage, unless approved for such use.
- 11.1.4.4 The exterior wall on the exposed side of a storage building within 50 ft (15.2 m) of a combustible building, a forest, combustible materials, and/or exposure hazards by ordinary combustible materials shall be a fire barrier wall with a

- minimum fire resistance rating of 2 hours in accordance with the building code.
- 11.1.4.5 In lieu of the fire barrier wall specified in 11.1.4.4, a means of exposure protection, such as a freestanding fire barrier wall, shall be permitted to be used where approved by the AHJ.
- **11.1.4.6** Buildings and structures shall be dry and free from water intrusion through the roof, walls, and floors.
- 11.1.4.7 Any heating source, including electric lamps, shall be located or guarded so as to preclude contact with bags or other combustible materials.
- 11.1.4.8 Bulk storage structures shall not exceed a height of 40 ft (12.2 m).
- 11.1.4.8.1 Where bulk storage structures are constructed of noncombustible material or facilities for fighting a roof fire are provided, the height of the storage building shall only be limited by the building construction type as specified in the building code adopted by the jurisdiction.
- 11.1.4.9 Floors shall be in accordance with 6.2.1.10.
- 11.1.4.9.1\* All flooring in storage and handling areas shall be without open drains, traps, tunnels, pits, or pockets.
- 11.1.4.9.2\* The noncombustible floor of the ammonium nitrate storage area shall be sloped in a manner that promotes a positive drainage of liquids, whether water or molten material in the case of a fire, away from the storage area to an open, unconfined area free from incompatible materials. (See 11.2.16.1 for a list of incompatibles.)
- 11.1.4.9.3 The floor shall be at least a 1 percent slope [ $\frac{1}{8}$  in. (3.2 mm) for every linear foot of floor] to obtain this positive drainage.
- **11.1.4.9.4** Floors where ammonium nitrate solids or liquids are dispensed or used in open systems shall be in accordance with 6.3.2.2.3.
- **△ 11.1.5\* Retroactivity.** Subsections 11.2.5, 11.2.6, 11.2.7, and 11.2.8 shall apply retroactively.
  - 11.2 General Requirements for Storage.
  - 11.2.1\* Spill Control. Spill control for ammonium nitrate solids shall be in accordance with 11.2.1.1 and 11.2.1.2 and not 6.2.1.9.2.
  - 11.2.1.1 If the contents of broken bags are uncontaminated, they shall be permitted to be salvaged by placing the damaged bag inside a clean, new slipover bag and closing it to prevent the discharge of contents.
  - 11.2.1.2 Contaminated spilled materials and containers that cannot be used as originally intended shall be managed in accordance with applicable state and/or federal environmental requirements.
  - 11.2.2 Drainage and Secondary Containment.
  - 11.2.2.1 Drainage and secondary containment that promotes a positive drainage of liquids, whether water or molten material, away from the storage area to an open, unconfined area free from incompatible materials shall be provided for ammonium nitrate in accordance with 6.2.1.9.3.4(4). (See 11.2.16.1 for a list of incompatibles.)

- **11.2.3\* Ventilation.** Ventilation in accordance with 6.2.1.5 shall not be required.
- **11.2.4 Treatment Systems.** Treatment systems are not required for ammonium nitrate.
- 11.2.5\* Fire Protection Systems. An automatic fire sprinkler system shall be provided in all buildings of Type III construction, Type IV construction, or any construction type with combustible content, including, but not limited to, all of the materials listed in 11.2.16.1.1 in accordance with NFPA 13 for a minimum extra hazard (Group 1).
- **N 11.2.5.1\*** The requirements of 11.2.5, 11.2.6, 11.2.7, and 11.2.8 shall apply retroactively to existing buildings of Type III construction, Type IV construction, Type V construction, or any construction type with combustible content.
- **N 11.2.5.2** Bulk ammonium nitrate shall be classified as a noncombustible material.
- Δ 11.2.5.3\* Only water-based suppression systems shall be permitted. Alternative automatic fire extinguishing systems using foam, dry-chemical or gaseous agents, or steam shall not be allowed.
- △ 11.2.6 Fire Detection Systems. Buildings shall be equipped throughout with an approved fire detection system, including, but not limited to, a smoke or heat detection system.
- **N 11.2.6.1 Supervision.** The fire detection system shall be supervised in accordance with 6.2.1.11.
  - **11.2.6.2 Audible and Visual Alarm.** Any activation of the fire detection system shall also automatically initiate activation of a local audible and visual alarm system to notify occupants.
- N 11.2.7 Public Notification/Siren System. An approved public notification/siren system capable of notifying individuals located within 1 mi (1609 m) of the facility of the need to evacuate shall be provided by the facility's owner in all new and existing buildings of Type III construction, Type IV construction, Type V construction, or any construction type with combustible content.
- **N** 11.2.7.1 The siren shall be located in a location on- or off-site that is not susceptible to damage by the potential event and is approved by the AHJ.
- **N 11.2.7.2\*** The public notification siren system shall be capable of being remotely activated by the local emergency communication center at the direction of an authorized first responder upon arriving at the scene and evaluating the situation.
- **N** 11.2.8 Monitoring/Supervision. Supervision shall be provided for the alarm, detection, and automatic fire extinguishing system in all new and existing buildings of Type III construction, Type IV construction, Type V construction, or any building construction type with combustible content in accordance with 6.2.1.11.
  - 11.2.9 Extinguishing Devices.
  - **11.2.9.1** Portable extinguishers shall be provided throughout the storage, use, and handling areas in accordance with the fire prevention code adopted by the jurisdiction and NFPA 10.
  - **11.2.9.1.1** Only water-based portable fire extinguishers shall be used on incipient fires involving ammonium nitrate.

- **11.2.9.1.2** All other types of extinguishers except dry-chemical extinguishers per 11.2.9.1.3 shall be prohibited from the ammonium nitrate building.
- **11.2.9.1.3** Where required by NFPA 10 for protection of combustibles, dry-chemical extinguishers shall be permitted for use on incipient fires that do not involve ammonium nitrate.
- **N 11.2.9.2** Portable fire extinguishers shall be inspected and maintained in accordance with NFPA 10.

#### 11.2.10 Fire Protection Water Supplies.

- 11.2.10.1 Water supplies shall be provided for the protection of the ammonium nitrate storage by hose streams and automatic sprinklers in accordance with the fire code adopted by the AHJ.
- 11.2.10.2 The duration of the water supply shall be a minimum of 2 hours.
- **11.2.11\* Explosion Control.** The requirements of 6.2.1.6 shall not apply.
- **11.2.12 Emergency and Standby Power.** Standby power shall be provided where required by 6.2.1.8.
- **11.2.13 Limit Controls.** Limit controls, where required, shall be in accordance with 6.2.1.7.

#### 11.2.14 Alarms.

- **11.2.14.1** A fire alarm system shall be provided to monitor the fire sprinkler system and provide notification in accordance with 6.2.1.1.3 and *NFPA 72*.
- **11.2.15 Monitoring/Supervision.** Supervision shall be provided for the alarm, detection, and automatic fire extinguishing system in accordance with 6.2.1.11.

## 11.2.16 Special Requirements.

## 11.2.16.1 Separation.

- 11.2.16.1.1\* Ammonium nitrate shall be isolated in a separate room by fire barrier walls constructed of concrete block having a minimum fire resistance rating of one hour and extending from the floor to the underside of the roof above or located in a separate building from the storage of any of the following:
- (1) Organic chemicals, acids, or other corrosive materials
- (2) Compressed flammable gases
- (3) Pyrophoric materials
- (4) Combustible materials
- (5) Flammable and combustible liquids
- (6) Other contaminating substances, including the following:
  - (a) Wood chips
  - (b) Organic materials
  - (c) Chlorides
  - (d) Phosphorus
  - (e) Finely divided metals
  - (f) Charcoals
  - (g) Diesel fuels and oils
  - (h) Animal fats
  - (i) Baled cotton
  - (j) Baled rags
  - (k) Baled scrap paper
  - (l) Bleaching powder
  - (m) Burlap or cotton bags
  - (n) Caustic soda

- (o) Coal
- (p) Coke
- (q) Charcoal
- (r) Cork
- (s) Camphor
- (t) Excelsior
- (u) Fibers of any kind
- (v) Fish oils
- (w) Fish meal
- (x) Foam rubber
- (y) Hay
- (z) Lubricating oil
- (aa) Linseed oil or other oxidizable or drying oils
- (ab) Naphthalene
- (ac) Oakum
- (ad) Oiled clothing
- (ae) Oiled paper
- (af) Oiled textiles
- (ag) Paint
- (ah) Straw
- (ai) Sawdust
- (aj) Wood shavings
- (ak) Vegetable oil

## 11.2.16.2 Prohibited Articles.

- 11.2.16.2.1 Sulfur, materials that require blasting during processing or handling, and finely divided metals shall not be stored in the same building with ammonium nitrate unless such storage conforms to NFPA 495.
- **11.2.16.2.2** Explosives and blasting agents shall not be stored in the same building with ammonium nitrate unless otherwise permitted by NFPA 495.
- 11.2.16.2.3 Explosives and blasting agents shall be permitted to be stored in the same building with ammonium nitrate on the premises of makers, distributors, and users/compounders of explosives or blasting agents.
- 11.2.16.2.4 Where explosives or blasting agents are stored in separate buildings, other than on the premises of makers, distributors, and users/compounders of explosives or blasting agents, they shall be separated from the ammonium nitrate by the distances or barricades specified in NFPA 495.
- **11.2.16.2.5** Storage or operations on the premises of makers, distributors, and users/compounders of explosives or blasting agents shall conform to NFPA 495.
- **11.2.16.3 Lightning.** In areas where lightning storms are prevalent, lightning protection shall be provided in accordance with NFPA 780.
- **11.2.16.4 Security (Control of Access).** Provisions shall be made to prevent unauthorized personnel from entering the ammonium nitrate storage area.

## 11.2.17\* Emergency Planning.

- **11.2.17.1 Emergency Action Plans.** Emergency action plans for facilities that store, use, or handle ammonium nitrate shall comply with the requirements of Chapter **7**, and 11.2.17.1.1 through 11.2.17.1.4.
- 11.2.17.1.1 The emergency action plan shall clearly state that fires potentially affecting ammonium nitrate storage beyond the initial (incipient) stage shall not be approached by facility personnel.

- 11.2.17.1.2 The emergency action plan shall state whether the ammonium nitrate storage building has an automatic sprinkler system and if the building storing ammonium nitrate is of combustible construction.
- 11.2.17.1.3\* The emergency action plan shall establish a safe evacuation distance based on an approved analysis of the permitted quantity and configuration of ammonium nitrate. Where no such analysis exists, a distance of at least 1 mile (1609 m) shall be used.
- **11.2.17.1.4** The emergency action plan shall be approved by the AHJ and updated and re-approved at least annually or if conditions change.
- 11.2.18\* Signage. In addition to the NFPA 704 placards required in 6.1.8.2.1, signs shall be conspicuously posted on the ammonium nitrate storage building stating: DO NOT FIGHT FIRE. EXPLOSION HAZARD. The signs shall be visible from 100 ft (30 m) and shall have 6 in. (15 cm) red block lettering on a white reflective background.

## 11.3 Indoor Storage.

- **11.3.1 Housekeeping.** Storage shall be arranged to facilitate manual access and handling, to maintain pile stability, to minimize breakage and spillage, and to promote good housekeeping.
- 11.3.1.1 All personnel that handle ammonium nitrate shall be trained on the general safety, regulatory controls, and industry standards on how to safely store, use, and handle ammonium nitrate.
- 11.3.1.2\* Good housekeeping shall be maintained at all times where ammonium nitrate is stored, used, or handled and the following housekeeping rules shall be followed:
- (1) Floors and storage areas shall be free of any clutter and debris.
- All spills shall be contained and properly disposed of immediately.
- (3) Any damaged container and/or waste shall be immediately and properly removed from the area to a safe location.
- (4) Policy, procedures, and practice shall be in place to ensure separation of incompatible materials is maintained at all times.
- (5) Storage of combustibles shall be prohibited in or around ammonium nitrate storage areas.
- **11.3.2 Storage Conditions/Arrangement.** Storage arrangement shall be in accordance with 11.3.2.1 through 11.3.2.3.
- **11.3.2.1 Containers.** Bags and containers used for ammonium nitrate shall comply with the specifications and standards established by the DOT.

## 11.3.2.2 Piles of Bags, Drums, or Other Containers.

- 11.3.2.2.1 Solid ammonium nitrate shall not be placed into containers where the temperature of the ammonium nitrate exceeds  $140^{\circ}F$  ( $60^{\circ}C$ ).
- 11.3.2.2.2 Bags of ammonium nitrate shall not be stored within 30 in. (76 cm) of the walls and partitions of the storage building.
- 11.3.2.2.3 Piles shall comply with the following dimensions:
- (1) The height of piles shall not exceed 20 ft (6.1 m).

- (2) The width of piles shall not exceed 20 ft (6.1 m).
- (3) The length of piles shall not exceed 50 ft (15.2 m), unless otherwise permitted by 11.3.2.2.3(4).
- (4) Where the building is of noncombustible construction, or is protected by automatic sprinklers, the length of piles shall not be limited.
- 11.3.2.2.4 In no case shall the ammonium nitrate be stacked closer than 3 ft (0.9 m) below the roof or its supporting overhead structure.
- **\Delta** 11.3.2.2.5 Aisles shall be provided to separate piles by a clear space of not less than 3 ft (0.9 m) in width, with at least one aisle in the storage area not less than 4 ft (1.2 m) in width.

## 11.3.2.3 Piles and Compartments for Bulk Solid Storage.

- 11.3.2.3.1\* Bins shall be of noncombustible construction.
- 11.3.2.3.2 Bins shall be clean and free of materials that can contaminate ammonium nitrate.
- **11.3.2.3.3** Bins shall be designed so that in the event of an external fire or self-accelerated decomposition, molten ammonium nitrate can flow away from the storage area to an open, unconfined area free from contamination with incompatible materials. (See 11.2.16.1.1 for a list of incompatibles.)
- 11.3.2.3.4\* Due to the corrosive and reactive properties of ammonium nitrate, and to avoid contamination, galvanized iron, copper, alloys of copper, lead, and zinc shall not be used in bin construction, except where such bins are protected against contact with the ammonium nitrate.
- 11.3.2.3.5\* Uncoated aluminum bins shall not be permitted.
- 11.3.2.3.6 The warehouse shall be permitted to be subdivided into any desired number of ammonium nitrate storage compartments or bins provided the design does not allow molten ammonium nitrate to accumulate in the storage area and become confined.
- 11.3.2.3.7 Each ammonium nitrate storage bin or pile inside buildings shall be clearly identified by a sign reading AMMO-NIUM NITRATE with letters at least 2 in. (5 cm) high.
- **11.3.2.3.8** Piles or bins shall be sized and arranged so that all material is accessible to a mechanical means to minimize caking of the stored ammonium nitrate.
- 11.3.2.3.9\* The height or depth of piles shall be limited by the caking tendency of the product; however, in no case shall the ammonium nitrate be piled higher at any point than 3 ft (0.9 m) below the roof or its supporting and overhead structure.
- 11.3.2.3.10 Ammonium nitrate shall not be placed into storage where the temperature of the product exceeds  $140^{\circ}$ F ( $60^{\circ}$ C).
- 11.3.2.3.11 Explosives and blasting agents shall not be used to break up or loosen caked ammonium nitrate.
- **11.3.3 Detached Storage.** The requirements of 6.2.3.4 shall apply.
- 11.4 Outdoor Storage.
- 11.4.1 Clearance from Combustibles.
- 11.4.1.1 Outdoor storage and use areas and the surrounding area shall be kept clear of weeds, debris, and common combus-

tible materials not necessary to the storage or use of hazardous materials for a minimum distance of 30 ft (9.0 m).

- 11.4.1.2 Outdoor storage and use areas for ammonium nitrate shall be located not closer than 30 ft (9 m) from a property line that can be built upon, a street, an alley, or a public way, except that a 2–hour fire barrier wall, without openings and extending no less than 30 in. (762 mm) above and to the sides of the storage area, shall be permitted in lieu of such distance.
- **11.4.2 Weather Protection.** Where provided, weather protection shall be in accordance with 6.2.7.2.
- **11.4.3 Outdoor Storage in Enclosed Hoppers or Bins.** In addition to the other requirements of Section 11.4, this section applies to outdoor storage of ammonium nitrate in quantities exceeding 1000 lb (453 kg).
- 11.4.3.1 All hoppers and bins in which bulk ammonium nitrate is stored shall be constructed of noncombustible materials.
- **11.4.3.2** Enclosed hoppers or bins shall be provided with a venting device to enable the discharge of gases generated in the event of a fire.
- **11.4.3.3\*** Parking of any vehicles or industrial trucks shall be prohibited within 30 ft (9.1 m) of the hoppers/bins.
- **N** 11.4.4 Storage in Railcars. Ammonium nitrate in railcars delivered to a private track or private siding shall be considered to be in non–transportation-regulated storage.
- **N** 11.4.4.1 Intra-plant movements to reposition railcars for the convenience of site operations shall not constitute a change of status from storage to transportation in commerce.
- **N** 11.4.4.2 Precautions shall be taken to minimize the risk of fire near ammonium nitrate railcars.
- **N** 11.4.4.3 Railcars being used to store ammonium nitrate shall be separated from combustible materials, including, but not limited to, those identified in 11.2.16.1.1, for not less than 30 ft (9 m) in all directions.
  - 11.4.5\* Special Requirements Outdoor Storage.
  - 11.5 General Requirements for Use.
  - **11.5.1 Spill Control.** Spill control shall be provided for ammonium nitrate liquids in accordance with 11.2.1.
  - 11.5.1.1 Spilled ammonium nitrate and leaking or broken containers shall be removed immediately by a competent individual to a safe, secure, dry outside area or to a location designated by the competent individual to await disposal in conformance with applicable regulations.

## 11.5.2 Drainage.

- **11.5.2.1** Drainage shall be provided for ammonium nitrate liquids in accordance with 6.3.1.4.2.10.
- **11.5.2.2** For ammonium nitrate solids, the requirements of 6.3.1.4.2.10 shall not apply.
- 11.5.3 Secondary Containment.
- **11.5.3.1** Secondary containment shall be provided for ammonium nitrate solids or liquids in accordance with 6.3.1.4.2.
- **11.5.3.2** For ammonium nitrate solids, the requirements of 6.3.1.4.2 shall not apply.

- **11.5.4 Ventilation.** The requirements of 6.3.2.1.3 shall apply.
- **11.5.5 Fire Protection Systems.** An automatic fire sprinkler system shall be provided in accordance with 11.2.6.
- 11.5.5.1\* Alternative automatic fire extinguishing systems using foam, dry-chemical or gaseous agents, or steam extinguishing systems shall not be allowed. Only water-based suppression systems shall be permitted.
- 11.5.5.2 Portable extinguishers shall be provided in accordance with 11.2.10.
- **11.5.6 Explosion Control.** The requirements of 6.3.2.1.4 shall not apply.
- **11.5.7 Emergency and Standby Power.** The requirements of 6.3.2.1.3.3 shall apply.
- **11.5.8 Limit Controls.** Limit controls shall be provided in accordance with 6.3.1.2.
- **11.5.9 Alarms.** Alarms shall be provided in accordance with 11.2.15.
- **11.5.10 Monitoring/Supervision.** Supervision shall be provided in accordance with 6.3.1.8.
- 11.5.11 System Design. System design shall be in accordance with 6.3.1.6.
- **11.5.12 Liquid Transfer.** Liquid transfer shall be in accordance with 6.3.1.7.
- 11.6 Indoor Use.
- 11.6.1 Open Systems.
- **11.6.1.1 Ventilation.** The requirements of 6.3.2.1.3 shall apply.
- **11.6.1.2 Explosion Control.** The requirements of 6.3.2.1.4 shall not apply.
- **11.6.1.3 Spill Control, Drainage, and Containment.** Secondary containment shall be provided for ammonium nitrate liquids in accordance with 6.3.2.2.4.
- 11.7 Outdoor Use.
- 11.7.1 Open Systems.
- **11.7.1.1 Location.** Outdoor use and dispensing shall be located in accordance with 6.3.3.1.1.
- 11.7.1.2 Spill Control, Drainage, and Containment. Spill control and secondary containment shall be provided for ammonium nitrate liquids in accordance with 6.3.3.2.2.
- **11.7.1.3 Clearance from Combustibles.** For outdoor use the requirements of 11.4.1 shall apply.
- 11.8 Handling.
- 11.8.1 Handling. Handling shall be in accordance with 6.3.4 and 11.8.1.
- 11.8.1.1 Vehicles and Lift Trucks.
- 11.8.1.1.1\* Powered vehicles of any type shall not be stored or left unattended in a building storing ammonium nitrate.
- 11.8.1.1.2 Powered vehicles used in ammonium nitrate storage facilities shall not be refueled within 50 ft (15 m) of the facility.

- 11.8.1.1.3 Fork trucks, tractors, platform lift trucks, and other specialized industrial trucks used within the warehouse shall be maintained so that fuels or hydraulic fluids do not contaminate the ammonium nitrate.
- 11.8.1.2\* Handling Equipment. Hollow spaces in nitrate-handling equipment, where nitrate is able to collect and be confined to become a source of explosion in the event of fire, shall be avoided.

## Chapter 12 Corrosive Solids and Liquids

- **12.1 General.** The requirements of this chapter shall apply to the storage, use, and handling of corrosive solids or liquids when the amount of corrosive solids or liquids exceeds the MAQs as set forth in Chapter 5. The storage, use, and handling of corrosive solids or liquids in any quantity shall also comply with the requirements of Chapters 1 through 4 and the applicable requirements of Chapters 5 through 10.
- **12.1.1 Construction Requirements.** Buildings, or portions thereof, in which corrosive solids or liquids are stored, handled, or used shall be constructed in accordance with the building code.
- 12.2 General Requirements for Storage.
- **12.2.1 Spill Control.** Spill control shall be provided for corrosive liquids in accordance with 6.2.1.9.2.
- **12.2.2 Drainage.** When provided, drainage shall be in accordance with 6.2.1.9.3.11.
- **12.2.3 Secondary Containment.** Secondary containment shall be provided for corrosive liquids in accordance with 6.2.1.9.3.
- **12.2.4 Ventilation.** Ventilation shall be provided for open containers in accordance with 6.2.1.5.
- **12.2.5 Fire Protection Systems.** An automatic fire sprinkler system shall be provided in accordance with 6.2.1.1.
- **12.2.6 Explosion Control.** The requirements of 6.2.1.6 shall not apply.
- **12.2.7 Emergency and Standby Power.** Standby power shall be provided when required by 6.2.1.8.
- **12.2.8 Limit Controls.** Limit controls shall be provided when required by 6.2.1.7.
- **12.2.9 Monitoring/Supervision.** Supervision shall be provided in accordance with 6.2.1.11.
- 12.3 Indoor Storage.
- **12.3.1 Floors.** Floors shall be in accordance with 6.2.1.10.
- **12.3.2 Detached Storage.** The requirements of 6.2.2.2, 6.2.3.4, 6.2.4.4, or 6.2.4.5 shall not apply.
- 12.4 Outdoor Storage.
- **12.4.1 Exposures.** Outdoor storage of corrosive solids or liquids shall be separated from exposure hazards in accordance with 12.4.1.
- **12.4.1.1 Clearance from Combustibles.** Clearance from combustible corrosives shall be in accordance with 6.2.7.1.
- **12.4.1.2 Location.** Outdoors storage of corrosive solids or liquids shall not be within 20 ft (6.1 m) of property lines,

- streets, alleys, public ways, means of egress to a public way, or buildings not used exclusively for the storage, distribution, or manufacturing of such corrosive, except as provided in 12.4.1.3.
- **12.4.1.3 Distance Reduction.** An unpierced 2-hour fireresistive wall extending not less than 30 in. (762 mm) above and to the side of the storage area shall be permitted in lieu of the distance specified in 12.4.1.2.
- **12.4.2 Weather Protection.** When provided, weather protection shall be in accordance with 5.1.2 and 6.2.7.2.
- 12.5 General Requirements for Use.
- **12.5.1 Spill Control.** Spill control shall be provided for corrosive liquids in accordance with 6.3.1.4.
- **12.5.2 Drainage.** When provided, drainage shall be in accordance with 6.3.1.4.2.10.
- **12.5.3 Secondary Containment.** Secondary containment shall be provided for corrosive liquids in accordance with 6.3.1.4.2.
- **12.5.4 Ventilation.** Ventilation shall be provided for open containers in accordance with 6.3.2.1.3 and 6.3.2.2.2.
- **12.5.5 Fire Protection System.** An automatic fire sprinkler system shall be provided in accordance with 6.3.2.1.1.
- **12.5.6 Explosion Control.** The requirements of 6.3.2.1.4 shall not apply.
- **12.5.7 Emergency and Standby Power.** Standby power shall be provided when required by 6.3.1.3.
- **12.5.8 Limit Controls.** Limit controls shall be provided in accordance with 6.3.1.2.
- **12.5.9 Monitoring/Supervision.** Supervision shall be provided in accordance with 6.3.1.8.
- **12.5.10 Clearance** from Combustibles. Clearance from combustible corrosives shall be in accordance with 6.2.7.1.
- **12.5.11 Floors.** Floors where corrosive solids or liquids are dispensed or used in open systems shall be in accordance with 6.3.2.2.3.
- **12.5.12 System Design.** System design shall be in accordance with 6.3.1.6.
- **12.5.13 Liquid Transfer.** Liquid transfer shall be in accordance with 6.3.1.7.
- 12.6 Indoor Use.
- 12.6.1 Open Systems.
- **12.6.1.1 Ventilation.** Ventilation shall be provided in accordance with 6.3.2.2.2.
- **12.6.1.2 Explosion Control.** The requirements of 6.3.2.1.4 shall not apply.
- **12.6.1.3 Spill Control, Drainage, and Containment.** Secondary containment shall be provided for corrosive liquids in accordance with 6.3.2.2.4.
- 12.6.2 Closed Systems.
- **12.6.2.1 Ventilation.** Ventilation shall be provided in accordance with 6.3.2.3.2.

- **12.6.2.2 Explosion Control.** The requirements of 6.3.2.1.4 shall not apply.
- **12.6.2.3 Spill Control, Drainage, and Containment.** Spill control and secondary containment shall be provided for corrosive liquids in accordance with 6.3.2.3.3.

## 12.7 Outdoor Use.

## 12.7.1 Open Systems.

- **12.7.1.1 Location.** Outdoor use and dispensing shall be located in accordance with 6.3.3.1.1.
- **12.7.1.2 Spill Control, Drainage, and Containment.** Spill control and secondary containment shall be provided for corrosive liquids in accordance with 6.3.3.2.2.
- **12.7.1.3 Clearance from Combustibles.** Clearance from combustible materials shall be in accordance with 6.3.3.1.2.

### 12.7.2 Closed Systems.

- **12.7.2.1 Location.** Outdoor use and dispensing shall be located in accordance with 6.3.3.1.1.
- **12.7.2.2 Spill Control, Drainage, and Containment.** Spill control and secondary containment shall be provided for corrosive liquids in accordance with 6.3.3.3.2.
- **12.7.2.3 Clearance from Combustibles.** Clearance from combustible materials shall be provided in accordance with 6.3.3.1.2.
- **12.8 Handling.** Handling of corrosive solids and liquids in indoor and outdoor areas shall be in accordance with 6.3.4.

### Chapter 13 Flammable Solids

- **13.1 General.** The requirements of this chapter shall apply to the storage, use, and handling of flammable solids when the amount of flammable solids exceeds the MAQ as set forth in Chapter 5. The storage, use, and handling of flammable solids in any quantity shall also comply with the requirements of Chapters 1 through 4 and the applicable requirements of Chapters 5 through 10.
- **13.1.1 Construction Requirements.** Buildings, or portions thereof, in which flammable solids are stored, handled, or used shall be constructed in accordance with the building code.

## 13.2 General Requirements for Storage.

- **13.2.1 Spill Control.** The requirements of 6.2.1.9.2 shall not apply.
- **13.2.2 Drainage.** The requirements of 6.2.1.9.3.11 shall not apply.
- **13.2.3 Secondary Containment.** The requirements of 6.2.1.9.3 shall not apply.
- **13.2.4 Ventilation.** The requirements of 6.2.1.5 shall not apply.
- **13.2.5 Fire Protection Systems.** An automatic fire sprinkler system shall be provided in accordance with 6.2.1.1.
- **13.2.6 Explosion Control.** The requirements of 6.2.1.6 shall not apply.

- **13.2.7 Emergency and Standby Power.** Standby power shall be provided when required by 6.2.1.8.
- **13.2.8 Limit Controls.** Limit controls shall be provided when required by 6.2.1.7.
- **13.2.9 Monitoring/Supervision.** Supervision shall be provided in accordance with 6.2.1.11.

## 13.3 Indoor Storage.

- **13.3.1 Floors.** The requirements of 6.2.1.10 shall not apply.
- **13.3.2 Detached Storage.** The requirements of 6.2.2.2, 6.2.3.4, 6.2.4.4, or 6.2.4.5 shall not apply.

### 13.4 Outdoor Storage.

- **13.4.1 Exposures.** Outdoor storage of flammable solids shall be separated from exposure hazards in accordance with 13.4.1.
- **13.4.1.1 Clearance from Combustibles.** Clearance from combustible materials shall be in accordance with 6.2.7.1.
- **13.4.1.2 Location.** Outdoor storage of flammable solids shall not be within 20 ft (6.1 m) of property lines, streets, alleys, public ways, means of egress to a public way, or buildings not used exclusively for the storage, distribution, or manufacturing of such material, except as provided in 13.4.1.3.
- **13.4.1.3 Distance Reduction.** An unpierced 2-hour fire–resistive wall extending not less than 30 in. (762 mm) above and to the side of the storage area shall be permitted in lieu of the distance specified in 13.4.1.2.
- **13.4.2 Weather Protection.** When provided, weather protection shall be in accordance with 5.1.2 and 6.2.7.2.

#### 13.4.3 Special Requirements.

- **13.4.3.1 Pile Size Limit.** Flammable solids stored outdoors shall be separated into piles not larger than 5000 ft<sup>3</sup> (141 m<sup>3</sup>).
- **13.4.3.2 Aisles.** Aisle widths between piles shall not be less than one-half the height of the piles or 10 ft (3 m), whichever is greater.

## 13.5 General Requirements for Use.

- **13.5.1 Spill Control.** The requirements of 6.3.1.4 shall not apply.
- **13.5.2 Drainage.** The requirements of 6.3.1.4.2.10 shall not apply.

- **13.5.6 Explosion Control.** The requirements of 6.3.2.1.4 shall not apply.
- **13.5.7 Emergency and Standby Power.** Standby power shall be provided when required by 6.3.1.3.

- **13.5.9 Monitoring/Supervision.** Supervision shall be provided in accordance with 6.3.1.8.

- **13.6.1.1 Ventilation.** Ventilation shall be provided in accordance with 6.3.2.2.2.

- **13.6.1.3 Spill Control, Drainage, and Containment.** The requirements of 6.3.2.2.4 shall not apply.
- 13.6.2 Closed Systems.
- **13.6.2.1 Ventilation.** Ventilation shall be provided in accordance with 6.3.2.3.2.
- **13.6.2.2 Explosion Control.** The requirements of 6.3.3.2.2 shall not apply.
- **13.6.2.3 Spill Control, Drainage, and Containment.** The requirements of 6.3.2.3.3 shall not apply.
- 13.7 Outdoor Use.
- 13.7.1 Open Systems.
- **13.7.1.1 Location.** Outdoor use and dispensing shall be located in accordance with 6.3.3.1.1.
- **13.7.1.2 Spill Control, Drainage, and Containment.** The requirements of 6.3.3.2.2 shall not apply.
- **13.7.1.3 Clearance from Combustibles.** Clearance from combustible materials shall be in accordance with 6.3.3.1.2.
- 13.7.2 Closed Systems.
- **13.7.2.1 Location.** Outdoor use and dispensing shall be located in accordance with 6.3.3.1.1.
- **13.7.2.2 Spill Control, Drainage, and Containment.** The requirements of 6.3.3.3.2 shall not apply.
- **13.7.2.3 Clearance from Combustibles.** Clearance from combustible materials shall be provided in accordance with 6.3.3.1.2.
- **13.8 Handling.** Handling of flammable solids in indoor and outdoor areas shall be in accordance with Section 13.8.
- **13.8.1 Handling.** Handling shall be in accordance with 6.3.4.

## Chapter 14 Organic Peroxide Formulations

## 14.1 General.

14.1.1\* The requirements of this chapter shall apply to the storage, use, and handling of classified solid or liquid organic peroxide formulations when the amount of organic peroxide solids or liquids exceeds the MAQ as set forth in Chapter 5.

- The storage, use, and handling of solid or liquid organic peroxide formulations classified in classes I, II, III, and IV in any quantity shall also comply with the requirements of Chapters 1 through 4 and the applicable requirements of Chapters 5 through 10.
- **14.1.2\* Construction Requirements.** Buildings, or portions thereof, in which solid or liquid organic peroxide formulations are stored, handled, or used shall be constructed in accordance with the building code.
- 14.2 General Requirements for Storage.
- **14.2.1 Spill Control.** Spill control shall be provided for organic peroxide liquid formulations in accordance with 6.2.1.9.2.
- **14.2.2 Drainage.** When provided, drainage shall be in accordance with 6.2.1.9.3.11.
- **14.2.3 Secondary Containment.** Secondary containment shall be provided for solid and liquid organic peroxide formulations in accordance with 6.2.1.9.3.
- **14.2.4\* Ventilation.** Ventilation shall be provided for open containers in accordance with 6.2.1.5.
- **14.2.5 Fire Protection Systems.** An automatic fire sprinkler system shall be provided in accordance with 14.2.5 and 6.2.1.1.
- 14.2.5.1\* Where required by other provisions of this code, automatic sprinklers and water spray systems shall be designed and installed according to the requirements of NFPA 13 and NFPA 15 and shall provide the following discharge densities:
- (1) Class I  $0.50 \text{ gpm/ft}^2 (20.4 \text{ L/min/m}^2)$
- (2) Class II  $-0.40 \text{ gpm/ft}^2 (16.3 \text{ L/min/m}^2)$
- (3) Class III  $-0.30 \text{ gpm/ft}^2 (12.2 \text{ L/min/m}^2)$
- (4) Class IV  $0.25 \text{ gpm/ft}^2 (10.2 \text{ L/min/m}^2)$
- $\triangle$  14.2.5.2 The system shall be designed as follows:
  - (1) The system shall provide the required density over the hydraulically most remote 3000 ft² (280 m²) area for areas protected by a wet pipe sprinkler system or singleinterlock preaction sprinkler system.
  - (2) Buildings using a dry pipe sprinkler system shall be provided with a required density over the hydraulically most remote 3900 ft² (360 m²) design area and, if used, the clearance between the sprinkler deflector and the top of any stored organic peroxide formulation shall not exceed 6 ft (1.8 m).
  - (3) The entire area of any building of less than 3000 ft<sup>2</sup> (280 m<sup>2</sup>) shall be used as the area of application.
  - **14.2.5.3** Where required for detached storage buildings containing Class I organic peroxide formulations in quantities exceeding 2000 lb (907 kg), automatic sprinkler protection shall be open-head deluge-type, designed and installed in accordance with NFPA 13.
- **N 14.2.5.4\*** Dry pipe and double-interlock preaction (DIPA) sprinkler systems shall not be permitted for protection of buildings or areas containing organic peroxide formulations except as provided for in 14.2.5.4.1 and 14.2.5.4.2.
- **N 14.2.5.4.1** Dry pipe and DIPA sprinkler systems shall be permitted for protection of Class I through Class III organic peroxide formulations in detached storage in Type I and Type II construction, as specified in the building code.

- **N 14.2.5.4.2** Dry pipe and DIPA sprinkler systems shall be permitted for protection of Class IV and Class V organic peroxide formulations in Type I through Type IV building construction, as specified in the building code.
  - **14.2.6 Explosion Control.** Explosion control shall be provided for liquid or solid organic peroxide formulations when required by 6.2.1.6.
  - **14.2.7 Emergency and Standby Power.** Standby power shall be provided when required by 6.2.1.8.
  - **14.2.7.1** Standby power for temperature control shall be permitted to be replaced by alternative methods of temperature control.
  - **14.2.8 Limit Controls.** Limit controls shall be provided when required by 6.2.1.7.
  - **14.2.9 Monitoring/Supervision.** Supervision shall be provided in accordance with 6.2.1.11.

## 14.2.10 Special Requirements.

- **14.2.10.1** All areas containing organic peroxide formulations shall be conspicuously identified by means of a sign containing the words ORGANIC PEROXIDES and by the organic peroxide class and NFPA 704 identification.
- **14.2.10.1.1 Different Classifications.** When organic peroxide formulations having different classifications as defined by Section 4.1 are located in the same area, the NFPA 704 designations indicated for the area shall be appropriate for the most severe class present.
- **14.2.10.2 Packaging** Marking. Original DOT shipping containers containing organic peroxide formulations shall be individually marked with the chemical name of the organic peroxide or with other pertinent information to indicate classification as required by this code.
- **14.2.10.3 Temperature Markings.** Packages containing organic peroxide formulations that require temperature control shall be marked with the recommended temperature range.
- **14.2.10.4 Maintenance Operations.** Maintenance operations in organic peroxide storage or use areas shall be subject to prior review by, and approval of, supervisory personnel.

## 14.2.10.5 Cutting and Welding.

- **14.2.10.5.1** Cutting and welding operations in organic peroxide storage or use areas shall not be conducted until all organic peroxide formulations have been removed from the area of storage or use.
- **14.2.10.5.1.1** Cutting and welding operations shall be conducted in accordance with the requirements of NFPA 51B.
- **14.2.10.6 Electrical.** In addition to the requirements of 6.1.10, the following shall apply to the interior of any refrigerator or freezer cabinet used for the storage of Class I, Class II, or Class III organic peroxide formulations:
- The cabinet shall be considered a Class I, Group D, Division 1 location, as defined in Article 500 of NFPA 70.
- (2) Any electrical equipment installed in the interior of such cabinets shall be approved for such use and shall be installed according to the requirements of Article 501 of NFPA 70.

- **14.2.10.6.1** Where the storage cabinet is ventilated, the following shall apply:
- The electrical equipment shall be considered a Class I, Division 2 location, as defined in Article 500 of NFPA 76.
- (2) Mechanical ventilation systems shall provide at least  $1 \text{ ft}^3/\text{min/ft}^2 (0.09 \text{ m}^3/\text{min}/0.03 \text{ m}^2)$  of floor area.
- **14.2.10.7 Combustible Waste.** Accumulation of combustible waste in organic peroxide storage or use areas shall be prohibited
- **14.2.10.8\* Damaged Containers.** Spilled material and leaking or damaged containers and packages shall immediately be removed for recovery or disposal away from the stored product or other combustibles.
- **14.2.10.9 Specific Disposal Procedures.** Specific disposal procedures shall be established for all organic peroxide areas.

## 14.2.10.10 Heating and Cooling.

- **14.2.10.10.1 Temperature Range.** Storage areas shall be maintained within the recommended storage temperature range for the materials requiring refrigerated storage.
- **14.2.10.10.2 Outside of Ambient Temperature.** Where the required storage temperature range extends beyond normal ambient temperatures, the following criteria shall be met:
- High- or low-temperature limit switches, or both, as applicable, shall be installed and maintained in addition to the normal temperature controls.
- (2) The limit switches shall actuate an alarm arranged to ensure prompt response.
- **14.2.10.10.3 Cooling Systems.** Cooling systems shall not utilize direct expansion of a flammable gas.
- **14.2.10.10.4 Heating Systems.** Heating systems shall use hot water, low pressure [a gauge pressure less than 15 psi (103 kPa)] steam, or indirectly heated warm air.
- **14.2.10.10.5 Container Contact.** Heating coils, radiators, air diffusers, cooling coils, piping, and ducts shall be installed so as to prevent direct contact with containers and to prevent overheating or overcooling of the materials stored.
- **14.2.10.11** The following shall apply to any floors or open spaces located below the organic peroxide storage area:
- (1) The floor of the storage area shall be made watertight and shall be provided with drainage that leads to a safe location.
- (2) Every means shall be taken to ensure that spilled material cannot run down into areas below the organic peroxide storage area.

#### 14.3 Indoor Storage.

- **14.3.1 Detection Systems.** A detection system that detects smoke, temperature, or rate of temperature rise shall be provided in storage areas used for the storage of liquid and solid organic peroxide formulations.
- **14.3.2\* Storage Conditions/Arrangement.** Storage arrangement shall be in accordance with 14.3.2.
- **14.3.2.1 Storage Limitations.** The MAQs of organic peroxide formulations that can be stored in a single area or building shall depend on the classification of the formulations, the classification of the formulations.

sification of the storage facility, and sprinkler protection, as set forth in Table 14.3.2.1(a) and Table 14.3.2.1(b).

- **14.3.2.2** The quantity of Class III organic peroxide formulations as it appears in Table 14.3.2.1(a) in cutoff storage shall be permitted to be increased to 20,000 lb (9070 kg) if the walls or partitions providing the cutoff have a fire resistance rating of at least 4 hours.
- **14.3.2.3** Class I organic peroxide formulation cutoff storage as it appears in Table 14.3.2.1(b) shall have interior walls with a blast resistance of 432 psf (0.2 bar).
- **14.3.2.4\*** Class I organic peroxide formulation cutoff storage as it appears in Table 14.3.2.1(b) shall have deflagration venting provided for exterior walls.
- **14.3.2.5\*** Where two or more different classes of organic peroxide formulations are stored in the same area, the following shall apply:
- The maximum quantity permitted shall be limited to the sum of the proportional amounts that each class bears to the maximum permitted for that class.
- (2) The total of the proportional amounts shall not exceed 100 percent.
- **14.3.2.6** Where the storage area is protected by a specially engineered fire protection system acceptable to the AHJ, the quantity of organic peroxide formulations shall be permitted to be increased.

**14.3.2.7** Organic peroxide formulations sensitive to shock shall not be stored where they can be exposed to the shock effects of explosive materials.

## 14.3.2.8 Storage Arrangements.

- **14.3.2.8.1** Storage shall be arranged to facilitate manual access and handling, to maintain pile stability, to minimize breakage and spillage, and to promote good housekeeping.
- **14.3.2.8.2** A clear space of at least 2 ft (0.6 m) shall be maintained between organic peroxide storage and uninsulated metal walls.
- **14.3.2.9 Separation Distance.** The following shall apply to separation distances:
- (1) Incompatible materials and flammable or combustible liquids shall not be stored within 25 ft (7.6 m) of organic peroxide formulations.
- (2) The effective separation distance shall be maintained by floor slope, drains, or dikes to prevent liquid leakage from encroaching on the organic peroxide formulation storage area.
- (3) Organic peroxide formulations that can also be classified as flammable or combustible liquids by their flash point shall be permitted to be stored with other organic peroxide formulations, and the more restrictive requirements of NFPA 30 or this code shall apply.
- △ 14.3.2.9.1 As an alternative to the 25 ft (7.6 m) separation distance of 14.3.2.9(1), a 1-hour liquidtight fire barrier shall be permitted.

- △ 14.3.2.9.3 Storage of bags, drums, and other containers and packages of organic peroxide formulations shall be in accordance with Table 14.3.2.9.3.
  - **14.3.2.9.4\*** Storage of 55 gal (208 L) drums of Class IIB or Class III organic peroxide formulations shall be stored only one drum high.
  - **14.3.2.9.4.1** Class I organic peroxide formulations shall not be stored in containers greater than 8 gal (30.3 L).
  - **14.3.2.9.5** Storage of Class V organic peroxide formulations shall meet the requirements of NFPA 1 as applicable.
  - **14.3.3 Floors.** The requirements of 6.2.1.10 shall apply.

## 14.3.4 Detached Storage.

- **14.3.4.2.2** For Class II, III, and IV organic peroxide formulations, detached storage buildings separated by less than 50 ft (15.3 m) shall be considered to be a single area when applying the limits for Table 14.3.2.1(a) and Table 14.3.2.1(b).

#### 14.3.4.3 Building Construction.

- **14.3.4.3.1\*** Detached storage buildings shall be single story, without a basement or crawl space.
- **14.3.4.3.2** Nonsprinklered buildings for storing more than 5000 lb (2270 kg) of Class I, Class II, or any refrigerated organic peroxide formulation that gives off flammable gases

upon decomposition shall be built of noncombustible construction.

**14.3.4.3.3\*** Buildings of combustible construction employing sun shields shall be permitted to be used for detached storage buildings storing less than 5000 lb (2270 kg) of organic peroxide formulations.

## 14.4 Outdoor Storage.

- **14.4.1 Exposures.** Outdoor storage of solid or liquid organic peroxide formulations shall be separated from exposure hazards in accordance with 14.4.1.
- **14.4.1.1 Clearance from Combustibles.** Clearance from combustible organic peroxide formulations shall be in accordance with 6.2.7.1.
- **14.4.1.2 Location.** Outdoor storage of solid or liquid organic peroxide formulations shall not be within 20 ft (6.1 m) of property lines, streets, alleys, public ways, means of egress to a public way, or buildings not used exclusively for the storage, distribution, or manufacturing of such organic peroxide formulations, except as provided in 14.4.1.3.
- **14.4.1.3 Distance Reduction.** An unpierced 2-hour fire–resistive wall extending not less than 30 in. (762 mm) above and to the side of the storage area shall be permitted in lieu of the distance specified in 14.4.1.2.
- **14.4.2 Weather Protection.** Where provided, weather protection shall be in accordance with 5.1.2 and 6.2.7.2.

#### 14.5 General Requirements for Use.

- **14.5.1 Spill Control.** Spill control shall be provided for organic peroxide formulations liquids in accordance with 6.3.1.4.
- **14.5.2 Drainage.** Where provided, drainage shall be in accordance with 6.3.1.4.2.10.

## Chapter 15 Oxidizer Solids and Liquids

- **15.1.1.1** The requirements of 15.3.2.1 shall apply to storage of Class 1 oxidizers where stored in quantities in excess of 4000 lb (1814.4 kg), irrespective of whether the amount of oxidizer solids or liquids exceeds the MAQs permitted in control areas.
- **15.1.1.2** The requirements of 15.3.5 shall apply to the display and storage, of Class 1 through Class 3 oxidizers in mercantile, storage, or industrial occupancies where the general public has access to the material for sale and to the storage of oxidizing materials in such occupancies in areas that are not accessible to the public.
- **15.1.2** The storage, use, and handling of oxidizer solids or liquids in any quantity shall also comply with the requirements of Chapters 1 through 4 and the applicable requirements of Chapters 5 through 10.

- **15.1.3 Construction Requirements.** Buildings, or portions thereof, in which oxidizing liquids and solids are stored, handled, or used shall be constructed in accordance with the building code.
- **15.1.4\*** The quantity and arrangement limits in this code shall not apply to the transient storage of oxidizers in process areas at plants where oxidizers are manufactured.
- **15.1.5** The construction requirements of this code shall not apply retroactively to the storage of solid and liquid oxidizers in existing buildings used for the storage of oxidizers at manufacturing plants.
- **15.1.6** Each class of oxidizer shall be considered independent of the others, and a facility shall be permitted to carry up to the maximum quantity for each class of material.

#### 15.2 General Requirements for Storage.

- **15.2.1 Spill Control.** Spill control shall be provided for oxidizer liquids in accordance with 6.2.1.9.2.
- **15.2.1.1\*** Where Class 2, Class 3, or Class 4 liquid oxidizers are stored, means shall be provided to prevent the liquid oxidizer from flowing out of a storage area into an area containing incompatible materials.
- **15.2.1.2\*** Spilled oxidizers, reacting oxidizers, and leaking or broken containers shall be removed immediately by a competent individual to a safe, secure, dry outside area or to a location designated by the competent individual to await disposal, in conformance with applicable regulations and manufacturer's and processor's instructions.
- **15.2.1.3** Spilled materials shall be placed in a clean, separate container and shall not be returned to the original container.
- **15.2.1.4** The disposal of spilled materials shall not be combined with that of ordinary trash.
- **15.2.2 Drainage.** Where provided, drainage shall be in accordance with 6.2.1.9.3.11.
- **15.2.3 Secondary Containment.** Secondary containment shall be provided for oxidizer solids and liquids in accordance with 6.2.1.9.3.
- **15.2.4 Ventilation.** Ventilation shall be provided for Class 4 oxidizers in open containers in accordance with 6.2.1.5.
- **15.2.5\* Fire Protection Systems.** An automatic fire sprinkler system shall be provided in accordance with 6.2.1.1, 15.3.2, and 15.3.5.

## 15.2.5.1\* Dry Pipe and Preaction Sprinkler Systems.

- **15.2.5.1.1** Dry pipe and double-interlock preaction (DIPA) sprinkler systems shall not be permitted for protection of buildings or areas containing oxidizers except as provided for in 15.2.5.1.2 through 15.2.5.1.4.
- **15.2.5.1.2** Dry pipe and DIPA systems shall be permitted for protection of Class 1 oxidizers in Type I through Type IV building construction and Class 2 and Class 3 oxidizers in detached storage in Type I and Type II construction, as specified in the building code.
- 15.2.5.1.3 Dry pipe and DIPA sprinkler systems shall be permitted in mercantile occupancies when the oxidizers are

- stored in open-air environments, such as retail garden centers and buildings without exterior walls.
- **15.2.5.1.4** For Class 3 oxidizers, the location of dry pipe and DIPA sprinkler systems shall be approved by the AHJ.

#### 15.2.5.2 Fire Protection Water Supplies.

- **15.2.5.2.1\*** Water supplies shall be adequate for the protection of the oxidizer storage by hose streams and automatic sprinklers.
- **15.2.5.2.2** The water system shall be capable of providing not less than 750 gpm (2840 L/min) where protection is by means of hose streams, or 500 gpm (1890 L/min) for hose streams in excess of the automatic sprinkler water demand.
- **15.2.5.2.3** The duration of the water supply shall be a minimum of 2 hours.

#### 15.2.5.3 Portable Extinguishers.

- 15.2.5.3.1\* Dry Chemical and CO<sub>2</sub> Extinguishers. The placement and use of carbon dioxide (CO<sub>2</sub>) or dry chemical extinguishers containing ammonium compounds (Class A:B:C) shall be prohibited in areas where oxidizers that can release chlorine or bromine are stored.
- **15.2.5.3.2\* Halon Extinguishers.** Halon extinguishers shall not be used in areas where oxidizers are stored.
- **15.2.5.3.3\* Halocarbon Clean Agent Extinguishers.** Halocarbon clean agent extinguishers shall not be used in areas where oxidizers are stored, unless they have been tested to the satisfaction of the AHJ.
- **15.2.6 Explosion Control.** The requirements of 6.2.1.6 shall not apply.
- **15.2.7 Emergency and Standby Power.** Standby power shall be provided when required by 6.2.1.8.
- **15.2.8 Limit Controls.** Limit controls shall be provided when required by 6.2.1.7.
- **15.2.8.1** Oxidizers shall be separated from sources of heat, such as heating units, piping, or ducts, so that they cannot be heated to within 25°F (14°C) of their decomposition temperature or to 125°F (52°C), whichever is lower and in accordance with the manufacturer's recommendations.
- **15.2.8.2** Oxidizers shall be stored so that the storage temperature cannot be within 25°F (14°C) of their decomposition temperature or 125°F (52°C), whichever is lower and in accordance with the manufacturer's recommendations.
- **15.2.9 Monitoring/Supervision.** Supervision shall be provided in accordance with 6.2.1.11.

## 15.2.10 Detection Systems.

- **15.2.10.1** A fire detection system shall be provided in accordance with Section 6.2 and 15.3.1 in indoor storage areas for liquid and solid oxidizers.
- **15.2.10.2** A fire detection system shall not be required for detached storage buildings protected by an automatic sprinkler system.
- **15.2.11\* Special Requirements.** This subsection contains specific requirements not found in Chapter 6.

- **15.2.11.1** Solid oxidizers shall not be stored directly beneath liquids.
- **15.2.11.2** Hydrogen peroxide (Class 2 through Class 4) stored in drums shall not be stored on wooden pallets.
- **15.2.11.3** At least one side of each pile of oxidizer shall be on an aisle.
- **15.2.11.4** Accumulation of combustible waste in oxidizer storage areas shall be prohibited.
- **15.2.11.5** Used, empty, combustible containers that previously contained oxidizers shall be stored in a detached or sprinklered area.
- **15.2.11.6** Storage shall be managed to prevent excessive dust accumulation.
- **15.2.11.7 Personnel Training and Procedures.** Training and procedures shall be in accordance with 6.1.4.
- 15.2.11.8 Storage Containers, Tanks, and Bins.
- **15.2.11.8.1 Shipping Containers.** Where a storage container for solid and liquid oxidizers also functions as the shipping container, the container shall meet the requirements of the U.S. Department of Transportation, 49 CFR 100–199, or the *Canadian Ministry of Transport Regulations* (Transport Canada).
- **15.2.11.8.2 Tanks and Bins.** Tanks for the storage of bulk liquid oxidizers and bins for the storage of bulk solid oxidizers shall meet the following requirements:
- Materials of construction shall be compatible with the oxidizer being stored.
- (2) Tanks and bins shall be designed and constructed in accordance with federal, state, and local regulations or, as a minimum, in accordance with nationally recognized engineering practices [e.g., American Society of Mechanical Engineers (ASME), American Petroleum Institute (API)].
- (3) Tanks and bins shall be equipped with a vent or other relief device to prevent overpressurization due to decomposition or fire exposure.
- **15.2.11.9 Materials Not Included.** Incompatible materials shall not include approved packaging materials, pallets, or other dunnage.
- **15.2.11.10\* Contact with Water.** Oxidizers shall be stored to prevent contact with water, which can affect either container integrity or product stability.
- **15.2.11.11\*** Absorptive combustible packing materials used to contain water-soluble oxidizers that have become wet during either fire or nonfire conditions, and wooden pallets that are exposed to water solutions of an oxidizer, shall be relocated to a safe outside area and shall be disposed of properly.
- **15.2.11.12** Mercantile Signage for Different Classifications. Where oxidizers having different classifications are stored in the same area, the area shall be marked for the most severe hazard class present.
- **15.2.11.13 Clearance from Combustibles.** Clearance from combustible materials shall be in accordance with 6.1.15.
- **15.2.11.13.1** The following shall apply where oxidizers are in segregated storage with flammable and combustible liquids:

- The oxidizer containers and flammable and combustible liquid containers shall be separated by at least 25 ft (7.6 m).
- (2) The separation shall be maintained by dikes, drains, or floor slopes to prevent flammable liquid leakage from encroaching on the separation.

## 15.3 Indoor Storage.

### 15.3.1 Detection Systems.

- **15.3.1.1** A fire detection system shall be provided in indoor storage areas for liquid and solid oxidizers.
- **15.3.1.2** A fire detection system shall not be required for detached storage buildings protected by an automatic sprinkler system.
- **15.3.2 Storage Conditions/Arrangement.** Storage conditions and storage arrangements, when required, shall be in accordance with 15.3.2.

#### 15.3.2.1 Bulk Storage of Class 1 Oxidizers.

- **15.3.2.1.1\* Combustible Building Materials.** Bulk storage in combustible buildings shall not come into contact with combustible building members, unless the members are protected by a compatible coating to prevent their impregnation by the oxidizer.
- **15.3.2.1.2 Bulk Storage Separation.** Bulk storage, either in permanent bins or in piles, shall be separated from all other materials.
- **15.3.2.1.3 Bins.** Bins shall be of noncombustible construction.
- **15.3.2.1.4 Wooden Bins.** Wooden bins shall be permitted to be protected with a compatible coating to prevent impregnation of the combustible material by the oxidizer.
- **15.3.2.1.5** The MAQs of oxidizer shall not be limited when the building is protected by an approved fire sprinkler system in accordance with Section 13.3 of NFPA 1.

## 15.3.2.2 Storage Arrangements of Class 1 Oxidizers.

**15.3.2.2.1 Nonsprinklered Buildings.** For Class 1 oxidizers stored in nonsprinklered buildings, the minimum aisle width shall be equal to the pile height.

#### 15.3.2.2.2 Class 1 Oxidizers.

- **15.3.2.2.1 Application.** Paragraph 15.3.2.2 shall apply to storage of Class 1 oxidizers where stored in quantities in excess of 4000 lb (1814 kg), irrespective of whether the amount of oxidizer solids or liquids exceeds the MAQ.
- △ 15.3.2.2.2.2 Storage Arrangements. Storage in quantities identified in Table 5.2.1.1.3, Table 5.2.1.2.1, Table 5.2.1.5.3(a), and Table 15.3.2.2.2.2(A)(a) shall be permitted in nonsprinklered buildings.
- △ (A)\* Storage of Class 1 Oxidizers. Storage of Class 1 oxidizers shall be in accordance with Table 15.3.2.2.2.2(A)(a) when stored in nonsprinklered or detached unprotected buildings or in accordance with Table 15.3.2.2.2.2(A)(b) when stored in sprinklered buildings.
  - **(B)** For Class 1 oxidizers stored in nonsprinklered buildings, the minimum aisle width shall be equal to the pile height.

- (C) For Class 1 oxidizers stored in sprinklered buildings, the minimum aisle width shall be equal to the pile height, but the aisle width shall be not less than 4 ft (1.2 m) and is not required to be greater than 8 ft (2.4 m).
- **(D)** There shall be no minimum distance from the pile to a wall for amounts less than 9000 lb (4082 kg).
- **(E)** Class 1 oxidizers shall be permitted to be separated from ordinary combustible and incompatible materials by a solid noncombustible barrier or by a horizontal distance in accordance with Table 15.3.2.2.2.2(A) (a) or Table 15.3.2.2.2.2(A) (b).
- **15.3.2.2.3\* Sprinkler Protection Class 1.** For applying the requirements of NFPA 13 Class 1 oxidizers shall be designated as follows:
- Class 1 oxidizers in noncombustible or combustible containers (paper bags or noncombustible containers with removable combustible liners) shall be designated as a Class I commodity.
- (2) Class 1 oxidizers contained in fiber drums, wooden or fiber boxes or barrels, or noncombustible containers in combustible packaging shall be designated as a Class II commodity.

- (3) Class 1 liquid oxidizers contained in 5 gal (18.9 L) or smaller plastic containers shall be designated as a Class I commodity.
- (4) Class 1 liquid oxidizers contained in plastic containers larger than 5 gal (18.9 L) shall be designated as a Class II commodity.
- (5) Class 1 solid oxidizers contained in 1 gal (3.8 L) or smaller plastic containers shall be designated as a Class IV commodity.
- (6) Class 1 solid oxidizers contained in plastic containers larger than 1 gal (3.8 L) shall be designated as an unexpanded plastic commodity.

## 15.3.2.2.4 Class 1 Detached Storage.

**15.3.2.2.4.1** To be considered detached, a building for storage of Class 1 oxidizers shall be separated from the following:

- (1) Flammable or combustible liquid storage
- (2) Flammable gas storage
- (3) Combustible material in the open
- (4) Any building, passenger railroad, public highway, or other tanks

15.3.2.2.4.2 The minimum separation distance shall be 25 ft (7.6 m).

#### 15.3.2.3 Class 2 Oxidizers.

**15.3.2.3.1** Paragraph 15.3.2.3 shall apply to Class 2 oxidizers where stored in quantities in excess of the MAQ permitted in control areas.

**15.3.2.3.2 Storage Arrangements of Class 2 Oxidizers.** Class 2 oxidizers shall be permitted to be separated from ordinary combustible and incompatible materials by a solid noncombustible barrier or by a horizontal distance in accordance with Table 15.3.2.3.2.3(a) when stored in detached, unprotected buildings in accordance with the building code, or in accordance with Table 15.3.2.3.2.3(b).

**15.3.2.3.2.1** The storage of Class 2 oxidizers shall be detached unless in a control area or at the appropriate protection level.

**15.3.2.3.2.2** Walls shall have a fire resistance rating as required by the building code.

**15.3.2.3.2.3 Storage of Class 2 Oxidizers.** Storage of Class 2 oxidizers shall be in accordance with Table 15.3.2.3.2.3(a) when stored in nonsprinklered or detached, unprotected buildings or in accordance with Table 15.3.2.3.2.3(b) when stored in sprinklered buildings.

**15.3.2.3.2.4** For Class 2 oxidizers stored in nonsprinklered buildings, the minimum aisle width shall be equal to the pile height.

**15.3.2.3.2.5** For Class 2 oxidizers stored in sprinklered buildings, the minimum aisle width shall be equal to the pile height, but the aisle width shall be not less than 4 ft (1.2 m) and is not required to be greater than 8 ft (2.4 m).

**15.3.2.3.2.6** For protection-level storage or detached storage under 4500 lb (2041 kg), there shall be no minimum separation distance between the pile and any wall.

**15.3.2.3.2.7\*** The building limit shall be permitted to be four times the quantities shown in Table 15.3.2.3.2.3(b) for protection level storage if noncombustible containers are used and

15.3.2.3.2.8 Storage in glass carboys shall not be more than two carboys high.

## 15.3.2.3.2.9 Basement Storage.

- (A) Storage in basements shall be prohibited.
- **(B)** Where the oxidizer is stored in stationary tanks, storage in basements shall be permitted.

## 15.3.2.3.2.10 Maximum Height of Storage.

- (A) Maximum storage height for nonsprinklered buildings shall be in accordance with Table 15.3.2.3.2.3(a).
- **(B)** Maximum storage height for sprinklered buildings shall be in accordance with Table 15.3.2.3.2.10(B).

## 15.3.2.3.3 Building Construction.

**15.3.2.3.3.1** Construction materials that can come into contact with oxidizers shall be noncombustible.

**15.3.2.3.3.2** All construction materials used in stories or basements below the storage of liquid oxidizers shall be noncombustible.

## 15.3.2.3.4 Sprinkler Protection.

**15.3.2.3.4.1** Sprinkler protection for Class 2 oxidizers shall be designed in accordance with Table 15.3.2.3.2.10(B).

**15.3.2.3.4.2** Ceiling sprinklers shall be high-temperature sprinklers.

## 15.3.2.3.4.3 Storage Protection with In-Rack Sprinklers.

(A) In-rack sprinklers shall be quick-response sprinklers with an ordinary-temperature rating and have a K-factor of not less than K=8.0.

**(B)** In-rack sprinklers shall be designed to provide 25 psi (172 kPa) for the six most hydraulically remote sprinklers on each level.

**(C)** The in-rack sprinklers shall be 8 ft to 10 ft (2.4 m to 3.0 m) spacings in the longitudinal flue space at the intersection of the transverse flue spaces.

## 15.3.2.3.5 Detached Storage.

**15.3.2.3.5.1** To be considered detached, a building for storage of Class 2 oxidizers shall be separated from the following:

- (1) Flammable or combustible liquid storage
- (2) Flammable gas storage
- (3) Combustible material in the open
- (4) Any building, passenger railroad, public highway, or other tanks

**15.3.2.3.5.2** The minimum separation distance shall be in accordance with *NFPA 5000*.

## 15.3.2.4 Class 3 Oxidizers.

**15.3.2.4.1** Paragraph 15.3.2.4 shall apply to Class 3 oxidizers where stored in quantities in excess of the MAQ permitted in control areas.

△ 15.3.2.4.2 Type of Storage. The storage of Class 3 oxidizers shall be detached unless in a control area or at the appropriate protection level.

**15.3.2.4.3** Class 3 oxidizer storage shall be located on the ground floor only.

**15.3.2.4.4** Protection level walls shall have a fire resistance rating as required by the building code.

**15.3.2.4.5 Storage of Class 3 Oxidizers.** Storage of Class 3 oxidizers shall be in accordance with Table 15.3.2.4.5(a) when stored in nonsprinklered or detached unprotected buildings or in accordance with Table 15.3.2.4.5(b) when stored in sprinklered buildings.

**15.3.2.4.6** For Class 3 oxidizers stored in nonsprinklered buildings, the minimum aisle width shall be equal to the storage height, but the aisle width shall be not less than 4 ft (1.2 m) and is not required to be greater than 8 ft (2.4 m).

**15.3.2.4.7** For protection-level storage or detached storage, no minimum separation distance shall be required between oxidizer storage of less than 2700 lb (1225 kg) (total weight in the storage area) and any wall.

**15.3.2.4.8** Class 3 oxidizers shall be permitted to be separated from ordinary combustible and incompatible materials by a solid noncombustible barrier or by a horizontal distance in accordance with Table 15.3.2.4.5(a) or Table 15.3.2.4.5(b).

15.3.2.4.9 Storage in glass carboys shall be one carboy high.

15.3.2.4.10 Bulk storage in open bins or piles shall not be permitted.

## 15.3.2.4.11 Maximum Height of Storage.

**15.3.2.4.11.1** Maximum storage height for nonsprinklered buildings shall be in accordance with Table 15.3.2.4.5(a).

**15.3.2.4.11.2** Maximum storage height for sprinklered buildings shall be in accordance with Table 15.3.2.4.13.1(B).

## 15.3.2.4.12 Building Construction.

**15.3.2.4.12.1** Buildings used for the storage of Class 3 liquid oxidizers shall not have basements.

**15.3.2.4.12.2** Construction materials that can come into contact with oxidizers shall be noncombustible.

**15.3.2.4.12.3** Storage of Class 3 oxidizers in excess of 30 tons (27.2 metric tons) shall be in buildings of Type I or Type II construction, as specified in the building code.

**15.3.2.4.12.4** If Class 3 oxidizers are stored in accordance with rack storage requirements in Table 15.3.2.4.13.4(B), they shall be permitted to be in buildings of construction Type I through Type IV, as specified in the building code.

#### 15.3.2.4.13 Sprinkler Criteria for Class 3 Oxidizers.

## 15.3.2.4.13.1 Class 3 Oxidizers Less Than 2700 lb (1225 kg).

(A) Sprinkler design criteria for buildings that require sprinkler protection and contain total quantities of Class 3 oxidizers less than 2700 lb (1225 kg) shall be in accordance with the requirements of 15.3.2.4.13.1(B).

Δ (B) Facilities that require sprinkler protection and contain total quantities of Class 3 oxidizers greater than 200 lb (91 kg), but less than 2700 lb (1225 kg), shall follow the sprinkler design criteria in Table 15.3.2.4.13.1(B).

**15.3.2.4.13.2** Ceiling sprinklers shall be high-temperature sprinklers.

## 15.3.2.4.13.3 In-Rack Sprinkler Criteria.

- (A) Where required by Table 15.3.2.4.13.1(B), in-rack sprinkler protection shall be as follows:
- In-rack sprinklers shall be installed above every level of oxidizer storage.
- (2) In-rack sprinklers shall be spaced at maximum 4 ft (1.2 m) intervals to provide one sprinkler in each flue space.
- (3) In-rack sprinklers shall be quick-response sprinklers with an ordinary-temperature rating and have a K-factor of not less than K = 8.0.
- (4) In-rack sprinklers shall be designed to provide 25 psi (172 kPa) for the six most hydraulically remote sprinklers on each level.
- **(B)** Class 3 oxidizers in racks meeting the requirements of 15.3.2.4.13.1(B) shall be permitted to be protected in accordance with 15.3.2.4.13.3.

## $15.3.2.4.13.4\ Class\ 3\ Oxidizers\ Greater\ Than\ or\ Equal\ to\ 2700\ lb\ (1225\ kg).$

(A) Facilities containing total quantities of Class 3 oxidizers equal to or greater than the threshold limits of 15.3.2.4.13.4 shall be protected in accordance with the requirements of 15.3.2.4.13.5(B).

△ (B) The sprinkler protection required by 15.3.2.4.13.4 shall be in accordance with Table 15.3.2.4.13.4(B).

# 15.3.2.4.13.5 Special In-Rack Sprinkler Protection for Class 3 Oxidizers Stored in Total Quantities Greater Than or Equal to 2700 lb (1225 kg).

- (A) Where required by Table 15.3.2.4.13.4(B), special in-rack sprinkler protection, which is required by 15.3.2.4.13.5(L), shall be as shown in Figure 15.3.2.4.13.5(A).
- **(B)** Racks shall be arranged in accordance with 15.3.2.4.13.5(C) through 15.3.2.4.13.5(K).
- (C) Racks shall be of steel construction.
- (D) Racks shall have vertical supports spaced no more than  $10\ \mathrm{ft}\ (3.1\ \mathrm{m})$  apart.
- **(E)** Horizontal rack members shall be spaced not more than 6 ft (1.8 m) apart vertically.
- **(F)** Display or storage shall be limited in height to two protected tiers.
- (G) Horizontal barriers constructed of plywood at least  $\frac{8}{8}$  in. (9.5 mm) thick shall be provided above each level of oxidizing material storage, and the following criteria also shall be met:



- (1) The barriers shall extend from rack face to rack face and shall be tight to the vertical barriers described in 15.3.2.4.13.5(H) and 15.3.2.4.13.5(I).
- (2) The barriers shall be supported by horizontal rack members.
- (H) Transverse vertical barriers constructed of plywood at least  $\frac{3}{8}$  in. (9.5 mm) thick shall be provided at the rack uprights extending from rack face to rack face.
- (I) For double-row racks, longitudinal vertical barriers constructed of plywood at least  $\frac{3}{6}$  in. (9.5 mm) thick shall be provided at the rack uprights in the center of the rack.
- (J) If intermediate shelves are used between the horizontal barriers, the shelves shall be constructed of open wire mesh or steel grating.
- (**K**) Pallets, if used, shall be of the solid-deck type.
- (L) In-rack automatic sprinklers shall be provided under each horizontal barrier and arranged in accordance with 15.3.2.4.13.5(M) through 15.3.2.4.13.5(T).
- **(M)** For double-row racks, two lines of in-rack sprinklers shall be provided between the face of the rack and the longitudinal vertical barrier located in the center of the rack.
- (N) For single-row racks, two lines of in-rack sprinklers shall be provided between each rack face.
- **(O)** Three in-rack sprinklers shall be provided on each in-rack sprinkler line as follows:
- Two sprinklers on each line shall be spaced approximately 1½ in. (38.1 mm) from each transverse vertical barrier.
- (2) One in-rack sprinkler on each in-rack sprinkler line shall be located approximately equidistant between the transverse vertical barriers.
- **(P)** In-rack sprinklers shall be of the upright or pendent type, with the fusible element located no more than 6 in. (152.4 mm) from the horizontal barrier.
- (Q) The stock shall be maintained at least 6 in. (152.4 mm) below the sprinkler deflector.
- (**R**) In-rack sprinklers shall be K = 8.0, quick-response, ordinary-temperature-rated sprinklers.

- (S) The in-rack sprinkler system shall be designed to supply 6 sprinklers on each line, with a total of 12 sprinklers operating at gauge pressure of 25 psi (172 kPa).
- (T) The design of the in-rack sprinkler system shall be independent of, and shall not be required to be balanced with, ceiling sprinkler systems.

# 15.3.2.4.14 Detached Storage.

15.3.2.4.14.1 To be considered detached, a building for storage of Class 3 oxidizers shall be separated from the following:

- Flammable or combustible liquid storage
- (2)Flammable gas storage
- Combustible material in the open
- Any building, passenger railroad, public highway, or other tanks

15.3.2.4.14.2 The minimum separation distance shall be in accordance with the building code.

#### 15.3.2.5 Class 4 Oxidizers.

15.3.2.5.1 Paragraph 15.3.2.5 shall apply to Class 4 oxidizers where stored in quantities in excess of the MAQ permitted in

15.3.2.5.2 Outdoor container storage shall meet the requirements of nonsprinklered buildings.

#### 15.3.2.5.3 Storage Arrangements.

- 15.3.2.5.3.1 The storage of Class 4 oxidizers shall be detached.
- **15.3.2.5.3.2** Storage in glass carboys shall be one carboy high.
- 15.3.2.5.3.3 Storage in drums, containers, or cases shall not exceed the limits outlined in Table 15.3.2.5.3.3.

15.3.2.5.3.4 Bulk storage in piles or fixed bins shall not be permitted.

#### 15.3.2.5.4 Building Construction and Location.

15.3.2.5.4.1 Buildings shall be constructed as one story without basement.

15.3.2.5.4.2 Construction materials that could come into contact with oxidizers shall be noncombustible.

15.3.2.5.4.3 Storage areas shall be provided with means to vent fumes in an emergency.

15.3.2.5.4.4 A storage building or storage tank shall be located not less than the minimum distance provided in Table 15.3.2.5.4.4 from the following:

- Flammable liquid storage
- (2)Combustible material in the open
- Any inhabited building, passenger railroad, public highway, property line, or tank other than oxidizer storage

15.3.2.5.4.5\* Where tanks are not separated from each other by 10 percent of the distance specified in Table 15.3.2.5.4.4 for the largest tank, the total contents of all tanks shall be used when applying Table 15.3.2.5.4.4.

#### 15.3.2.5.4.6 Sprinkler Protection.

(A) Sprinkler protection for Class 4 oxidizers shall be installed on a deluge sprinkler system to provide water density of 0.35 gpm/ft<sup>2</sup> (14.4 L/min/m<sup>2</sup>) over the entire storage area.

- (B) Sprinkler protection shall be installed in accordance with NFPA 13.
- **15.3.3 Floors.** Floors shall be in accordance with 6.2.1.10.
- **15.3.4 Detached Storage.** Detached storage shall be provided for oxidizer solids or liquids when required by 15.3.2 and 6.2.2.2, 6.2.3.4, 6.2.4.4, or 6.2.4.5.
- 15.3.5 Special **Requirements.** This subsection contains specific requirements not found in Chapter 6.
- 15.3.5.1 Application for Mercantile, Storage, or Industrial **Occupancies.** Section 15.3.5 applies to the display and storage of Class 1 through Class 3 oxidizers in mercantile, storage, or industrial occupancies where the general public has access to the materials for sale and also applies to the storage of additional oxidizing materials in such occupancies in areas that are not accessible to the public.
- **15.3.5.2 General Requirements.** Oxidizing materials that are displayed or stored in areas accessible to the general public shall meet the requirements of 15.3.5.2.1 through 15.3.5.2.13.2.
- 15.3.5.2.1\* Oxidizing materials shall be separated from ordinary combustible and incompatible materials by a solid noncombustible barrier or by a horizontal distance of not less than 4 ft (1.2 m).
- **15.3.5.2.1.1** Ordinary combustibles shall not include approved packaging materials, pallets, or other dunnage used for the oxidizers.
- 15.3.5.2.1.2 Separation from ordinary combustible materials shall not be required for Class 1 oxidizers.
- 15.3.5.2.2 Solid oxidizing materials shall not be displayed directly beneath liquids.

- **15.3.5.2.3** For sprinklered mercantile occupancies and storage occupancies, storage heights and sprinkler protection criteria shall be in accordance with 15.3.2.2 through 15.3.3.
- **15.3.5.2.4** Storage and display of solids shall not exceed 200 lb/ft<sup>2</sup> (978 kg/m<sup>2</sup>) of floor area actually occupied by solid merchandise.
- **15.3.5.2.5** Storage and display of liquids shall not exceed  $20~\text{gal/ft}^2$  (76 L/m²) of floor area actually occupied by liquid merchandise.
- **15.3.5.2.6** Racks and shelves used for storage or display shall be of substantial construction and adequately braced and anchored.
- 15.3.5.2.7 Containers shall be approved for their intended use.
- **15.3.5.2.8** Individual containers in mercantile occupancies shall not exceed 100 lb (45.4 kg) capacity for solids or 10 gal (38 L) capacity for liquids.
- **15.3.5.2.9** Aisles 4 ft (1.2 m) in width shall be maintained on three sides of the storage or display area.
- **15.3.5.2.10** Hazard identification signs shall be provided in accordance with NFPA 1.
- 15.3.5.2.11 Storage Arrangements in Nonsprinklered Mercantile, Storage, or Industrial Occupancies.
- 15.3.5.2.11.1 Storage and display of Class 2 and Class 3 oxidizing materials shall extend not higher than 6 ft  $(1.8\ m)$  from the floor to the top of the uppermost container.
- 15.3.5.2.11.2 The storage and display of Class 2 and Class 3 oxidizers shall not exceed 4 ft (1.2 m) in depth.
- **15.3.5.2.12 Containers.** Individual containers less than 5 gal (19 L), or less than 25 lb (11 kg), shall be stored or displayed on pallets, racks, or shelves.

# 15.3.5.2.13 Quantity Limitations.

- **15.3.5.2.13.1** The quantity of oxidizing materials permitted in a mercantile, storage, or industrial occupancy shall not exceed the quantities given in Table 5.2.1.5.3(a) for either a nonsprinklered or sprinklered area, whichever is applicable.
- **15.3.5.2.13.2** Facilities that require sprinkler protection having total quantities of Class 3 oxidizers greater than 200 lb (91 kg), but less than 2700 lb (1225 kg), shall comply with 15.3.2.4.13.1(B).

# 15.4 Outdoor Storage.

- **15.4.1 Exposures.** Outdoor storage of oxidizer solids or liquids shall be separated from exposure hazards in accordance with 15.4.1.
- **15.4.1.1 Clearance from Combustibles.** Clearance from combustible materials shall be in accordance with 6.2.7.1.
- **15.4.1.2 Location.** Outdoor storage of oxidizer solids or liquids shall not be within 20 ft (6.1 m) of property lines, streets, alleys, public ways, means of egress to a public way, or buildings not used exclusively for the storage, distribution, or manufacturing of such material, except as provided in 15.4.1.3.
- **15.4.1.3 Distance Reduction.** An unpierced 2-hour fire-resistive wall extending not less than 30 in. (762 mm) above

- and to the side of the storage area shall be permitted in lieu of the distance specified in 15.4.1.2.
- **15.4.2 Weather Protection.** When provided, weather protection shall be in accordance with 5.1.2 and 6.2.7.2.
- **15.4.3 Special Requirements.** This subsection contains specific requirements not found in Chapter 6.
- **15.4.3.1** The size of outside storage tanks for Class 1, Class 2, and Class 3 oxidizers shall not be limited by this code.
- **15.4.3.2** The size of outside storage tanks for Class 4 oxidizers shall be limited in accordance with this code.
- 15.5 General Requirements for Use.
- **15.5.1 Spill Control.** Spill control shall be provided for oxidizer liquids in accordance with 6.3.1.4.
- **15.5.2 Drainage.** When provided, drainage shall be in accordance with 6.3.1.4.2.10.
- **15.5.3 Secondary Containment.** Secondary containment shall be provided for oxidizer solids or liquids in accordance with 6.3.1.4.2.
- **15.5.4 Ventilation.** Ventilation shall be provided for Class 4 oxidizers in open containers in accordance with 6.3.2.1.3 and 6.3.2.2.2.
- **15.5.5 Fire Protection System.** An automatic fire sprinkler system shall be provided in accordance with 6.3.2.1.1.
- 15.5.5.1 Portable Extinguishers.
- **15.5.5.1.1 Dry Chemical and CO\_2 Extinguishers.** The placement and use of carbon dioxide ( $CO_2$ ) or dry chemical extinguishers containing ammonium compounds (Class A:B:C) shall be prohibited in areas where oxidizers that can release chlorine or bromine are stored.
- **15.5.5.1.2 Halon Extinguishers.** Halon extinguishers shall not be used in areas where oxidizers are stored.
- **15.5.5.1.3 Halocarbon Clean Agent Extinguishers.** Halocarbon clean agent extinguishers shall not be used in areas where oxidizers are stored, unless they have been tested to the satisfaction of the AHI.
- **15.5.6 Explosion Control.** The requirements of 6.3.2.1.4 shall not apply.
- **15.5.7 Emergency and Standby Power.** Standby power shall be provided when required by 6.3.1.3.
- **15.5.8 Limit Controls.** Limit controls shall be provided in accordance with 6.3.1.2.
- **15.5.9 Monitoring/Supervision.** Supervision shall be provided in accordance with 6.3.1.8.
- **15.5.10 Alarms.** A fire detection system shall be required in accordance with Section 6.2 and 15.6.2 for indoor use.
- **15.5.11 Clearance** from Combustibles. Clearance from combustible materials shall be in accordance with 6.2.7.1.
- **15.5.12 Floors.** Floors where oxidizer solids or liquids are dispensed or used in open systems shall be in accordance with 6.3.2.2.3.

- 15.5.13 System Design. System design shall be in accordance with 6.3.1.6.
- **15.5.14 Liquid Transfer.** Liquid transfer shall be in accordance with 6.3.1.7.
- 15.6 Indoor Use.
- 15.6.1 Open Systems.
- **15.6.1.1 Ventilation.** Ventilation shall be provided for Class 4 oxidizers in open containers in accordance with 6.3.2.2.2.
- **15.6.1.2 Explosion Control.** The requirements of 6.3.2.1.4 shall not apply.
- **15.6.1.3 Spill Control, Drainage, and Containment.** Secondary containment shall be provided for oxidizer liquids in accordance with 6.3.2.2.4.
- **15.6.2 Detection Systems.** A fire detection system shall be required for indoor use.
- 15.6.3 Closed Systems.
- **15.6.3.1 Ventilation.** The requirements of 6.3.2.3.2 shall not apply.
- **15.6.3.2 Explosion Control.** The requirements of 6.3.2.1.4 shall not apply.
- **15.6.3.3** Spill Control, Drainage, and Containment. Spill control and secondary containment shall be provided for oxidizer liquids in accordance with 6.3.2.3.3.
- 15.7 Outdoor Use.
- 15.7.1 Open Systems.
- **15.7.1.1 Location.** Outdoor use and dispensing shall be located in accordance with 6.3.3.1.1.
- **15.7.1.2 Spill Control, Drainage, and Containment.** Spill control and secondary containment shall be provided for oxidizer liquids in accordance with 6.3.3.2.2.
- **15.7.1.3 Clearance from Combustibles.** Clearance from combustible materials shall be in accordance with 6.3.3.1.2.
- 15.7.2 Closed Systems.
- **15.7.2.1 Location.** Outdoor use and dispensing shall be located in accordance with 6.3.3.1.1.
- **15.7.2.2 Spill Control, Drainage, and Containment.** Spill control and secondary containment shall be provided for liquids in accordance with 6.3.3.3.2.
- **15.7.2.3 Clearance from Combustibles.** Clearance from combustible materials shall be provided in accordance with 6.3.3.1.2.
- **15.8 Handling.** Handling of oxidizers in indoor and outdoor areas shall be in accordance with Section 15.8.
- 15.8.1 Handling. Handling shall be in accordance with 6.3.4.

# Chapter 16 Reserved

### Chapter 17 Pyrophoric Solids and Liquids

- 17.1 General. The requirements of this chapter shall apply to the storage, use, and handling of pyrophoric solids or liquids when the amount of pyrophoric solids or liquids exceeds the MAQ as set forth in Chapter 5. The storage, use, and handling of pyrophoric solids or liquids in any quantity shall also comply with the requirements of Chapters 1 through 4 and the applicable requirements of Chapters 5 through 10.
- **17.1.1 Construction Requirements.** Buildings, or portions thereof, in which pyrophoric solids or liquids are stored, handled, or used shall be constructed in accordance with the building code.
- 17.2 General Requirements for Storage.
- **17.2.1 Spill Control.** Spill control shall be provided for pyrophoric liquids in accordance with 6.2.1.9.2.
- 17.2.1.1\* Liquid spills shall be directed away from tanks and containers.
- **17.2.2 Drainage.** When provided, drainage shall be in accordance with 6.2.1.9.3.11.
- **17.2.3 Secondary Containment.** Secondary containment shall be provided for pyrophoric liquids in accordance with 6.2.1.9.3.
- 17.2.3.1 Secondary containment shall be designed to prevent spilled liquids from accumulating under process vessels, storage tanks, and containers.
- **17.2.4 Ventilation.** Ventilation shall be provided for open containers in accordance with 6.2.1.5.
- **17.2.5\* Fire Protection Systems.** An approved fire protection system shall be provided in accordance with 6.2.1.1.
- **17.2.6 Explosion Control.** The requirements of 6.2.1.6 shall not apply.
- **17.2.7 Emergency and Standby Power.** Standby power shall be provided when required by 6.2.1.8.
- **17.2.8 Limit Controls.** Limit controls shall be provided when required by 6.2.1.7.
- **17.2.9 Monitoring/Supervision.** Supervision shall be provided in accordance with 6.2.1.11.
- 17.3 Indoor Storage.

- 17.4.1.2\* Location. The separation of pyrophoric solids and liquids from buildings, property lines, streets, alleys, public ways, or means of egress to a public way shall be twice the separation required by NFPA 30 for an equivalent volume of Class I-B flammable liquid.
- **17.4.1.3 Distance Reduction.** An unpierced 2-hour fireresistive wall extending not less than 30 in. (762 mm) above and to the side of the storage area shall be permitted in lieu of the distance specified in 17.4.1.2.
- **17.4.2 Weather Protection.** When provided, weather protection shall be in accordance with 5.1.2 and 6.2.7.2.

# 17.4.3 Special Requirements.

17.4.3.1\* Storage Arrangement. The quantities, arrangement, and spacing for pyrophoric liquids and solids in tanks, portable tanks, and containers shall be in accordance with NFPA 30 as required for Class I-B flammable liquids.

**18.1 General.** The requirements of this chapter shall apply to the storage, use, and handling of toxic or highly toxic solids or liquids when the amount of toxic or highly toxic solids or liquids exceeds the MAQ as set forth in Chapter 5. The storage, use, and handling of toxic or highly toxic solids or liquids in any quantity shall also comply with the requirements of Chapters 1 through 4 and the applicable requirements of Chapters 5 through 10.

- **18.1.1 Construction Requirements.** Buildings, or portions thereof, in which toxic or highly toxic solids or liquids are stored, handled, or used shall be constructed in accordance with the building code.
- 18.2 General Requirements for Storage.
- **18.2.1 Spill Control.** Spill control shall be provided for toxic or highly toxic liquids in accordance with 6.2.1.9.2.
- **18.2.2 Drainage.** When provided, drainage shall be in accordance with 6.2.1.9.3.11.
- **18.2.3 Secondary Containment.** Secondary containment shall be provided for toxic or highly toxic solids or liquids in accordance with 6.2.1.9.3.
- **18.2.4 Ventilation.** Ventilation shall be provided for open containers of highly toxic solids or liquids in accordance with 6.2.1.5.
- **18.2.5 Treatment Systems.** The storage area for highly toxic liquids that liberate highly toxic vapors in the event of a spill or other accidental discharge shall not be located outside of a building unless effective collection and treatment systems are provided.
- **18.2.5.1** The treatment system shall comply with 21.3.9.3 for highly toxic gases.
- **18.2.6 Fire Protection Systems.** An automatic fire sprinkler system shall be provided in accordance with 6.2.1.1.
- **18.2.7 Explosion Control.** The requirements of 6.2.1.6 shall not apply.
- **18.2.8 Emergency and Standby Power.** Standby power shall be provided when required by 6.2.1.8.
- **18.2.9 Limit Controls.** Limit controls shall be provided when required by 6.2.1.7.
- **18.2.10 Monitoring/Supervision.** Supervision shall be provided in accordance with 6.2.1.11.
- 18.3 Indoor Storage.
- **18.3.1 Floors.** Floors shall be in accordance with 6.2.1.10.
- **18.3.2 Detached Storage.** The requirements of 6.2.2.2 shall not apply.
- 18.3.3 Special Requirements.
- **18.3.3.1** Highly toxic solids and liquids not stored in approved hazardous materials storage cabinets shall be isolated from other hazardous materials storage by a 1-hour-rated fire barrier.
- 18.4 Outdoor Storage.
- **18.4.1 Exposures.** Outdoor storage of toxic or highly toxic solids or liquids shall be separated from exposure hazards in accordance with 18.4.1.
- **18.4.1.1 Clearance from Combustibles.** Clearance from combustible materials shall be in accordance with 6.2.7.1.
- **18.4.1.2 Location.** Outdoors storage of toxic or highly toxic solids or liquids shall not be within 20 ft (6.1 m) of property lines, streets, alleys, public ways, means of egress to a public way, or buildings not used exclusively for the storage, distribution, or manufacturing of such material, except as provided in 18.4.1.3.

- **18.4.1.3 Distance Reduction.** An unpierced 2-hour fire–resistive wall extending not less than 30 in. (762 mm) above and to the side of the storage area shall be permitted in lieu of the distance specified in 18.4.1.2.
- **18.4.2 Weather Protection.** Where provided, weather protection shall be in accordance with 5.1.2 and 6.2.7.2.

# 18.4.3 Special Requirements.

- **18.4.3.1 Fire-Extinguishing Systems.** The outdoor storage area for highly toxic solids and liquids shall consist of fire-resistive containers or shall comply with one of the following:
- The storage area shall be protected by an automatic, open head, deluge fire sprinkler system in accordance with NFPA 13.
- (2) Storage shall be located under a noncombustible weather protection structure in accordance with 18.4.2, with the canopied area protected by an automatic fire sprinkler system in accordance with NFPA 13.

# 18.4.3.2 Storage Arrangement.

- **18.4.3.2.1 Pile Size Limit.** Highly toxic solids and liquids stored outdoors shall be separated into piles, each not larger than  $2500 \text{ ft}^3$  ( $70.8 \text{ m}^3$ ).
- **18.4.3.2.2 Aisles.** Aisle widths between piles shall not be less than one-half the height of the pile or 10 ft (3 m), whichever is greater.

### 18.4.3.3 Treatment System.

- **18.4.3.3.1** The storage area for highly toxic liquids that liberate highly toxic vapors in the event of a spill or other accidental discharge shall not be located outside of a building unless effective collection and treatment systems are provided.
- **18.4.3.3.2** The treatment system shall comply with the design requirements of Chapter 21 for highly toxic gases.

# 18.5 General Requirements for Use.

- **18.5.1 Spill Control.** Spill control shall be provided for toxic or highly toxic liquids in accordance with 6.3.1.4.
- **18.5.2 Drainage.** When provided, drainage shall be in accordance with 6.3.1.4.2.10.
- **18.5.3 Secondary Containment.** Secondary containment shall be provided for toxic or highly toxic solids or liquids in accordance with 6.3.1.4.2.
- **18.5.4 Ventilation.** Ventilation shall be provided for open containers of highly toxic solids or liquids in accordance with 6.3.2.1.3 and 6.3.2.2.2.
- **18.5.5 Treatment Systems.** Exhaust scrubbers or other systems for processing vapors of highly toxic liquids shall be provided where a spill or accidental release of such liquids can be expected to release highly toxic vapors at normal temperature and pressure. Treatment systems and other processing systems shall be installed in accordance with the mechanical code adopted by the jurisdiction.
- **18.5.5.1** The treatment system shall comply with the design requirements of Chapter 21 for highly toxic gases.
- **18.5.6 Fire Protection System.** An automatic fire sprinkler system shall be provided in accordance with 6.3.2.1.1.

The storage, use, and handling of unstable (reactive) solids or liquids in any quantity shall also comply with the requirements of Chapters 1 through 4 and the applicable requirements of Chapters 5 through 10.
- **19.1.1 Construction Requirements.** Buildings, or portions thereof, in which unstable (reactive) solids or liquids are stored, handled, or used shall be constructed in accordance with the building code.
- 19.2 General Requirements for Storage.
- **19.2.1 Spill Control.** Spill control shall be provided for unstable (reactive) liquids in accordance with 6.2.1.9.2.
- **19.2.2 Drainage.** When provided, drainage shall be in accordance with 6.2.1.9.3.11.
- **19.2.3 Secondary Containment.** Secondary containment shall be provided for unstable (reactive) solids or liquids in accordance with 6.2.1.9.3.
- 19.2.4 Ventilation. The requirements of 6.2.1.5 shall not apply.
- **19.2.5 Fire Protection Systems.** An automatic fire sprinkler system shall be provided in accordance with 6.2.1.1.
- **19.2.6 Explosion Control.** Explosion control shall be provided for Class 3 or 4 unstable (reactive) solids or liquids when required by 6.2.1.6.

- **19.3.3 Special Requirements.** Unstable (reactive) materials that are required to be stored under refrigeration to prevent a

hazardous reaction shall be stored under refrigeration in accordance with the manufacturer's recommendations.

#### 19.4 Outdoor Storage.

- **19.4.1 Exposures.** Outdoor storage of unstable (reactive) solids or liquids shall be separated from exposure hazards in accordance with 19.4.1.
- **19.4.1.1 Clearance from Combustibles.** Clearance from combustible materials shall be in accordance with 6.2.7.1.

#### 19.4.1.2 Location.

- **19.4.1.2.1 Nondeflagrating Material.** Outdoor storage of (Class 1 or 2) (nondeflagrating) unstable (reactive) solids or liquids shall not be within 20 ft (6.1 m) of property lines, streets, alleys, public ways, means of egress to a public way, or buildings not used exclusively for the storage, distribution, or manufacturing of such material, except as provided in 19.4.1.3.
- **19.4.1.2.2 Deflagrating Material.** The outdoor storage area for (Class 3 nondetonable) unstable (reactive) solids and liquids (that can deflagrate) shall not be within 75 ft (23 m) of buildings, property lines, streets, alleys, public ways, or means of egress to a public way.
- **19.4.1.2.3 Detonable Material.** Outdoor storage of Class 3 detonable or Class 4 unstable (reactive) solids and liquids shall be located in accordance with the requirements of NFPA 495 for Division 1.1 Explosive Materials.
- **19.4.1.3 Distance Reduction.** An unpierced 2-hour fireresistive wall extending not less than 30 in. (762 mm) above and to the side of the storage area shall be permitted in lieu of the distance specified in 19.4.1.2.1.
- **19.4.1.3.1 Nondeflagrating Materials.** An unpierced 2-hour fire-resistive wall extending not less than 30 in. (762 mm) above and to the side of the storage area shall be permitted in lieu of the distance specified in 19.4.1.2.1 for (Class 1 and Class 2) (nondeflagrating) materials.
- **19.4.2 Weather Protection.** When provided, weather protection shall be in accordance with 5.1.2 and 6.2.7.2.
- **19.4.3 Special Requirements.** Unstable (reactive) materials that are required to be stored under refrigeration to prevent a hazardous reaction shall be stored under refrigeration in accordance with the manufacturer's recommendations.

The storage, use, and handling of water-reactive solids or liquids in any quantity shall also comply with the requirements of Chapters 1 through 4 and the applicable requirements of Chapters 5 through 10.
- **20.1.1 Construction Requirements.** Buildings, or portions thereof, in which water-reactive solids or liquids are stored, handled, or used shall be constructed in accordance with the building code.

### 20.2 General Requirements for Storage.

- **20.2.1 Spill Control.** Spill control shall be provided for water-reactive liquids in accordance with 6.2.1.9.2.
- **20.2.2 Drainage.** When provided, drainage shall be in accordance with 6.2.1.9.3.11.
- **20.2.3 Secondary Containment.** Secondary containment shall be provided for water-reactive solids or liquids in accordance with 6.2.1.9.3.

- **20.2.4 Ventilation.** Ventilation shall be provided for open containers in accordance with 6.2.1.5.
- **20.2.5 Fire Protection Systems.** An automatic fire sprinkler system shall be provided in accordance with 6.2.1.1.
- **20.2.6 Explosion Control.** Explosion control shall be provided for Class 3 and Class 2, deflagrating water-reactives in accordance with 6.2.1.6.
- **20.2.7 Emergency and Standby Power.** Standby power shall be provided when required by 6.2.1.8.
- **20.2.8 Limit Controls.** Limit controls shall be provided when required by 6.2.1.7.
- **20.2.9 Monitoring/Supervision.** Supervision shall be provided in accordance with 6.2.1.11.

### 20.3 Indoor Storage.

- **20.3.1 Floors.** Floors shall be in accordance with 6.2.1.10.
- **20.3.2 Detached Storage.** Detached storage shall be provided for Class 3 and Class 2, deflagrating water-reactive solids and liquids when required by 6.2.2.2, 6.2.3.4, 6.2.4.4, or 6.2.4.5.

# 20.4 Outdoor Storage.

- **20.4.1 Exposures.** Outdoor storage of water-reactive solids or liquids shall be separated from exposure hazards in accordance with 20.4.1.
- **20.4.1.1 Clearance from Combustibles.** Clearance from combustible materials shall be in accordance with 6.2.7.1.
- **20.4.1.2 Location.** The outdoor storage area for Class 3 water-reactive solids and liquids shall not be within 75 ft (23 m) of buildings, property lines, streets, alleys, public ways, or means of egress to a public way.
- **20.4.1.2.1** Class 1 and 2 Materials. The outdoor storage area for Class 1 and Class 2 water-reactive solids and liquids shall not be within 20 ft (6.1 m) of buildings, property lines, streets, alleys, public ways, or means of egress to a public way, except as provided in 20.4.1.3.
- **20.4.1.3 Distance Reduction.** An unpierced 2-hour fireresistive wall extending not less than 30 in. (762 mm) above and to the side of the storage area shall be permitted in lieu of the distance specified in 20.4.1.2.
- **20.4.2 Weather Protection.** When provided, weather protection shall be in accordance with 5.1.2 and 6.2.7.2.

# 20.4.3 Special Requirements.

- **20.4.3.1 Pile Size Limits.** Pile sizes for water-reactive solids and liquids shall be limited as follows:
- (1) Class 3 water-reactive solids and liquids shall be limited to piles not greater than 100 ft<sup>3</sup> (2.83 m<sup>3</sup>).
- (2) Class 1 or Class 2 water-reactive solids and liquids shall be limited to piles not greater than 1000 ft<sup>3</sup> (28.3 m<sup>3</sup>).
- **20.4.3.2 Aisles.** Aisle widths between piles shall not be less than one-half the height of the pile or 10 ft (3 m), whichever is greater.

#### 20.5 General Requirements for Use.

**20.5.1 Spill Control.** Spill control shall be provided for water-reactive liquids in accordance with 6.3.1.4.

- **20.5.2 Drainage.** When provided, drainage shall be in accordance with 6.3.1.4.2.10.
- **20.5.3 Secondary Containment.** Secondary containment shall be provided for water-reactive solids or liquids in accordance with 6.3.1.4.2.
- **20.5.3.1** Secondary containment areas in outdoor areas subject to rainfall shall be designed with a means to prevent water from entering the area of containment or otherwise limited to prevent an uncontrolled reaction with water-reactive materials that might enter the area of containment.
- **20.5.4 Ventilation.** Ventilation shall be provided for open containers in accordance with 6.3.2.1.3 and 6.3.2.2.2.
- **20.5.5 Fire Protection System.** An automatic fire sprinkler system shall be provided in accordance with 6.3.2.1.1.
- **20.5.6 Explosion Control.** Explosion control shall be provided for Class 3 and Class 2, deflagrating water-reactives in accordance with 6.3.2.1.4.
- **20.5.7 Emergency and Standby Power.** Standby power shall be provided when required by 6.3.1.3.
- **20.5.8 Limit Controls.** Limit controls shall be provided in accordance with 6.3.1.2.
- **20.5.9 Monitoring/Supervision.** Supervision shall be provided in accordance with 6.3.1.8.
- **20.5.10 Clearance** from Combustibles. Clearance from combustible materials shall be in accordance with 6.2.7.1.
- **20.5.11 Floors.** Floors where water-reactive solids or liquids are dispensed or used in open systems shall be in accordance with 6.3.2.2.3.
- 20.5.12 System Design. System design shall be in accordance with 6.3.1.6.
- **20.5.13 Liquid Transfer.** Liquid transfer shall be in accordance with 6.3.1.7.
- 20.6 Indoor Use.
- 20.6.1 Open Systems.
- **20.6.1.1 Ventilation.** Ventilation shall be provided in accordance with 6.3.2.2.2.
- **20.6.1.2 Explosion Control.** Explosion control shall be provided for Class 3 and Class 2, deflagrating water-reactives in accordance with 6.3.2.1.4.
- **20.6.1.3 Spill Control, Drainage, and Containment.** Secondary containment shall be provided for water-reactive liquids in accordance with 6.3.2.2.4.
- **20.6.1.3.1\*** Secondary containment used for Class 2 or Class 3 water-reactive solids and liquids in outdoor areas subject to rainfall shall be designed to prevent water from accumulating in the area of containment.
- 20.6.2 Closed Systems.
- **20.6.2.1 Ventilation.** The requirements of 6.3.2.3.2 shall not apply.
- **20.6.2.2 Explosion Control.** Explosion control shall be provided for Class 3 and Class 2, deflagrating water-reactives in accordance with 6.3.2.1.4.

- **20.6.2.3 Spill Control, Drainage, and Containment.** Spill control and secondary containment shall be provided for water-reactive liquids in accordance with 6.3.2.2.4.
- **20.6.2.3.1\*** Secondary containment used for Class 2 or Class 3 water-reactive solids and liquids in outdoor areas subject to rainfall shall be designed to prevent water from accumulating in the area of containment.

#### 20.7 Outdoor Use.

# 20.7.1 Open Systems.

- **20.7.1.1 Location.** Outdoor use and dispensing shall be located in accordance with 6.3.3.1.1.
- **20.7.1.2** Spill Control, Drainage, and Containment. Spill control and secondary containment shall be provided for water-reactive liquids in accordance with 6.3.3.1.2.
- **20.7.1.2.1\*** Secondary containment used for Class 2 or Class 3 water-reactive solids and liquids in outdoor areas subject to rainfall shall be designed to prevent water from accumulating in the area of containment.
- **20.7.1.3 Clearance from Combustibles.** Clearance from combustible materials shall be in accordance with 6.3.3.1.2.

# 20.7.2 Closed Systems.

- **20.7.2.1 Location.** Outdoor use and dispensing shall be located in accordance with 6.3.3.1.1.
- **20.7.2.2 Spill Control, Drainage, and Containment.** Spill control and secondary containment shall be provided for water-reactive liquids in accordance with 6.3.3.3.2.
- **20.7.2.3 Clearance from Combustibles.** Clearance from combustible material shall be provided in accordance with 6.3.3.1.2.
- **20.8 Handling.** Handling of water-reactive solids or liquids in indoor and outdoor areas shall be in accordance with Section 20.8.
- **20.8.1 Handling.** Handling shall be in accordance with 6.3.4.

# Chapter 21 Storage, Use, and Handling of Compressed Gases and Cryogenic Fluids

#### 21.1 General Provisions.

- **21.1.1 Applicability.** This chapter shall apply to the installation, storage, use, and handling of compressed gases and cryogenic fluids in portable and stationary cylinders, containers, equipment, and tanks in all occupancies. [55:1.1.1]
- **21.1.1.1** The requirements in this chapter shall apply to users, producers, distributors, and others who are involved with the storage, use, or handling of compressed gases or cryogenic fluids. [55:1.3]

# 21.1.1.2 Specific Applications.

- **21.1.1.2.1** This chapter shall not apply to the following:
- (1)\* Off-site transportation of [compressed gases or cryogenic fluids]
- (2) Storage, use, and handling of radioactive gases in accordance with NFPA 801

- (3)\* Use and handling of medical compressed gases at health care facilities in accordance with NFPA 99
- (4) Systems consisting of cylinders of oxygen and cylinders of fuel gas used for welding and cutting in accordance with NFPA 51
- (5)\* Flammable gases used as a vehicle fuel when stored on a vehicle
- (6)\* Storage, use, and handling of liquefied and nonliquefied compressed gases in laboratory work areas that are in accordance with NFPA 45
- (7) Storage, use, and handling of liquefied petroleum gases in accordance with NFPA 58
- (8) Storage, use, and handling of compressed gases within closed-cycle refrigeration systems complying with the mechanical code
- (9) Liquefied natural gas (LNG) storage at utility plants under NFPA 59A
- (10) Compressed natural gas (CNG) and liquefied natural gas (LNG) utilized as a vehicle fuel in accordance with NFPA 52
- (11)\* Compressed hydrogen gas (GH<sub>2</sub>), or liquefied hydrogen gas (LH<sub>2</sub>) generated, installed, stored, piped, used, or handled in accordance with NFPA 2 when there are no specific or applicable requirements in NFPA 55
- (12) Nonflammable mixtures of ethylene oxide with other chemicals
- (13) Ethylene oxide in chambers 10 scf (0.283 Nm³) or less in volume, or for containers holding 7.05 oz (200 g) of ethylene oxide or less

**[55:**1.1.2]

#### 21.1.2 Hazardous Materials Classification.

- **21.1.2.1 Hazard Classification Pure Gases.** Compressed gases and cryogenic fluids shall be classified according to hazard categories in accordance with Section 4.1.
- **21.1.2.2 Other Hazards.** Although it is possible that there are other known hazards, the classification of such gases is not within the scope of this code and they shall be handled, stored, or used as an *other gas.* [55:5.1.2]
- **21.1.2.3 Mixtures.** Mixtures shall be classified in accordance with the hazards of the mixture as a whole. [55:5.1.3]
- **21.1.2.4 Responsibility for Classification.** Classification shall be performed by an approved organization, individual, or testing laboratory. [55:5.1.4]
- **21.1.2.5 Toxicity.** The toxicity of gas mixtures shall be classified in accordance with CGA P-20, *Standard for the Classification of Toxic Gas Mixtures*, or by testing in accordance with the requirements of 29 CFR 1910.1000 or DOT 49 CFR 173 or ISO 10298, *Determination of toxicity of a gas or gas mixture*. [55:5.1.4.1]
- 21.1.2.6 Flammability of Gas Mixtures. For gas mixtures other than those containing ammonia and nonflammable gases, flammability of gas mixtures shall be classified in accordance with CGA P-23, Standard for Categorizing Gas Mixtures Containing Flammable and Nonflammable Components; or by physical testing in accordance with ASTM E681, Standard Test Method for Concentration Limits of Flammability of Chemicals (Vapors and Gases); or ISO 10156, Gases and gas mixtures determination of fire potential and oxidizing ability for the selection of cylinder valve outlets. [55:5.1.4.2]

#### 21.2 Building-Related Controls.

#### 21.2.1 General.

- **21.2.1.1 Occupancy.** Occupancies containing compressed gases and cryogenic fluids shall comply with this chapter in addition to other applicable requirements of this code. [55:6.1.1.1]
- **21.2.1.1.1 Occupancy Classification.** The occupancy of a building or structure, or portion of a building or structure, shall be classified in accordance with 1.1.1.1. [55:6.1.1.2]
- **21.2.1.2** Flammable and Oxidizing Gases. [55:6.3.1.6]
- **21.2.1.2.1** Flammable and oxidizing gases shall not be stored or used in other than industrial and storage occupancies. [55:6.3.1.6.1]
- **21.2.1.2.2** Cylinders, containers, or tanks not exceeding 250 scf (7.1 Nm<sup>3</sup>) content at normal temperature and pressure (NTP) and used for maintenance purposes, patient care, or operation of equipment shall be permitted. [55:6.3.1.6.2]
- **21.2.1.3 Toxic and Highly Toxic Compressed Gases.** Except for containers or cylinders not exceeding 20 scf (0.6 Nm³) content at NTP stored or used within gas cabinets or exhausted enclosures of educational occupancies, toxic or highly toxic compressed gases shall not be stored or used in other than industrial and storage occupancies. [55:6.3.1.7]

#### 21.2.2 Control Areas.

- **21.2.2.1 Construction.** Control areas shall be separated from each other by fire barriers in accordance with Table 5.2.2.1. [55:6.2.1]
- **21.2.2.2 Number.** The number of control areas in buildings or portions of buildings shall be in accordance with 5.2.2.1.
- △ 21.2.2.3 Quantities Less than or Equal to the MAQ. Building-related controls in areas with compressed gases or cryogenic fluids stored or used within an indoor control area in quantities less than or equal to those shown in Table 5.2.1.2.1 shall be in accordance with 21.2.1.2, 21.2.1.3, 21.2.7, 21.2.8, 21.2.12, 21.2.15, and 21.2.16.

# 21.2.3 Occupancy Protection Levels.

- 21.2.3.1 Quantity Thresholds for Compressed Gases and Cryogenic Fluids Requiring Special Provisions. Where the quantities of compressed gases or cryogenic fluids stored or used within an indoor control area exceed those shown in Table 5.2.1.1.3 and Table 5.2.1.2.1, the area shall meet the requirements for Protection Levels 1 through 5 in accordance with the building code, based on the requirements of 21.2.3.2. [55:6.3.1.1]
- **21.2.3.1.1 Quantities Greater than the MAQ.** Building-related controls in areas with compressed gases or cryogenic fluids stored or used within an indoor area in quantities greater than those shown in Table 5.2.1.1.3 and Table 5.2.1.2.1 shall be in accordance with Section 21.2.
- **21.2.3.1.2 Incompatible Materials.** When the classification of materials in individual containers requires the area to be placed in more than one protection level, the separation of protection levels shall not be required, provided the area is constructed to meet the requirements of the most restrictive

protection level and that the incompatible materials are separated as required by 21.3.1.7.2. [55:6.3.1.4]

- **21.2.3.1.3 Multiple Hazards.** Where a compressed gas or cryogenic fluid has multiple hazards, all hazards shall be addressed and controlled in accordance with the provisions for the protection level for which the threshold quantity is exceeded. [55:6.3.1.5]
- **21.2.3.2 Classification of Protection Levels.** The protection level required shall be based on the hazard class of the material involved as indicated in 21.2.3.2.1 through 21.2.3.2.4. [55:6.3.2]
- **21.2.3.2.1 Protection Level 1.** Occupancies used for the storage or use of unstable reactive Class 4 and unstable reactive Class 3 detonable compressed gases in quantities that exceed the quantity thresholds for gases requiring special provisions shall be classified Protection Level 1. [55:6.3.2.1]
- **21.2.3.2.2 Protection Level 2.** Occupancies used for the storage or use of flammable, pyrophoric, and nondetonable, unstable reactive Class 3 compressed gases or cryogenic fluids in quantities that exceed the quantity thresholds for gases requiring special provisions shall be classified as Protection Level 2. [55:6.3.2.2]
- **21.2.3.2.3 Protection Level 3.** Occupancies used for the storage or use of oxidizing, and unstable reactive Class 2 compressed gases or cryogenic fluids in quantities that exceed the quantity thresholds for gases requiring special provisions shall be classified as Protection Level 3. [55:6.3.2.3]
- **21.2.3.2.4 Protection Level 4.** Occupancies used for the storage or use of toxic, highly toxic, and corrosive compressed gases in quantities that exceed the quantity thresholds for gases requiring special provisions shall be classified as Protection Level 4. [55:6.3.2.4]
- **21.2.3.2.5 Protection Level 5.** Buildings and portions thereof used for fabrication of semiconductors or semiconductor research and development and containing quantities of hazardous materials exceeding the maximum allowable quantities of high-hazard level 5 contents permitted in control areas shall be classified as Protection Level 5. [**55:**6.3.2.5]
- **21.2.4 Gas Rooms.** Where a gas room is used to increase the threshold quantity for a gas requiring special provisions or where otherwise required by the material or application-specific requirements of Chapters 7 through 15 of NFPA 55, the room shall meet the requirements of 21.2.4.1 through 21.2.4.5.[55:6.4]
- **21.2.4.1 Pressure Control.** Gas rooms shall operate at a negative pressure in relationship to the surrounding area. [55:6.4.1]
- **21.2.4.2 Exhaust Ventilation.** Gas rooms shall be provided with an exhaust ventilation system. [55:6.4.2]
- **21.2.4.3 Construction.** Gas rooms shall be constructed in accordance with the building code. [55:6.4.3]
- **21.2.4.4 Separation.** Gas rooms shall be separated from other occupancies by a minimum of 1-hour fire resistance. [55:6.4.4]
- **21.2.4.5 Limitation on Contents.** The function of compressed gas rooms shall be limited to storage and use of compressed gases and associated equipment and supplies. [55:6.4.5]

21.2.5\* Detached Buildings. Occupancies used for the storage or use of compressed gases, including individual bulk hydrogen compressed gas systems in quantities exceeding those specified in Table 21.2.5, shall be in detached buildings constructed in accordance with the provisions of the building code. [55:6.5]

#### **21.2.6 Weather Protection.** [**55**:6.6]

- **21.2.6.1** For other than explosive materials and hazardous materials presenting a detonation hazard, a weather protection structure shall be permitted to be used for sheltering outdoor storage or use areas, without requiring such areas to be classified as indoor storage or use. [55:6.6.1]
- **21.2.6.1.1** Weather protection shall be constructed in accordance with 6.2.7.2.
- **21.2.7 Electrical Equipment.** Electrical wiring and equipment shall be in accordance with 21.2.7 and *NFPA 70.* [55:6.7]

#### 21.2.7.1 Standby Power.

- **21.2.7.1.1** Where the following systems are required by this code for the storage or use of compressed gases or cryogenic fluids that exceed the quantity thresholds for gases requiring special provisions, such systems shall be connected to a standby power system in accordance with *NFPA 70*:
- (1) Mechanical ventilation
- (2) Treatment systems
- (3) Temperature controls
- (4) Alarms
- (5) Detection systems
- (6) Other electrically operated systems [55:6.7.1, 6.7.1.1]
- **21.2.7.1.2** The requirements of 21.2.7.1 shall not apply where emergency power is provided in accordance with 21.2.7.2 and *NFPA 70.* [55:6.7.1.2]
- **21.2.7.2 Emergency Power.** When emergency power is required, the system shall meet the requirements for a Level 2 system in accordance with NFPA 110. [55:6.7.2]
- **21.2.8\* Employee Alarm System.** Where required by government regulations, an employee alarm system shall be provided to allow warning for necessary emergency action as called for in

- **21.2.9\* Explosion Control.** Explosion control shall be provided as required by Table 21.2.9 in accordance with NFPA 68 or NFPA 69 where amounts of compressed gases in storage or use exceed the quantity thresholds requiring special provisions. [55:6.9]
- **21.2.10\* Fire Protection Systems.** Except as provided in 21.2.10.1, buildings or portions thereof required to comply with Protection Levels 1 through 5 shall be protected by an approved automatic fire sprinkler system complying with NFPA 13. [55:6.10]
- **21.2.10.1** Rooms or areas that are of noncombustible construction with wholly noncombustible contents shall not be required to be protected by an automatic fire sprinkler system. [55:6.10.1]
- **21.2.10.2 Sprinkler System Design.** Where sprinkler protection is required, the area in which compressed gases or cryogenic fluids are stored or used shall be protected with a sprinkler system designed to be not less than that required by 11.2.3.1.1 of NFPA 13 for the Ordinary Hazard Group 2 density/area curve. [**55**:6.10.2.1]
- **21.2.10.2.1** Where sprinkler protection is required, the area in which the flammable or pyrophoric compressed gases or cryogenic fluids are stored or used shall be protected with a sprinkler system designed to be not less than that required by 11.2.3.1.1 of NFPA 13 for the Extra Hazard Group 1 density/area curve. [55:6.10.2.2]
- **21.2.11 Lighting.** Approved lighting by natural or artificial means shall be provided for areas of storage or use. [**55:**6.11]

# 21.2.12 Hazard Identification Signs. [55:6.12]

- **21.2.12.1** Hazard identification signs shall be placed at all entrances to locations where compressed gases are produced, stored, used, or handled in accordance with NFPA 704. [55:6.12.1]
- **21.2.12.1.1** Ratings shall be assigned in accordance with NFPA 704. [55:6.12.1.1]
- **21.2.12.1.2 Identification of Gas Rooms and Cabinets.** Rooms or cabinets containing compressed gases shall be conspicuously labeled as follows:

COMPRESSED GAS [55:4.10.2.3]

- **21.2.1.3.** The authority having jurisdiction shall be permitted to waive 21.2.12.1 where consistent with safety. [55:6.12.1.2]
- **21.2.12.2 Signs.** Signs shall not be obscured or removed. [55:6.12.2.1]
- **21.2.12.3 No Smoking.** Signs prohibiting smoking or open flames within 25 ft (7.6 m) of area perimeters shall be provided in areas where toxic, highly toxic, corrosive, unstable reactive, flammable, oxidizing, or pyrophoric gases are produced, stored, or used. [55:6.12.2.2]
- **21.2.13** Spill Control, Drainage, and Secondary Containment. Spill control, drainage, and secondary containment shall not be required for compressed gases. [55:6.13]
- **21.2.14 Shelving.** [**55:**6.14]
- **21.2.14.1** Shelves used for the storage of cylinders, containers, and tanks shall be of noncombustible construction and designed to support the weight of the materials stored. [55:6.14.1]
- **21.2.14.2** In seismically active areas, shelves and containers shall be secured from overturning. [55:6.14.2]
- **21.2.15 Vent Pipe Termination.** The termination point for piped vent systems serving cylinders, containers, tanks, and gas systems used for the purpose of operational or emergency venting shall be located to prevent impingement exposure on the system served and to minimize the effects of high temperature thermal radiation or the effects of contact with the gas from the escaping plume to the supply system, personnel, adjacent structures, and ignition sources. [55:6.15]
- **21.2.16 Ventilation.** Indoor storage and use areas and storage buildings for compressed gases and cryogenic fluids shall be provided with mechanical exhaust ventilation or fixed natural ventilation, where natural ventilation is shown to be acceptable for the material as stored. [55:6.16]
- **21.2.16.1 Compressed Air.** The requirements of 21.2.16 shall not apply to cylinders, containers, and tanks containing compressed air. [55:6.16.2]
- **21.2.16.2 Mechanical Exhaust Ventilation.** Where mechanical exhaust ventilation is provided, the system shall be operational during the time the building or space is occupied. [55:6.16.3]
- **21.2.16.2.1 Ventilation Rate.** Mechanical exhaust or fixed natural ventilation shall be provided at a rate of not less than  $1 \text{ scf/min/ft}^2$  (0.3048  $\text{Nm}^3/\text{min/m}^2$ ) of floor area over the area of storage or use. [55:6.16.3.2]

- **21.2.16.2.2 Continuous Operation.** When operation of ventilation systems is required, systems shall operate continuously unless an alternative design is approved by the AHJ. [55:6.16.3.1]
- **21.2.16.2.3 Shutoff Controls.** Where powered ventilation is provided, a manual shutoff switch shall be provided outside of the room in a position adjacent to the principal access door to the room or in an approved location. [55:6.16.3.3]
- **21.2.16.2.4 Manual Shutoff Switch.** The switch shall be the breakglass or equivalent type and shall be labeled as follows:

- **21.2.16.3** Inlets to the Exhaust System. [55:6.16.4]
- **21.2.16.3.1** The exhaust ventilation system design shall take into account the density of the potential gases released. [55:6.16.4.1]
- **21.2.16.3.2** For gases that are heavier than air, exhaust shall be taken from a point within 12 in. (305 mm) of the floor. The use of supplemental inlets shall be allowed to be installed at points above the 12 in. (305 mm) threshold level. [55:6.16.4.2]
- **21.2.16.3.3** For gases that are lighter than air, exhaust shall be taken from a point within 12 in. (305 mm) of the ceiling. The use of supplemental inlets shall be allowed to be installed at points below the 12 in. (305 mm) threshold level. [55:6.16.4.3]
- **21.2.16.3.4** The location of both the exhaust and inlet air openings shall be designed to provide air movement across all portions of the floor or ceiling of the room or area to prevent the accumulation of vapors within the ventilated space. [55:6.16.4.4]
- **21.2.16.4 Recirculation of Exhaust.** Exhaust ventilation shall not be recirculated. [**55**:6.16.5]
- **21.2.16.5 Ventilation Discharge.** Ventilation discharge systems shall terminate at a point not less than 50 ft (15 m) from intakes of air-handling systems, air-conditioning equipment, and air compressors. [55:6.16.6]
- **21.2.16.6 Air Intakes.** Storage and use of compressed gases shall be located not less than 50 ft (15 m) from air intakes. For material-specific requirements, see 21.3.4 through 21.3.10. [55:6.16.7]
- **21.2.17 Gas Cabinets.** Where a gas cabinet is required, is used to provide separation of gas hazards, or is used to increase the threshold quantity for a gas requiring special provisions, the gas cabinet shall be in accordance with 21.2.17.1 through 21.2.17.5. [**55:**6.17]
- **21.2.17.1 Construction.** [55:6.17.1]
- **21.2.17.1.1 Materials of Construction.** The gas cabinet shall be constructed of not less than 0.097 in. (2.46 mm) (12 gauge) steel. [55:6.17.1.1]
- **21.2.17.1.2 Access to Controls.** The gas cabinet shall be provided with self-closing limited access ports or noncombustible windows to give access to equipment controls. [55:6.17.1.2]
- **21.2.17.1.3 Self-Closing Doors.** The gas cabinet shall be provided with self-closing doors. [**55:**6.17.1.3]

# **21.2.17.2** Ventilation Requirements. [55:6.17.2]

- **21.2.17.2.1** The gas cabinet shall be provided with an exhaust ventilation system designed to operate at a negative pressure relative to the surrounding area. [55:6.17.2.1]
- **21.2.17.2.2** Where toxic; highly toxic; pyrophoric; unstable, reactive Class 3 or Class 4; or corrosive gases are contained, the velocity at the face of access ports or windows, with the access port or window open, shall not be less than 200 ft/min (61 m/min) average, with not less than 150 ft/min (46 m/min) at any single point. [**55**:6.17.2.2]
- **21.2.17.3 Fire Protection.** Gas cabinets used to contain toxic, highly toxic, or pyrophoric gases shall be internally sprinklered. [55:6.17.3]
- **21.2.17.4 Quantity Limits.** Gas cabinets shall contain not more than three cylinders, containers, or tanks. [55:6.17.4]
- **21.2.17.5 Separation of Incompatibles.** Incompatible gases, as defined by Table 21.3.1.7.2, shall be stored or used within separate gas cabinets. [**55**:6.17.5]
- **21.2.18** Exhausted Enclosures. [55:6.18]
- **21.2.18.1 Ventilation Requirements.** Where an exhausted enclosure is required or used to increase the threshold quantity for a gas requiring special provisions, the exhausted enclosure shall be provided with an exhaust ventilation system designed to operate at a negative pressure in relationship to the surrounding area. [55:6.18.1]
- **21.2.18.1.1 Control Velocity at Access Openings.** Where toxic; highly toxic; pyrophoric; unstable, reactive Class 3 or Class 4; or corrosive gases are contained, the velocity at the face openings providing access shall be not less than 200 ft/min (61 m/min) average, with not less than 150 ft/min (46 m/min) at any single point. [55:6.18.1.1]
- **21.2.18.1.2 Separation of Incompatible Gases Within Enclosures.** Cylinders, containers, and tanks within enclosures shall be separated in accordance with Table 21.3.1.7.2. [**55:**6.18.1.2]
- **21.2.18.1.3 Fire Protection.** Exhausted enclosures shall be internally sprinklered. [55:6.18.1.3]
- **21.2.18.1.4 Separation.** Incompatible gases, as defined by Table 21.3.1.7.2, shall be stored or used within separate exhausted enclosures. [55:6.18.2]
- **21.2.19 Source Valve.** Bulk gas systems shall be provided with a source valve. [55:6.19]
- **21.2.19.1** The source valve shall be marked. [**55:**6.19.1]
- **21.2.19.2** The source valve shall be designated on the design drawings for the installation. [55:6.19.2]
- 21.3 Compressed Gases.
- **21.3.1 General.** The storage, use, and handling of compressed gases in containers, cylinders, and tanks shall be in accordance with Sections 21.1, 21.3, and 21.6 as applicable.
- 21.3.1.1 Compressed Gas Systems. [55:7.1.2]
- **21.3.1.1.1 Design.** Compressed gas systems shall be designed for the intended use and shall be designed by persons competent in such design. [55:7.1.2.1]

- **21.3.1.1.2 Installation.** Installation of bulk compressed gas systems shall be supervised by personnel knowledgeable in the application of the standards for their construction and use. [55:7.1.2.2]
- **21.3.1.2** Cylinders, Containers, and Tanks. [55:7.1.5]
- **21.3.1.2.1 Design and Construction.** Cylinders, containers, and tanks shall be designed, fabricated, tested, and marked (stamped) in accordance with regulations of DOT, Transport Canada (TC) *Transportation of Dangerous Goods Regulations*, or the ASME *Boiler and Pressure Vessel Code*, "Rules for the Construction of Unfired Pressure Vessels," Section VIII. [**55:**7.1.5.1]
- 21.3.1.2.2 Defective Cylinders, Containers, and Tanks. [55:7.1.5.2]
- **21.3.1.2.2.1** Defective cylinders, containers, and tanks shall be returned to the supplier. [55:7.1.5.2.1]
- **21.3.1.2.2.2** Suppliers shall repair the cylinders, containers, and tanks, remove them from service, or dispose of them in an approved manner. [55:7.1.7.2.2]
- **21.3.1.2.2.3** Suppliers shall ensure that defective cylinders, containers, and tanks that have been repaired are evaluated by qualified individuals to verify that the needed repairs and any required testing has been performed and that those repaired or tested are in a serviceable condition before returning them to service. [55:7.1.5.3]
- **21.3.1.2.3 Supports.** Stationary cylinders, containers, and tanks shall be provided with engineered supports of noncombustible material on noncombustible foundations. [55:7.1.5.3]
- **21.3.1.2.4 Cylinders, Containers, and Tanks Containing Residual Gas.** Compressed gas cylinders, containers, and tanks containing residual product shall be treated as full except when being examined, serviced, or refilled by a gas manufacturer, authorized cylinder requalifier, or distributor. [55:7.1.5.4]
- **21.3.1.2.5** Pressure Relief Devices. [55:7.1.5.5]
- **21.3.1.2.5.1** When required by 21.3.1.2.5.2, pressure relief devices shall be provided to protect containers and systems containing compressed gases from rupture in the event of overpressure from thermal exposure. [55:7.1.5.5.1]
- 21.3.1.2.5.2 Pressure relief devices to protect containers shall be designed and provided in accordance with CGA S-1.1, Pressure Relief Device Standards Part 1 Cylinders for Compressed Gases, for cylinders; CGA S-1.2, Pressure Relief Device Standards Part 2 Cargo and Portable Tanks for Compressed Gases, for portable tanks; and CGA S-1.3, Pressure Relief Device Standards Part 3 Stationary Storage Containers for Compressed Gases, for stationary tanks or applicable equivalent requirements in the country of use. [55:7.1.5.5.2]
- **21.3.1.2.5.3** Pressure relief devices shall be sized in accordance with the specifications to which the container was fabricated. [55:7.1.5.5.3]
- **21.3.1.2.5.4** The pressure relief device shall have the capacity to prevent the maximum design pressure of the container or system from being exceeded. [55:7.1.5.5.4]
- **21.3.1.2.5.5** Pressure relief devices shall be arranged to discharge unobstructed to the open air in such a manner as to prevent any impingement of escaping gas upon the container, adjacent structures, or personnel. This requirement shall not

- apply to DOT specification containers having an internal volume of 2.0 ft<sup>3</sup>scf (0.057 Nm<sup>3</sup>) or less. [55:7.1.5.5.5]
- **21.3.1.2.5.6** Pressure relief devices or vent piping shall be designed or located so that moisture cannot collect and freeze in a manner that would interfere with operation of the device. [55:7.1.5.5.6]
- **21.3.1.3 Cathodic Protection.** Where required, cathodic protection shall be in accordance with 21.3.1.3. [55:7.1.6]
- **21.3.1.3.1 Operation.** Where installed, cathodic protection systems shall be operated and maintained to continuously provide corrosion protection. [55:7.1.6.1]
- **21.3.1.3.2 Inspection.** Container systems equipped with cathodic protection shall be inspected for the intended operation by a cathodic protection tester. [55:7.1.6.2]
- **21.3.1.3.2.1** The frequency of inspection shall be determined by the designer of the cathodic protection system. [55:7.1.6.2]
- **21.3.1.3.2.2** The cathodic protection tester shall be certified as being qualified by the National Association of Corrosion Engineers, International (NACE). [55:7.1.6.2.1]
- △ 21.3.1.3.3 Impressed Current Systems. Systems equipped with impressed current cathodic protection systems shall be inspected in accordance with the requirements of design and 21.3.1.3.2. [55:7.1.6.3]
  - **21.3.1.3.3.1** The design limits of the cathodic protection system shall be available to the AHJ upon request. [55:7.1.6.3.1]
  - **21.3.1.3.3.2** The system owner shall maintain the following records to demonstrate that the cathodic protection is in conformance with the requirements of the design:
  - (1) The results of inspections of the system
  - (2) The results of testing that has been completed [55:7.1.6.3.2]

#### 21.3.1.3.4 Corrosion Expert.

- **21.3.1.3.4.1** Repairs, maintenance, or replacement of a cathodic protection system shall be under the supervision of a corrosion expert certified by NACE. [55:7.1.6.4]
- **21.3.1.3.4.2** The corrosion expert shall be certified by NACE as a senior corrosion technologist, a cathodic protection specialist, or a corrosion specialist or shall be a registered engineer with registration in a field that includes education and experience in corrosion control. [**55:**7.1.6.4.1]
- **21.3.1.4** Labeling Requirements. [55:7.1.7]
- **21.3.1.4.1 Containers.** Individual compressed gas cylinders, containers, and tanks shall be marked or labeled in accordance with DOT requirements or those of the applicable regulatory agency. [55:7.1.7.1]
- **21.3.1.4.2 Label Maintenance.** The labels applied by the gas manufacturer to identify the liquefied or nonliquefied compressed gas cylinder contents shall not be altered or removed by the user. [55:7.1.7.2]
- 21.3.1.4.3 Stationary Compressed Gas Cylinders, Containers, and Tanks. [55:7.1.7.3]

- **21.3.1.4.3.1** Stationary compressed gas cylinders, containers, and tanks shall be marked in accordance with NFPA 704. [55:7.1.7.3.1]
- **21.3.1.4.3.2** Markings shall be visible from any direction of approach. [55:7.1.7.3.2]

# **21.3.1.4.4 Piping Systems.** [55:7.1.7.4]

- **21.3.1.4.4.1** Except as provided in 21.3.1.4.4.2, piping systems shall be marked in accordance with ASME A13.1, *Scheme for the Identification of Piping Systems*, or other applicable approved standards as follows:
- Marking shall include the name of the gas and a direction-of-flow arrow.
- (2) Piping that is used to convey more than one gas at various times shall be marked to provide clear identification and warning of the hazard.
- (3) Markings for piping systems shall be provided at the following locations:
  - (a) At each critical process control valve
  - (b) At wall, floor, or ceiling penetrations
  - (c) At each change of direction
  - (d) At a minimum of every 20 ft (6.1 m) or fraction thereof throughout the piping run

#### **[55:**7.1.7.4.1]

**21.3.1.4.4.2** Piping within gas manufacturing plants, gas processing plants, refineries, and similar occupancies shall be marked in an approved manner. [**55:**7.1.7.4.2]

# **21.3.1.5 Security.** [55:7.1.8]

- **21.3.1.5.1 General.** Compressed gas cylinders, containers, tanks, and systems shall be secured against accidental dislodgement and against access by unauthorized personnel. [55:7.1.8.1]
- **21.3.1.5.2 Security of Areas.** Storage, use, and handling areas shall be secured against unauthorized entry. [55:7.1.8.2]

# **21.3.1.5.3 Physical Protection.** [55:7.1.8.3]

- **21.3.1.5.3.1** Compressed gas cylinders, containers, tanks, and systems that could be exposed to physical damage shall be protected. [55:7.1.8.3.1]
- **21.3.1.5.3.2** Guard posts or other means shall be provided to protect compressed gas cylinders, containers, tanks, and systems indoors and outdoors from vehicular damage. (See Section 4.11 of NFPA 55.) [**55:**7.1.8.3.2]
- **21.3.1.5.4 Securing Compressed Gas Cylinders, Containers, and Tanks.** Compressed gas cylinders, containers, and tanks in use or in storage shall be secured to prevent them from falling or being knocked over by corralling them and securing them to a cart, framework, or fixed object by use of a restraint, unless otherwise permitted by 21.3.1.5.4.1 and 21.3.1.5.4.2. [55:7.1.8.4]
- **21.3.1.5.4.1** Compressed gas cylinders, containers, and tanks in the process of examination, servicing, and refilling shall not be required to be secured. [55:7.1.8.4.1]
- **21.3.1.5.4.2** At cylinder-filling plants, authorized cylinder requalifier's facilities, and distributors' warehouses, the nesting of cylinders shall be permitted as a means to secure cylinders. [55:7.1.8.4.2]

### **21.3.1.6 Valve Protection.** [55:7.1.9]

- **21.3.1.6.1 General.** Compressed gas cylinder, container, and tank valves shall be protected from physical damage by means of protective caps, collars, or similar devices. [55:7.1.9.1]
- **21.3.1.6.1.1** Valve protection of individual valves shall not be required to be installed on individual cylinders, containers, or tanks installed on tube trailers or similar transportable bulk gas systems equipped with manifolds that are provided with a means of physical protection that will protect the valves from physical damage when the equipment is in use. Protective systems required by DOT for over the road transport shall provide an acceptable means of protection. [55:7.1.9.1.1]
- **21.3.1.6.1.2** Valve protection of individual valves shall not be required on cylinders, containers, or tanks that comprise bulk or non-bulk gas systems where the containers are stationary, or portable equipped with manifolds, that are provided with physical protection in accordance with Section 4.11 and 7.1.8.3 of NFPA 55 or other approved means. Protective systems required by DOT for over the road transport shall provide an acceptable means of protection. [55:7.1.9.1.1.1]
- **21.3.1.6.2 Valve-Protective Caps.** Where compressed gas cylinders, containers, and tanks are designed to accept valve-protective caps, the user shall keep such caps on the compressed gas cylinders, containers, and tanks at all times, except when empty, being processed, or connected for use. [55:7.1.9.2]

#### **21.3.1.6.3** Valve Outlet Caps or Plugs. [55:7.1.9.3]

- **21.3.1.6.3.1** Gastight valve outlet caps or plugs shall be provided and in place for all full or partially full cylinders, containers, and tanks containing toxic, highly toxic, pyrophoric, or unstable reactive Class 3 or Class 4 gases that are in storage. [55:7.1.9.3.1]
- **21.3.1.6.3.2** Valve outlet caps and plugs shall be designed and rated for the container service pressure. [55:7.1.9.3.2]

#### 21.3.1.7 Separation from Hazardous Conditions. [55:7.1.10]

#### **21.3.1.7.1 General.** [55:7.1.10.1]

- **21.3.1.7.1.1** Compressed gas cylinders, containers, tanks, and systems in storage or use shall be separated from materials and conditions that present exposure hazards to or from each other. [55:7.1.10.1]
- **21.3.1.7.2\* Incompatible Materials.** Gas cylinders, containers, and tanks shall be separated in accordance with Table 21.3.1.7.2. [**55:**7.1.10.2]
- **21.3.1.7.2.1** Subparagraph 21.3.1.7.2 shall not apply to gases contained within closed piping systems. [**55:**.7.1.10.2.1]
- **21.3.1.7.2.2** The distances shown in Table 21.3.1.7.2 shall be permitted to be reduced without limit when compressed gas cylinders, tanks, and containers are separated by a barrier of noncombustible construction that has a fire resistance rating of at least 0.5 hour and interrupts the line of sight between the containers. [55:7.1.10.2.2]
- **21.3.1.7.2.3** The 20 ft (6.1 m) distance shall be permitted to be reduced to 5 ft (1.5 m) where one of the gases is enclosed in a gas cabinet or without limit where both gases are enclosed in gas cabinets. [55:7.1.10.2.3]

**21.3.1.7.2.4** Cylinders without pressure relief devices shall not be stored without separation from flammable and pyrophoric gases with pressure relief devices. [55:7.1.10.2.4]

**21.3.1.7.2.5** Spatial separation shall not be required between cylinders deemed to be incompatible in gas production facilities where cylinders are connected to manifolds for the purposes of filling, analysis of compressed gases, or manufacturing procedures, assuming the prescribed controls for the manufacture of gas mixtures are in place. [55:7.1.10.2.5]

**21.3.1.7.3\* Clearance from Combustibles and Vegetation.** Combustible waste, vegetation, and similar materials shall be kept a minimum of 10 ft (3.1 m) from compressed gas cylinders, containers, tanks, and systems. [55:7.1.10.3]

**21.3.1.7.3.1** A noncombustible partition without openings or penetrations and extending sides not less than 18 in. (457 mm) above and to the sides of the storage area shall be permitted in lieu of the minimum distance. [55:7.1.10.3.1]

**21.3.1.7.3.2** The noncombustible partition shall either be an independent structure or the exterior wall of the building adjacent to the storage area. [55:7.1.10.3.2]

**21.3.1.7.4 Ledges, Platforms, and Elevators.** Compressed gas cylinders, containers, and tanks shall not be placed near elevators, unprotected platform ledges, or other areas where compressed gas cylinders, containers, or tanks could fall for distances exceeding one-half the height of the cylinder, container, or tank. [55:7.1.10.4]

**21.3.1.7.5 Temperature Extremes.** Compressed gas cylinders, containers, and tanks, whether full or partially full, shall not be exposed to temperatures exceeding 125°F (52°C) or subambient (low) temperatures unless designed for use under such exposure. [**55:**7.1.10.5]

**21.3.1.7.6 Falling Objects.** Compressed gas cylinders, containers, and tanks shall not be placed in areas where they are capable of being damaged by falling objects. [55:7.1.10.6]

**21.3.1.7.7 Heating.** Compressed gas cylinders, containers, and tanks, whether full or partially full, shall not be heated by devices that could raise the surface temperature of the cylinder, container, or tank to above 125°F (52°C). [**55:7.1.10.7**]

**21.3.1.7.7.1 Electrically Powered Heating Devices.** Electrical heating devices shall be in accordance with *NFPA 70*. [55:7.1.10.7.1]

**21.3.1.7.7.2 Fail-Safe Design.** Devices designed to maintain individual compressed gas cylinders, containers, and tanks at constant temperature shall be designed to be fail-safe. [55:7.1.10.7.2]

**21.3.1.7.8 Sources of Ignition.** Open flames and high-temperature devices shall not be used in a manner that creates a hazardous condition. [55:7.1.10.8]

**21.3.1.7.9 Exposure to Chemicals.** Compressed gas cylinders, containers, and tanks shall not be exposed to corrosive chemicals or fumes that could damage cylinders, containers, tanks, or valve-protective caps. [55:7.1.10.9]

**21.3.1.7.10** Exposure to Electrical Circuits. Compressed gas cylinders, containers, and tanks shall not be placed where they could become a part of an electrical circuit. [55:7.1.10.10]

**21.3.1.8 Service and Repair.** Service, repair, modification, or removal of valves, pressure relief devices, or other compressed gas cylinder, container, or tank appurtenances shall be performed by trained personnel and with the permission of the container owner. [55:7.1.11]

**21.3.1.9 Unauthorized Use.** Compressed gas cylinders, containers, and tanks shall not be used for any purpose other than to serve as a vessel for containing the product for which it was designed. [55:7.1.12]

**21.3.1.10 Cylinders, Containers, and Tanks Exposed to Fire.** Compressed gas cylinders, containers, and tanks exposed to fire shall not be used or shipped while full or partially full until they are requalified in accordance with the pressure vessel code under which they were manufactured. [55:7.1.13]

21.3.1.11 Leaks, Damage, or Corrosion. [55:7.1.14]

**21.3.1.11.1 Removal from Service.** Leaking, damaged, or corroded compressed gas cylinders, containers, and tanks shall be removed from service. [55:7.1.14.1]

**21.3.1.11.2 Replacement and Repair.** Leaking, damaged, or corroded compressed gas systems shall be replaced or repaired. [55:7.1.14.2]

- 21.3.1.11.3\* Handling of Cylinders, Containers, and Tanks Removed from Service. Compressed gas cylinders, containers, and tanks that have been removed from service shall be handled in an approved manner. [55:7.1.14.3]
- **21.3.1.11.4 Leaking Systems.** Compressed gas systems that are determined to be leaking, damaged, or corroded shall be repaired to a serviceable condition or shall be removed from service. [55:7.1.14.4]
- **21.3.1.12 Surfaces.** [**55**:7.1.15]
- **21.3.1.12.1** To prevent bottom corrosion, cylinders, containers, and tanks shall be protected from direct contact with soil or surfaces where water might accumulate. [55:7.1.15.1]
- **21.3.1.12.2** Surfaces shall be graded to prevent accumulation of water. [**55:**7.1.15.2]
- **21.3.1.13 Storage Area Temperature.** [55:7.1.16]
- **21.3.1.13.1 Compressed Gas Containers.** Storage area temperatures shall not exceed 125°F (52°C). [**55:**7.1.16.1]
- **21.3.1.14** Underground Piping. [55:7.1.17]
- **21.3.1.14.1** Underground piping shall be of welded construction without valves, unwelded mechanical joints, or connections installed underground. [55:7.1.17.1]
- **21.3.1.14.1.1** Valves or connections located in boxes or enclosures shall be permitted to be installed underground when such boxes or enclosures are accessible from above ground and where the valves or connections contained are isolated from direct contact with earth or fill. [55:7.1.17.1.1]
- **21.3.1.14.1.2** Valve boxes or enclosures installed in areas subject to vehicular traffic shall be constructed to resist uniformly distributed and concentrated live loads in accordance with the building code, for areas designated as vehicular driveways and yards, subject to trucking. [55:7.1.17.1.1.1]
- **21.3.1.14.1.3\*** Piping installed in trench systems located below grade where the trench is open to above shall not be considered to be underground. [55:7.1.17.1.2]
- **21.3.1.14.2** Gas piping in contact with earth or other material that could corrode the piping shall be protected against corrosion in an approved manner. [55:7.1.17.2]
- **21.3.1.14.2.1** When cathodic protection is provided, it shall be in accordance with 21.3.1.3. [55:7.1.17.2.1]
- **21.3.1.14.3** Underground piping shall be installed on a bedding of at least 6 in. (150 mm) of well-compacted backfill material. [**55**:7.1.17.3]

- 21.3.2.1.2 Upright Storage Flammable Gas in Solution and Liquefied Flammable Gas. Cylinders, containers, and tanks containing liquefied flammable gases and flammable gases in solution shall be positioned in the upright position. [55:7.2.1.2]
- **21.3.2.1.2.1 Cylinders and Containers of 1.3 Gal (5 L) or Less.** Containers with a capacity of 1.3 gal (5 L) or less shall be permitted to be stored in a horizontal position. [**55:**7.2.1.2.1]
- 21.3.2.1.2.2 Cylinders, Containers, and Tanks Designed for Horizontal Use. Cylinders, containers, and tanks designed for use in a horizontal position shall be permitted to be stored in a horizontal position. [55:7.2.1.2.2]
- **21.3.2.1.2.3 Palletized Cylinders, Containers, and Tanks.** Cylinders, containers, and tanks, with the exception of those containing flammable liquefied compressed gases, that are palletized for transportation purposes shall be permitted to be stored in a horizontal position. [55:7.2.1.2.3]
- 21.3.2.1.3 Classification of Weather Protection as an Indoor Versus Outdoor Area. For other than explosive materials and hazardous materials presenting a detonation hazard, a weather protection structure shall be permitted to be used for sheltering outdoor storage or use areas, without requiring such areas to be classified as indoor storage. - **21.3.3.1.1 Applicability.** The use and handling of compressed gas cylinders, containers, tanks, and systems shall be in accordance with 21.3.3.1. [55:7.3.1.1]
- **21.3.3.1.2 Controls.** [55:7.3.1.2]
- **21.3.3.1.2.1** Compressed gas system controls shall be designed to prevent materials from entering or leaving the process at an unintended time, rate, or path. [55:7.3.1.2.1]
- **21.3.3.1.2.2** Automatic controls shall be designed to be fail-safe. [55:7.3.1.2.2]
- **21.3.3.1.3 Piping Systems.** Piping, tubing, fittings, and related components shall be designed, fabricated, and tested in accordance with the requirements of the applicable parts of ASME B31.3, *Process Piping*, or other approved standards. [55:7.3.1.3]
- **21.3.3.1.3.1 Integrity.** Piping, tubing, pressure regulators, valves, and other apparatus shall be kept gastight to prevent leakage. [55:7.3.1.3.1]
- **21.3.3.1.3.2 Backflow Prevention.** Backflow prevention or check valves shall be provided when the backflow of hazardous materials could create a hazardous condition or cause the unauthorized discharge of hazardous materials. [55:7.3.1.3.2]

- **21.3.3.1.4.1** Valves utilized on compressed gas systems shall be designed for the gas or gases and pressure intended and shall be accessible. [55:7.3.1.4.1]
- **21.3.3.1.4.2** Valve handles or operators for required shutoff valves shall not be removed or otherwise altered to prevent access. [55:7.3.1.4.2]
- **21.3.3.1.5** Vent Pipe Termination. [55:7.3.1.5]
- **21.3.3.1.5.1** Venting of gases shall be directed to an approved location. [55:7.3.1.5.1]
- **21.3.3.1.5.2** The termination point for piped vent systems serving cylinders, containers, tanks, and gas systems used for the purpose of operational or emergency venting shall be in accordance with 21.2.15. [**55:**7.3.1.5.2]

- **21.3.3.1.11.1** Accessible manual or automatic emergency shutoff valves shall be provided to shut off the flow of gas in case of emergency. [55:7.3.1.11.1]
- (A)\* Manual emergency shutoff valves or the device that activates an automatic emergency shutoff valve on a bulk source or piping system serving the bulk supply shall be identified by means of a sign. [55:7.3.1.11.1.1]

- **21.3.3.3.2.1** Cylinders, containers, and tanks shall be moved using an approved method. [55:7.3.3.2.1]
- **21.3.3.3.2.2** Where cylinders, containers, or tanks are moved by hand cart, hand truck, or other mobile device, such carts, trucks, or devices shall be designed for the secure movement of cylinders, containers, or tanks. [55:7.3.3.2.2]
- **21.3.3.3.3 Lifting Devices.** Ropes, chains, or slings shall not be used to suspend compressed gas cylinders, containers, and tanks unless provisions at time of manufacture have been made on the cylinder, container, or tank for appropriate lifting attachments, such as lugs. [55:7.3.3.3]

- **21.3.5.3.4 Treatment Systems.** Treatment systems, except as provided for in 21.3.5.3.4.1, gas cabinets, exhausted enclosures, and gas rooms containing corrosive gases in use shall be provided with exhaust ventilation, with all exhaust directed to a treatment system designed to process the accidental release of gas. - **21.3.6.1.1** The storage or use of flammable gases exceeding the quantity thresholds for gases requiring special provisions as specified in Table 5.2.1.1.3 and Table 5.2.1.2.1 shall be in accordance with Sections 21.1 and 21.2, 21.3.1 through 21.3.3, and 21.3.6. [55:7.6.1.1]

- **21.3.6.2.1** Bulk gas systems for flammable gases other than hydrogen shall be in accordance with Table 10.3.2.1(a), Table 10.3.2.1(b), or Table 3.2.1(c) of NFPA 55 where the quantity of

- three sides with connecting angles of approximately 135 degrees (2.36 rad). [55:7.9.2.2.1.4]
- **21.3.9.2.2.2** Where the storage or use area is located closer than 23 m (75 ft) to a building not associated with the manufacture or distribution of toxic or highly toxic compressed gases, openings in the building other than for piping shall not be permitted above the height of the top of the 2-hour fire barrier wall or within 50 ft (15 m) horizontally from the storage area, regardless of whether the openings are shielded by a fire barrier. [**55:**7.9.2.2.2]
- **21.3.9.2.3 Air Intakes.** Storage and use of toxic or highly toxic compressed gases shall not be located within 75 ft (23 m) of air intakes. [55:7.9.2.3]
- **21.3.9.3 Treatment Systems.** Except as provided in 21.3.9.3.1 and 21.3.9.3.2, gas cabinets, exhausted enclosures, and gas rooms containing toxic or highly toxic gases shall be provided with exhaust ventilation, with all exhaust directed to a treatment system designed to process accidental release of gas. - **21.3.9.3.1 Storage of Toxic or Highly Toxic Gases.** Treatment systems shall not be required for toxic or highly toxic gases in storage where cylinders, containers, and tanks are provided with the controls specified in 21.3.9.3.1.1 through 21.3.9.3.1.3. [55:7.9.3.1]
- **21.3.9.3.1.1 Valve Outlets Protected.** Valve outlets shall be equipped with outlet plugs or caps, or both, rated for the container service pressure. [55:7.9.3.1.1]
- **21.3.9.3.1.2 Handwheels** Secured. Where provided, handwheel-operated valves shall be secured to prevent movement. [55:7.9.3.1.2]
- **21.3.9.3.1.3 Containment Devices Provided.** Approved cylinder containment vessels or cylinder containment systems shall be provided at an approved location. [55:7.9.3.1.3]
- **21.3.9.3.2 Use of Toxic Gases.** Treatment systems shall not be required for toxic gases in use where containers, cylinders, and tanks are provided with the controls specified in 21.3.9.3.2.1 and 21.3.9.3.2.2. [**55:**7.9.3.2]
- **21.3.9.3.2.1 Gas Detection.** [55:7.9.3.2.1]
- (A) A gas detection system with a sensing interval not exceeding 5 minutes shall be provided. [55:7.9.3.2.1.1]
- **(B)** The gas detection system shall monitor the exhaust system at the point of discharge from the gas cabinet, exhausted enclosure, or gas room. [55:7.9.3.2.1.2]
- **21.3.9.3.2.2 Fail-Safe Automatic Closing Valve.** An approved automatic-closing fail-safe valve shall be located on or immediately adjacent to and downstream of active cylinder, container, or tank valves. [55:7.9.3.2.2]

- (A)\* Where source cylinders, containers, and tanks are used in attended process operations, with an operator present at the enclosure where the activity occurs, the volume of the release shall be limited to the estimated amount released from the process piping system within a period not to exceed 5 minutes. - (5) *Piping System Accessibility*. Piping systems shall be designed to provide for readily accessible manual shutdown controls.

**21.3.9.4.2 Containment Vessels or Systems.** Where containment vessels or containment systems are provided, they shall comply with 21.3.9.4.2.1 through 21.3.9.4.2.3. [55:7.9.4.2]

**21.3.9.4.2.1 Performance.** Containment vessels or containment systems shall be capable of fully containing or terminating a release. [55:7.9.4.2.1]

**21.3.9.4.2.2 Personnel.** Trained personnel capable of operating the containment vessel or containment system shall be available at an approved location. [55:7.9.4.2.2]

**21.3.9.4.2.3 Location.** Containment vessels or systems shall be capable of being transported to the leaking cylinder, container, or tank. [55:7.9.4.2.3]

**21.3.9.5** Emergency Power. [55:7.9.5]

**21.3.9.5.1 General.** Emergency power shall comply with 21.3.9.5 in accordance with *NFPA 70.* [55:7.9.5.1]

**21.3.9.5.2 Alternative to Emergency Power.** Emergency power shall not be required where fail-safe engineering is provided for mechanical exhaust ventilation, treatment systems, and temperature control, and standby power is provided to alternative systems that utilize electrical energy. [55:7.9.5.2]

**21.3.9.5.3 Where Required.** Emergency power shall be provided for the following systems:

- (1) Exhaust ventilation
- (2) Treatment system
- (3) Gas detection system
- (4) Temperature control system

**21.3.9.5.4 Level.** Emergency power systems shall comply with the requirements for a Level 2 system in accordance with NFPA 110. [**55:**7.9.5.4]

- **21.3.10.3.1** Unstable reactive Class 3 compressed gases stored in cylinders, containers, or tanks shall be arranged to limit individual groups of cylinders, containers, or tanks to areas not exceeding 100 ft<sup>2</sup> (9.3 m<sup>2</sup>). [**55:**7.10.3.1]
- **21.3.10.3.2** Multiple areas shall be separated by aisles. [55:7.10.3.2]
- **21.3.10.3.3** Asile widths shall not be less than the height of the cylinders, containers, or tanks or 4 ft (1.2 m), whichever is greater. [55:7.10.3.3]
- **21.3.10.4 Basements.** Unstable reactive compressed gases shall not be stored in basements. [55:7.10.4]
- 21.3.10.5 Unstable Reactive Gases (Detonable). [55:7.10.5]

- **21.3.10.5.2 Location.** The location of storage areas shall be determined based on the requirements of the building code for explosive materials. [55:7.10.5.2]
- 21.4 Cryogenic Fluids.
- **21.4.1 General.** This section shall apply to all cryogenic fluids, including those fluids regulated elsewhere in this code, except that when specific requirements are provided in Sections 21.5 or 21.7, those specific requirements shall apply as applicable. [55:8.1]
- **21.4.1.1** Storage, use, and handling of cryogenic fluids shall be in accordance with Sections 21.1, 21.2, and 21.4 as applicable. [55:8.1.1]
- **21.4.1.2** Storage, use and handling of inert cryogenic fluids shall be in accordance with CGA P-18, *Standard for Bulk Inert Gas Systems*, [55:8.1.2]

- **21.4.2\* Containers Design, Construction, and Maintenance.** Containers employed for the storage or use of cryogenic fluids shall be designed, fabricated, tested, marked (stamped), and maintained in accordance with DOT regulations; Transport Canada (TC) *Transportation of Dangerous Goods Regulations*; the ASME *Boiler and Pressure Vessel Code*, "Rules for the Construction of Unfired Pressure Vessels"; or regulations of other administering agencies. [**55:**8.2]
- **21.4.2.1 Aboveground Tanks.** Aboveground tanks for the storage of cryogenic fluids shall be in accordance with 21.4.2.1. [55:8.2.1]
- **21.4.2.1.1 Construction of the Inner Vessel.** The inner vessel of storage tanks in cryogenic fluid service shall be designed and constructed in accordance with Section VIII, Division 1 of the ASME *Boiler and Pressure Vessel Code* and shall be vacuum jacketed in accordance with 21.4.2.1.2. [55:8.2.1.1]
- 21.4.2.1.2 Construction of the Vacuum Jacket (Outer Vessel). [55:8.2.1.2]
- **21.4.2.1.2.1** The vacuum jacket used as an outer vessel for storage tanks in cryogenic fluid service shall be of welded steel construction designed to withstand the maximum internal and external pressure to which it will be subjected under operating conditions to include conditions of emergency pressure relief of the annular space between the inner and outer vessel. [55:8.2.1.2.1]
- **21.4.2.1.2.2** The jacket shall be designed to withstand a minimum collapsing pressure differential of 30 psi (207 kPa). [55:8.2.1.2.2]

### **21.4.2.1.2.3 Vacuum Level Monitoring.** [55:8.2.1.2.3]

- **(A)** A connection shall be provided on the exterior of the vacuum jacket to allow measurement of the pressure within the annular space between the inner and outer vessel. [55:8.2.1.2.3.1]

- **21.4.2.2.1** Containers, equipment, and devices that are not in compliance with recognized standards for design and construction shall be permitted if approved by the authority having jurisdiction upon presentation of evidence that they are designed and constructed for safe operation. [55:8.2.2.1]
- **21.4.2.2.2** The following data shall be submitted to the authority having jurisdiction with reference to the deviation from the code with the application for approval:
- (1) Type and use of container, equipment, or device
- (2) Material to be stored, used, or transported
- (3) Description showing dimensions and materials used in construction
- (4) Design pressure, maximum operating pressure, and test pressure
- (5) Type, size, and setting of pressure-relief devices [55:8.2.2.2]
- **21.4.2.3 Foundations and Supports.** Stationary tanks shall be provided with concrete or masonry foundations or structural

- steel supports on firm concrete or masonry foundations, and 21.4.2.3.1 through 21.4.2.3.5 also shall apply. [55:8.2.3]
- **21.4.2.3.1 Excessive Loads.** Stationary tanks shall be supported to prevent the concentration of excessive loads on the supporting portion of the shell. [55:8.2.3.1]
- **21.4.2.3.2 Expansion and Contraction.** Foundations for horizontal containers shall be constructed to accommodate expansion and contraction of the container. [55:8.2.3.2]
- **21.4.2.3.3 Support of Ancillary Equipment.** [55:8.2.3.3]
- **21.4.2.3.3.1\*** Foundations shall be provided to support the weight of vaporizers and/or heat exchangers. [55:8.2.3.3.1]
- **21.4.2.3.3.2** Foundations shall be designed to withstand soil and frost conditions as well as the anticipated seismic, snow, wind, and hydrostatic loading under operating conditions. [55:8.2.3.3.2]
- **21.4.2.3.4 Temperature Effects.** Where drainage systems, terrain, or surfaces beneath stationary tanks are arranged in a manner that can subject stationary tank foundations or supports to temperatures below -130°F (-90°C), the foundations or supports shall be constructed of materials that are capable of withstanding the low-temperature effects of cryogenic fluid spillage. [**55:**8.2.3.4]
- **21.4.2.3.5 Corrosion Protection.** Portions of stationary tanks in contact with foundations or saddles shall be painted to protect against corrosion. [**55:**8.2.3.5]
- **21.4.2.4 Pressure-Relief Devices.** [55:8.2.4]
- **21.4.2.4.1 General.** [**55:**8.2.4.1]
- **21.4.2.4.1.1** Pressure-relief devices shall be provided to protect containers and systems containing cryogenic fluids from rupture in the event of overpressure. [55:8.2.4.1.1]
- **21.4.2.4.1.2** Pressure-relief devices shall be designed in accordance with CGA S-1.1, Pressure Relief Device Standards Part 1 Cylinders for Compressed Gases, and CGA S-1.2, Pressure Relief Device Standards Part 2 Cargo and Portable Tanks for Compressed Gases, for portable tanks; and CGA S-1.3, Pressure Relief Device Standards Part 3 Stationary Storage Containers for Compressed Gases, for stationary tanks. [55:8.2.4.1.2]
- **21.4.2.4.2 Containers Open to the Atmosphere.** Portable containers that are open to the atmosphere and are designed to contain cryogenic fluids at atmospheric pressure shall not be required to be equipped with pressure-relief devices. [55:8.2.4.2]
- **21.4.2.4.3 Equipment Other than Containers.** Heat exchangers, vaporizers, insulation casings surrounding containers, vessels, and coaxial piping systems in which liquefied cryogenic fluids could be trapped due to leakage from the primary container shall be provided with a pressure relief device. [55:8.2.4.3]

- **21.4.4.3.1** The nameplate shall be installed on the container in an accessible location. [55:8.4.3.1]
- **21.4.4.3.2** The nameplate shall be marked in accordance with nationally recognized standards. [55:8.4.3.2]

- **21.4.4.4.1** Container inlet and outlet connections, liquid-level limit controls, valves, and pressure gauges shall be identified using one of the following methods:

- Δ 21.4.5.1 Bulk cryogenic fluid systems in medical gas applications at health care facilities shall be in accordance with Section 21.4, 21.1.1.2.1(3), and the material-specific requirements of Section 21.5, as applicable. [55:8.5.1]
- △ 21.4.5.1.1 Bulk cryogenic fluid systems shall be in accordance with the following provisions as applicable:
  - Where located in a court, systems shall be in accordance with 21.4.13.2.7.
  - (2) Where located indoors, systems shall be in accordance with 21.4.13.1.
  - (3) Systems shall be installed by personnel qualified in accordance with CGA M-1, Guide for Medical Gas Supply Systems at Health Care Facilities, or ANSI/ASSE/IAPMO 6015, Bulk Medical Gas Systems Installers.
  - (4) Systems shall be installed in compliance with Food and Drug Administration Current Good Manufacturing Practices as found in 21 CFR 210 and 21 CFR 211

- (7) Tank pressure gauge

- **21.4.5.1.3** Bulk cryogenic fluid system shall be anchored with foundations in accordance with the provisions of CGA M-1, *Guide for Medical Gas Supply Systems at Health Care Facilities.* [55:8.5.1.3]
- **21.4.5.1.4** Bulk cryogenic fluid systems shall consist of the following:
- (1) One or more main supply vessel(s), whose capacity shall be determined after consideration of the customer usage requirements, delivery schedules, proximity of the facility to alternate supplies, and the emergency plan
- (2) A contents gauge on each of the main vessel(s)
- (3) A reserve supply sized for greater than an average day's supply, with the size of vessel or number of cylinders being determined after consideration of delivery schedules, proximity of the facility to alternate supplies, and the facility's emergency plan
- (4) At least two main vessel relief valves and rupture discs installed downstream of a three-way (three-port) valve
- (5) A check valve located in the primary supply piping upstream of the intersection with a secondary supply or reserve supply

- **21.4.5.1.5** Bulk cryogenic fluid reserve supply systems consisting of either a second cryogenic fluid source or a compressed gas source shall include the following:

- **21.4.6.4 Securing of Vaporizers.** Vaporizers, heat exchangers, and similar equipment shall be secured to foundations, and their connecting piping shall be designed and constructed to provide for the effects of expansion and contraction due to temperature changes. [55:8.6.4]
- **21.4.6.5 Physical Protection.** Containers, piping, valves, pressure-relief devices, regulating equipment, and other appurtenances shall be protected against physical damage and tampering. [55:8.6.5]

#### 21.4.7 Separation from Hazardous Conditions. [55:8.7]

- **21.4.7.1 General.** Cryogenic containers and systems in storage or use shall be separated from materials and conditions that present exposure hazards to or from each other in accordance with 21.4.7. [55:8.7.1]
- **21.4.7.2\* Stationary Cryogenic Containers.** Stationary containers located outdoors shall be separated from exposure hazards in accordance with the minimum separation distances indicated in Table 21.4.7.2. [55:8.7.2]
- **21.4.7.2.1 Fire Barriers.** A 2-hour fire barrier wall shall be permitted in lieu of the distances specified by Table 21.4.7.2, for items 1, 4, 7, 8, and 9, when in accordance with the provisions of 21.4.7.2.1.1 through 21.4.7.2.1.4. [**55:**8.7.2.1]
- **21.4.7.2.1.1** The fire barrier wall shall be without openings or penetrations with the exception of 21.4.7.2.1.2. [**55:**8.7.2.1.1]
- **21.4.7.2.1.2** Penetrations of the fire barrier wall by conduit or piping shall be permitted provided that the penetration is protected with a fire stop system in accordance with the building code. [55:8.7.2.1.1.1]
- **21.4.7.2.1.3** The fire barrier wall shall be either an independent structure or the exterior wall of the building adjacent to the storage system. [**55:**8.7.2.1.2]
- **21.4.7.2.1.4** The fire barrier wall shall be located not less than 5 ft (1.5 m) from any exposure. [55:8.7.2.1.3]

- **21.4.7.2.1.5** The fire barrier wall shall not have more than two sides at 90 degree (1.57 rad) directions, or not more than three sides with connecting angles of 135 degrees (2.36 rad). [55:8.7.2.1.4]
- (A) The connecting angles between fire barrier walls shall be permitted to be reduced to less than 135 degrees (2.36 rad) for installations consisting of three walls when in accordance with 8.13.2.7.2 of NFPA 55. [55:8.7.2.1.4.1]

#### Annex A Explanatory Material

Annex A is not a part of the requirements of this NFPA document but is included for informational purposes only. This annex contains explanatory material, numbered to correspond with the applicable text paragraphs.

**A.1.1.1** Manufacturing operations are covered by this code when the manufacturing operation involves the storage or use of hazardous materials regulated by this code.

When quantities exceed Occupational Safety and Health Administration (OSHA) or Environmental Protection Agency (EPA) threshold quantities for hazardous materials (or classes of materials), additional federal requirements under the Process Safety Management (29 CFR 1910.119) and Risk Management Program (40 CFR 68) regulations might apply. These can be found at www.osha.gov and www.epa.gov.

- A.1.1.1(10) It is not intended that NFPA 400 regulate compressed gases or cryogenic fluids outside of the scope of NFPA 55, including LPG as regulated by NFPA 58, fuel gas as regulated by NFPA 54, vehicular fuels as regulated by NFPA 52, or LNG as regulated by NFPA 59. Refer to the specific exemptions referred to in 21.1.1.2.
- **A.1.2** The term *handling* includes onsite transportation.
- A.1.8 Permit applications might require submittal of a hazardous materials management plan and a hazardous materials inventory statement in accordance with Sections 1.11 and 1.12.
- A.1.11.1 See Section C.3 for a model hazardous materials management Plan (HMMP).
- **A.1.12** See Section C.2 for a model hazardous materials inventory statement (HMIS).
- A.3.1 The use of parenthetical terms (solid, liquid, gas, and flammable and combustible liquid) following definitions extracted from other NFPA hazardous materials codes and standards is intended to aid the user in understanding the application of specific terms. The parenthetical terms apply only to extracted definitions.
- **A.3.2.1 Approved.** The National Fire Protection Association does not approve, inspect, or certify any installations, procedures, equipment, or materials; nor does it approve or evaluate testing laboratories. In determining the acceptability of installations, procedures, equipment, or materials, the authority having jurisdiction may base acceptance on compliance with NFPA or other appropriate standards. In the absence of such standards, said authority may require evidence of proper installation, procedure, or use. The authority having jurisdiction may also refer to the listings or labeling practices of an organization that is concerned with product evaluations and is thus in

a position to determine compliance with appropriate standards for the current production of listed items.

- A.3.2.2 Authority Having Jurisdiction (AHJ). The phrase "authority having jurisdiction," or its acronym AHJ, is used in NFPA documents in a broad manner, since jurisdictions and approval agencies vary, as do their responsibilities. Where public safety is primary, the authority having jurisdiction may be a federal, state, local, or other regional department or individual such as a fire chief; fire marshal; chief of a fire prevention bureau, labor department, or health department; building official; electrical inspector; or others having statutory authority. For insurance purposes, an insurance inspection department, rating bureau, or other insurance company representative may be the authority having jurisdiction. In many circumstances, the property owner or his or her designated agent assumes the role of the authority having jurisdiction; at government installations, the commanding officer or departmental official may be the authority having jurisdiction.
- A.3.2.3 Code. The decision to designate a standard as a "code" is based on such factors as the size and scope of the document, its intended use and form of adoption, and whether it contains substantial enforcement and administrative provi-
- A.3.2.5 Listed. The means for identifying listed equipment may vary for each organization concerned with product evaluation; some organizations do not recognize equipment as listed unless it is also labeled. The authority having jurisdiction should utilize the system employed by the listing organization to identify a listed product.
- A.3.3.1 Absolute Pressure [Gas]. Measured from this reference point, the standard atmospheric pressure at sea level is an absolute pressure of 14.7 psi (101.3 kPa). [55, 2016]
- NA.3.3.2 Access Aisle. Access aisles are used for instances including, but not limited to, inventory and leak checks. An access aisle can be used to define the boundary of the pile and is not considered part of the pile size. The term access aisle is used for what was previously referred to as an "additional aisle."
- **N A.3.3.3 Aisle.** The aisle can be used to define the boundary of the pile and is not considered part of the pile size. The term aisle is used for what was previously referred to as a "main" aisle or "working" aisle.
  - A.3.3.11 Bulk Hydrogen Compressed Gas System [Gas]. The bulk system terminates at the source valve, which is the point where the gas supply, at service pressure, first enters the supply line, or at a piece of equipment that utilizes the hydrogen gas, such as a hydrogen dispenser. The containers are either stationary or movable, and the source gas for the system is stored as a compressed gas. [**55**, 2016]

Bulk hydrogen compressed gas systems can include a bulk storage source, transfer piping and manifold system, compression system, and other components. The gaseous source can include a tube trailer, tube bank, or other high-pressure storage vessels used to serve the piping system that transports hydrogen to the end user. Compressors can be installed downstream of the storage supply to boost the pressure of the source gas, and intermediate high-pressure storage might be present. This is done where the end use requires hydrogen at a pressure higher than that of the bulk supply. In these instances, there might be intermediate storage vessels used to store the gas at elevated pressures. It is not uncommon for the bulk supply as

delivered to be furnished at nominal gauge pressure of 3000 psi (20,684 kPa), and the intermediate high-pressure storage to be stored at gauge pressures up to 15,000 psi (103,421 kPa). [See Figure A.3.3.11(a) through Figure A.3.3.11(f)]. [55, 2016]

**A.3.3.12 Bulk Inert Gas System.** The bulk system terminates at the source valve, which is commonly the point where the gas supply, at service pressure, first enters the supply line or a piece of equipment that utilizes the gas or the liquid. The containers are either stationary or movable, and the source gas is stored as a compressed gas or cryogenic fluid. [55, 2016]

Bulk inert gas systems can be used to supply gas in either its compressed gaseous or liquefied form. Systems that can be used to supply both gaseous and liquid forms are referred to as hybrid systems. The following bulk inert gas systems are typical of those in use:

- (1) When the primary supply of the gas as stored is from a compressed gaseous source that is used in the compressed and gaseous form, the bulk inert gas system is said to be a bulk inert compressed gas system.
- (2) When the primary supply of the gas as stored is in a liquid form and the system is designed to transfer only liquid, the system is said to be a bulk liquefied inert gas system.
- (3) When the primary supply of the gas as stored is in a liquid form and the system is designed to transfer or store the gas in a compressed gaseous form, with or without a feature that can also allow the subsequent transfer and use of liquid, the bulk inert gas system is said to be a hybrid bulk inert gas system.

For the purposes of the application of the code, a hybrid system is viewed as a bulk liquefied inert gas system. [55, 2016]

**A.3.3.13 Bulk Liquefied Hydrogen System [Gas].** The bulk system terminates at the source valve, which is commonly the point where the gas supply, at service pressure, first enters the supply line or a piece of equipment that utilizes the gas or the liquid, such as a hydrogen dispenser. The containers are either stationary or movable, and the source gas for the system is stored as a cryogenic fluid. [55, 2016]

A bulk liquefied hydrogen gas system can include a liquid source where the liquid is vaporized and subsequently compressed and transferred to storage in the compressed gaseous form. It is common for liquid hydrogen systems to be equipped with vaporizers that are used to gasify the cryogen for ultimate use in the compressed state; however, there are also systems that can be used to transfer liquid in the cryogenic state. Bulk liquefied hydrogen gas systems can be either in an all-liquid state or in a hybrid system that can consist of storage containers for gas in the liquid state and other containers for gas in the compressed state. For the purposes of the application of the code, a hybrid system is viewed as a bulk liquefied hydrogen gas system. [55, 2016]

**A.3.3.14 Bulk Oxygen System.** The bulk oxygen system terminates at the source valve, which is commonly the point where oxygen at service pressure first enters the supply line or a piece of equipment that utilizes the oxygen gas or liquid. The oxygen containers are either stationary or movable, and the oxygen is stored as a compressed gas or cryogenic fluid. [55, 2016]

Bulk oxygen systems can be used to supply gas in either its compressed gaseous or liquefied form. Systems that can be used to supply both gaseous and liquid forms are referred to as hybrid systems. The following bulk oxygen systems are typical of those in use:

- (1) When the primary supply of the gas as stored is from a compressed gaseous source that is used in the compressed and gaseous form, the bulk oxygen system is said to be a bulk compressed oxygen gas system.
- (2) When the primary supply of the gas as stored is in a liquid form and the system is designed to transfer only liquid, the system is said to be a bulk liquefied oxygen system.
- (3) When the primary supply of the gas as stored is in a liquid form and the system is designed to transfer or store the gas in a compressed gaseous form, with or without a feature that can also allow the subsequent transfer and use of liquid, the bulk oxygen system is said to be a hybrid bulk oxygen system.




FIGURE A.3.3.11(a) Symbol Legend for Figures A.3.3.11(b) through A.3.3.11(f).




FIGURE A.3.3.11(b) Typical Tube Trailer.

**A.3.3.18 Combustible Dust.** Dusts traditionally were defined as material 420 µm or smaller (i.e., capable of passing through a U.S. No. 40 standard sieve). For consistency with other standards, 500 μm (i.e., capable of passing through a U.S. No. 35 standard sieve) is now considered an appropriate size criterion. Particle surface area-to-volume ratio is a key factor in determining the rate of combustion. Combustible particulate solids with a minimum dimension more than 500 µm generally have a surface-to-volume ratio that is too small to pose a deflagration hazard. Flat platelet-shaped particles, flakes, or fibers with lengths that are large compared to their diameter usually do not pass through a 500 µm sieve, yet could still pose a deflagration hazard. Many particulates accumulate electrostatic charge in handling, causing them to attract each other, forming agglomerates. Often, agglomerates behave as if they were larger particles, yet when they are dispersed they present a significant hazard. Therefore, it can be inferred that any particulate that has a minimum dimension less than or equal to 500 um could behave as a combustible dust if suspended in air or the process specific oxidizer. If the minimum dimension of the particulate is greater than 500 μm, it is unlikely that the material would be a combustible dust, as determined by test. The determination of whether a sample of combustible material presents a flash-fire or explosion hazard could be based on a screening test methodology such as provided in ASTM E1226, Standard Test Method for Explosibility of Dust Clouds. Alternatively, and a standardized test method such as ASTM E1515, Standard Test Method for Minimum Explosible Concentration of Combustible Dusts, could be used to determine dust explosibility. Chapter 5 of NFPA 652 has additional information on testing requirements. [652, 2019]

There is some possibility that a sample will result in a false positive in the 20 L sphere when tested by the ASTM E1226 screening test or the ASTM E1515 test. This is due to the high energy ignition source overdriving the test. When the lowest ignition energy allowed by either method still results in a positive result, the owner/operator can elect to determine whether the sample is a combustible dust with screening tests performed in a larger scale ( $\geq 1 \,$  m³) enclosure, which is less susceptible to overdriving and thus will provide more realistic results. [652, 2019]

This possibility for false positives has been known for quite some time and is attributed to "overdriven" conditions that exist in the 20 L chamber due to the use of strong pyrotechnic igniters. For that reason, the reference method for explosibility




FIGURE A.3.3.11(c) Typical Bulk Compressed Gaseous Storage System.

testing is based on a 1 m³ chamber, and the 20 L chamber test method is calibrated to produce results comparable to those from the 1 m³ chamber for most dusts. In fact, the U.S. standard for 20 L testing (ASTM E1226) states, "The objective of this test method is to develop data that can be correlated to those from the 1 m³ chamber (described in ISO 6184-1 and VDI 3673)..." ASTM E1226 further states, "Because a number of factors (concentration, uniformity of dispersion, turbulence of ignition, sample age, etc.) can affect the test results, the test vessel to be used for routine work must be standardized using dust samples whose  $K_{St}$  and  $P_{max}$  parameters are known in the 1 m³ chamber." [652, 2019]

NFPA 68 also recognizes this problem and addresses it stating that "the 20 L test apparatus is designed to simulate results of the 1 m³ chamber; however, the igniter discharge makes it problematic to determine  $K_{St}$  values less than 50 bar-m/sec. Where the material is expected to yield  $K_{St}$  values less than 50 bar-m/sec, testing in a 1 m³ chamber might yield lower values." [652, 2019]

Any time a combustible dust is processed or handled, a potential for deflagration exists. The degree of deflagration hazard varies, depending on the type of combustible dust and the processing methods used. [652, 2019]

A dust deflagration has the following four requirements:

- (1) Combustible dust
- (2) Dust dispersion in air or other oxidant
- (3) Sufficient concentration at or exceeding the minimum explosible concentration (MEC)
- (4) Sufficiently powerful ignition source such as an electrostatic discharge, an electric current arc, a glowing ember, a hot surface, welding slag, frictional heat, or a flame

[**652**, 2019]

If the deflagration is confined and produces a pressure sufficient to rupture the confining enclosure, the event is, by definition, an "explosion." [652, 2019]

Evaluation of the hazard of a combustible dust should be determined by the means of actual test data. Each situation should be evaluated and applicable tests selected. The following list represents the factors that are sometimes used in determining the deflagration hazard of a dust:

- (1) MEC
- (2) MIE
- (3) Particle size distribution
- (4) Moisture content as received and as tested
- (5) Maximum explosion pressure at optimum concentration
- (6) Maximum rate of pressure rise at optimum concentration



- (8) Layer ignition temperature
- (9) Dust cloud ignition temperature
- (10) Limiting oxidant concentration (LOC) to prevent ignition
- (11) Electrical volume resistivity
- (12) Charge relaxation time
- (13) Chargeability

It is important to keep in mind that as a particulate is processed, handled, or transported, the particle size generally decreases due to particle attrition. Therefore, it is often necessary to evaluate the explosibility of the particulate at multiple points along the process. Where process conditions dictate the use of oxidizing media other than air, which is nominally taken as 21 percent oxygen and 79 percent nitrogen, the applicable tests should be conducted in the appropriate process-specific medium. [652, 2019]

**A.3.3.20 Compressed Gas System.** A compressed gas system can consist of a compressed gas container or containers, reactors, and appurtenances, including pumps, compressors, and connecting piping and tubing. [55, 2016]

**A.3.3.21.2 Container [Flammable and Combustible Liquid].** The U.S. DOT defines *non-bulk packaging* as having up to 119 gal (450 L) capacity in 49 CFR 171.8. [**30**, 2018]

A.3.3.21.6 Nonmetallic Container [Solid, Flammable and Combustible Liquid]. Permissible nonmetallic containers for shipping Class I, Class II, and Class IIIA liquids are governed by the hazardous materials transportation regulations promulgated by the United Nations publication *Recommendations on the Transport of Dangerous Goods, Model Regulations,* and the U.S. Department of Transportation's Hazardous Materials Regulations, Title 49, Code of Federal Regulations. Small tanks for Class IIIB liquids are not governed by these regulations. Fiber portable tanks for Class IIIB liquids include composite designs consisting of a multi-ply cardboard box with a rigid or flexible plastic bladder. [30, 2018]

**A.3.3.21.9.1 Stationary Tank [Gas].** A stationary tank does not include a cylinder having less than 1000 lb (453.5 kg) water capacity.

**A.3.3.21.10.1** Atmospheric Tank [Flammable and Combustible Liquid]. Older-style flat roof tanks were designed to operate at pressures of atmospheric through a gauge pressure of 0.5 psi (3.5 kPa), measured at the top of the tank. This limitation was established to avoid continuous stress on the roof plates of the tank. [30, 2018]

A.3.3.21.11 Portable Tank [Flammable and Combustible Liquid]. The term *portable tank* does not include an intermedi-




FIGURE A.3.3.11(e) Typical Chemical Energy Storage Model (CESM).

ate bulk container (IBC). The standards of construction for portable tanks are different from those used for the construction of containers and IBCs.

**A.3.3.21.11.1 Portable Tank [Gas].** A portable tank (gas) does not include any cylinder having less than 1000 lb (453.5 kg) water capacity, cargo tank, tank car tank, or trailer carrying cylinders of over 1000 lb (453.5 kg) water capacity.

A.3.3.21.11.2 Nonmetallic Portable Tank [Flammable and Combustible Liquid]. Permissible nonmetallic portable tanks for shipping Class I, Class II, and Class IIIA liquids are governed by the hazardous materials transportation regulations promulgated by the United Nations (UN) and the U.S. Department of Transportation (DOT). Small tanks for Class IIIB liquids are not governed by either UN or DOT hazardous materials regulations. Fiber portable tanks for Class IIIB liquids include composite designs consisting of a multi-ply corrugated box with a rigid or flexible inner plastic bladder. [30, 2018]

**A.3.3.21.12 Pressure Vessel.** Pressure vessels of any type can be subject to additional regulations imposed by various states or other legal jurisdictions. Users should be aware that compliance with DOT or ASME requirements might not satisfy all of the required regulations for the location in which the vessel is to be installed or used. Pressure vessels may be constructed to meet requirements of other regulatory agencies, including regulations for Transport, Canada (TC) or various ANSI standards that may be applicable for specific uses. [55: A.8.2]

**A.3.3.21.14.1 Tube Trailer [Gas].** The characteristic internal water volume of individual tubular cylinders ranges from 43 ft<sup>3</sup> (1218 L) to 93 ft<sup>3</sup> (2632 L) or a water capacity of 2686 lb (1218 kg) to 5803 lb (2632 kg).


**A.3.3.21.15 ISO Module.** The frame of an ISO container module and its corner casings are specifically designed and dimensioned to be used in multimodal transportation service on container ships, special highway chassis, and container on flatcar railroad equipment.

**A.3.3.21.16 Safety Can [Liquid].** Safety cans listed to ANSI/UL 30, Standard for Metal Safety Cans, are limited to 5 U.S. gal (19 L). ANSI/UL 1313, Standard for Nonmetallic Safety Cans or Petroleum Products, allows for capacities up to 5 Imperial gal (23 L). [30, 2018]

**A.3.3.25 Cylinder** [Gas]. The term *cylinder* (*gas*) does not include a portable tank, multiunit tank car tank, cargo tank, or tank car.

**A.3.3.28 Cylinder Pack [Gas].** *Six-packs* and *twelve-packs* are terms used to further define cylinder packs with a specific number of cylinders involved. The characteristic internal water volume of individual cylinders in a cylinder pack ranges from 1.52 scf to 1.76 scf (43 L to 50 L) or a water capacity of from 95 lb to 110 lb (43 kg to 50 kg). [55, 2016]

Δ A.3.3.38 Exhausted Enclosure [Gas]. Such enclosures include laboratory hoods, exhaust fume hoods, and similar appliances and equipment used to retain and exhaust locally the gases, fumes, vapors, and mists that could be released. Rooms or areas

provided with general ventilation, in and of themselves, are not exhausted enclosures. [55, 2016]

A.3.3.39 Explosion Control [Gas]. NFPA 68 provides guidance on the use of deflagration venting systems for use in buildings and other enclosures. The primary purpose of a venting system is to relieve the overpressure produced in an explosion to limit the potential damage to the building where the explosion occurs. Although some structural damage can be anticipated, the use of relief venting is expected to prevent massive building failure and collapse. In cases where detonation is probable, venting is often used in conjunction with barricade construction where the pressure-resistant portions of the building have been constructed to resist the pressures anticipated should an explosive event occur. Design of barricade systems is highly specialized, and the subject of military standards applicable to the subject. NFPA 69 provides guidance on the use of suppression, ventilation systems, and the limiting of oxidants as a means to prevent the occurrence of an explosion. When relief vents are to be used as a means to provide explosion relief, the fundamental requirements of the building code for structural elements including snow, wind, and seismic events should be considered. In some instances, the requirements for wind resistance can impose more rigorous requirements on the relief vents than required by the engineering analysis used to determine the relief pressure. In such cases, users must demonstrate that the relief vents will not become airborne or release in such a manner as to create secondary hazards within or external to the building in which they are installed. Specific designs might require approval by the AHJ. **[55,** 2016]

- **A.3.3.41 Explosive.** Explosives in Class 1 are divided into six divisions as follows:
  - Division 1.1 consists of explosives that have a mass explosion hazard. A mass explosion is one that affects almost the entire load instantaneously.
  - Division 1.2 consists of explosives that have a projection hazard but not a mass explosion hazard.
  - Division 1.3 consists of explosives that have a fire hazard and either a minor blast hazard or a minor projection hazard, or both, but not a mass explosion hazard.
  - Division 1.4 consists of explosives that present a minor explosion hazard. The explosive effects are largely confined to the package, and no projection of fragments of appreciable size or range is to be expected. An external fire must not cause virtually instantaneous explosion of almost the entire contents of the package.
  - Division 1.5 consists of very insensitive explosives. (The probability of transition from burning to detonation is greater when large quantities are transported in a vessel.) This division is comprised of substances that have a mass explosion hazard but are so insensitive that there is very

little probability of initiation or of transition from burning to detonation under normal conditions of transport.

(6) Division 1.6 consists of extremely insensitive articles that do not have a mass explosion hazard. (The risk from articles of Division 1.6 is limited to the explosion of a single device.) This division is comprised of articles that contain only extremely insensitive detonating substances and that demonstrate a negligible probability of accidental initiation or propagation.

A list of explosives determined to be within the scope of 18 USC 40, "Importation, Manufacture, Distribution and Storage of Explosive Materials," is published at least annually by the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF), U.S. Department of Justice. The classification of explosives described in 49 CFR 171–180, "Hazardous Materials Regulations," is provided in Annex E. These regulations were revised in 1991. The term includes, but is not limited to, dynamite, black powder, pellet powder, initiating explosives, detonators, safety fuses, squibs, detonating cord, igniter cord, and igniters. The term includes any material determined to be within the scope of 18 USC 40, and also includes any material classified as an explosive by 49 CFR 100–199, "Pipeline and Hazardous Materials Safety Administration, Department of Transportation."

**A.3.3.42 Explosive Decomposition.** The term includes both deflagration and detonation.

**A.3.3.43 Explosive Reaction.** For further information on venting explosive reactions, see NFPA 68.

**A.3.3.46 Flammable Liquid (Class I).** Flammable liquids do not include compressed gases or cryogenic fluids. Flammable liquids are further categorized into a group known as Class I liquids. The Class I category is subdivided as follows:

- Class I-A liquids are those having a flash point below 73°F (22.8°C) and a boiling point below 100°F (37.8°C).
- (2) Class I-B liquids are those having a flash point below 73°F (22.8°C) and a boiling point at or above 100°F (37.8°C).
- (3) Class I-C liquids are those having a flash point at or above 73°F (22.8°C) and below 100°F (37.8°C).

**A.3.3.47 Flammable Solid.** Flammable solids include finely divided solid materials that, when dispersed in air as a cloud, could be ignited and cause an explosion.

**A.3.3.49.1 Compressed Gas [Gas].** The states of a compressed gas are categorized as follows:

- Nonliquefied compressed gases are gases, other than those in solution, that are in a packaging under the charged pressure and are entirely gaseous at a temperature of 20°C (68°F).
- (2) Liquefied compressed gases are gases that, in a packaging under the charged pressure, are partially liquid at a temperature of 20°C (68°F). Cryogenic fluids represent a transient state of a gas that is created through the use of refrigeration. Cryogenic fluids cannot exist in the liquid form or partial liquid form at temperatures of 20°C (68°F), hence, they are not "compressed gases" as defined.
- (3) Compressed gases in solution are nonliquefied gases that are dissolved in a solvent.
- (4) Compressed gas mixtures consist of a mixture of two or more compressed gases contained in a packaging, the

hazard properties of which are represented by the properties of the mixture as a whole.

[**55**, 2016]

**A.3.3.49.7 Irritant Gas [Gas].** A chemical is a skin irritant if, when tested on the intact skin of albino rabbits by the methods of 16 CFR 1500.41, for an exposure of 4 or more hours or by other appropriate techniques, it results in an empirical score of 5 or more. A chemical is classified as an eye irritant if so determined under the procedure listed in 16 CFR 1500.42, or other appropriate techniques.

**A.3.3.49.9 Other Gas [Gas].** A gas classified as an "other gas" might be a nonflammable gas or an inert gas. [55, 2016]

**A.3.3.49.13 Unstable Reactive Gas [Gas].** Unstable reactive materials are subdivided into five classifications. Class 4 materials are materials that in themselves are readily capable of detonation or explosive decomposition or explosive reaction at normal temperatures and pressures. They include the following:

- Materials that are sensitive to localized thermal or mechanical shock at normal temperatures and pressures
- (2) Materials that have an instantaneous power density (product of heat of reaction and reaction rate) at 482°F (250°C) of 1000 W/mL or greater

[**55**, 2016]

Class 3 materials are materials that in themselves are capable of detonation or explosive decomposition or explosive reaction but require a strong initiating source or heat under confinement before initiation. [55, 2016]

Class 3 materials include the following:

- (1) Materials that have an instantaneous power density (product of heat of reaction and reaction rate) at 482°F (250°C) at or above 100 W/mL and below 1000 W/mL
- (2) Materials that are sensitive to thermal or mechanical shock at elevated temperatures and pressures
- (3) Materials that react explosively with water without requiring heat or confinement

**[55,** 2016]

Class 2 materials are materials that readily undergo violent chemical change at elevated temperatures and pressures, including the following:

- (1) Materials that have an instantaneous power density (product of heat of reaction and reaction rate) at 482°F (250°C) at or above 10 W/mL and below 100 W/mL
- (2) Materials that react violently with water or form potentially explosive mixtures with water

[**55**, 2016]

Class 1 materials are materials that in themselves are normally stable but that can become unstable at elevated temperatures and pressures, including the following:

- (1) Materials that have an instantaneous power density (product of heat of reaction and reaction rate) at 482°F (250°C) at or above 0.01 W/mL and below 10 W/mL
- Materials that react vigorously with water, but not violently
- (3) Materials that change or decompose on exposure to air, light, or moisture

[**55**, 2016]

Class 0 materials are materials that in themselves are normally stable, even under fire conditions, including the following:

- Materials that have an instantaneous power density (product of heat of reaction and reaction rate) at 482°F (250°C) below 0.01 W/mL
- Materials that do not react with water
- Materials that do not exhibit an exotherm at temperatures less than or equal to 932°F (500°C) when tested by differential scanning calorimetry

[**55**, 2016]

A.3.3.50 Gas Cabinet [Gas]. Doors and access ports for exchanging cylinders and accessing pressure-regulating controls are permitted to be included as part of a gas cabinet. **[55,** 2016]

A.3.3.52 Gas Room [Gas]. Gas rooms must be constructed and utilized in accordance with 21.2.4.

A.3.3.53 Gaseous Hydrogen (GH<sub>2</sub>) System. The system includes stationary or portable containers, pressure regulators, pressure relief devices, manifolds, interconnecting piping, and controls as required. [55, 2016]

A.3.3.57 Immediately Dangerous to Life and Health (IDLH) [Gas]. This level is established by the National Institute for Occupational Safety and Health (NIOSH). If adequate data do not exist for precise establishment of IDLH, an independent certified industrial hygienist, industrial toxicologist, or appropriate regulatory agency should make such determination. [55, 2016]

A.3.3.58 ISO Module [Gas]. The characteristic internal water volume of individual tubular cylinders is 43 scf (1218 L) or a water capacity of 2686 lb (1218 kg). The frame of an ISO container module and its corner castings are specially designed and dimensioned to be used in multi-modal transportation service on container ships, special highway chassis, and container-on-flatcar railroad equipment. [55, 2016]

A.3.3.59.2 Permissible Exposure Limit (PEL) [Gas]. The maximum permitted time-weighted average exposures to be utilized are those published in 29 CFR 1910.1000. [55, 2016]

A.3.3.59.3 Short-Term Exposure Limit (STEL) [Gas]. STEL limits are published in 29 CFR 1910.1000. [55, 2016]

**A.3.3.62.2 Corrosive Material.** A chemical is considered to be corrosive if it destroys or irreversibly changes the structure of the tissue at the site of contact within a specified period of time using one of the in vivo or in vitro OECD test methods authorized in 49 CFR 173.137. For purposes of this code, this term does not refer to action on inanimate surfaces (e.g., steel or aluminum). Available testing data produced prior to September 30, 1995 from the test method in Appendix A to 49 CFR 173 in effect on October 1, 1994 can also be used to determine the corrosivity of a material.

A.3.3.62.4 Hazardous Material. Hazardous wastes might or might not be classified as hazardous materials. Management and disposal of hazardous waste is regulated by the EPA under the Resource Conservation and Recovery Act (RCRA). EPA requires wastes identified as hazardous to be handled, stored, treated, and disposed of according to the stipulations of the RCRA hazardous waste program in 40 CFR 260-299, "Solid Wastes."

A.3.3.62.5 Incompatible Material. Information on incompatible materials can be found in safety data sheets (SDS) or manufacturers' product bulletins.

A.3.3.62.7 Noncombustible Material. A material that is reported as complying with the pass/fail criteria of ASTM E136, Standard Test Method for Behavior of Materials in a Vertical Tube Furnace at 750°C, when tested in accordance with the test method and procedure in ASTM E2652, Standard Test Method for Behavior of Materials in a Tube Furnace with a Cone-shaped Airflow Stabilizer, at 750°C, is considered a noncombustible material. (See 4.6.1 for additional information on noncombustible material.) [5000, 2018]

For the purposes of this code, noncombustible construction and limited-combustible construction are both considered to be noncombustible.

A.3.3.62.9 Toxic Material. While categorization is basically simple in application, the degree of hazard depends on many variables that should be carefully considered individually and in combination. Some examples include the following:

- Materials wherein the toxic component or mixtures thereof are inextricably bound and cannot be released so there is little or no potential for exposure
- Nonfriable solid hazardous materials existing in product forms and in the demonstrated absence of inhalable particles that might not present the same inhalation hazard as the chemical components existing in a friable
- Mixtures of toxic materials with ordinary materials, such (3) as water, that might not warrant classification as toxic

Any hazard evaluation that is required for the precise categorization of toxic material is required to be performed by experienced, technically competent persons.

A.3.3.62.9.1 Highly Toxic Material. While categorization is basically simple in application, the degree of hazard depends on many variables that should be carefully considered individually and in combination. Some examples include the following:

- Materials wherein the highly toxic component or mixtures thereof are inextricably bound and cannot be released so there is little or no potential for exposure
- Nonfriable solid hazardous materials existing in product forms and in the demonstrated absence of inhalable particles that might not present the same inhalation hazard as the chemical components existing in a friable
- Mixtures of highly toxic materials with ordinary materials, such as water, that might not warrant classification as highly toxic

Any hazard evaluation that is required for the precise categorization of highly toxic material is required to be performed by experienced, technically competent persons.

A.3.3.62.10 Unstable [Reactive] Material. Unstable (reactive) material is classified as follows:

Class 4 unstable (reactive) materials are those that, in themselves, are readily capable of detonation, explosive decomposition, or explosive reaction at normal temperatures and pressures and include, among others, materials that are sensitive to localized thermal or mechanical shock at normal temperatures and pressures.

- (2) Class 3 unstable (reactive) materials are those that, in themselves, are capable of detonation, explosive decomposition, or explosive reaction, but that require a strong initiating source or that must be heated under confinement before initiation, and include, among others, materials that are sensitive to thermal or mechanical shock at elevated temperatures and pressures.
- (3) Class 2 unstable (reactive) materials are those that readily undergo violent chemical change at elevated temperatures and pressures and include, among others, materials that exhibit an exotherm at temperatures less than or equal to 30°F (-1°C) when tested by differential scanning calorimetry.
- (4) Class 1 unstable (reactive) materials are those that, in themselves, are normally stable, but that can become unstable at elevated temperatures and pressures and include among others, materials that change or decompose on exposure to air, light, or moisture and that exhibit an exotherm at temperatures greater than 30°F (-1°C), but less than or equal to 57°F (14°C), when tested by differential scanning calorimetry.
- **A.3.3.62.10.1 Class 1 Unstable [Reactive].** Materials that have an instantaneous power density (product of heat of reaction and reaction rate) at  $482^{\circ}F$  ( $250^{\circ}C$ ) at or above 0.01 W/mL and below 10 W/mL. [**704:**Table 7.2]
- **A.3.3.62.10.2 Class 2 Unstable [Reactive].** Materials that have an instantaneous power density (product of heat of reaction and reaction rate) at 482°F (250°C) at or above 10 W/mL and below 100 w/mL. [704:Table 7.2]
- **A.3.3.62.10.3 Class 3 Unstable [Reactive].** Materials that are sensitive to thermal and mechanical shock elevated temperatures and pressures. Materials that have an instantaneous power density (product of heat of reaction and reaction rate) at 482°F (250°C) at or above 100 W/mL and below 1000 W/mL. [704:Table 7.2]
- **A.3.3.62.10.4 Class 4 Unstable [Reactive].** Materials that are sensitive to localized thermal or mechanical shock at normal temperatures and pressures. Materials that have an instantaneous power density (product of heat of reaction and reaction rate) at 482°F (250°C) of 1000 W/mL or greater.
- **A.3.3.62.11 Water-Reactive Material.** Class 1 water-reactive materials are materials whose heat of mixing is at or above 30 cal/g and less than 100 cal/g. Class 2 water-reactive materials are materials whose heat of mixing is at or above 100 cal/g and less than 600 cal/g. Class 3 water-reactive materials are materials whose heat of mixing is greater or equal to 600 cal/g.
- A.3.3.63 Maximum Allowable Quantity Per Control Area (MAQ). See A.5.1.
- **A.3.3.65 Mobile Supply Unit [Gas].** Examples include ISO modules, tube trailers, and cylinder packs. [55, 2016]
- **A.3.3.66 Nesting [Gas].** A wall or a railing could be used to provide a means of solid support.
- **A.3.3.67 Nonbulk Flammable Gas System.** Nonbulk systems can have more than  $5000 \text{ scf } (141.6 \text{ Nm}^3)$  as long as the volume of any individual container or connected system is less than  $5000 \text{ scf } (141.6 \text{ Nm}^3)$ . Table 21.3.6.2 shows exposure distances for nonbulk flammable gases with a total storage up to  $200,000 \text{ scf } (5660 \text{ Nm}^3)$ . [55, 2016]

**A.3.3.68 Normal Temperature and Pressure (NTP) [Gas].** There are different definitions of normal conditions. The normal conditions defined here are the ones most commonly used in the compressed gas and cryogenic fluid industry. [55, 2016]

**A.3.3.69.1 Assembly Occupancy.** Assembly occupancies might include the following:

- (1) Armories
- (2) Assembly halls
- (3) Auditoriums
- (4) Bowling lanes
- (5) Club rooms
- (6) College and university classrooms, 50 persons and over
- (7) Conference rooms
- (8) Courtrooms
- (9) Dance halls
- (10) Drinking establishments
- (11) Exhibition halls
- (12) Gymnasiums
- (13) Libraries
- (14) Mortuary chapels
- (15) Motion picture theaters
- (16) Museums
- (17) Passenger stations and terminals of air, surface, underground, and marine public transportation facilities
- (18) Places of religious worship
- (19) Pool rooms
- (20) Recreation piers
- (21) Restaurants
- (22) Skating rinks
- (23) Special amusement buildings, regardless of occupant load
- (24) Theaters

Assembly occupancies are characterized by the presence or potential presence of crowds with attendant panic hazard in case of fire or other emergency. They are generally open or occasionally open to the public, and the occupants, who are present voluntarily, are not ordinarily subject to discipline or control. Such buildings are ordinarily occupied by able-bodied persons and are not used for sleeping purposes. Special conference rooms, snack areas, and other areas incidental to, and under the control of, the management of other occupancies, such as offices, fall under the 50-person limitation.

Restaurants and drinking establishments with an occupant load of fewer than 50 persons should be classified as mercantile occupancies.

**A.3.3.69.2 Business Occupancy.** Business occupancies include the following:

- (1) Air traffic control towers (ATCTs)
- (2) City halls
- (3) College and university instructional buildings, classrooms under 50 persons, and instructional laboratories
- (4) Courthouses
- (5) Dentists' offices
- (6) Doctors' offices
- (7) General offices
- (8) Outpatient clinics (ambulatory)
- (9) Town halls

Doctors' and dentists' offices are included, unless of such character as to be classified as ambulatory health care occupancies. (See 3.3.69.6.1.)

Birth centers should be classified as business occupancies if they are occupied by fewer than four patients, not including infants, at any one time; do not provide sleeping facilities for four or more occupants; and do not provide treatment procedures that render four or more patients, not including infants, incapable of self-preservation at any one time. For birth centers occupied by patients not meeting these parameters, see A.3.3.69.6 or A.3.3.69.6.1, as appropriate.

Service facilities common to city office buildings, such as newsstands, lunch counters serving fewer than 50 persons, barber shops, and beauty parlors are included in the business occupancy group.

City halls, town halls, and courthouses are included in this occupancy group, insofar as their principal function is the transaction of public business and the keeping of books and records. Insofar as they are used for assembly purposes, they are classified as assembly occupancies.

# **A.3.3.69.3 Day-Care** Occupancy. Day-care occupancies include the following:

- (1) Adult day-care occupancies, except where part of a health care occupancy
- (2) Child day-care occupancies
- (3) Day-care homes
- (4) Kindergarten classes that are incidental to a child daycare occupancy
- (5) Nursery schools

In areas where public schools offer only half-day kindergarten programs, many child day-care occupancies offer stateapproved kindergarten classes for children who need full-day care. Because these classes are normally incidental to the daycare occupancy, the requirements of the day-care occupancy should be followed.

# **A.3.3.69.4 Detention and Correctional Occupancy.** Detention and correctional occupancies include the following:

- (1) Adult and juvenile substance abuse centers
- (2) Adult and juvenile work camps
- (3) Adult community residential centers
- (4) Adult correctional institutions
- (5) Adult local detention facilities
- (6) Juvenile community residential centers
- (7) Juvenile detention facilities
- (8) Juvenile training schools

# **A.3.3.69.5 Educational Occupancy.** Educational occupancies include the following:

- (1) Academies
- (2) Kindergartens
- (3) Schools

An educational occupancy is distinguished from an assembly occupancy in that the same occupants are regularly present.

# **A.3.3.69.6 Health Care Occupancy.** Health care occupancies include the following:

- (1) Hospitals
- (2) Limited care facilities
- (3) Nursing homes

Occupants of health care occupancies typically have physical or mental illness, disease, or infirmity. They also include infants, convalescents, or infirm aged persons. **A.3.3.69.6.1** Ambulatory Health Care Occupancy. It is not the intent that occupants be considered to be incapable of self-preservation just because they are in a wheelchair or use assistive walking devices, such as a cane, a walker, or crutches. Rather it is the intent to address emergency care centers that receive patients who have been rendered incapable of self-preservation due to the emergency, such as being rendered unconscious as a result of an accident or being unable to move due to sudden illness.

# **A.3.3.69.7 Industrial Occupancy.** Industrial occupancies include the following:

- (1) Drycleaning plants
- (2) Factories of all kinds
- (3) Food processing plants
- (4) Gas plants
- (5) Hangars (for servicing/maintenance)
- (6) Laundries
- (7) Power plants
- (8) Pumping stations
- (9) Refineries
- (10) Sawmills
- (11) Telephone exchanges

In evaluating the appropriate classification of laboratories, the AHJ should treat each case individually, based on the extent and nature of the associated hazards. Some laboratories are classified as occupancies other than industrial; for example, a physical therapy laboratory or a computer laboratory.

# **A.3.3.69.8 Mercantile Occupancy.** Mercantile occupancies include the following:

- (1) Auction rooms
- (2) Department stores
- (3) Drugstores
- (4) Restaurants with fewer than 50 persons
- (5) Shopping centers
- (6) Supermarkets

Office, storage, and service facilities incidental to the sale of merchandise and located in the same building should be considered part of the mercantile occupancy classification.

# **A.3.3.69.10 Residential Board and Care Occupancy.** The following are examples of facilities that are classified as residential board and care occupancies:

- (1) Group housing arrangement for physically or mentally handicapped persons who normally attend school in the community, attend worship in the community, or otherwise use community facilities
- (2) Group housing arrangement for physically or mentally handicapped persons who are undergoing training in preparation for independent living, for paid employment, or for other normal community activities
- (3) Group housing arrangement for the elderly that provides personal care services but that does not provide nursing care
- (4) Facilities for social rehabilitation, alcoholism, drug abuse, or mental health problems that contain a group housing arrangement and that provide personal care services but do not provide acute care
- (5) Assisted living facilities
- (6) Other group housing arrangements that provide personal care services but not nursing care

**A.3.3.69.11 Residential Occupancy.** Residential occupancies are treated as separate occupancies in this code as follows:

- (1) One- and two-family dwellings
- (2) Lodging or rooming houses
- (3) Hotels, motels, and dormitories
- (4) Apartment buildings

**A.3.3.69.12 Storage Occupancy.** Storage occupancies include the following:

- (1) Barns
- (2) Bulk oil storage
- (3) Cold storage
- (4) Freight terminals
- (5) Grain elevators
- (6) Hangars (for storage only)
- (7) Parking structures
- (8) Stables
- (9) Truck and marine terminals
- (10) Warehouses

Storage occupancies are characterized by the presence of relatively small numbers of persons in proportion to the area.

**A.3.3.73 Oxidizer.** Examples of other oxidizing gases include bromine, chlorine, and fluorine.

The classification of oxidizers is based on the technical committee's evaluation of available scientific and technical data, actual experience, and its considered opinion. Classification refers to the pure oxidizer. Gross contamination can cause oxidizers of all classes to undergo exothermic or explosive reaction, particularly if they also are subjected to confinement and heating. (See G.2.2 through G.2.5 for oxidizer classifications.)

The classification of oxidizers is based on the degree to which an oxidizing chemical increases, if at all, the burning rate of available combustible fuels. Factors that can influence the burning rate of oxidizers are concentration, particle size, product form, product packaging, and packaging configuration. Examples of Class 1, 2, 3, and 4 chemical oxidizers are listed in Section G.2. The definition of the current classes and the oxidizers listed as typical of each Class in Section G.2 are based on the technical committee's evaluation of available data, experience, and results of tests done by the Bureau of Mines and GE Research in the 1970s.

The definition of Class 1, 2, 3, and 4 oxidizers is subjective. Currently, there is no bench scale test method that adequately measures the burning rate of oxidizers for large-scale storage. The UN's Recommendations on the Transport of Dangerous Goods, Model Regulations, includes a bench scale test method (Test O.1) to assign packing groups to solid oxidizers. Thirty grams (1.06 oz) of a mixture of the test substance and cellulose powder is ignited with a Nichrome wire. The time from ignition to the end of visible burning of the mixture is compared with the burning time of several different mixtures of potassium bromate (Class 3) and cellulose powder. The test does not characterize chemical reactivity or thermal stability. The test is not representative of packaged oxidizers. The determination of burning time is strongly dependent on test conditions, particle size, and the test operator's perception of the end of active burning.

The Fire Protection Research Foundation (FPRF) published *National Oxidizing Pool Chemicals Storage Fire Test Project* in August 1998. The technical report includes literature abstracts, large-scale calorimetry test data, and intermediate scale rack storage

tests. The peak rate of heat release of packaging and packaged oxidizers trichloroisocyanuric acid (Trichlor, Class 1) and calcium hypochlorite (available chlorine >68%, Class 3) are summarized in Table A.3.3.73.

The Class 1 Trichlor did not increase the burning rate of the combustible packaging. Class 3 calcium hypochlorite (available chlorine >68%) caused a severe increase in the burning rate of the combustible packaging.

In 2006, the FPRF published a report on the *Development of an Enhanced Hazard Classification System for Oxidizers*. The report includes a review of fire losses, historical test data, and current test methods for oxidizing materials used by transportation and environmental regulatory agencies. Two classification schemes with multiple test methods and performance-based criteria were proposed to distinguish between Class 1, 2, 3, and 4 oxidizers in a storage situation.

Future FPRF effort is proposed to define an appropriate bench scale test, validated by medium scale free burn testing, for oxidizers. The goal of the enhanced classification system would be to prescribe tests and use performance based criteria to define the different classes of oxidizers based on the degree of burning rate enhancement, chemical reactivity, and thermal stability.

The FPRF completed a project that resulted in the development of a bench-scale test, validated by intermediate scale testing, for solid oxidizers. An enhanced classification system with prescribed tests and performance-based criteria to define the different classes of oxidizers based on the degree of burning rate enhancement was developed. [Buc, Elizabeth C., Oxidizer Classification Research Project: Tests and Criteria, Fire Protection Research Foundation, November 2009]

**A.3.3.75 Protection Level.** NFPA uses the concept of protection levels in a manner that is analogous to Group H occupancies in other model codes. Although NFPA 1 and *NFPA 5000* do

not have unique occupancy classifications for occupancies containing hazardous materials, Protection Levels 1 to 5 in NFPA codes and standards reflect increased building safety requirements that are applicable to occupancies containing hazardous materials, which generally correlate to the Group H, Division 1 to 5 occupancy classifications in other codes.

- **A.3.3.77 Safety Data Sheet (SDS).** SDSs in the United States are prepared in accordance with the Occupational Safety and Health Administration (OSHA) hazard communication standard (29 CFR 1910.1200, "Hazard Communication"). Chemicals transported internationally might include additional requirements. (See Annex B for additional information regarding SDSs.)
- **A.3.3.78 Secondary Containment.** Examples of secondary containment include dikes, curbing, remote impoundment, and double-walled tanks.
- **A.3.3.82 Storage** (Hazardous Material). Storage can include transient storage, which is intended to describe those materials being staged for transport. They are called transient while they are in the manufacturing area because they are not in their storage location. In the manufacturing location, finished goods can be found in a packaged state where they can be further palletized or otherwise arranged or collected awaiting transportation.
- **A.3.3.84 Tank.** Pipes and piping systems are not considered to be tanks.
- **A.3.3.84.2 Portable Tank.** A portable tank does not include any cylinder having less than 453.5 kg (1000 lb) water capacity, cargo tank, tank car tank, or trailers carrying cylinders of over 453.5 kg (1000 lb) water capacity. [55, 2016]
- **A.3.3.84.3 Stationary Tank.** A stationary tank does not include a cylinder having less than 1000 lb (453.5 kg) water capacity. [55, 2016]
- **A.3.3.87 Tube Trailer [Gas].** The characteristic internal water volume of individual tubular cylinders ranges from 43 scf (1218 L) to 93 scf (2632 L) or a water capacity of 2686 lb (1218 kg) to 5803 lb (2632 kg). [55, 2016]
- **A.3.3.88 Use.** Examples of use include, but are not limited to, blending, mixing, reacting, distillation, heating or cooling, pumping, compressing, drying, screening, filling, loading and unloading, repackaging, scrubbing, absorbing, neutralizing, and incineration.
- **A.3.3.88.1 Closed System Use.** Examples of closed systems for solids and liquids include reaction process operations and product conveyed through a piping system into a closed vessel, system, or piece of equipment.
- **A.3.3.88.2 Open System Use.** Examples of open systems for solids and liquids include dispensing from or into open beakers or containers, and dip tank and plating tank operations.
- **A.3.4.6 Exposure Fire.** An exposure fire usually refers to a fire that starts outside a building, such as a wildlands fire or vehicle fire, and that, consequently, exposes the building to a fire. [101, 2018]
- **A.3.4.7 Fire Model.** Due to the complex nature of the principles involved, models are often packaged as computer software. Any relevant input data, assumptions, and limitations needed to properly implement the model will be attached to the fire models. [101, 2018]

**A.3.4.8 Fire Scenario.** A fire scenario defines the conditions under which a proposed design is expected to meet the fire safety goals. Factors typically include fuel characteristics, ignition sources, ventilation, building characteristics, and occupant locations and characteristics. The term *fire scenario* includes more than the characteristics of the fire itself but excludes design specifications and any characteristics that do not vary from one fire to another; the latter are called assumptions. The term *fire scenario* is used here to mean only those specifications required to calculate the fire's development and effects, but, in other contexts, the term might be used to mean both the initial specifications and the subsequent development and effects (i.e., a complete description of fire from conditions prior to ignition to conditions following extinguishment). [101, 2018]

- **A.3.4.9 Fuel Load.** Fuel load includes interior finish and trim.
- **A.3.4.12 Performance Criteria.** Performance criteria are stated in engineering terms. Engineering terms include temperatures, radiant heat flux, and levels of exposure to fire products. Performance criteria provide threshold values used to evaluate a proposed design.
- **A.3.4.13 Proposed Design.** The design team might develop a number of trial designs that will be evaluated to determine whether they meet the performance criteria. One of the trial designs will be selected from those that meet the performance criteria for submission to the AHJ as the proposed design.

The proposed design is not necessarily limited to fire protection systems and building features. It also includes any component of the proposed design that is installed, established, or maintained for the purpose of life safety, without which the proposed design could fail to achieve specified performance criteria. Therefore, the proposed design often includes emergency procedures and organizational structures that are needed to meet the performance criteria specified for the proposed design.

**A.4.1** The categorization and classification of hazardous materials enables the code user to determine the applicability of requirements based on hazard category and class related to the physical and health hazards of materials. The current definitions found in Chapter 3 have been developed using a compilation of criteria found in NFPA codes and standards, requirements of the U.S. DOT, and in some cases definitions established by OSHA in 29 CFR.

The Globally Harmonized System of Classification and Labelling of Chemicals (GHS) has been developed based on standards for classification published by the United Nations (UN) Subcommittee of Experts on the GHS. The U.S. continues its efforts to incorporate the GHS in its federal regulatory scheme. OSHA published its revised Hazard Communication Standard (29 CFR 1910.1200) to align with the GHS in March 2012. The revised standard became effective in May 2012.

It is anticipated by the Committee that over time, the GHS will be reviewed for applicability and possible integration into the regulatory scheme developed in NFPA 400 for hazardous materials storage, use, and handling. The evolution of this system of classification will be facilitated by the changes associated with classification, labeling, and safety data sheets. It is not anticipated that the GHS will be fully implemented immediately within NFPA 400, recognizing the historical basis that exists for some of the classifications of materials, such as flammable and combustible liquids.

- **A.4.4** Where a conflict exists between applicable requirements, an analysis should be made and the proper applicable requirement should be implemented or conformed to subject to the approval of the AHJ.
- **A.4.5** The safe handling, collection, and disposal of hazardous waste can be accomplished only if the physical, chemical, and hazardous properties of its components are known and that information is properly applied. The categorization of a material as waste is normally under the purview of the user. In some cases the waste might be contaminated or "off spec" material, or material where the concentration of the hazardous components has been diluted. In other cases the waste might consist of cleaning materials that have become contaminated with a hazardous material.

The classifiers of waste are cautioned that the classification of hazardous waste under the requirements of the Environmental Protection Agency (EPA) or Department of Transportation (DOT) for labeling required for shipping purposes might not correspond to the system of classification incorporated into Section 4.1. In addition, some judgment is needed to apply the code in circumstances where the waste material is not in a form that is normally encountered when the hazardous material employed is in its virgin state. For example, a material that might not have been hazardous in its pure form might become hazardous when it becomes contaminated as use occurs. A tank of water used for rinsing parts on a plating line will eventually become contaminated by the materials that are being rinsed from parts as they travel through the line. If the concentration of the material being rinsed from parts becomes high enough, the content of hazardous materials in the rinse tank might be present in a concentration sufficient enough to cause the waste rinse water to be classified as hazardous. See Section B.5 for examples on the classification of dilute solutions of common corrosive materials.


In many cases the waste material could be a mixture of materials that must be classified in accordance with the requirements of Section 4.3.

- **A.4.5.1** Just because a decision has been made that a material no longer has a useful life does not exempt the material from compliance with the applicable provisions of the code. Materials that have been classified as hazardous based on the system of classification used in Section 4.1 are required to comply with applicable sections of the code in the same manner as might be required for nonwaste material.
- **A.4.6.1** The provisions of 4.6.1 do not require inherently noncombustible materials to be tested in order to be classified as noncombustible materials. [5000:A,7.1.4.1]
- **A.4.6.1.1(1)** Examples of such materials include steel, concrete, masonry, and glass. [5000:A.7.1.4.1.1(1)]
- **A.4.6.2** Material subject to increase in combustibility or flame spread index beyond the limits herein established through the effects of age, moisture, or other atmospheric condition is considered combustible. (*See NFPA 259 and NFPA 220.*) [5000:A,7.1.4.2]
- △ A.5.1 This chapter introduces the concepts of control areas and MAQ. The purpose is to permit limited amounts of hazardous contents in occupancies having minimum controls without triggering the more restrictive Protection Level 1 through Protection Level 4 building requirements. The MAQs in Table 5.2.1.1.3 and Table 5.2.1.2.1 are based on demonstrated need

and historical safe storage and use of hazardous contents. Section 5.3, however, establishes additional controls for occupancies exceeding the hazardous contents limits prescribed for control areas.

All of the hazardous materials within the scope of 1.1.1 are high-hazard contents [see 4.2.1.1]. However, not all of the hazardous materials categories are placed into high-hazard levels 1–4 requiring Protection Levels 1–4 are considered to be high-hazard contents, and some of these materials have been recognized as being of low or ordinary hazards, depending on their nature in a fire. In some cases, Class 1 unstable (reactive) materials, Class 1 water-reactive materials, and Class IV and Class V organic peroxides do not have a MAQ and, therefore, are not required to comply with the requirements for Protection Level 1 through Protection Level 4. Figure A.5.1 helps to illustrate the conditions under which the protection level requirements are applicable.

- **N A.5.2.1.1.2** Powered industrial trucks' power packs and fuel tanks (electrolyte, compressed gas, or propane) do not count toward the MAQs for such chemicals. Powered industrial trucks do not count as part of the emergency power or uninterrupted power supply amounts.
- △ A.5.2.1.1.3 Where footnote a and footnote b both apply, the increase for footnote a and footnote b is permitted to be applied accumulatively (or additively). For example, the MAQ for the storage of a flammable solid is 125 lb (57 kg). If the material is stored in an approved cabinet in accordance with this code, the MAQ will increase to 250 lb (113 kg) (footnote a). If the building is equipped throughout with an automatic sprinkler system in accordance with NFPA 13, the MAQ will increase to 250 lb (113 kg) (footnote b). If both footnote a and footnote b apply, the MAQ will be 500 lb (226 kg).

See A.5.2.1.5.3 for more information on and examples of applying MAQ increases to control areas.

**NA.5.2.1.5.3** The MAQ is an amount of material generally felt to represent a reasonable risk, or an amount that does not represent a significant risk when a specific control has been applied.

Where Table 5.2.1.1.3 allows for a 100 percent increase in the MAQ for quantities stored in approved cabinets or another specified control, a combination of storage both inside and outside approved cabinets in the control area is permitted. Storage amounts up to the MAQ are allowed outside of cabinets where the 100 percent increase is applied.

Example: The MAQ for storage of a Class 2 oxidizer is 250 lb (113 kg). The MAQ is allowed to be increased 100 percent to 500 lb (226 kg) per control area where stored in approved cabinets. Because the MAQ allows for 250 lb (113 kg) of Class 2 oxidizers outside of cabinets, only 250 lb (113 kg) of the 500 lb (226 kg) is required to be confined to cabinets.

Similarly, where Table 5.2.1.1.3 allows for a 100 percent increase for both cabinets and building sprinklers, storage outside of cabinets is permitted in the control area up to the MAQ for sprinklered buildings even after the cabinet increase is applied.

Example: The MAQ for storage of a Class 2 oxidizer is 250 lb (113 kg). The MAQ is allowed to be increased 100 percent to 500 lb (226 kg) in buildings equipped throughout with an approved sprinkler system. The MAQ is also allowed to be increased 100 percent where stored in approved storage cabinets. Because both increases are allowed and the sprinklered building increase allows for storage of 500 lb (226 kg) outside of cabinets, only 500 lb (226 kg) of the 1000 lb (454 kg) aggregate storage amount allowed is required to be confined to cabinets.

- **NA.5.4** Where a detached building is required for indoor storage in accordance with Table 5.3.7, detached outdoor storage can be used in lieu of indoor storage. Where detached outdoor storage is implemented, the outdoor storage requirements in Chapter 5, Chapter 6, and any material-specific chapters apply.
  - **A.6.1.1.1** Outdoor control areas are not classified with protection levels.
  - **A.6.1.1.2** Outdoor control areas are not classified with protection levels.
  - A.6.1.2 Readily available can mean access to the product manufacturer's or user's paper or electronic copies of SDSs.
  - **A.6.1.3.4** There might be additional regulations that must be complied with to notify other agencies.
  - A.6.1.4 The hazard potential of a facility is not dependent on any single factor. Physical size, number of employees, and the quantity and the nature of the hazardous materials are important considerations. The level of training can vary with the complexity of the facility under consideration.
  - A.6.1.4.4 Emergency responders can include on-site personnel that have been designated and trained to respond to emergencies, persons from the public sector such as fire department personnel, or persons from the private sector that can be contracted or otherwise engaged to perform emergency response duties. (See Annex I.)

A.6.1.4.4.1 OSHA describes an Incident Command System as a standardized on-scene incident management concept designed specifically to allow responders to adopt an integrated organizational structure equal to the complexity and demands of any single incident or multiple incidents without being hindered by jurisdictional boundaries.

- **A.6.1.4.4.2** Responses to releases of hazardous materials where there is no potential safety or health hazard such as fire, explosion, or chemical exposure are not considered emergency responses as defined within the context of this code.
- **A.6.1.4.4.3** Emergency response training will vary depending on the level of emergency response required and by the requirements of the governmental agency.
- A.6.1.5.3.1 The approved powered industrial trucks addressed in NFPA 505 are trucks that are listed by a testing laboratory for the use intended and should be tested and labeled in accordance with ANSI/UL 558, Standard for Safety Industrial Trucks, Internal Combustion Engine-Powered, or ANSI/UL 583, Standard for Safety Electric-Battery-Powered Industrial Trucks.
- A.6.1.14 For seismic requirements and the seismic zone in which the material is located, see the building code.
- **A.6.1.16.1** Maintenance procedures are an important part of any mechanical integrity program. They should contain information on which equipment is covered; what tests and inspections are to be performed; how to perform the tests and inspections in accordance with recognized industry standards and manufacturer's recommendations; what constitutes acceptance of the measured parameters; corrective actions to be taken if the equipment does not meet requirements; and the frequency of the testing and inspection. For examples of additional guidance, refer to Guidelines for Mechanical Integrity Systems (AIChE/CCPS); Guidelines for Safe and Reliable Instrumented Protective Systems (AIChE/CCPS); and Guidelines for Writing Effective Operating and Maintenance Procedures (AIChE/CCPS).
- A.6.1.16.2.3 Testing can include visual inspection, x-ray, spark testing, pressure testing, leak testing, or other nondestructive methods.
- A.6.2.1.6 The following items should be considered in the design:
- (1)Deflagration vents designed to release from the exterior walls or roofs of the building should discharge directly to the exterior of the building where an unoccupied space of not less than 50 ft (15 m) in width is provided between the exterior walls of the building and the property line, unless the vents comply with A.6.2.1.6(2).
- Deflagration vents designed to remain attached to the building when venting a deflagration should be located so that the discharge opening is not less than 10 ft (3050 mm) vertically from window openings and exit discharge doors in the building and not less than 20 ft (6100 mm) horizontally from exit discharge doors in the building, window openings and exit discharge doors in adjacent buildings on the same property, and property lines.
- Deflagration vents should not discharge into the interior of the building.
- Additional guidance for deflagration venting can be found in NFPA 68.

(5) An authoritative standard used for the design of barricades is TM 5-1300 (NAVFAC P-397, AFM 88-22), "Structures to Resist the Effects of Accidental Explosions."

A.6.2.2.2.1 The use of multistoried detached buildings that might be needed to house special processes in occupancies requiring Protection Level 1 controls might be able to be approved through the use of alternative materials and methods. As detonation of Protection Level 1 materials is contemplated, the analysis of the proposed design must consider activities, occupancy, and means of egress from each level of the building. In some instances the "floors" in the process area might be of open grated construction. The restrictions regarding use for other purposes are intended to exclude other uses not directly related to the process or storage being conducted. Control rooms, restrooms, and ancillary electrical and mechanical rooms directly associated with the process are allowed. An engineering office, conference room, cafeteria, or similar use, although related to the process, would not be allowed, as these uses have occupancy that is outside of that intended to be addressed by Protection Level 1 controls.

It is to be expected that materials with multiple hazards might be present, and not intended that such materials be excluded providing those that are incompatible are separated by distance or barrier as required. Also see 6.2.2.2.3.

A.6.2.3.4.1 The use of multistoried detached buildings that might be needed to house special processes in occupancies requiring Protection Level 1 controls might be able to be approved through the use of alternative materials and methods. As detonation of Protection Level 1 materials is contemplated, the analysis of the proposed design must consider activities, occupancy, and means of egress from each level of the building. In some instances the "floors" in the process area might be of open grated construction. The restrictions regarding use for other purposes are intended to exclude other uses not directly related to the process or storage being conducted. Control rooms, restrooms, and ancillary electrical and mechanical rooms directly associated with the process are allowed. An engineering office, conference room, cafeteria, or similar use, although related to the process, would not be allowed, as these uses have occupancy that is outside of that intended to be addressed by Protection Level 1 controls.

It is to be expected that materials with multiple hazards might be present, and not intended that such materials be excluded providing those that are incompatible are separated by distance or barrier as required. Also see 6.2.2.2.3.

A.6.2.4.4.1 The use of multistoried detached buildings that might be needed to house special processes in occupancies requiring Protection Level 1 controls might be able to be approved through the use of alternative materials and methods. As detonation of Protection Level 1 materials is contemplated, the analysis of the proposed design must consider activities, occupancy, and means of egress from each level of the building. In some instances the "floors" in the process area might be of open grated construction. The restrictions regarding use for other purposes are intended to exclude other uses not directly related to the process or storage being conducted. Control rooms, restrooms, and ancillary electrical and mechanical rooms directly associated with the process are allowed. An engineering office, conference room, cafeteria, or similar use, although related to the process, would not be allowed, as these uses have occupancy that is outside of that intended to be addressed by Protection Level 1 controls.

It is to be expected that materials with multiple hazards might be present, and not intended that such materials be excluded providing those that are incompatible are separated by distance or barrier as required. Also see 6.2.2.2.3.

- **A.6.3.1** For storage, see Section 6.3.
- A.7.1 Laboratory operations defined in NFPA 45 are not considered to be industrial processes.
- A.7.1.2.1(3) One example is a maximum airborne concentration that does exceed an Emergency Response Planning Guide (ERPG-2) concentration at 65.6 ft (20 m) for 1 hour.
- **A.7.2.1** Understanding the hazards associated with chemicals and applying a means to control those hazards will vary depending on the nature of the chemicals used and the processing conditions. The level of understanding needed might consist of reviewing the basic hazard information contained within safety data sheets for chemicals being used, or to more detailed analytical techniques, including, but not limited to, a formal process hazards analysis described in other publications.
- A.7.3.1.2 Operating procedures help control the hazards in a process and provide guidance and direction on how to operate the process. Operating procedures also provide information about the hazards of the process and how those hazards are controlled and are also essential for training the operators. Operating procedures contain, but are not limited to, the following:
- (1)Clear instructions for all phases of operation, including startup, normal operation, emergency shutdown, emergency operations, and startup after an unscheduled shutdown or maintenance
- The safe limits of operation for each process variable, the consequences of deviations, and the corrective actions that should be taken
- A discussion of the safety systems that are used to control the hazards of the process, including but not limited to instrumentation, alarms, interlocks, pressure relief and effluent handling systems, water sprays, deluge systems, and containment systems
- Safe work practices for preparing equipment for maintenance, including but not limited to lockout/tagout, opening process equipment, confined space entry, hot work and admission of visitors, contractor, maintenance and other support personnel into the process area

For guidance on preparing operating procedures, refer to the latest editions of Guidelines for Technical Management of Chemical Process Safety (AIChE/CCPS); Guidelines for Safe Process Operations and Maintenance (AIChE/CCPS); and Guidelines for Writing Effective Operating and Maintenance Procedures (AIChE/CCPS).

- **A.7.3.2.2** The inspection and testing of alarms, interlocks, and controls are to ensure the safe operation of process equipment as designed. These systems include, but are not limited to, emergency alarms, shutdown systems, and isolation systems.
- A.7.4 Conditions that might require repeating a review include, but are not limited to, the following:
- When changes occur in the materials in process (1)
- (2)When changes occur in process equipment
- (3) When changes occur in process control
- When changes occur in operating procedures

**A.7.5.1** The investigation should begin as soon as possible to avoid loss of critical information, but should be initiated not later than 48 hours after the incident. The contributing and root causes of the incident should be determined. A procedure should be in place to promptly address and resolve incident findings. All actions to correct the causes and the dates completed should be documented. The incident report should be communicated to all affected personal. Measures should be taken to prevent a recurrence.

#### **A.9.1.2** See Annex D.

△ A.10.1 The performance option of this code establishes acceptable levels of risk for facilities (i.e., buildings and other structures and the operations therewith associated) as addressed in Section 1.3. (Note that *facility* and *building* can be used interchangeably; *facility* is the more general term.) While the performance option of this code does contain goals, objectives, and performance criteria necessary to provide for an acceptable level of risk, it does not describe how to meet these goals, objectives, and performance criteria. Design and engineering are needed to meet the provisions of Chapter 5. For fire protection designs, the *SFPE Engineering Guide to Performance-Based Fire Protection* provides a framework for these assessments.

Preconstruction design requirements address those issues, which have to be considered before the certificate of occupancy is issued for a facility.

- **A.10.1.1** Performance code approaches written for other model codes can be used by the AHJ.
- **A.10.1.2** Performance code approaches written for other model codes can be used by the AHJ.
- **A.10.1.3** Qualifications should include experience, education, and credentials that demonstrate knowledge and responsible use of applicable models and methods.
- △ A.10.1.4 The SFPE Engineering Guide to Performance-Based Fire Protection outlines a process for using a performance-based approach in the design and assessment of building fire safety design and identifies parameters that should be considered in the analysis of a performance-based design. As can be seen, this process requires the involvement of all stakeholders who have a share or interest in the successful completion of the project. The steps that are recommended by the SFPE Engineering Guide to Performance-Based Fire Protection for this process are shown in Figure A.10.1.4.

The guide specifically addresses building fire safety performance-based design. It might not be directly applicable to performance-based designs involving other systems and operations covered within this code, such as hot work operations or hazardous materials storage. However, the various steps for defining, developing, evaluating, and documenting the performance-based design should still provide a useful framework for the overall design process.

The steps in the performance-based design process are as follows:

- (1) Step 1: Defining Project Scope. The first step in a performance-based design is to define the scope of the project. Defining the scope consists of identifying and documenting the following:
  - (a) Constraints on the design and project schedule

(b) The stakeholders associated with project

- (c) The proposed building construction and features desired by the owner or tenant
- (d) Occupant and building characteristics
- (e) The intended use and occupancy of the building
- (f) Applicable codes and regulations

An understanding of these items is needed to ensure that a performance-based design meets the stakeholders' needs.

- (2) Step 2: Identifying Goals. Once the scope of the project is defined, the next step in the performance-based design process is to identify and document the fire safety goals of various stakeholders. Fire safety goals could include levels of protection for people and property, or they could provide for continuity of operations, historical preservation, and environmental protection. Goals could be unique for different projects, based on the stakeholders' needs and desires. The stakeholders should discuss which goals are the most important for the project. In order to avoid problems later in the design process, all stakeholders should be aware of and agree to the goals prior to proceeding with the performance-based design process (see Step 7).
- (3) Step 3: Defining Stakeholder and Design Objectives. The third step in the design process is to develop objectives. The objectives are essentially the design goals that are further refined into tangible values that can be quantified in engineering terms. Objectives could include mitigating the consequences of a fire expressed in terms of dollar values, loss of life, or other impact on property operations, or maximum allowable conditions, such as extent of fire spread, temperature, spread of combustion products, and so forth.
- (4) Step 4: Developing Performance Criteria. The fourth step in the design process is the development of performance criteria to be met by the design. These criteria are a further refinement of the design objectives and are numerical values to which the expected performance of the trial designs can be compared. Performance criteria could include threshold values for temperatures of materials, gas temperatures, carboxyhemoglobin (COHb) levels, smoke obscuration, and thermal exposure levels.
- (5) Step 5: Developing Design Scenarios. Once the performance criteria have been established, the engineer will develop and analyze design alternatives to meet performance criteria. The first part of this process is the identification of possible scenarios and design scenarios. Fire scenarios are descriptions of possible fire events, and consist of fire characteristics, building characteristics (including facility operations), and occupant characteristics. The fire scenarios identified will subsequently be filtered (i.e., combined or eliminated) into a subset of design fire scenarios against which trial designs will be evaluated. Hazardous materials scenarios can be treated similarly.
- (6) Step 6: Developing Trial Design(s). Once the project scope, performance criteria, and design scenarios are established, the engineer develops preliminary designs, referred to as trial designs, intended to meet the project requirements. The trial design(s) include proposed fire protection systems, construction features, and operation that are provided in order for a design to meet the performance criteria when evaluated using the design fire scenarios. The evaluation method should also be determined at this point. The evaluation methods used

- should be appropriate for the situation and agreeable to the stakeholders.
- (7) Step 7: Developing a Fire Protection Engineering Design Brief. At this point in the process a fire protection engineering design brief should be prepared and provided to all stakeholders for their review and concurrence. This brief should document the project scope, goals, objectives, trial designs, performance criteria, design fire scenarios, and analysis methods. Documenting and agreeing upon these factors at this point in the design process will help avoid possible misunderstandings later.
- (8) Step 8: Evaluating Trial Designs. Each trial design is then evaluated using each design scenario. The evaluation results will indicate whether the trial design will meet the performance criteria. Only trial design(s) that meet the performance criteria can be considered as final design proposals. Yet, the performance criteria can be revised with the stakeholders' approval. The criteria cannot be arbitrarily changed to ensure that a trial design meets a criterion, but can be changed based on additional analysis and the consideration of additional data.
- (9) Step 9: Modifying Designs or Objectives. If none of the trial designs evaluated comply with the previously agreed upon performance criteria, it could be necessary to either develop and evaluate new trial designs, or revisit the objectives and performance criteria previously agreed upon by the stakeholders to determine if stakeholder objectives and performance criteria should be modified.
- (10) Step 10: Selecting the Final Design. Once an acceptable trial design is identified using the evaluation, it can be considered for the final project design. If multiple trial designs are evaluated, further analysis will be needed to select a final design. The selection of an acceptable trial design for the final design could be based on a variety of factors, such as financial considerations, timeliness of installation, system and material availability, ease of installation, maintenance and use, and other factors.
- (11) Step 11: Preparing Performance-Based Design Report. Once the final design is identified, design documents need to be prepared. Proper documentation will ensure that all stakeholders understand what is necessary for the design implementation, maintenance, and continuity of the fire protection design. The documentation should include the fire protection engineering design brief, a performance design report, detailed specifications and drawings, and a facility operations and maintenance manual.
- Step 12: Preparing Specifications, Drawings, and Operations and Maintenance Manual. The specifications and drawings portion of the performance-based design report convey to building and system designers and installing contractors how to implement the performance design. Specifications and drawings could include required sprinkler densities; hydraulic characteristics and spacing requirements; the fire detection and alarm system components and programming; special construction requirements, including means of egress and location of fire-resistive walls; compartmentation; and the coordination of interactive systems. The detailed specifications are the implementation document of the performancebased design report. The detailed drawings will graphically represent the results of the performance design. The operations and maintenance (O&M) manual clearly states the requirement of the facility operator to ensure

that the components of the performance design are in place and operating properly. The O&M manual describes the commissioning requirements and the interaction of the different systems' interfaces. All subsystems are identified, and inspection and testing regimes and schedules are created.

The O&M manual also gives instruction to the facility operator on restrictions placed on facility operations. These limitations are based on the engineering assumptions made during the design and analysis. These limiting factors could include critical fire load, sprinkler design requirements, building use and occupancy, and reliability and maintenance of systems. The O&M manual can be used to communicate to tenants and occupants these limits and their responsibilities as a tenant. It could also be used as a guide for renovations and changes. It also can be used to document agreements between stakeholders.

**A.10.1.5** A third-party reviewer is a person or group of persons chosen by the AHJ to review proposed performance-based designs. Qualifications of the third-party reviewer should include experience, education, and credentials that demonstrate knowledge and responsible use of applicable models and methods.

**A.10.1.8** See Step 12 of A.10.1.4 for a description of these documents.

**A.10.1.9** Information that could be needed by the fire service arriving at the scene of a fire in a performance-based designed facility includes, but is not limited to, the following:

- (1) Safe shutdown procedures of equipment and processes
- (2) Facility personnel responsible for assisting the fire service
- (3) Operating procedures required to maintain the effectiveness of the performance-based designed fire protection system (i.e., when it is and is not appropriate to alter, shut down, or turn off a design feature; assumptions that have to be maintained if a fire occurs; suggested fire-fighting tactics that relate to the specific nature of the performance-based design)

The design specifications and O&M manual documentation described in 10.1.8 should provide a guide for the facility owner and tenants to follow in order to maintain the required level of safety anticipated by the original design. It should also provide a guide for the AHJ to use in conducting ongoing inspections of the facility.

**A.10.1.10** Continued compliance with the goals and objectives of the code involves many factors. The building construction, including openings, interior finish, and fire- and smokeresistive construction, and the building and fire protection systems need to retain at least the same level of performance as is provided for by the original design parameters. The use and occupancy should not change to the degree that assumptions made about the occupant characteristics, combustibility of furnishings, and existence of trained personnel are no longer valid. In addition, actions provided by other personnel, such as emergency responders, should not be diminished below the documented assumed levels. Also, actions needed to maintain reliability of systems at the anticipated level need to meet the initial design criteria.

Subsection 10.1.10 deals with issues that arise after the facility has been constructed and a certificate of occupancy has been issued. Therefore, any changes to the facility or the oper-




FIGURE A.10.1.4 Steps in the Performance-Based Analysis and the Conceptual Design Procedure for Fire Protection Design.

ations conducted therein, up to and including the demolition of the facility, that affect the assumptions of the original design are considered part of the management of change.

The following is a process for evaluating performance-based facilities:

- Review of original design analysis and documentation as follows:
  - (a) Assumptions
  - (b) Input parameter values

- (c) Predictions and/or results of other calculations
- (2) Review of design analysis and documentation for any subsequent renovations, additions, modifications, and so forth, as in Step 1 of A.10.1.4
- (3) Review of the facility's operations and maintenance manual, including any and all revisions to it
- (4) On-site inspection, involving the following:
  - (a) Consideration of "prescriptive" issues (e.g., blocked egress paths, poor maintenance of systems)

- (b) Comparison of assumptions to specific, pertinent on-site conditions
- (c) Comparison of input parameter values to pertinent on-site conditions
- (d) Review of maintenance and testing documentation to ensure adherence to the schedules detailed in the facility's O&M manual
- (5) Reconciliation of discrepancies as follows:
  - (a) A listing of discrepancies
  - (b) Consultation with the facility owner and/or their representative
  - (c) Preparation of a schedule that reconciles the discrepancies
- **A.10.1.11** Private fire inspection services can be used to meet this provision provided that they are qualified to assess the impact of changes on the performance-based design and assumptions.
- **A.10.2.2** The performance criteria in Section 10.2 define an acceptable level of performance that should be agreed upon by the stakeholders, including the owner and the AHJ. The acceptable level of performance can vary widely between facilities based on a number of factors, including the existence of potential ignition sources, potential fuel loads present, reactivity and quantity of hazardous materials present, the nature of the operations conducted at the facility, and the characteristics and number of personnel likely to be present at the facility.
- **A.10.2.2.1** Many of the performance criteria related to safety from fire can also be found in the annex of NFPA *101*.
- **A.10.2.2.2** It is anticipated that the design provides protection for occupants who are not intimate with the initial unintentional detonation or deflagration of explosive materials, and individuals immediately adjacent to the property. It is recognized that employees should be trained and knowledgeable in the hazards of the materials present in the workplace. It is recognized that some of these individuals could experience psychological and physical injuries, such as hearing problems, on either a short or long term basis. However, the intent is that they do not experience thermal burns or loss of life or limb as a direct result of the explosion.

It is not the intent of the code to provide protection against explosions caused by acts of terrorism. This would involve the introduction of an unknown quantity of explosives in an unknown location within or adjacent to a building. Where protection is needed against such acts of terrorism, the appropriate military and law enforcement agencies should be consulted

**A.10.2.2.3** Given the nature and variety of hazardous materials, more than one performance criterion for a specific facility could need to be developed. Criteria have to be developed for each hazardous material and possibly for different personnel; for example, higher levels of exposure can be tolerated by personnel that are in some way protected than those personnel having no protection. Development of performance criteria for hazardous materials should be developed by the facility owner and the facility's safety personnel in conjunction with the AHJ and the emergency response personnel expected to respond to an incident.

It is anticipated that the design provides protection for occupants inside or immediately adjacent to the facility who are not intimate with the initial unauthorized release of hazardous materials, or the initial unintentional reaction of hazardous materials. However, it is assumed that these individuals depart from the area of the incident in a time frame reasonable for their circumstances, based on their observation of the event, or some other form of notification.

It is also anticipated that employees and emergency response personnel are trained and aware of the hazardous materials present in the facility, and the potential consequences of their involvement in the incident, and take appropriate measures to ensure their own safety during search and rescue operations.

It is not the intent of the code to provide protection against acts of terrorism involving the introduction of hazardous materials into a facility. This involves the introduction of an unknown quantity of materials in an unknown location within or adjacent to a building. Where protection is needed against such acts of terrorism, the appropriate military and law enforcement agencies should be consulted.

**A.10.2.2.4** Each facility designed using a performance-based approach most likely has different levels of acceptable and unacceptable property damage. This reflects the unique aspects of the performance-based designed facility and the reasons for pursuing a performance-based design. Therefore, the definition of an acceptable and an unacceptable level of property damage results from discussions between the facility's owner, manager and engineer, the designer, (possibly) the insurance underwriter and field engineer, and the AHJ. There could be cases where a property damage criterion is not needed.

Note that the structural integrity performance criteria for property damage most likely differ from the structural integrity performance criteria for life safety. This reflects the difference in the associated objectives: A life safety criterion probably is more restrictive than one for property damage.

- **A.10.2.2.5** Each facility designed using a performance-based approach most likely has a different level of acceptable and unacceptable interruption of the facility's mission. This reflects the unique aspects of the performance-based designed facility and the reasons for pursuing a performance-based design. Therefore, the definition of an acceptable and an unacceptable interruption of the facility's mission results from discussions between the facility's owner, manager and engineer, the designer, (possibly) the insurance underwriter and field engineer, and the AHJ. There could be cases where a mission continuity criterion is not needed.
- **A.10.3.2** In jurisdictions where NFPA electrical standards are not adopted, the provisions of the electrical standards adopted by the AHJ should be used.
- **A.10.3.4** In jurisdictions where NFPA *101* is not adopted, the provisions of the building code adopted by the AHJ should be used.
- **A.10.4** Many events can occur during the life of a facility; some have a higher probability of occurrence than others. Some events, though not typical, could have a devastating effect on the facility. A reasonable design should be able to achieve the goals, objectives, and performance criteria of this code for any typical or common design scenario and for some of the nontypical, potentially devastating scenarios, up to some level commensurate with society's expectations as reflected in this code.

The challenge in selecting design scenarios is finding a manageable number that are sufficiently diverse and representative so that, if the design is reasonably safe for those scenarios, it should then be reasonably safe for all scenarios, except for those specifically excluded as being unrealistically severe or sufficiently infrequent to be fair tests of the design.

- △ A.10.4.1.2 The SFPE Engineering Guide to Performance-Based Fire Protection identifies methods for evaluating fire scenarios.
  - **A.10.4.1.3** It is desirable to consider a wide variety of different design scenarios to evaluate the complete capabilities of the building or structure. Design scenarios should not be limited to one or two worst-case events.
  - A.10.4.2.1 An example of such a scenario for a health care occupancy is a patient room with two occupied beds with a fire initially involving one bed and the room door open. This is a cursory example in that much of the explicitly required information indicated in 10.4.2.1 can be determined from the information provided in the example. Note that it is usually necessary to consider more than one scenario to capture the features and conditions typical of an occupancy.
  - **A.10.4.2.2** Examples of such scenarios are a fire involving ignition of gasoline as an accelerant in a means of egress, clothing racks in corridors, renovation materials, and other fuel configurations that can cause an ultrafast fire. The means of egress chosen is the doorway with the largest egress capacity among doorways normally used in the ordinary operation of the building. The baseline occupant characteristics for the property are assumed. At ignition, doors are assumed to be open throughout the building.
  - **A.10.4.2.3** An example of such a scenario is a fire in a storage room adjacent to the largest occupiable room in the building. The contents of the room of fire origin are specified to provide the largest fuel load and the most rapid growth in fire severity consistent with the normal use of the room. The adjacent occupiable room is assumed to be filled to capacity with occupants. Occupants are assumed to be somewhat impaired in whatever form is most consistent with the intended use of the building. At ignition, doors from both rooms are assumed to be open. Depending on the design, doorways connect the two rooms or they connect via a common hallway or corridor.

For purposes of this scenario, an occupiable room is a room that could contain people (i.e., a location within a building where people are typically found).

- **A.10.4.2.4** An example of such a scenario is a fire originating in a concealed wall- or ceiling-space adjacent to a large, occupied function room. Ignition involves concealed combustibles, including wire or cable insulation and thermal or acoustical insulation. The adjacent function room is assumed to be occupied to capacity. The baseline occupant characteristics for the property are assumed. At ignition, doors are assumed to be open throughout the building.
- **A.10.4.2.5** An example of such a scenario is a cigarette fire in a trash can. The trash can is close enough to room contents to ignite more substantial fuel sources but is not close enough to any occupant to create an intimate-with-ignition situation. If the intended use of the property involves the potential for some occupants to be incapable of movement at any time, then the room of origin is chosen as the type of room likely to have such occupants, filled to capacity with occupants in that condition. If the intended use of the property does not involve the

potential for some occupants to be incapable of movement, then the room of origin is chosen to be an assembly or function area characteristic of the use of the property, and the trash can is placed so that it is shielded by furniture from suppression systems. At ignition, doors are assumed to be open throughout the building.

**A.10.4.2.6** An example of such a scenario is a fire originating in the largest fuel load of combustibles possible in normal operation in a function or assembly room or in a process/ manufacturing area, characteristic of the normal operation of the property. The configuration, type, and geometry of the combustibles are chosen so as to produce the most rapid and severe fire growth or smoke generation consistent with the normal operation of the property. The baseline occupant characteristics for the property are assumed. At ignition, doors are assumed to be closed throughout the building.

This scenario includes everything from a big couch fire in a small dwelling to a rack storage fire in combustible liquids stock in a big box retail store.

**A.10.4.2.7** An example of such a scenario is an exposure fire. The initiating fire is the closest and most severe fire possible consistent with the placement and type of adjacent properties and the placement of plants and combustible adornments on the property. The baseline occupant characteristics of the property are assumed.

This category includes wildland/urban interface fires and exterior wood shingle problems, where applicable.

A.10.4.2.8 This scenario addresses a set of conditions with a typical fire originating in the building with any one passive or active fire protection system or feature being ineffective. Examples include unprotected openings between floors or between fire walls or fire barrier walls, rated fire doors that fail to close automatically or are blocked open, sprinkler system water supply that is shut off, a fire alarm system that is nonoperative, a smoke management system that is not operational, or automatic smoke dampers that are blocked open. This scenario should represent a reasonable challenge to the other building features provided by the design and presumed to be available.

The exemption from Fire Design Scenario 8 is applied to each active or passive fire protection system individually and requires two different types of information to be developed by analysis and approved by the AHJ. System reliability is to be analyzed and accepted. Design performance in the absence of the system is also to be analyzed and accepted, but acceptable performance does not require fully meeting the stated goals and objectives. It might not be possible to meet fully the goals and objectives if a key system is unavailable, and yet no system is totally reliable. The AHJ determines which level of performance, possibly short of the stated goals and objectives, is acceptable, given the very low probability (that is, the system's unreliability probability) that the system will not be available.

**A.10.4.3.1** This scenario is intended to address facilities where explosives and products containing explosives are manufactured, stored, sold, or handled. From an overall safety standpoint, the operations being performed at these facilities should include stringent safety procedures that significantly reduce the likelihood of an explosion from occurring. However, if an explosion does occur, protection methods such as storage magazines, property set backs, deflagration, and explosion

venting and containment need to be in place, as appropriate, to minimize potential injury and loss of life and property.

Where products containing explosives, such as pyrotechnic displays or fireworks, are stored, handled, or used in buildings, such as arenas, an explosion scenario should not result in significant injuries to occupants not intimate with the materials.

**A.10.4.4** Design hazardous materials scenarios should explicitly account for the following:

- (1) Occupant activities, training, and knowledge
- (2) Number and location of occupants
- (3) Discharge location and surroundings
- (4) Hazardous materials' properties
- (5) Ventilation, inerting, and dilution systems and conditions
- (6) Normal and emergency operating procedures
- (7) Safe shutdown and other hazard mitigating systems and procedures
- (8) Weather conditions affecting the hazard
- (9) Potential exposure to off-site personnel

Design hazardous materials scenarios should be evaluated as many times as necessary by varying the factors previously indicated. Design hazardous materials scenarios could need to be established for each different type of hazardous material stored or used at the facility.

**A.10.4.4.4.2** This provision should be applied to each protection system individually and requires two different types of information to be developed by analysis and approved by the AHJ. System reliability is to be analyzed and accepted. Design performance in the absence of the system is also to be analyzed and accepted, but acceptable performance does not require fully meeting the stated goals and objectives. It might not be possible to meet fully the goals and objectives if a key system is unavailable, and yet no system is totally reliable. The AHJ determines which level of performance, possibly short of stated goals and objectives, is acceptable, given the very low probability (that is, the systems' unreliability probability) that the system will be unavailable.

**A.10.4.5.1** An example of such a scenario would involve a fire or earthquake effectively blocking the principal entrance/exit but not immediately endangering the occupants. The full occupant load of the assembly space has to exit using secondary means

**A.10.6** The assessment of precision required in 10.7.7 requires a sensitivity and uncertainty analysis, which can be translated into safety factors.

Sensitivity Analysis. The first run a model user makes should be labeled as the base case, using the nominal values of the various input parameters. However, the model user should not rely on a single run as the basis for any performance-based fire safety system design. Ideally, each variable or parameter that the model user made to develop the nominal input data should have multiple runs associated with it, as should combinations of key variables and parameters. Thus, a sensitivity analysis should be conducted that provides the model user with data that indicates how the effects of a real fire could vary and how the response of the proposed fire safety design could also vary.

The interpretation of a model's predictions can be a difficult exercise if the model user does not have knowledge of fire dynamics or human behavior. Reasonableness Check. The model user should first try to determine whether the predictions actually make sense; that is, they don't upset intuition or preconceived expectations. Most likely, if the results don't pass this test, an input error has been committed.

Sometimes the predictions appear to be reasonable but are, in fact, incorrect. For example, a model can predict higher temperatures farther from the fire than close to it. The values themselves could be reasonable; for example, they are not hotter than the fire, but they don't "flow" down the energy as expected.

A margin of safety can be developed using the results of the sensitivity analysis in conjunction with the performance criteria to provide the possible range of time during which a condition is estimated to occur.

Safety factors and margin of safety are two concepts used to quantify the amount of uncertainty in engineering analyses. Safety factors are used to provide a margin of safety and represent, or address, the gap in knowledge between the theoretically perfect model; that is, reality and the engineering models that can only partially represent reality.

Safety factors can be applied to either the predicted level of a physical condition or to the time at which the condition is predicted to occur. Thus, a physical or a temporal safety factor, or both, can be applied to any predicted condition. A predicted condition (that is, a parameter's value) and the time at which it occurs are best represented as distributions. Ideally, a computer fire model predicts the expected or nominal value of the distribution. Safety factors are intended to represent the spread of these distributions.

Given the uncertainty associated with data acquisition and reduction, and the limitations of computer modeling, any condition predicted by a computer model can be thought of as an expected or nominal value within a broader range. For example, an upper layer temperature of 1110°F (600°C) is predicted at a given time. If the modeled scenario is then tested (that is, full-scale experiment based on the computer model's input data), the actual temperature at that given time could be 1185°F (640°C) or 1085°F (585°C). Therefore, the temperature should be reported either as 1110°F, +75°F or -25°F (600°C, +40°C or -15°C) or as a range of 1085°F to 1184°F (585°C to 640°C).

Ideally, predictions are reported as a nominal value, a percentage, or an absolute value. As an example, an upper layer temperature prediction could be reported as 1112°F (600°C), 86°F (30°C), or 1112°F (600°C), 5 percent. In this case, the physical safety factor is 0.05 (i.e., the amount by which the nominal value should be degraded and enhanced). Given the state-of-the-art of computer fire modeling, this is a very low safety factor. Physical safety factors tend to be on the order of tens of percent. A safety factor of 50 percent is not unheard of.

Part of the problem in establishing safety factors is that it is difficult to state the percentage or range that is appropriate. These values can be obtained when the computer model predictions are compared to test data. However, using computer fire models in a design mode does not facilitate this since (1) the room being analyzed has not been built yet and (2) test scenarios do not necessarily depict the intended design.

A sensitivity analysis should be performed based on the assumptions that affect the condition of interest. A base case that uses all nominal values for input parameters should be developed. The input parameters should be varied over reasonable ranges, and the variation in predicted output should be noted. This output variation can then become the basis for physical safety factors.

The temporal safety factor addresses the issue of when a condition is predicted and is a function of the rate at which processes are expected to occur. If a condition is predicted to occur 2 minutes after the start of the fire, then this can be used as a nominal value. A process similar to that described for physical safety factors can also be employed to develop temporal safety factors. In this case, however, the rates (e.g., of heat release and toxic product generation) will be varied instead of absolute values (e.g., material properties).

The margin of safety can be thought of as a reflection of societal values and can be imposed by the AHJ for that purpose. Since the time for which a condition is predicted is most likely the focus of the AHJ (e.g., the model predicts occupants have 5 minutes to safely evacuate), the margin of safety is characterized by temporal aspects and tacitly applied to the physical margin of safety.

Escaping the harmful effects of fire (or mitigating them) is, effectively, a race against time. When assessing fire safety system designs based on computer model predictions, the choice of an acceptable time is important. When an AHJ is faced with the predicted time of untenability, a decision needs to be made regarding whether sufficient time is available to ensure the safety of facility occupants. The AHJ is assessing the margin of safety. Is there sufficient time to get everyone out safely? If the AHJ feels that the predicted egress time is too close to the time of untenability, then the AHJ can impose an additional time that the designer has to incorporate into the system design. In other words, the AHJ can impose a greater margin of safety than that originally proposed by the designer.

△ A.10.7.1 The *SFPE Engineering Guide to Performance-Based Fire Protection* describes the documentation that should be provided for a performance-based design.

Proper documentation of a performance design is critical to the design acceptance and construction. Proper documentation also ensures that all parties involved understand what is necessary for the design implementation, maintenance, and continuity of the fire protection design. If attention to details is maintained in the documentation, then there should be little dispute during approval, construction, startup, and use.

Poor documentation could result in rejection of an otherwise good design, poor implementation of the design, inadequate system maintenance and reliability, and an incomplete record for future changes or for testing the design forensically.

- **A.10.7.2** The sources, methodologies, and data used in performance-based designs should be based on technical references that are widely accepted and used by the appropriate professions and professional groups. This acceptance is often based on documents that are developed, reviewed, and validated under one of the following processes:
- Standards developed under an open consensus process conducted by recognized professional societies, codes or standards organizations, or governmental bodies

(2) Technical references that are subject to a peer review process and published in widely recognized peer-reviewed journals, conference reports, or other publications

(3) Resource publications such as the SFPE Handbook of Fire Protection Engineering, which are widely recognized technical sources of information

The following factors are helpful in determining the acceptability of the individual method or source:

- Extent of general acceptance in the relevant professional community. Indications of this acceptance include peerreviewed publication, widespread citation in the technical literature, and adoption by or within a consensus document.
- (2) Extent of documentation of the method, including the analytical method itself, assumptions, scope, limitations, data sources, and data reduction methods.
- (3) Extent of validation and analysis of uncertainties. This includes comparison of the overall method with experimental data to estimate error rates as well as analysis of the uncertainties of input data, uncertainties and limitations in the analytical method, and uncertainties in the associated performance criteria.
- (4) Extent to which the method is based on sound scientific principles.
- (5) Extent to which the proposed application is within the stated scope and limitations of the supporting information, including the range of applicability for which there is documented validation. Factors such as spatial dimensions, occupant characteristics, and ambient conditions can limit valid applications.

In many cases, a method is built from and includes numerous component analyses. These component analyses should be evaluated using the same factors that are applied to the overall method as outlined in items (1) through (5).

A method to address a specific fire safety issue, within documented limitations or validation regimes, might not exist. In such a case, sources and calculation methods can be used outside of their limitations, provided that the design team recognizes the limitations and addresses the resulting implications.

The technical references and methodologies to be used in a performance-based design should be closely evaluated by the design team and the AHJ, and possibly by a third-party reviewer. The strength of the technical justification should be judged using criteria in items (1) through (5). This justification can be strengthened by the presence of data obtained from fire testing.

- **A.10.7.11** Documentation for modeling should conform to ASTM E1472, *Standard Guide for Documenting Computer Software for Fire Models*, although most, if not all, models were originally developed before this standard was promulgated.
- **A.11.1.1** Determine the classification of ammonium nitrate in accordance with Chapter 4. Chapter 11 takes precedence to address the specific requirements for solid and liquid ammonium nitrate, when 1,000 lb is exceeded. The physical hazards of ammonium nitrate are dependent on the properties of the specific material or mixture of materials as a whole. Where used as a fertilizer, it is common for ammonium nitrate to exist as a component of a chemical mixture. It is not uncommon for the user to describe the mixture as ammonium nitrate when in reality the mixture can contain components that contribute to

altering the end classification of the material. The manufacturer's safety data sheet (SDS) should be used to assess the overall hazards of these materials. The user is cautioned that the DOT shipping classification for transportation purposes alone is not a sufficient means by which to determine the storage and use hazards of these materials. Ammonium nitrate in the undiluted or pure form has a higher degree of overall hazard than does ammonium nitrate when mixed or blended with compatible materials that can reduce the concentration. The tables in Chapter 5 are hazard specific; they are not chemical specific. Ammonium nitrate as such is not included in the tables, because the actual hazard classification varies with the material under consideration. The question must be answered as to whether the material is an oxidizer, and, if so, what Class; whether it is an unstable reactive, and, if so, what Class; or whether there are other physical or health hazards attendant to the mixture under evaluation. (See Annex E for additional information.)

- **A.11.1.1.5** Ammonium nitrate and ammonium nitrate–based materials that are DOT Hazard Class 1 explosives should be stored in accordance with the requirements of NFPA 495. Sensitivity is determined by the application of the UN Test Series 1, which includes testing to determine impact sensitivity, friction sensitivity, sensitivity to electrostatic discharge, and thermal stability.
- **A.11.1.1.6** Agricultural application refers to the actual transporting and spreading of the fertilizers in fields. Storage in a building for eventual agricultural use is not an agricultural application.
- **A.11.1.4.9.1** This requirement is intended to prohibit floor drains, traps, tunnels, pits, or pockets into which any molten ammonium nitrate is able to flow and be confined in the event of fire.
- **A.11.1.4.9.2** The slope of the storage floor should be pitched in such a manner that it drains away from the ammonium nitrate pile and toward a containment area. As noted in other sections, no drainage pits, sumps, or confined piping should be designed into this drainage plan.
- **A.11.1.5** Where a documented risk analysis demonstrates to the AHJ that an equivalent level of fire safety can be achieved using alternatives to the requirements of this section, such an approach is an acceptable alternative. The risk analysis should be submitted to the AHJ in accordance with the requirements of 1.5.3. A risk analysis report should demonstrate equivalent fire safety by addressing relevant topics, including, but not limited to, the following:
- (1) Location of the facility
- (2) Distance to exposed structures and population density of public areas and other areas associated with the ammonium nitrate facility.
- (3) Construction type
- (4) Storage configuration
- (5) Exposing combustible materials
- (6) Emergency response capability
- (7) Water supply
- (8) Ammonium nitrate mixtures, blends, and uses
- (9) Fire protection features provided (fire barriers, fire detection and alarm, and so on)
- **A.11.2.1** Sumps and collection systems as required by 6.2.1.9.2 create confinement conditions and should be avoided with molten ammonium nitrate, which could be created in a fire.

Δ A.11.2.3 Storage of ammonium nitrate prills at ambient temperature [up to 140°F (60°C)] does not create decomposition products to a level that would create hazards to personnel and is not sufficient to catalyze higher rates of decomposition and uncontrolled heating.

Ammonium nitrate storage facilities do not purposefully bring fresh air into buildings since ammonium nitrate is a hygroscopic material. Constant exposure to humid air leads to caking, product degradation, and breakdown. Some facilities, especially large manufacturing sites, use dehumidification to prevent moist air from contacting ammonium nitrate solids. Most retail facilities are substantially open to outside air (i.e., naturally ventilated and not mechanically refreshed with ambient air).

The following is stated in "Summary Report: Workshop on Ammonium Nitrate" from the European Commission's Joint Research Center:

"Pure ammonium nitrate can undergo thermal decomposition if it receives enough energy. Gases are then emitted, especially nitrogen oxides and ammonia, both toxic. With proper ventilation, the decomposition stops as soon as the energy flow stops. The decomposition rate is not dangerously high at moderate temperatures, and the overall thermal effect is not significant since the exothermic reactions are accompanied by endothermic disassociation..."

Providing ventilation for severely contaminated product would not be practical because an appropriate hazardous gas production rate cannot be realistically predicted. Ventilation for fire conditions involving ordinary combustibles that are adequately controlled by automatic sprinklers has not been shown to have a significant effect on control of the fire.

The proper loss prevention approach is to prevent product contamination and either to eliminate combustible construction or occupancy (preferred) or to control burning combustibles by providing adequate automatic sprinkler protection.

- **N A.11.2.5** It is not the intent to apply the requirements of 11.2.5, 11.2.7, or 11.2.8 to new or existing buildings of Type I and Type II construction storing only bulk ammonium nitrate.
- **N A.11.2.5.1** Where existing or equivalent methods are intended to meet the retroactive criteria, suitable documentation should be submitted to the AHJ (see 1.5.1 and 1.5.2). The documentation should follow the guidelines outlined in the performance-based option (see Chapter 10) focused on the specific alternative.
  - **A.11.2.5.3** Foam, dry-chemical, or gaseous extinguishing systems are ineffective in controlling fires involving ammonium nitrate, which is an oxidizer that supplies its own oxygen. Steam is similarly ineffective and should not be used due to the addition of heat to the decomposing mass. Water cools the ammonium nitrate and reduces molten ammonium nitrate formation and decomposition.
- **N A.11.2.7.2** When first responders arrive at the facility after the emergency communications center has alerted them of activation of the alarm, detection, or automatic fire extinguishing system, they will need to size-up the situation and determine if the public notification/siren system needs to be activated.
- △ A.11.2.11 Explosion control methods required by 6.2.1.6 are not warranted for ammonium nitrate regulated by this chapter. Deflagration control methods described in NFPA 69 (primarily deflagration venting) are not effective for the detonations that

can sometimes result from ammonium nitrate that is involved in a fire situation. In Chapter 11, the emphasis is on explosion prevention, but using methods that will be effective on ammonium nitrate and not those required by NFPA 69 — namely combustible concentration reduction, oxidant concentration reduction, and deflagration control. The other requirements of Chapter 11 are intended to prevent ammonium nitrate explosions and are more effective than the requirements of 6.2.1.6 for this material. Ammonium nitrate that is formulated to be an explosive is regulated in accordance with NFPA 495 and not this chapter.

**A.11.2.16.1.1** Provisions should be made to avoid the following conditions with ammonium nitrate:

- (1) Heating in a confined space
- Localized heating potentially leading to development of high-temperature areas
- (3) Exposure to strong shock waves
- (4) Contamination with combustible materials or incompatible inorganic and organic substances that can result in sensitivity to explosion.
- (5) Low pH or acidic conditions

**A.11.2.17** A pre-incident best practices plan should be developed by the local fire department in conjunction with any facility that stores, uses, or handles ammonium nitrate. NFPA 1620 can be used for further guidance.

**A.11.2.17.1.3** A 1-mile (1.6 km) public evacuation distance has been recommended in the rare event of a facility containing ammonium nitrate becoming involved in a fire. This evacuation distance is recommended because the exact conditions of a facility during the emergency might not be known to the emergency response personnel. Under these potentially unknown conditions a worst-case scenario is assumed to ensure the public is evacuated to a safe distance. These unknown conditions can include the following:

- (1) The condition of the ammonium nitrate involved in the fire. For example, contamination from a material that can behave as a fuel could potentially lead to a more violent release of energy than uncontaminated ammonium nitrate.
- (2) Presence of a burning structure.
- (3) The quantity of ammonium nitrate involved in the fire.

Overpressure calculations alone are not adequate to determine evacuation distances and debris field modeling is necessary to help ensure public safety. The 1-mile (1.6 km) distance is based on a quantitative risk analysis of a scenario that involves ammonium nitrate mixed with a fuel source and the presence of a burning structure. Quantities up to one million pounds (453,592 kg) of ammonium nitrate were used in the determination based on projectile travel distance.

**A.11.2.18** NFPA 704 currently lists ammonium nitrate under emergency conditions as Health = 0, Flammability = 0, Instability = 3, and Other = OX (oxidizer). Safety data sheets that provide NFPA 704 ratings typically agree with all ratings except Health where ratings of 0, 1, or 2 are reported by different manufacturers. Because decomposition products include various nitrogen oxides (NOx) and nitric acid, the minimum health rating should be considered 1.

**A.11.3.1.2** Housekeeping information can be found in *Safety* and *Security Guidelines for the Storage and Transportation of Fertilizer Grade Ammonium Nitrate at Fertilizer Retail Facilities*, and EPA 550-

F-15-001, Chemical Advisory: Safe Storage, Handling, and Management of Solid Ammonium Nitrate Prills.

**A.11.3.2.3.1** Wood impregnated with ammonium nitrate is a fire hazard. It can be ignited by a low-energy source with a vigorous fire.

**A.11.3.2.3.4** Metal bins can be protected by special coatings such as sodium silicate, epoxy coatings, or polyvinyl chloride (PVC) coatings.

**A.11.3.2.3.5** Storage in aluminum transport vehicles is not recommended.

**A.11.3.2.3.9** Bulk and bagged ammonium nitrate can become caked and degrade in storage. This is a factor affected by humidity and temperature in the storage space and by prill quality. Temperature cycles through 90°F (32°C) and high atmospheric humidity are undesirable for storage in depth.

**A.11.4.3.3** Active loading or unloading of vehicles with ammonium nitrate from the hoppers/bins is not considered parking and is permitted. The vehicle operator should remain within 25 ft (7.6 m) of the vehicle during loading or unloading operations. Immediately upon completion of the loading/unloading activity, the vehicle should be moved at least 30 ft (9.1 m) away from the hopper/bins.

**A.11.4.5** Many of the general principles for the storage of ammonium nitrate–based fertilizers apply equally to fertilizers stored in the open and those stored in a building. It is generally recommended that bagged ammonium nitrate fertilizers should not be stored in large piles outdoors.

It should be noted that repeated temperature cycles can cause physical deterioration of some products. Physical deterioration can result in the breakdown of the fertilizer particles and damage to packages. The product should be protected from direct sunlight. Due note should be taken of ground conditions when storing outdoors to avoid damage to the product. Outdoor storage areas should be protected against unauthorized access, for example, by means of a fence. Warnings against unauthorized entry should be posted.

**A.11.5.5.1** Foam, dry-chemical, or gaseous extinguishing systems are ineffective in controlling fires involving ammonium nitrate, an oxidizer that supplies its own oxygen. Steam is similarly ineffective.

**A.11.8.1.1.1** This includes battery-powered vehicles and vehicles powered by internal combustion engines such as motor vehicles, lift trucks, and cargo conveyors. It is recommended that electric or LP-Gas-powered trucks be employed rather than gasoline- or diesel to reduce the potential for contamination to ammonium nitrate. (See A.11.4.3.3.)

**A.11.8.1.2** Examples of hollow spaces include hollow conveyor rollers and hollow screw conveyor shafts.

**A.14.1.1** The classification system for organic peroxides is package and burn rate dependent. To address the scope of NFPA 400 for storage, use and handling of each organic peroxide formulation is to be classified with respect to quantity and type of container based upon testing performed to reach a transport classification. Classification should be done by professionals familiar with the properties of the organic peroxide formulation. Property information used for classification of organic peroxide formulations for UN Transportation of Dangerous Goods can be useful for the NFPA 400 classification.

Additionally the small-scale and sometimes large-scale burn rate data from actual experiments are used, in addition to the transport classification, to reach the storage classification. Other useful information includes density, small fire test data, and fire data for response to sprinkler conditions. For further guidance, see Annex F.

- **A.14.1.2** For information on combustible or limited-combustible construction, see NFPA 220.
- **A.14.2.4** In the venting equation, use the fuel characteristic constant for "gases with fundamental burning velocity less than 1.3 times that of propane." See NFPA 68 for information on vent design. Refer to manufacturers' technical data for information on organic peroxide formulations that give off flammable gases upon decomposition.
- **A.14.2.5.1** Fire protection systems for material in containers other than original DOT packaging, including bulk tanks, and materials in the unpackaged state should be designed by design professionals familiar with the nature of the product under fire conditions.
- **N A.14.2.5.4** Dry pipe and double-interlock preaction (DIPA) sprinkler systems are not permitted for protection of buildings or areas containing Class I through Class III organic peroxide formulations, except as noted in 14.2.5.4.1. These formulations generally have a fast burning rate and high-heat release rate, requiring a quick response and immediate discharge of water from the sprinklers. Dry pipe and DIPA sprinkler systems generally result in delayed discharge of water when sprinkler activation occurs.
  - **A.14.2.10.8** The method of disposal can vary depending on the specific formulation and materials with which they might have been contaminated. Refer to the manufacturer or the supplier of the specific formulation for advice.
  - **A.14.3.2** The classification system described in Section 4.1 is used only to determine the storage requirements established by this code. It is not meant to be a substitute for the hazard identification system established by NFPA 704. Since the hazard characteristics of organic peroxide formulations vary widely depending on the type of organic peroxide, the diluent, and their relative concentrations, each specific formulation will have to be rated individually according to the criteria established in NFPA 704.

For the purpose of this document, an important building is one that is occupied or that contains facilities vital to the operation of the plant.

- **A.14.3.2.4** In the venting equation, use the fuel characteristic constant for "gases with fundamental burning velocity less than 1.3 times that of propane." See NFPA 68 for information on vent design. Refer to manufacturers' technical data for information on organic peroxide formulations that give off flammable gases upon decomposition.
- **A.14.3.2.5** For example, a sprinklered building, detached by 50 ft (15.3 m), can contain up to 500 lb (227 kg) of Class I, 50,000 lb (22,700 kg) of Class II, and 50,000 lb (22,700 kg) of Class III formulations, according to the following ratios:

(1) Class I:

[A.14.3.2.5a]

  $\frac{227 \text{ kg}}{907 \text{ kg (max)}} \times 100 = 25\%$ 

(2) Class II:

(3) Class III:


[A.14.3.2.5c]

In no case does the quantity in storage exceed the maximum for its class, nor does the sum of the percentages exceed 100 percent.

- **A.14.3.2.9.4** Since no commercially available Class I organic peroxide formulations are supplied in 55 gal (208 L) drums, there is no requirement for such storage.
- **A.14.3.4.3.1** A detached, mechanically refrigerated building for storing organic peroxide formulations that require temperature control is illustrated in Figure A.14.3.4.3.1.
- **A.14.3.4.3.3** Figure A.14.3.4.3.3 is an example of a nonrefrigerated building for storing less than 5000 lb (2270 kg) of organic peroxide formulations for detached storage as allowed by 14.3.4.3.3.
- **A.14.5.7** Considerations should be given for maintaining proper refrigeration capability in the event of a loss of power. Some materials, when frozen, could cause separation of a carrier from the organic peroxide.
- **A.14.5.14.3** The method of disposal can vary depending on the specific formulation and materials.
- **A.15.1.4** In the manufacturing process, materials are collected and staged for transportation from manufacturing areas to a storage or warehouse location. Transient storage is intended to describe those materials being staged for transport. They are called transient while they are in the manufacturing area because they are not in their storage location. In the manufacturing location, finished goods can be found in a packaged state where they can be further palletized or otherwise arranged or collected awaiting transportation.
- **A.15.2.1.1** The NFPA Fire Protection Guide to Hazardous Materials should be used for guidance on compatibility.
- **A.15.2.1.2** Spill control, drainage, and containment are typically required under environmental regulations. Check the building code to determine whether it contains spill control requirements.

## (a) OUTSIDE VIEW




FIGURE A.14.3.4.3.1 Refrigerated Storage Building and Key Recommendations.




FIGURE A.14.3.4.3.3 Detached Storage Building for Storing Less than 5000 lb (2270 kg) of Organic Peroxide Formulations.

The decomposition of stored commercially available strengths of liquid and solid oxidizers can emit toxic gases. Additionally, the runoff from spills of stored oxidizers or from oxidizers mixed with fire-extinguishing agents can contain materials hazardous to the environment.

The hazards of stored oxidizers can manifest themselves in one or more of five distinct hazardous situations as follows:

- (1) They can increase the burning rate of combustible materials
- (2) They can cause spontaneous ignition of combustible materials.
- (3) They can decompose rapidly.
- (4) They can liberate hazardous gases.
- (5) They can undergo self-sustained decomposition, which can result in an explosion.
- (6) They can react explosively if mixed with incompatibles or in fire conditions.

**A.15.2.5** Automatic sprinklers are an effective method to control fires involving oxidizers in conjunction with the other fire prevention requirements in the document.

**A.15.2.5.1** Dry pipe and double-interlock preaction (DIPA) sprinkler systems are generally prohibited by 15.2.5.1.1 for use with oxidizers. In mercantile occupancies with open-air environments that are already protected by these types of systems as prescribed by other codes, it is considered acceptable to store quantities defined by this code, with the recognition that these commodities might not be adequately protected. Outside storage in this manner is preferred to inside storage.

**A.15.2.5.2.1** Conditions that affect the need for hydrant protection include nearness of the exposures, size and construction of the building, amount and class of the oxidizer stored, and availability of public fire protection.

**A.15.2.5.3.1** A dry-chemical fire-extinguishing agent containing ammonium compounds (such as some A:B:C agents) should not be used on oxidizers that contain chlorine and

bromine. The reaction between the oxidizer and the ammonium salts in the fire-extinguishing agent can produce the explosive compound nitrogen trichloride (NCl<sub>3</sub>). Carbon dioxide or other extinguishing agents that function by a smothering action for effective use are of no value in extinguishing fires involving oxidizers.

**A.15.2.5.3.2** Halon extinguishers should not be used on fires involving oxidizers because they can react with the oxidizer.

△ A.15.2.5.3.3 Halocarbon clean agent extinguishers as identified in NFPA 2001 are chemically similar to Halon and unless proved different should be assumed to react with the oxidizer.

**A.15.2.11** Care should be exercised because some oxidizers are mutually incompatible. Chlorinated isocyanurates and hypochlorites are examples of oxidizers that are incompatible. The NFPA *Fire Protection Guide to Hazardous Materials* lists many oxidizers and other materials that result in hazardous interactions.

**A.15.2.11.10** This requirement to restrict exposure to water is not intended to apply to the application of fire protection water.


**A.15.2.11.11** Where absorptive combustible packing materials used to contain water-soluble oxidizers have become wet during either fire or nonfire conditions, the oxidizer can impregnate the packing material. This creates a serious fire hazard when the packing material dries. Wooden pallets that are exposed to water solutions of an oxidizer also can exhibit this behavior.

**A.15.3.2.1.1** Impregnation of wood for fire retardancy or to prevent decay does not protect the wood from impregnation by the oxidizer.

**N A.15.3.2.2.2.2(A)** Figure A.15.3.2.2.2.2(A) shows an example of a storage layout in a typical sprinklered warehouse.

**A.15.3.2.2.3** The term *commodity* is used as defined in NFPA 13.




△ FIGURE A.15.3.2.2.2.2(A) Sample Layout for Class 1 Oxidizers in Sprinklered Buildings.

**A.15.3.2.3.2.7** Only the building limit, not the pile limit, height, or width, can be increased by this provision.

**A.15.3.2.5.4.5** For example, two tanks containing 4000 lb (1814 kg) and 3000 lb (1360 kg) of Class 4 oxidizer are separated by 25 ft (7.6 m). Because they are separated by less than 10 percent of 300 ft (92 m), the total quantity of 7000 lb (3175 kg) requires a minimum separation of 400 ft (122 m) to the nearest important structure in accordance with 15.3.2.5.3.4.

**A.15.3.5.2.1** Recommended mercantile store arrangements for mutually incompatible oxidizers are shown in Figure A.15.3.5.2.1(a) and Figure A.15.3.5.2.1(b). These two diagrams illustrate arrangements that minimize the chance of exposure to incompatible materials. Wherever possible, vertical separation should be maintained between incompatible materials.




Oxidizers A, B, and C are mutually incompatible.

**A.17.2.1.1** The retention of spilled pyrophoric liquids around process tanks, storage tanks, or vessels and other containers should be avoided to prevent a catastrophic failure of the vessels or containers in the event of fire.

**A.17.2.5** Pyrophoric liquids catch fire easily and are often water reactive. The amount of water needed to put out a fire might depend on the volume of material burning. Adding insufficient amounts of water could result in an uncontrolled reaction.



Oxidizers A, B, C, and D are mutually incompatible with each other and with the incompatible liquids.

**A.17.4.1.2** When solids are involved, an approximation of the liquid volume of the containers used is to be determined. For example, if the solids were packaged in a 55-gallon drum, a volume of 55 gal would be used. If the solids were packaged in 1-gallon containers, the volume would be determined accordingly.

**A.17.4.3.1** In no event should the distance between exposures indicated in 17.4.1.2 be less than twice the distance required by NFPA 30 for an equivalent volume of Class IB flammable liquid.

**A.17.6.1.3** Secondary containment areas can be designed to be remote from process or storage areas. Drainage can be used as a means to remove the spilled liquid and transport it to a remote location. Buried tanks can be used as a means to contain spilled liquids. Sloped floors or floors designed to drain spilled liquids away from storage tanks and container storage all serve to minimize a fire event created by a spill.

**A.17.6.2.3.1** See A.17.6.1.3.

**A.17.7.1.2** See A.17.6.1.3.

**A.17.7.2.2.1** See A.17.6.1.3.

**A.20.6.1.3.1** Secondary containment areas can be designed to be remote from process or storage areas. Drainage can be used as a means to remove spilled liquids and transport them to a remote location.

**A.20.6.2.3.1** See A.20.6.1.3.1.

**A.20.7.1.2.1** See A.20.6.1.3.1.

**A.21.1.1.2.1(1)** For regulations on the transportation of gases, see 49 CFR 100–185, "Pipeline and Hazardous Materials Safety Administration, Department of Transportation," and *Transportation of Dangerous Goods Regulations.* [55:A,1.1.2(1)]

**A.21.1.1.2.1(3)** Bulk compressed gas and cryogenic fluid system installations are intended to be covered by the requirements of this code. Instrumentation and alarms that are attendant to the system and designed to interface with the application in a health care facility are to be retained within the purview of NFPA 99. [55:A.1.1.2(3)]

**A.21.1.1.2.1(5)** For information, see NFPA 52 or NFPA 58. [55:A.1.1.2(5)]

**A.21.1.1.2.1(6)** The storage of and use of compressed gases and cryogenic fluids outside the boundaries of laboratory work areas is covered by this code. [55:A,1.1.2(6)]

 $\triangle$  A.21.1.1.2.1(11) NFPA 55 is used as the source document for the fundamental requirements for compressed hydrogen gas (GH<sub>2</sub>), or liquefied hydrogen gas (LH<sub>2</sub>) system installations. Correlation between NFPA 55 and NFPA 2 is the responsibility of the two technical committees involved. The installation requirements for bulk GH2 or LH2 are viewed as fundamental provisions. On the other hand, use-specific requirements for designated applications such as vehicular fueling are not resident in NFPA 55 and are under the purview of the NFPA 2 Technical Committee. Where there are specific provisions or controls included in NFPA 55, the specific controls of NFPA 55 will govern except that modifications made to provisions that have been extracted can be followed when the modifications have been made within NFPA's extract procedure as indicated in the Manual of Style for NFPA Technical Committee Documents. [**55:**A.1.1.2(1)]

A.21.2.5 Bulk hydrogen compressed gas systems terminate at the source valve. In cylinder filling or packaging operations, cylinders located on filling manifolds located downstream of the source valve are not considered to be part of the bulk gas system. For definitions of source valve and bulk hydrogen compressed gas system, see 3.3.88 and 3.3.93.2 of NFPA 55. Additional requirements for source valves can be found in Section 6.19 of NFPA 55. [55:A.6.5]

A.21.2.8 Under the requirements of 29 CFR 1910.38, "Emergency Action Plans," established by OSHA regulations, employers must establish an employee alarm system that complies with 29 CFR 1910.165, "Employee Alarm Systems." The requirements of 29 CFR 1910.165 for the employee alarm system include, but are not limited to, systems that are capable of being perceived above ambient noise or light levels by all employees in the affected portions of the workplace. Tactile devices may be used to alert those employees who would not otherwise be able to recognize the audible or visual alarm. The alarm system can be electrically powered or powered by pneumatic or other means. State, local, or other governmental regulations might also establish requirements for employee alarm systems. [**55:**A.6.7]

A.21.2.9 See NFPA 55 for more information on this subject.

**A.21.2.10** The intent of this section is to require a water-based fire extinguishing system to keep vessels containing compressed gases cool in the event of an exposure fire, thereby minimizing the likelihood of a release and associated consequences. Accordingly, alternative fire extinguishing systems, such as dry-chemical or gaseous agent systems, should not be substituted. [55:A.6.9]

**A.21.3.1.7.2** Figure A.21.3.1.7.2 is a schematic showing the separation distances required by 21.3.1.7.2. [55:A.7.1.12.2]

**A.21.3.1.7.3** Clearance is required from combustible materials to minimize the effects of exposure fires to the materials stored or used. The requirement to separate the materials from vegetation should not be interpreted to mean that the area is maintained free of all vegetation. In some settings, gas systems are located on grounds that are maintained with formal landscaping. Some judgment must be exercised to determine whether the vegetation poses what might be viewed as an exposure hazard to the materials stored. Cut lawns, formal landscaping, and similar vegetation do not ordinarily present a hazard and should be allowed. On the other hand, tall, dry grass or weeds and vegetation that fringes on the border of an urban-wildland interface might be viewed as a hazard. [55:7.1.10.3]

**A.21.3.1.11.3** The gas supplier should be consulted for advice under these circumstances. [55:A.7.1.15.3]

A.21.3.1.14.1.3 Underground piping systems are those systems that are buried and in contact with earth fill or similar materials. Piping located in open-top or grated-top trenches is not considered to be underground although it may be below grade. [**55:**A.7.1.18.1.2]

A.21.3.3.1.11.1(A) In operations where an automatic emergency shutoff valve is activated by a control system that is operated from a remote station or by remote station software, the software system should be designed to provide a visual indication of the emergency shutdown control system. The visual emergency shutdown function should be able to be identified by trained operators and recognizable to emergency response personnel. [55:A.7.3.1.11.1.1]




FIGURE A.21.3.1.7.2 Separation of Gas Cylinders by Hazard.

A.21.3.3.1.12.1 Bulk cryogenic fluids are not subject to the requirements for excess flow control based on a health hazard ranking due to cold temperature when installed in accordance with the requirements of NFPA 55. Bulk cryogenic fluids that are vaporized and distributed as a compressed gas downstream of the source valve are subject to the requirements for excess flow control if the gas has either a health hazard rating of Class 3 or 4 based on corrosivity or toxicity or a reactivity ranking of Class 3 or 4. [55:A.7.3.1.12.1]

A.21.3.5.2.2.1 Portions of the system upstream of the source valve include the containers or bulk supply as well as control equipment designed to control the flow of gas into a piping system. The piping system downstream of the source valve is protected by excess flow control should failure occur in the piping system and is not required to be protected by the fire barrier. The fire barrier serves to protect those portions of the system that are the most vulnerable, along with the necessary controls used to operate the system. [55:7.5.2.1.1]

**A.21.3.7.2.1.1** See A.21.3.5.2.2.1. [**55:**A.7.7.2.1.1]

**A.21.3.8.3.1.1** See A.21.3.5.2.2.1. [**55:**A.7.8.3.1.1]

**A.21.3.9.3.4.3(A)** See A.21.3.5.2.2.1. [55:A.7.9.2.2.1.1]

A.21.3.9.3.6 The areas for typical restricted flow orifices are shown in Table A.21.3.9.3.6. [55:A.7.9.3.6]

△ A.21.3.9.3.6.2 The formula has been taken from industry publications, including the Scott Specialty Gases Design and Safety Handbook. It is based on estimated flow rates for air at 70°F (21°C) discharging to normal atmospheric pressure through an average shape and quality orifice. It can be assumed to be ±15 percent accurate. Correction factors have

been built into the formula as presented in 21.3.9.3.6.2 to accommodate the use of gases other than air (e.g., use of specific gravity data). [55:A.7.9.3.6.2]

**A.21.3.10.1.2.1** See A.21.3.5.2.2.1. [**55:**A.7.10.1.2.1]

**A.21.3.10.2.2.1** See A.21.3.5.2.2.1. [**55:**A.7.10.2.2.1]

**A.21.4.2** Pressure vessels of any type can be subject to additional regulations imposed by various states or other legal jurisdictions. Users should be aware that compliance with DOT or ASME requirements might not satisfy all of the required regulations for the location in which the vessel is to be installed or used. [55:A,8.2]

A.21.4.2.3.3.1 Vaporizers or heat exchangers used to vaporize cryogenic fluids can accumulate a large load of ice during operation. Additional requirements to be considered in the design include snow load for the area where the installation is located as well as the requirements for seismic conditions. The operating conditions of systems vary, and the designer has a responsibility to consider all the loads that might be imposed. Foundations that could be used to support delivery vehicles as well might require special consideration relevant to live loads as well as for the dead loads imposed by the equipment itself. [55:A,8.2.3.3]

**A.21.4.2.4.5.1** Pressure relief valves typically are spring-loaded valves where the relief pressure is set by adjustment of a spring. Valves should be made to be tamper resistant in order to prevent adjustment by other than authorized personnel typically found at a retest facility. An ASME pressure relief valve is designed to comply with the requirements of the ASME *Boiler and Pressure Vessel Code* and typically is equipped with a wire and lead seal to prevent tampering. [55:A,8.2.4.5.1]

**A.21.4.4.1.1.2** An example of this identification is 360 degree wrap-around tape. [55:8.1.1.2]

**A.21.4.7.2** It is not uncommon to have inert cryogenic fluids used to provide stage effects for theatrical performances that are conducted within assembly occupancies. The fluids are sometimes placed within these occupancies with special controls, including ventilation systems, fire detection systems, monitors for oxygen deficiency, warning signs, and remote fill indicating devices that indicate tank volume when a remote filling point is provided and stationary tanks are involved.

Such installations are normally permitted on a case-by-case basis under the requirements of Section 1.5.

Clearance is required from combustible materials to minimize the effects of exposure fires to the materials stored or used. The requirement to separate the materials from vegetation should not be interpreted to mean that the area is maintained free of all vegetation. In some settings, gas systems are located on grounds that are maintained with formal landscaping. Some judgment must be exercised to determine whether

the vegetation poses what might be viewed as an exposure hazard to the materials stored. Cut lawns, formal landscaping, and similar vegetation do not ordinarily present a hazard, and should be allowed. On the other hand, tall, dry grass or weeds and vegetation that fringes on the border of an urban–wildland interface might be viewed as a hazard. [55:A.8.7.2]

**A.21.4.13.2.5** Flood hazard areas typically are identified on either (1) the special flood hazard area shown on the flood insurance rate map or (2) the area subject to flooding during the design flood and shown on a jurisdiction's flood hazard map or otherwise legally designated. [55:A.8.13.2.5]

**A.21.4.13.2.6.4(B)** The intent of these provisions is to make certain that the cryogenic installation is not exposed to the potential of a pool fire from the release of flammable or combustible liquids. Cryogenic fluids are not diked in order that they are allowed to dissipate should leakage occur. Studies conducted by NASA (NSS 1740.16, Safety Standard for Hydrogen and Hydrogen Systems) show that the use of dikes around liquid hydrogen storage facilities serves to prolong ground-level flammable cloud travel and that the dispersion mechanism is enhanced by vaporization-induced turbulence. The travel of spilled or leaked cryogenic fluid to distances greater than a few feet (meters) from the source given the nature of the typical leak is considered to be implausible due to the character of cryogenic fluids and their ability to quickly absorb heat from the surrounding environment.

**A.21.4.13.2.7.2** The placement of stationary containers is limited with respect to exposure hazards. Table 21.4.7.2 establishes the minimum separation distance between a building and any stationary tank at 1 ft (0.3 m). Additional limitations are placed on wall openings, air intakes, and other exposures. The material-specific tables for liquid hydrogen and liquid oxygen specify increased distances according to the type of construction adjacent to the tank. A problem arises when courtyards are configured so as to interrupt the free movement of air around a tank where an asphyxiation hazard, a flammable hazard, or an oxygen-enriched environment can be created. [55:A.8.13.2.7.2]

Placement of stationary containers proximate to the wall of the building served is allowable provided the minimum separation distances for exposure hazards are met. When additional walls encroach on the installation to form a court, the focus of concern shifts away from the exposure hazards associated with the building itself to the hazards associated with personnel due to hazardous atmospheres that can be created due to the lack of free air movement and ventilation.

By specifying the minimum distance between the tank and the encroaching walls that form the court, the circulation of adequate air is ensured. Placing the tank at not less than the height of two of the three encroaching walls results in creating an opening such that the angular dimension between the top of two of the three encroaching walls and the point over which the tank is placed is not greater than 45 degrees, thereby allowing the circulation of air through the space in which the tank is installed.

**A.21.4.13.2.7.2(A)** See Figure A.21.4.13.2.7.2(A).

△ A.21.4.14.1.3.1(A) CGA P-18, Standard for Bulk Inert Gas Systems, recommends periodic inspection intervals for inert gas systems. [55:A,8.14.1.3.1.1]




FIGURE A.21.4.13.2.7.2(A) Illustration of Minimum Separation Distance to Exposure from Stationary Tank.

**A.21.4.14.11.2.3** In operations where an automatic emergency shutoff valve is activated by a control system that is operated from a remote station or by remote station software, the software system should be designed to provide a visual indication of the emergency shutdown control system. The visual emergency shutdown function should be able to be identified by trained operators and recognizable to emergency response personnel. [55:A]8.14.11.2.3.1]

**A.21.4.14.11.3.4** The inert cryogens, nitrogen and argon, do not require the installation of a noncombustible spill pad, because they do not typically condense oxygen from the air in sufficient quantities to pose a hazard during transfer. [55:A.8.14.11.3.4]

**A.21.4.14.11.3.4(A)** The noncombustible spill pad is provided for liquid helium transfer operations, because the cryogen is at a temperature that is sufficiently low enough to liquefy oxygen, presenting a hazard when in contact with combustible surfaces. [55:A.8.14.11.3.4.1]

#### Annex B Chemical Data

This annex is not a part of the requirements of this NFPA document but is included for informational purposes only.

**B.1 General.** The information provided in Annex B is not a part of the requirements of this document but is included for informational purposes.

△ B.2 Hazard Recognition. Chapter 5 introduces the concepts of control areas and MAQs. The purpose is to permit limited amounts of hazardous materials in occupancies having minimum controls without triggering the more restrictive Protection Level 1 through Protection Level 5 building requirements. The allowable quantities in Table 5.2.1.1.3 and Table 5.2.1.2.1 are based on demonstrated need and historical safe storage and use of hazardous contents. The preponderance of provisions contained in Chapter 6 and those of Chapters 11 through 21 establish additional controls for occupancies exceeding the hazardous materials limits (MAQs) prescribed for control areas.

Not all of the hazardous materials categories are placed into the high-hazard category, and some of these materials (contents) have been recognized as being of low or ordinary hazards, depending on their nature in a fire. Class IIIB combustible liquids, Class 1 unstable (reactive) materials, Class 1 water-reactive materials, Class 1 oxidizing solids and liquids, and Class IV and Class V organic peroxides are high-hazard materials, which, in some cases, do not have an MAQ and, therefore, are not required to comply with the requirements for Protection Level 1 through Protection Level 5. Some materials, though classified as high-hazard, such as aerosols, are exempt from the requirements of NFPA 400 as they are regulated elsewhere in the code. For additional exceptions, see 1.1.2. [5000:A,34.1.1]

Figure B.2 helps to illustrate the conditions under which the protection level requirements are applicable. [5000:A,34.1.1]

Safety data sheets (SDS) are used as a primary means to assess the hazards of a specific material. In the U.S., the OSHA Hazard Communication Standard (29 CFR 1910.1200) prescribes what information is to be provided by the SDS. It also specifies the layout of SDS, including a 16-section format with standardized headings, the numbering and order of these headings, and the information required to complete the SDS. The major headings of this standard include the following:

Section 1: Identification

Section 2: Hazard(s) Identification

Section 3: Composition/Information on Ingredients

Section 4: First-Aid Measures

Section 5: Fire-Fighting Measures

Section 6: Accidental Release Measures

Section 7: Handling and Storage

Section 8: Exposure Controls/Personal Protection

Section 9: Physical and Chemical Properties

Section 10: Stability and Reactivity

Section 11: Toxicological Information

Section 12: Ecological Information

Section 13: Disposal Considerations

Section 14: Transport Information

Section 15: Regulatory Information

Section 16: Other Information, including date of preparation or last revision

The American Chemical Society publishes chemical abstracts as pointers to the chemical literature. Since 1907, their Chemical Abstracts Service (CAS) has indexed and summarized chemistry-related articles from more than 40,000 scientific journals, in addition to patents, conference proceedings, and other documents pertinent to chemistry, life sciences, and many other fields. In total, abstracts for more than 25 million documents are accessible online through CAS.

Substance identification is a special strength of CAS. It is widely known as the CAS Registry, the largest substance identification system in existence. When CAS processes a chemical substance newly encountered in the literature, its molecular

structure diagram, systematic chemical name, molecular formula, and other identifying information are added to the Registry, and it is assigned a unique CAS Registry Number. The Registry now contains records for more than 30 million organic and inorganic substances and more than 58 million sequences.

Individual chemicals are identified through the use of a CAS registry number, commonly referred to as the CAS number or CASRN. The number, which has no chemical significance, is used to link the material through its molecular structure into an index system where the Chemical Abstracts name is provided.

The CAS number is unique for each given material; however, with few exceptions, mixtures of chemicals are not assigned a CAS number per se, since each individual component of the mixture has its own unique CAS number. For the purposes of hazard classification and the application of NFPA 400, there are three primary identifiers for each chemical that must be known:

- (1) CAS number (unless it is a chemical mixture)
- Concentration (typically expressed in weight percent for solids or liquids and volume percent for gases)
- (3) Physical state (solid, liquid, or gas)

For example, consider the material hydrochloric acid, also called hydrogen chloride. It can exist in the anhydrous form (as a gas) or in a water solution as the aqueous liquid material of varying concentrations. The hazard properties of the material vary with the form.

The regulatory approach used by NFPA 400 is based on hazard classification of the materials to be regulated. The materials under consideration must be evaluated to classify their hazards within the context of the code. The starting point begins with the SDS, where the material can be identified by name and other information, such as CAS registry number and physical state, is provided. Although there are 16 different main headings in the SDS, the primary need for classification of materials rests with determining the physical and health hazards of the material or mixture in question.

Within the context of NFPA 400, the user must determine whether the physical and/or health hazards of the material place it into one or more of the following hazard categories:

- (1) Corrosive solids and liquids
- (2) Flammable solids
- (3) Organic peroxide formulations
- (4) Oxidizer solids and liquids
- (5) Pyrophoric solids and liquids
- (6) Toxic and highly toxic solids and liquids
- (7) Unstable (reactive) solids and liquids
- (8) Water-reactive solids and liquids

Each of the hazard categories can be further subdivided into subcategories, each with its attendant hazard properties. For example, oxidizer solids and liquids are subdivided into Class 4, Class 3, Class 2, and Class 1 subcategories commonly referred to as the hazard classes.

Although it might be expected that the above nomenclature would appear on the SDS, this is not always the case. Appendices A and B of OSHA's Hazard Communication Standard (29 CFR 1910.1200) identify specific health and physical hazards that might differ from that of NFPA 400. Terms used in this code are consistent with those used in other NFPA standards and codes (see Annex J for a comparison of these hazard defini-

tions). The user must review the physical and chemical properties, as well as the health hazard information provided, to make a determination as to the appropriate hazard category and class for the material being regulated.

### B.3 Chemical Family — A Pointer to Hazard Classification.

**B.3.1 General.** It is quite common that preparers of SDSs indicate the *chemical family* to which a material belongs, that is, the group of chemical substances that have a similar molecular structure. For example, materials such as acetone, methyl ethyl ketone, and amyl ethyl ketone are members of the *ketone* family. While the properties of various hazardous materials within a chemical family can vary, the chemical family becomes a pointer to the more likely hazard categories of the material under consideration.

While hundreds of thousands of chemicals are in use, this annex categorizes the more commonly used industrial chemicals into chemical families or unique groupings that have similar properties. Materials and/or chemicals exhibit a wide range of properties, some of which are hazardous. This code provides guidance for known physical and health hazards of materials within its scope.

△ B.3.2 Chemical Families Related to Hazard Category. Table B.3.2 provides a summary of chemical families with associated physical and health hazard properties, which are subdivided into specific categories. This table is for informational purposes only. The physical and health hazards indicated are broad representations for the various chemical families. These classifications are not intended to cover all the hazards of a material. A more detailed description of the chemical families, subfamilies,




FIGURE B.2 Flow Chart Illustrating Protection Level Applicability. [5000:Figure A.34.1.1]

lies, and chemical structure of specific hazards are contained in the explanatory material following the table. For specific information, the chemical-specific SDS must be consulted. Additional information can be obtained from the manufacturer.

B.3.2.1 Table Descriptions. Nineteen general chemical families are listed in the first column of Table B.3.2. The chemical families include organic chemicals, inorganic chemicals, gases, and metals. Some of the general chemical families are further divided into subfamilies if one or more hazard category or categories further depend on chemical structure. The second column, Chemical Structure, shows the basic chemical formula or structure representing the chemical family and/or subfami-

The next several columns list the seven physical hazard categories and three health hazard categories. The specific hazard categories are defined in Chapter 3. The physical hazard categories include the following:

- Unstable Reactive (1)
- (2)Water Reactive
- Oxidizer (3)
- (4)Pyrophoric
- (5)Flammable Solid
- (6) Organic Peroxide
- Flammable/Combustible

The health hazards include the following:

- (1)Corrosive
- Toxic (2)
- (3) Highly Toxic

Hazard categories are defined by the following symbols. A triple check mark  $(\sqrt{\sqrt{}})$  is used to indicate that most or all of the chemicals within the family or subfamily have the indicated physical or health hazard. A double check mark  $(\checkmark\checkmark)$  is used to identify that some of the chemicals in the family might have this additional hazard. A single check mark  $(\checkmark)$  indicates that only a select few chemicals within a specific family display the relevant physical and health hazard(s). The check marks are provided to inform the user as to the likely property of materials in each of the hazard categories listed. However, it must be recognized that the ultimate classification of a material is dependent on the application of the definitions found in Chapter 3 and the interpretation of the information provided relative to tests conducted by authoritative entities within the framework established by the definitions.

The last column provides examples of chemicals with the indicated hazards. The examples illustrate materials in the concentrated or undiluted state. Concentration-specific hazards for common materials are provided in the explanatory material following the table (see Section B.5).

B.3.2.2 Multiple Hazard Materials. A specific chemical can exhibit multiple hazard categories. In other words, there could be materials with more than one physical hazard property that also have one or more health hazard properties. The regulatory controls integral to NFPA 400 require that all hazards be addressed. It is incumbent on the code user to identify each applicable hazard property to properly classify the hazards of the material. It should also be recognized that each of the hazards considered could be concentration dependent.

**B.3.2.2.1 Illustration of Table B.3.2.** To illustrate the utility of Table B.3.2, consider the chemical family of mineral acids, listed in column 1 of Table B.3.2. Specific examples of mineral acids are listed in the last column of Table B.3.2. Well-known mineral acids are hydrochloric acid and sulfuric acid. The row entries with dashes (—) under the physical hazard categories indicate that, in general, mineral acids are not considered to have the physical hazards of being unstable/reactive, oxidizer, pyrophoric, flammable solids, organic peroxides, or flammable/combustible. Specific mineral acids are water reactive (√) based on concentration and the specific mineral acid itself. The row entries show the principal hazard properties of mineral acids are Health Hazards, especially Corrosive  $(\sqrt{\checkmark})$ . The one checkmark under Toxic ( $\checkmark$ ) indicates that a select few of the chemicals in the mineral acid family have this additional health hazard. (See B.4.1.1 for additional information on mineral acids.)The SDS for the specific mineral acid should be consulted for more detailed information relating to physical and health hazards.

### **B.4** Description of Chemical Families.

B.4.1 General. Dilution can cause the hazard characteristics of an individual chemical to diminish until the property is no longer pertinent. Each chemical must be individually reviewed by the manufacturer to provide the data to assess the physical and health hazards. For compressed gases, there are accepted standards that can be used to estimate both the flammability and toxicity without actual test data.

### **B.4.1.1** Acids.

B.4.1.1.1 Acids (Carboxylic) (R-COOH, Ar-COOH). Carboxylic acids are weak acids, unlike mineral acids, such as hydrochloric acid. Most are readily soluble in water. Physical and health properties vary significantly based on molecular weight and the number of carboxylic acid groups. Smaller molecular weight aliphatic carboxylic acids (such as formic and acetic acid) are liquids and are flammable and corrosive. Larger chain, higher molecular weight carboxylic acids are often solids with minimal hazards (such as citric acid). Aromatic acids are sometimes corrosive.

B.4.1.1.2 Acids (Peroxy) (R-OOH, Ar-OOH). All peroxy acids are classified as organic peroxides and are classified as oxidizers and corrosive. Aromatic peroxy acids (such as perbenzoic acid) are solids and are unstable reactive and toxic. Most are pastes or liquids and require refrigeration. Some forms of this acid family are often found as their sodium, potassium, or ammonium salts.

**B.4.1.1.3** Acids (Mineral). These are all strong acids, are liquids, and are corrosive, even in dilute solutions. These include hydrofluoric acid (HF), hydrochloric acid (HCl), hydrobromic acid (HBr), phosphoric acid (H<sub>3</sub>PO<sub>4</sub>), and sulfuric acid (H<sub>2</sub>SO<sub>4</sub>). In some cases they are toxic and water reactive depending on acid and concentration.

- **B.4.1.1.4** Acids (Gaseous). The common acid gases, which include hydrogen bromide (HBr), hydrogen chloride (HCl), hydrogen fluoride (HF), and hydrogen iodide (HI), are corrosive and in some cases toxic. They are highly soluble in water, forming the corresponding aqueous acid and are packaged as liquefied compressed gases. Other acid gases include boron trichloride (BCl $_3$ ), boron trifluoride (BF $_3$ ) and silicon tetrafluoride (SiF $_4$ ).
- **B.4.1.1.5 Acids (Oxidizing).** Some strong acids are also oxidizing acids, most commonly nitric acid (HNO $_3$ ). As oxidizers, they are also corrosive and toxic. These physical and health properties are exhibited even in dilute solutions.

### B.4.1.2 Alcohols.

**B.4.1.2.1 Aliphatic Alcohols (R-OH).** The category includes primary (1°), secondary (2°), and tertiary (3°) branched and cyclic alcohols. Most common alcohols include methanol, ethanol, isopropanol, t-butanol (2-methylpropan-2-ol), n-butanol (butan-1-ol) and cyclohexanol. Many alcohols, especially smaller chain alcohols, are highly flammable even in dilute solutions. This generally does not hold true for the small-chain glycols (or polyhydroxylated compounds), such as propylene glycol, which have significantly higher boiling points. Most

smaller chain aliphatic alcohols are readily soluble in water. Longer chain alcohols "fatty alcohols" (e.g., dodecanol, hexadecanol, and octadecanol) are solids, are not flammable, and are not miscible with water.

- **B.4.1.2.2** Aromatic Alcohols (Ar-OH). The most common aromatic alcohol is phenol (hydroxybenzene). Others include the dihydroxybenzenes (e.g., catechol) and hydroxytoluenes (e.g., o-cresol). Most phenols are usually solids or high-boiling point liquids and readily soluble in water. Phenol and p-cresol are highly corrosive and toxic. Functionalized phenol derivatives (e.g., 2,4-dichlorophenol), while also soluble in water, are not flammable and can be toxic. Higher molecular weight phenols such as hydroxynaphthalene (e.g., naphthol) can also be toxic but are not corrosive. The chemical and physical properties of aliphatic and aromatic alcohols vary significantly depending on the structure of the alcohol and other functional groups.
- **B.4.1.3** Alkyl Halides (R-X). This chemical family includes halogenated alkyl analogues, such as methylene chloride, chloroform, carbon tetrachloride, bromoform, dichloroethane, perchloroethylene, methyl bromide and methyl iodide, fluoroethane, and Freon® derivatives. Often these chemicals are nonflammable gases and liquids, used as fire extinguishers,

refrigerants, and solvents. The most widely known category is the chlorofluorocarbons (CFCs). Nonflammable gases include bromochlorodifluoromethane (Halon 1211) and dichlorodifluoromethane (Freon-12). Some chemicals in this family are flammable. Highly substituted alkyl halides (i.e., those chemicals with many halogen atoms present in a molecule) such as 1,2-dichloroethane and 1,1,2,2-tetrachloroethane are liquids and toxic.

#### B.4.1.4 Amines.

**B.4.1.4.1 Amines** (Aliphatic) (R-NH<sub>2</sub>, R<sub>2</sub>NH, R<sub>3</sub>N). The aliphatic amines consist of primary (1°), secondary (2°), and tertiary (3°) branched compounds. Lower molecular weight amines such as ethylamine, propylamine, butylamine, and triethylamine are highly flammable liquids, corrosive and readily soluble in water. Some are toxic. Many amines, such as methylamine, are sold in diluted aqueous solutions, and are typically flammable. (For ammonia, see B.4.1.5.2.)

**B.4.1.4.2** Amines (Aromatic) (Ar-NH<sub>2</sub>, Ar(N)). This family includes substituted aromatic amines, such as benzene derivatives (e.g., aniline, and o-aminoaniline) and hetroaromatics (e.g., pyridine and picoline). Most of these chemicals are solids or liquids and can be readily soluble in water and are toxic. Some are flammable. Health hazards associated with these chemicals depend heavily on the ring structure, degree of substitution, and location of the nitrogen(s) within the heteroaromatic ring.

### B.4.1.5 Bases.

**B.4.1.5.1 Alkalis.** Bases are found either as solids or as concentrated aqueous solutions. Most bases are highly corrosive with all tissues with which they come in contact. Bases, such as sodium carbonate ( $Na_2CO_3$ ), sodium hydroxide (NaOH), and potassium hydroxide (KOH), readily absorb moisture from the air. When dissolved in water, these chemicals often liberate substantial heat and form corrosive solutions in concentrated form. The corrosiveness and toxicity of these chemicals decreases with dilution.

**B.4.1.5.2 Gaseous.** The common basic gases, ammonia (NH<sub>3</sub>) and the lower molecular weight amines (methylamine, dimethylamine, and trimethylamine), are all are corrosive but not toxic. They are highly soluble in water and are liquefied compressed gases. The common bases are flammable gases with a narrow flammability range. They are often sold commercially as aqueous solutions, which are also flammable.

**B.4.1.6 Carbides/Nitrides.** Carbides have varying degrees of physical hazards. Carbides, such as calcium carbide  $(CaC_2)$  and sodium carbide  $(Na_2C_2)$ , react violently with water, are flammable in the presence of moisture, and could be corrosive. Other carbides, such as zirconium carbide (ZrC), tungsten carbide (WC), and silicon carbide (SiC), have little reactivity. Nitrides, such as boron nitride (BN), are usually stable.

# **B.4.1.7** Carbonyl Compounds.

**B.4.1.7.1 Carbonyl Compounds** (Acid Anhydrides) ( $R_1$ -C(O)OC(O)- $R_2$ ). These chemicals, often referred to as simply "anhydrides," are more reactive than their corresponding carboxylic acids. Anhydrides react with water to form the corresponding acid or base, and are often good dehydrating agents. Lower molecular weight anhydrides, such as acetic anhydride, propionic anhydride, and isobutyric anhydride, are most often corrosive, flammable, and could react violently with water.

Functionalized anhydrides such as trifluoroacetic anhydride are highly corrosive and highly water reactive. Aromatic anhydrides, such as phthalic anhydride, are also corrosive but not water reactive.

B.4.1.7.2 Carbonyl Compounds (Acyl Halides) (R, Ar-C(O)X; R, Ar-SO<sub>2</sub>-X). These chemicals include the most common acid halides and sulfonyl halides and are considerably more reactive than the corresponding anhydrides. Acyl halides are most often corrosive, water reactive, and volatile. Higher molecular weight aromatic acid halides, such as benzoyl chloride, are toxic and corrosive and have limited water solubility and lower water reactivity. Lower molecular weight acid halides such as acetyl chloride are flammable, highly corrosive, and react violently with water.

**B.4.1.7.3 Carbonyl Compounds (Aldehydes) (R-CH=O, Ar-CH=O).** Most aldehydes are volatile organic compounds. Simple, lower molecular weight alkyl aldehydes, such as acetal-dehyde, propionaldehyde (methylacetaldehyde), butyraldehyde, and 2-butenaldehyde (crotonaldehyde), for example, exist as liquids, and are most often highly flammable. Formal-dehyde is known to be toxic. Many aromatic aldehydes, such as benzaldehyde, have limited flammability.

**B.4.1.7.4 Carbonyl Compounds (Esters)** ( $R_1O(C=O)R_2$ ). In general, the category possesses few physical or health hazards. Aliphatic and aromatic esters are significantly more stable than the acid anhydrides and are not water reactive. Lower molecular weight alkyl esters, such as methyl formate, ethyl acetate, and n-butyl acetate, are flammable liquids.

**B.4.1.7.5 Carbonyl Compounds (Halides) (C(O)X<sub>2</sub>, C(S)X<sub>2</sub>).** These compounds are very reactive chemicals and are considered highly toxic, highly water reactive, and corrosive. Phosgene is a nonflammable gas, while thiophosgene and oxalyl chloride are liquids. Trichloromethyl chloroformate (diphosgene) and methyl chloroformate are liquids and less reactive but still water reactive.

**B.4.1.7.6 Carbonyl Compounds (Ketones)** ( $R_1R_2C=O$ ). Similar to aldehydes, most ketones are volatile organic compounds. Many ketones are also flammable liquids. Simple, low molecular weight ketones, such as acetone, cyclohexanone, methyl ethyl ketone (MEK), and methyl isobutyl ketone (MIBK), for example, are liquids and highly flammable. Common functionalized ketones, such as chloroacetone, 1,3-dichloro-2-propanone, and chloroacetophenone (chloromethyl phenyl ketone), while not flammable, are toxic. Many aromatic ketones have limited flammability.

### B.4.1.8 Cyanides.

**B.4.1.8.1 Cyanides (Gaseous).** The common cyanide gases, hydrogen cyanide (HCN), cyanogen chloride (ClCN), and cyanogen  $(C_2N_2)$ , are highly toxic. Hydrogen cyanide is a liquid, but is treated and packaged as a gas. Cyanogen and hydrogen cyanide are flammable, while cyanogen chloride is corrosive.

**B.4.1.8.2 Cyanides (Inorganic) (M-CN).** Common inorganic cyanides include sodium cyanide (NaCN) and trimethylsilyl cyanide (TMSCN). This family is characterized as highly toxic. Cyanide salts are readily soluble in water and highly toxic.

Trimethylsilyl cyanide is water reactive. The family does not include the many organic compounds that contain the CN

group (called nitriles). Nitriles do not display the toxicity of the inorganic cyanides such as sodium and potassium cyanide.

**B.4.1.8.3 Nitriles** (Organic). Common, lower molecular weight nitriles, including acetonitrile and 2-propenenitrile (acrylonitrile), are highly flammable liquids and toxic. Many aromatic nitriles (benzonitriles) are solids and often toxic, depending on substituents. Benzonitriles have limited flammability.

**B.4.1.9 Epoxides.** Epoxides are very reactive chemicals. Common epoxides include ethylene oxide, which is a gas, and propylene oxide and 1-chloro-2,3-epoxypropane (epichlorohydrin), which are liquids. These chemicals most often have flammable, toxic, water-reactive, and unstable reactive hazard characteristics.

**B.4.1.10** Ethers/Glycols **(R-O-R).** This broad includes both simple alcohol ethers and polyhydroxylated glycol ethers. Simple, low molecular weight ethers such as diethyl ether or vinyl ether are low-boiling liquids or compressed gases and highly flammable. Cyclic ethers, such as tetrahydrofuran (THF) and 1,4-dioxane, are highly flammable liquids while slightly toxic. Common higher molecular weight glycol ethers, such as 1,2-dimethoxyethane (glyme), ethylene glycol monomethyl ether (EGME, 2-methoxyethanol), dipropylene glycol monomethyl ether (DPM, 1-(2-methoxy-2methylethoxy)-2-propanol), propylene glycol monomethyl ether (PGME, 1-methoxy-2-propanol), diethylene glycol monomethyl ether (DEGME), and dipropylene glycol monomethyl ether (DPGME), are often water soluble liquids and combustible. Lower molecular weight glycol ethers are flammable liquids. Many are high-boiling point liquids.

**B.4.1.11 Gases.** Within the context of the model codes, gases are regulated as either compressed gases or as cryogenic fluids. Compressed gases can be found either in the nonliquefied or liquefied state. Any gas can be liquefied at a sufficiently low temperature by increasing its pressure through the use of compression. Gases that cannot be liquefied at normal ambient temperatures are called "permanent" gases. A permanent gas is able to be liquefied by reducing the temperature below ambient temperatures and increasing its pressure. However, at normal ambient temperatures of 68°F (20°C) these gases remain in a nonliquefied state.

The scientific explanation for this phenomenon is generally explained in the following discussion. There is a temperature for each gas at or below which it can be liquefied by pressure, but above which it is impossible to liquefy at any pressure. This temperature is called the critical temperature of the gas. At temperatures above the critical temperature, the substance can exist only in the gaseous state regardless of the pressure applied. The pressure that will just liquefy a gas at its critical temperature is called the critical pressure. In other words, the critical pressure of a gas is equal to the vapor pressure exerted by the liquefied gas at its critical temperature. All that is necessary to liquefy a gas is to cool it to its critical temperature and subject it to a pressure equal to or greater than its critical pressure. The farther below the critical temperature it is cooled, the less the pressure required for liquefaction. At the critical conditions of temperature and pressure the gaseous and liquid forms of the substance have the same density.

Atmospheric air is a mixture of permanent gases and principally composed of argon, oxygen, and nitrogen. Under normal ambient conditions it remains in the gaseous state. The critical temperature of air is -221.1°F (-140.6°C). The critical pressure is an absolute pressure of 547 psi (3771 kPa, absolute). To liquefy compressed air, the temperature must be reduced to -221.1°F (-140.6°C) or less with a commensurate increase in pressure above absolute pressure of 547 psi (3771 kPa, absolute). By comparison, liquefied petroleum gas (LP-Gas), is a mixture of hydrocarbon gases, principally propane and butane, which is found in the liquid form under ambient conditions. These gases have a critical temperature well in excess of 68°F (20°C), and as a result, they are found as liquefied compressed gases under ambient temperatures.

Cryogenic fluids are refrigerated liquefied gases with a boiling point lower than  $-130^{\circ}\text{F}$  ( $-90^{\circ}\text{C}$ ) at an atmospheric pressure of an absolute pressure of 14.7 psi (101.3 kPa, absolute). They are maintained in the cryogenic (super-cooled) state by artificial means.

**B.4.1.11.1 Gases (Flammable).** Common nonliquefied flammable compressed gases include carbon monoxide and hydrogen. Other flammable gases are hydrocarbon gases. The alkanes include methane ( $CH_4$ ), ethane ( $C_2H_6$ ), and propane ( $C_3H_8$ ). Ethane and propane are liquefied compressed gases at ambient temperature. The alkenes include ethylene ( $C_2H_4$ ) and propylene ( $C_3H_6$ ), both liquefied compressed gases, and the alkynes include acetylene ( $C_2H_2$ ). Acetylene is an unstable reactive gas; it is found in cylinders, packaged as a compressed gas dissolved in a solution of acetone or dimethyl formamide. While acetylene can be liquefied at ambient temperatures, for safety reasons it is shipped as a nonliquefied compressed gas.

**B.4.1.11.2 Gases (Halogens) (X-X).** The pure halogen gases, fluorine  $(F_2)$ , chlorine  $(Cl_2)$ , bromine trifluoride  $(BrF_3)$ , and chlorine trifluoride  $(ClF_3)$ , are extremely powerful oxidizers, and are corrosive and toxic. Fluorine and chlorine are only slightly soluble in water, while bromine trifluoride and chlorine trifluoride are extremely water reactive. Bromine trifluoride is explosive on contact with water. Fluorine is a compressed gas while chlorine, bromine trifluoride, and chlorine trifluoride are liquefied compressed gases.

Gases that are fully halogenated, such as hexafluoroethane  $(C_2F_6)$ , carbon tetrafluoride  $(CF_4)$ , and sulfur hexafluoride  $(SF_6)$ , are inert and nonreactive.

- **B.4.1.11.3 Gases** (Nonflammable). The atmospheric gases, with the exception of oxygen, have limited chemical reactivity, and are not corrosive, flammable, or toxic. These gases include nitrogen, argon, and carbon dioxide. Their greatest hazard is asphyxiation. The rare gases, such as helium, neon, krypton, xenon, and argon, were once thought to be inert (having no chemical activity at all); however, within the last 20 years compounds have been made through the use of strong oxidizer gases, such as fluorine, to form nitrogen trifluoride.
- **B.4.1.11.4 Gases (Oxidizing).** The more common oxidizing gases are oxygen, nitrous oxide, and nitrogen trifluoride. Oxygen and nitrogen trifluoride are compressed gases, while nitrous oxide is a liquefied compressed gas.
- **B.4.1.11.5 Gases (Pyrophoric).** Gases with an autoignition temperature below 130°F (54°C) are classified as pyrophoric. Silane (SiH<sub>4</sub>) is probably one of the most common pyrophoric gases found in use today. Other pyrophoric gases include methylsilane (CH<sub>3</sub>SiH<sub>3</sub>) and disilane (Si<sub>2</sub>H<sub>6</sub>). Silane and methylsilane are compressed gases, while disilane is a liquefied compressed gas. Some pyrophoric gases, such as phosphine

 $(PH_3)$  and diborane  $(B_2H_6)$ , are also highly toxic. Although all pyrophoric gases are flammable by nature, they are regulated as pyrophoric gases within the context of the model codes.

**B.4.1.11.6 Gases (Sulfur Gases) (R-SH).** The common sulfur gases are hydrogen sulfide ( $H_2S$ ), methyl mercaptan ( $CH_3SH$ ), and carbonyl sulfide (COS) and are toxic and flammable. They are all liquefied compressed gases.

### **B.4.1.12** Hydrocarbons.

**B.4.1.12.1 Hydrocarbons (Aliphatic) (R).** Commonly referred to as saturated hydrocarbons, alkanes as a whole are unreactive chemicals. The aliphatic hydrocarbons pentane, decane, and cyclohexane are flammable liquids. Lower molecular weight hydrocarbons such as methane, ethane, propane, and butane are flammable compressed gases.

**B.4.1.12.2 Hydrocarbons (Alkenes) (R<sub>1</sub>CH=CHR<sub>2</sub>).** Alkenes are a very broad category of hydrocarbons and are commonly referred to as unsaturated hydrocarbons, olefins, or vinyl compounds. Alkenes are relatively stable compounds, but are more reactive than alkanes. Smaller chain alkenes, such as ethylene, propylene, and butene, are all flammable gases and readily form explosive mixtures with air. Common derivatized alkenes, such as styrene (vinyl benzene), vinyl chloride (monochloroethylene), vinyl acetate, and 1,4-dichloro-2-butene, are toxic. Some are flammable liquids. They also readily polymerize (without inhibitors), which leads to unstable reactive characteristics.

**B.4.1.12.3 Hydrocarbons** (**Alkynes**) (**R**<sub>1</sub>**C**≡**CR**<sub>2</sub>, **R**-**C**≡**CH**). Of all the aliphatic hydrocarbons, alkynes are the most reactive. Many alkynes are highly reactive and considered unstable reactive, especially as molecular weights increase. Many halogenated alkynes and metal derivatives can be explosive. The most common alkynes are gases, including acetylene (ethyne — see Flammable Gases) and methyl acetylene (1-propyne), can form explosive mixtures with air. The most common derivatized alkyne is propargyl alcohol (2-propyn-1-ol), which is flammable, corrosive, and toxic.

**B.4.1.12.4** Hydrocarbons (Aromatic) (Ar). This family is very broad and derived from such compounds as benzene and toluene and have limited alkyl (methyl, ethyl, etc.) substitution on the ring. Smaller aromatic hydrocarbons (benzene, toluene (methyl benzene), ethyl benzene, and xylene) are flammable liquids and are sometimes toxic. High-molecular-weight compounds with many aromatic rings (such as naphthalene and anthracene) are solids and are often toxic. Substituted analogues, such as dichlorobenzene, have varying degrees of toxicity based on the degree of substitution and arrangement on its ring structure. Many are also flammable solids.

**B.4.1.13 Isocyanates** (R-N=C=O, Ar-N=C=O). This family includes compounds such as toluene diisocyanate (TDI), ptoluenesulfonyl isocyanate, and methylene bisphenyl isocyanate (MDI). The chemicals are liquids and are typically unstable reactive, water-reactive, corrosive, and toxic. Some are highly toxic. Some are violently water reactive.

### B.4.1.14 Metals.

**B.4.1.14.1 Metal Alkyls (M-R).** All metal alkyls are pyrophoric, corrosive, and highly reactive. The simple metal alkyls trimethylalluminum (TMAI), trimethylgallium (TMG), and trimethylindium (TMI) are pyrophoric liquids. They are also violently

water reactive. Dimethylzinc and trimethylaluminum are also unstable reactive. Tetramethyltin is a flammable liquid.

**B.4.1.14.2 Metal Halides (M-X).** Physical and health hazards of this chemical family vary significantly based on the corresponding metal. Most metal halides are typically inert (such as sodium chloride [table salt], calcium chloride, magnesium fluoride, aluminum chloride, and palladium (II) chloride), while some have a much higher reactivity (such as silver bromide and chromium (III) chloride) and are strong oxidizers. The chemical and physical properties vary significantly depending on the metal. If a metal halide contains a heavy metal, such as lead, chromium, thallium, and mercury, it is assumed to be highly toxic. Fluoride and bromide salts are more toxic than the corresponding chloride salts.

**B.4.1.14.3 Metal Hydrides (Solids).** Compounds such as lithium aluminum hydride (LiAlH<sub>4</sub>), sodium borohydride (NaBH<sub>4</sub>), and sodium hydride (NaH) are flammable solids, water-reactive, and corrosive. Metal hydrides react violently with water.

**B.4.1.14.4 Metal Hydrides (Gaseous).** The more common metal hydride gases are arsine (arsenic hydride,  $AsH_3$ ), diborane (boron hydride,  $B_2H_6$ ), hydrogen selenide (selenium hydride,  $H_2Se$ ), and phosphine (phosphorus hydride,  $PH_3$ ). In general, these chemicals are toxic, liquefied compressed gases, with many being highly toxic. They are flammable and some have autoignition temperatures low enough to make them pyrophoric, such as diborane and phosphine. The key exception is silane (SiH<sub>4</sub>), which is not toxic. Silane is a compressed gas rather than a liquefied compressed gas.

**B.4.1.14.5 Metals (Alkali).** This category includes sodium, potassium, and lithium. All are highly corrosive and can often explode if they are exposed to water. They are all flammable solids as well.

**B.4.1.14.6 Metals (Powdered).** Metals, especially those in a finely divided state, are usually categorized as flammable solids, such as aluminum, magnesium, sodium, and potassium. Some, but not all, react violently and are water-reactive. Some are also toxic.

### **B.4.1.15** Nitrated Organic Compounds.

**B.4.1.15.1 Organic Nitro Compounds (R, Ar-NO<sub>2</sub>).** Most often, smaller alkyl nitro compounds, such as nitromethane, are flammable, unstable reactive, and often toxic. Aromatic nitro analogues are toxic or highly toxic and unstable reactive, the latter being dependent on the amount of ring substitution.

**B.4.1.15.2 Azo** (Aliphatic) (R-N=N-R). Aliphatic azo derivatives are inherently unstable and readily decompose, often violently, upon the application of heat. Aliphatic azo compounds are characterized as unstable reactive, flammable solids and are often toxic.

**B.4.1.15.3** Azo (Aromatic) (Ar-N=N-Ar). Aromatic azo derivatives have superior thermal stability properties compared to aliphatic azo derivatives. Many aromatic azo derivatives are quite stable and often used as dyes. They have a wide array of chemical and physical properties depending on the substituents on the aromatic ring and the number of azo groups present in the molecule (mono-, dis-, tris-, tetrakis-, etc.). Most exhibit low to moderate toxicity.

- **B.4.1.15.4 Azides (R, Ar-N<sub>3</sub>).** The most common chemicals of this family are the metal azides, including sodium and lithium azide. All the compounds in this family are unstable reactive and highly toxic.
- **B.4.1.15.5** Nitrites (Inorganic) (M-NO<sub>2</sub>). The most common nitrites are sodium and potassium nitrite. All are strong oxidizers and toxic.
- **B.4.1.15.6** Nitrates (Inorganic) (M-NO<sub>3</sub>). Examples of inorganic nitrates include sodium nitrate, silver nitrate, zinc nitrate, lithium nitrate, and lead nitrate. While all inorganic nitrates are strong oxidizers, the physical and health properties vary significantly depending on the metal. Many of these compounds are corrosive and can have unstable reactive properties. Toxicity varies with the associated metal.
- **B.4.1.16** Nitrogen-Halogen Compounds (R-N-X). This chemical family includes chlorinated isocyanurates (trichloroisocyanuric acid, sodium dichloroisocyanurate), halogenated succinimides (N-bromosuccinimide), and halogenated hydantoins (e.g., 1-bromo-3-chloro-5,5-dimethylhydantoin). Some are strong oxidizers and corrosive in their pure states, with varying properties of unstable reactive, water-reactive, and toxicity hazards. Specially formulated chlorinated isocyanurate products have been shown to reduce oxidizer properties.
- **B.4.1.17 Oxyanion (M-ClO<sub>2</sub>, M-ClO<sub>3</sub>, M-ClO<sub>4</sub>, M-OCl).** This chemical family includes chlorites, chlorates, perchlorates, bromates, and hypochlorites. The most common chemicals are sodium chlorite (NaClO<sub>2</sub>), sodium chlorate (NaClO<sub>3</sub>), ammonium perchlorate (NH<sub>4</sub>ClO<sub>4</sub>), potassium bromate (KBrO<sub>3</sub>), and calcium hypochlorite (Ca(OCl)<sub>2</sub>). Most are strong oxidizers and corrosive in their pure states with varying properties of unstable reactive, water reactive, and toxicity hazards. Chlorites and chlorates are most commonly found as diluted solutions that reduce toxicity and oxidizing properties. Specially formulated calcium hypochlorite products have been shown to reduce their oxidizing properties. Sodium hypochlorite (liquid bleach) is too unstable in solid form and is found only in dilute solutions that are corrosive.

# B.4.1.18 Peroxides.

**B.4.1.18.1 Peroxides** (**Organic**) (**R-O-O-R**). The common organic peroxides include such chemicals as *t*-amyl hydroperoxide, dibenzoyl peroxide, di-*t*-butyl peroxide, diacetyl peroxide, methyl ethyl ketone peroxide, diisopropyl peroxydicarbonate, and cumyl hydroperoxide. Organic peroxides possess a wide range of properties based on the many physical forms and concentrations and have a large range of safety-related properties, including physical as well as health hazards. Organic peroxides are either used as the technically pure compound or as formulations where the peroxide might be found in a diluted form, such as solutions, pastes, or solid granules.

Organic peroxide formulations vary in reactivity hazard from self-extinguishing to the potential for a violent deflagration or detonation. Decomposition can be initiated by heat, friction, mechanical shock, or contamination, though sensitivity to these stimuli varies greatly. Dilution with water or other solvents is used as a means to reduce the level of sensitivity to outside stimuli and the potential for decomposition. Refrigeration is also used as a means to reduce the potential for decomposition. The health hazards of these materials as provided in

commerce vary greatly depending on concentration and formulation itself.

- **B.4.1.18.2 Metal Peroxides** (Inorganic) (M-O-O). Metal peroxides, such as sodium peroxide and calcium peroxide, are all oxidizers. Some are corrosive and water reactive. Reaction with water can be explosive in some instances.
- **B.4.1.19 Phosphorus-Halogen** Compounds (O=P-X<sub>3</sub>, P-X). These phosphorus analogues are corrosive and often react violently with water and include such chemicals as phosphorus oxychloride (POCl<sub>3</sub>), phosphorus trichloride (PCl<sub>3</sub>), and phosphorus pentachloride (PCl<sub>5</sub>). They are water reactive, corrosive, and toxic.

# **B.5** Hazard Category Based on Concentration.

- **B.5.1 General.** Some chemicals exhibit different physical and/or health hazards based on the concentration. Some pertinent examples of concentration-dependent hazards of specific chemicals are provided in the following list. Additional information on concentration-dependent hazards should be contained in the SDS.
  - (1) Acetic Acid (64-19-7). Concentration: 100 percent corrosive, flammable/combustible; 36 percent aqueous corrosive; <5 percent aqueous not corrosive.
  - (2) Ammonia (7664-41-7). Concentration: anhydrous corrosive, flammable gas; <50 percent aqueous not corrosive.
  - (3) Formaldehyde (50-00-0). Concentration: anhydrous flammable, corrosive, highly toxic; 37 percent aqueous combustible, highly toxic 10 percent aqueous combustible.
  - (4) Hydrogen Fluoride (7664-39-3). Concentration: anhydrous corrosive, water reactive, toxic; 10–48 percent corrosive, toxic; 2–10 percent aqueous corrosive.
  - (5) Nitric Acid (7697-37-2). Concentration: 7–40 percent aqueous oxidizer, corrosive; 1–6 percent aqueous not oxidizer, not corrosive.
  - (6) Phosphine (CAS numbers based on concentration). Concentration: 5 percent phosphine, 95 percent nitrogen pyrophoric, toxic; phosphine: 2 percent phosphine, 98 percent nitrogen toxic.
  - (7) Phosphoric Acid (7664-38-2). Concentration: 85-86 percent aqueous corrosive; <80 percent aqueous not corrosive.
  - (8) Potassium Hydroxide (1310-58-3). Concentration: 100 percent corrosive, water reactive, toxic; 45 percent aqueous corrosive, water reactive; 5 percent aqueous corrosive.
  - (9) 2-Propanol (Isopropanol) (67-63-0). Concentration: > 91 percent aqueous flammable; 25-50 percent aqueous combustible.
- (10) Sodium chlorate (7775-09-9). Concentration: 100 percent
   corrosive, oxidizer, unstable reactive; 40–50 percent
   aqueous corrosive, oxidizer.
- (11) Sodium hydroxide (1310-73-2). Concentration: 100 percent corrosive, water reactive, toxic; 1–50 percent aqueous corrosive.
- (12) Sulfuric Acid (7664-93-9). Concentration: 92–98 percent aqueous corrosive, water reactive, toxic; 12.7–50 percent aqueous corrosive, water reactive, toxic; 4–12.6 percent aqueous corrosive.
- (13) Sodium Hypochlorite (7681-52-9). Concentration: 12–15 percent aqueous corrosive; 3–5 percent aqueous not corrosive.

# **B.6** Safety Data Sheets (SDSs) — A Starting Point for Hazards Identification.

**B.6.1 General.** Safety data sheets (SDSs) have been established as a primary means of hazard identification under OSHA's Hazard Communication standard (29 CFR 1910.1200). SDSs are provided by manufacturers or importers as a means to communicate hazards within a set of standardized terms and elements or bodies of information.

**B.6.2 SDS** Format. In 2012, OSHA revised its Hazard Communication Standard (40 CFR 1910.1200) to align with the United Nations Globally Harmonized System of Classification and Labelling of Chemicals (GHS). The Hazard Communication Standard requires the use of a 16-section format for SDSs, similar to that of the format provided in ANSI Z400.1/Z129.1, Hazardous Workplace Chemicals — Hazard Evaluation and Safety Data Sheet and Precautionary Labeling Preparation. As manufacturers, importers, and distributors transition to the 16-section SDS format, they will include information in the 16 sections referenced in Section B.2. To classify the hazards of a given material, users should refer to key sections of the SDS that contain the following information:

- (1) Identification (SDS Section 1)
- (2) Hazard(s) identification (SDS Section 2)
- (3) Composition/information on ingredients (SDS Section 3)
- (4) Physical and chemical properties (SDS Section 9)
- (5) Stability and reactivity (SDS Section 10)
- (6) Toxicological information (SDS Section 11)
- (7) Transport information (SDS Section 14)

Each section should contain relevant information that can be used in the hazard classification process. The following subsections provide useful information to help the user with these required SDS sections.

**B.6.2.1 Identification.** Product identification will typically include the chemical name, common name, and synonyms. Pure materials, sometimes referred to as "neat" to indicate that they are in an undiluted form, are typically referred to by their chemical name. However, it is not uncommon to find that the manufacturer has identified the material under a trade name chosen by that particular manufacturer. Chemical synonyms will frequently be shown; however, it should be expected that the list of synonyms might be an abbreviated listing and that there could be other synonyms that are not listed.

For chemical mixtures the material will typically be identified by its trade name. Some confusion can be created when a material in its "neat" form is further identified in the Hazard Identification section as containing other constituents. Commercially available materials even in the pure or neat form contain impurities from the manufacturing process. Although there is no hard-and-fast rule, materials in concentrations of 95 percent or greater are generally considered to be in the pure form and are referred to by the CASRN for the major component. The impurities from manufacturing are generally not considered for the purposes of material identification and such materials are not considered to be "mixtures" of chemicals per se.

The product identification section provides additional information, including the identification of the manufacturer of the material and nomenclature intended to link the SDS to the label provided on the material in the container(s) as furnished by the manufacturer.

In addition to the product identifier, Section 1 of the SDS will list the chemical name, and the name, address, and phone number of the responsible party.

Similar to NFPA, the Hazard Communication Standard requires that hazardous chemicals be classified according to the severity of hazard presented by the chemical. However, the hazard categories defined and assigned by the Hazard Communication Standard are different than those used by NFPA. For example, the Hazard Communication Standard defines oxidizers differently than the NFPA (see Annex I for a comparison of these definitions). Within the hazard category of oxidizer, there are four subcategories or Classes of hazards recognized under the NFPA system, Class 4, Class 3, Class 2, and Class 1 materials. Hazard classes are used to describe a range of hazards within a given hazard category, and the class system is used for materials that are oxidizers other than oxidizing gases, organic peroxides, unstable reactives, and water reactives. Although not the subject of regulation by NFPA 400, flammable liquids are further subdivided into Class I, Class II, and Class III, and combustible liquids are further subdivided into Class II, IIIA, and IIIB liquids.

**B.6.2.2 Hazards Identification.** Section 2 of the SDS lists the hazard identification of the chemical, including the classification of the chemical, signal word, the pictogram(s), hazard statement(s), description of hazard(s), and precautionary statements. SDS Section 2 also describes hazards that are not otherwise classified.

The hazard identification section of the SDS provides an emergency overview of the material and includes information on health and physical hazards that can result from exposure to the material.

**B.6.2.3** Composition/Information on **Ingredients.** The composition of the material or information on ingredients is listed in SDS Section 3, per the OSHA Hazard Communication Standard. The composition section typically lists the hazardous components as defined by OSHA, and not those categories used by NFPA 400. Although the OSHA hazard categories have been incorporated into the regulatory scheme used by NFPA 400, there are differences and the converse is not true. For example, OSHA does not incorporate the traditional NFPA hazard ratings used in NFPA 704. The revised Hazard Communication Standard allows the completed NFPA 704 diamond to be provided on the SDS. NFPA and OSHA developed a Quick Card to compare the classification and rating systems, located at www.nfpa.org/704.

The composition section is required to list hazardous components of a material and are themselves classified and contribute to the classification of the chemical. For mixtures, the composition section must also list the chemical name and concentration of all ingredients classified as health hazards and that are present above their cut-off/concentration limits or present a health risk below the cut-off/concentration limits. The SDS can also list components that are nonhazardous. The CASRN for each component is typically listed in this section of the SDS.

**B.6.2.4 Physical and Chemical Properties.** Section 9 of the SDS lists the physical and chemical properties of the materials. A description of its physical properties, including its physical state (i.e., solid, liquid, gas), is required. It is typical to find a wide array of physical and chemical properties listed. The phys-

ical and chemical properties required in SDS Section 9 include the following:

- (1)Appearance (physical state, color, and so on)
- (2)Odor
- (3) Odor threshold
- (4)рΗ
- (5)Melting/freezing point (specify which)
- (6) Initial boiling point and boiling range
- (7)Flash point
- (8)Evaporation rate
- (9)Flammability (solid, gas)
- (10)Upper/lower flammability or explosive limits
- (11)Vapor pressure
- Vapor density (12)
- (13) Relative density
- (14) Solubility(ies) (specify solvent, e.g., water)
- (15) Partition coefficient:n-octanol/water
- (16) Auto-ignition temperature
- (17) Decomposition temperature
- (18) Viscosity

B.6.2.5 Stability and Reactivity. Section 10 of the SDS lists information about the stability and reactivity of materials. This section typically describes conditions that affect the intrinsic stability of a material. An intrinsic property is a property that is inherent in the material in and of itself, as compared to its properties under conditions that are brought about by the environment in which it is located. Environmental conditions can be described as extrinsic conditions, such as when the material is exposed to heat, fire, shock, or other effects.

This section of the SDS is used as a means to assess its nature within the context of the unstable reactive hazard category. While many materials have an intrinsic stability, they can become unstable when exposed to high temperatures or mechanical or physical shock. Therefore, the information found on an SDS might have to be supplemented by referring to other authoritative sources regarding the reactivity of the material.

**B.6.2.6 Toxicological Information.** Section 11 of the SDS lists toxicological information. This section contains information on the health effects of the material or its components. It typically supports the detail provided in the section on hazards identification in the SDS. The information provided is written for use by health care professionals and those that have the technical training and experience in the safety and toxicology aspects of interface with materials from a toxicological perspective.

However, this section of the SDS contains information that is used to establish the approach to control integral to NFPA 400 with respect to toxicity and corrosivity. Data including the effects of acute exposure to mammals and other life forms or information regarding the irreversible destruction of tissue at the site of contact will be found in this section of the SDS.

There could be other information regarding the toxicological effects resulting in, but not limited to, irritation, sensitization, carcinogenicity, reproductive effects, and genetic and target organ effects, none of which fall under the scope of NFPA 400.

**B.6.2.7 Transportation.** Section 14 of the SDS lists the system of classification used by the Department of Transportation (DOT) to classify materials for shipment purposes, which is not compatible with the system used to classify materials within the context of NFPA 400. With the alignment to the United Nations Globally Harmonized System of Classification and Labeling of Chemicals (GHS), it must be recognized that OSHA's system of hazard communication has now become harmonized with the system used by the DOT. OSHA's hazard communication system embodied in the SDS, correlates with the DOT regulations for transporting hazardous chemicals, located in 49 CFR. The OSHA system, contemplates that users and producers of hazardous materials will encounter these materials in their unpackaged state where the materials are reasonably foreseen to have a potential for bodily contact or use within the work environment on a regular basis. On the other hand, the DOT system of control views the materials in their final packaging as required for transportation where the materials are not subject to exposure to personnel except under upset conditions.

Because OSHA does not enforce the contents of Section 14 of the SDS, users can find additional information in the section for transportation on the SDS, which might or might not be further explained in preceding sections. It is important to recognize that the classification for the purposes of transportation will not suffice as a means to assign the material to a given hazard category under the requirements of NFPA 400, and the user must carefully apply the material specific definitions found in Chapter 3 along with the criteria obtained from the SDS and other resources to determine the appropriate classification of a given material.

### Annex C Hazardous Materials Management Plans and **Hazardous Materials Inventory Statements**

This annex is not a part of the requirements of this NFPA document unless specifically adopted by the authority having jurisdiction.

**C.1 Scope.** Hazardous materials inventory statements (HMIS) and hazardous materials management plans (HMMP), which are required by the AHJ pursuant to Chapter 1, must be provided for hazardous materials in accordance with Annex C.

Exception No. 1: Materials that have been satisfactorily demonstrated not to present a potential danger to public health, safety, or welfare, based upon the quantity or condition of storage, when approved.

Exception No. 2: Chromium, copper, lead, nickel, and silver need not be considered hazardous materials for the purposes of this annex unless they are stored in a friable, powdered, or finely divided state. Proprietary and trade secret information must be protected under the laws of the state or AHI.

### C.2 Hazardous Materials Inventory Statements (HMIS).

C.2.1 Where Required. A separate HMIS must be provided for each building, including its appurtenant structures, and each exterior facility in which hazardous materials are stored. The hazardous materials inventory statement must list by hazard class all hazardous materials stored. The hazardous materials inventory statement must include the following information for each hazardous material listed:

- Hazard class
- (2)Common or trade name
- Chemical name, major constituents, and concentrations if a mixture; if a waste, the waste category
- Chemical Abstracts Service Registry number (CAS number), which can be found in the SDS
- Whether the material is pure or a mixture, and whether the material is a solid, liquid, or gas
- Maximum aggregate quantity stored at any one time

- (7) Storage conditions related to the storage type, temperature, and pressure
- **C.2.2 Changes to HMIS.** An amended HMIS must be provided within 30 days of the storage of any hazardous materials that changes or adds a hazard class or that is sufficient in quantity to cause an increase in the quantity which exceeds 5 percent for any hazard class.
- C.3 Hazardous Materials Management Plan (HMMP).
- **C.3.1 General.** Applications for a permit to store hazardous materials must include an HMMP standard form or short form in accordance with C.3.3 and must provide a narrative description of the operations and processes taking place at the facility. (See Figure C.3.1.)
- **C.3.2 Information Required.** The HMMP standard form must include the following information.
- **C.3.2.1 General Information.** General information, including business name and address, emergency contacts, business activity, business owner or operator, SIC code, number of employees and hours, Dunn and Bradstreet number, and signature of owner, operator, or designated representative must be included.
- **C.3.2.2 General Site Plan.** A general site plan drawn at a legible scale which must include, but not be limited to, the location of buildings, exterior storage facilities, permanent access ways, evacuation routes, parking lots, internal roads, chemical loading areas, equipment cleaning areas, storm and sanitary sewer accesses, emergency equipment, and adjacent property uses must be included. The exterior storage areas must be identified with the hazard class and the maximum quantities per hazard class of hazardous materials stored. When required by the AHJ, information regarding the location of wells, flood plains, earthquake faults, surface water bodies, and general land uses within 1 mi (1.6 km) of the facility boundaries must be included.
- **C.3.2.3 Building Floor Plan.** A building floor plan drawn to a legible scale, which must include, but not be limited to, hazardous materials storage areas within the building and must indicate rooms, doorways, corridors, means of egress and evacuation routes must be included. Each hazardous materials storage facility must be identified by a map key that lists the individual hazardous materials, their hazard class, and quantity present for each area.
- **C.3.2.4 Hazardous Materials Handling.** Information showing that activities involving the handling of hazardous materials between the storage areas and manufacturing processes on site are conducted in a manner to prevent the accidental release of such materials must be included.
- **C.3.2.5 Chemical Compatibility and Separation.** Information showing procedures, controls, signs, or other methods used to ensure separation and protection of stored materials from factors that could cause accidental ignition or reaction of ignitable, reactive, or incompatible materials in each area must be included.
- **C.3.2.6 Monitoring Program.** Information including, but not limited to, the location, type, manufacturer's specifications, if applicable, and suitability of monitoring methods for each storage facility when required must be included.

- **C.3.2.7 Inspection and Record Keeping.** Schedules and procedures for inspecting safety and monitoring and emergency equipment must be included. The permittee must develop and follow a written inspection procedure acceptable to the AHJ for inspecting the facility for events or practices that could lead to unauthorized discharges of hazardous materials. Inspections must be conducted at a frequency appropriate to detect problems prior to a discharge. An inspection check sheet must be developed to be used in conjunction with routine inspections. The check sheet must provide for the date, time, and location of inspection; note problems and dates and times of corrective actions taken; and include the name of the inspector and the countersignature of the designated safety manager for the facility.
- **C.3.2.8 Employee Training.** A training program appropriate to the types and quantities of materials stored or used must be conducted to prepare employees to safely handle hazardous materials on a daily basis and during emergencies. The training program must include the following:
- Instruction in safe storage and handling of hazardous materials, including maintenance of monitoring records
- (2) Instruction in emergency procedures for leaks, spills, fires or explosions, including shutdown of operations and evacuation procedures
- (3) Record-keeping procedures for documenting training given to employees
- **C.3.2.9 Emergency Response.** A description of facility emergency procedures must be provided.
- C.3.3 HMMP Short Form (Minimal Storage Site). A facility must qualify as a minimal storage site if the quantity of each hazardous material stored in one or more facilities in an aggregate quantity for the facility is 500 lb (227 kg) or less for solids, 55 gal (208.2 L) or less for liquids, or 200 ft<sup>3</sup> (5.7 m³) or less at NTP for compressed gases and does not exceed the threshold planning quantity as listed in 40 CFR 355, "Emergency Planning and Notification," Sections 302 and 304. The applicant for a permit for a facility that qualifies as a minimal storage site must be permitted to file the short form HMMP. Such plan must include the following components:
- (1) General facility information
- (2) A simple line drawing of the facility showing the location of storage facilities and indicating the hazard class or classes and physical state of the hazardous materials being stored
- (3) Information describing that the hazardous materials will be stored and handled in a safe manner and will be appropriately contained, separated, and monitored
- (4) Assurance that security precautions have been taken, employees have been appropriately trained to handle the hazardous materials and react to emergency situations, adequate labeling and warning signs are posted, adequate emergency equipment is maintained, and the disposal of hazardous materials will be in an appropriate manner
- **C.4 Maintenance of Records.** Hazardous materials inventory statements and hazardous materials management plans must be maintained by the permittee for a period of not less than three (3) years after submittal of updated or revised versions. Such records must be made available to the AHJ upon request.

- 3. List all special land uses within 1 mi (1.609 km).

# 1.3 Part C—Facility Storage Map (Confidential Information)

- Provide a floor plan of each building on 8½ in. by 11 in. (215 mm by 279 mm) paper, using letters on the top and bottom margins and numbers on the right and left side margins, with approximate scale and northern direction, showing the location of each storage area. Mark map clearly "Confidential —Do Not Disclose" for trade-secret information as specified by federal, state, and local laws.
- 2. Identify each storage area with an identification number, letter, name, or symbol.
- 3. Show the following:
  - $(a) \ Accesses \ to \ each \ storage \ area.$
  - (b) Location of emergency equipment.
  - (c) The general purpose of other areas within the facility.
  - (d) Location of all aboveground and underground tanks to include sumps, vaults, below-grade treatment systems, piping, etc.
- 4. Provide the following on the map or in a map key or legend for each storage area:
  - (a) A list of hazardous materials, including wastes
  - (b) Hazard class of each hazardous waste
  - (c) The maximum quantity for hazardous materials
  - (d) The contents and capacity limit of all tanks at each area and indicate whether they are above or below ground
- 5. List separately any radioactives, cryogens, and compressed gases for each facility.
- 6. Trade-secret information shall be listed as specified by federal, state, and local laws.

SECTION II — HAZARDOUS MATERIALS INVENTORY STATEMENT (HMIS)

### 2.1 Part A—Declaration

Fill out all appropriate information.

### 2.2 Part B—Inventory Statement

- You must complete a separate inventory statement for all waste and nonwaste hazardous materials. List all hazardous materials in alphabetical order by hazard class.

The objective of conducting a security vulnerability assessment (SVA) is to identify security hazards, threats, and vulnerabilities facing a facility, and to evaluate the countermeasures to provide for the protection of the public, workers, national interests, the environment, and the company. With this information security risks can be assessed and strategies can be

formed to reduce vulnerabilities as required. SVA is a tool to assist management in making decisions on the need for countermeasures to address the threats and vulnerabilities.

### Annex E Properties and Uses of Ammonium Nitrate and Fire-Fighting Procedures

This annex is not a part of the requirements of this NFPA document but is included for informational purposes only.

**<u>A E.1 Properties and Uses of Ammonium Nitrate.</u>** Ammonium nitrate (AN) (NH<sub>4</sub>NO<sub>3</sub>, CAS 6484-52-2) is used, handled, and stored in solid and liquid forms in various concentrations (see Table E.1). It is commercially produced by reacting nitric acid with ammonia and evaporating the resultant solution of AN to make a concentrated AN melt, which is then spray granulated in a prilling tower or pelletized or flaked by some other means. Prill-form AN is used in industrial applications, including explosives for mining, and in agricultural applications as fertilizer. Solid and liquid AN can be used undiluted or in mixtures. Pure AN is stable; however, under certain conditions, AN can become explosive. AN in undiluted or pure form has a higher degree of overall hazard than does AN mixed or blended with materials that can reduce the concentration. Contamination must be avoided so that an unstable, unintentional mixture does not result.

Most solid, liquid, and gaseous nitrates are oxidizers. AN is an oxidizer. AN is classed as an oxidizer by the U.S. Department of Transportation (DOT) and Pipeline and Hazardous Materials Safety Administration (PHMSA). Pure AN melts and meets the definition of an oxidizer that is not combustible in and of itself but accelerates the burning of combustible materials with which it comes into contact. The burning rate of technical-grade AN prill falls within the Class 2 oxidizer criteria in Annex G. The loss history of AN also indicates potential for unstable reactive hazard properties, uncontrolled decomposi-

tion, and/or detonation if subject to one or more of the following conditions:

- (1) Fire
- (2) Heating in a confined space
- Localized heating potentially leading to development of high-temperature areas
- (4) Exposure to strong shock waves
- (5) Contamination with combustible materials, incompatible inorganic and organic substances that can result in sensitivity to explosion (see 11.2.16.1.1 for examples)
- (6) Low pH or acidic conditions

The requirements in Chapter 11 are intended to protect AN as an oxidizer with multiple physical hazards and to prevent AN from exhibiting unstable reactive physical hazard properties. With code compliance and proper precautions against fire and explosion, AN can be stored safely.

The physical hazards of pure AN are: capable of detonation with reported TNT equivalence between 25 and 45 percent, accelerated burning of combustibles, and self-sustaining decomposition. The health hazards of AN are toxic gaseous products of decomposition and fire off-gases: oxygen, ammonia, nitric acid, and nitrous oxide.

Factors influencing the risk of detonation of AN are the following:

- (1) Heating under confinement permitting high-pressure buildup
- (2) Strong shocks, such as those from an explosive

The sensitivity of AN to detonation increases with contamination and elevated temperatures. The likelihood of an explosion in a typical warehouse fire where AN is stored increases under the following conditions:

- (1) If molten AN can accumulate in large pools
- (2) If there is potential for confinement of molten AN, such as in drains, pits, sumps, sewers, or dead spaces in equipment
- (3) If there is potential for physical shock of the molten AN, such as high-velocity projectiles generated in a fire
- (4) If the AN is or becomes contaminated before or during a fire
- (5) If the temperature is in excess of 554°F (290°C) at atmospheric pressure and adiabatic conditions

Although AN can be contaminated before a fire, it can also become contaminated during a fire. Potential sources of contamination from the fire can include carbon black (creosote, asphalt, and soot), charcoal from combustible materials (wood, paper, pallets, organics, etc.), spilled diesel fuel, oils, plastics, polyethylene (from bags, etc.), aluminum, and copper.

AN as an oxidizer can support combustion even in the absence of atmospheric oxygen, such as in poorly ventilated structures. Molten AN is a powerful oxidizer capable of igniting some combustible materials with which it comes in contact and of reacting explosively with organic materials and finely divided metals. AN can undergo self-sustaining decomposition when exposed to elevated temperatures including exposure to fire. The rate of self-sustained decomposition can be increased by contamination. Contamination by carbon black; charcoal; finely divided metals (copper, iron, etc.); sulfur; or potash, which liberates chlorine as it decomposes, can catalyze the decomposition mechanism into a self-sustaining, internal exothermic reaction that will spread within a fertilizer pile

creating a zone of decomposition. This reaction can continue and spread through the entire fertilizer mass, even after the actual fire is suppressed.

AN melts at approximately 338°F (170°C). Temperatures between 374°F (190°C) and 446°F (230°C) are considered sufficient to initiate self-sustained decomposition for some mixtures and contaminated AN; however, some mixtures of AN fertilizer can undergo self-sustained decomposition at lower temperatures. A self-sustained decomposition cannot be controlled by smothering.

Typical solid and liquid AN products are listed in Table E.1.

AN is commonly blended with other fertilizer materials, such as diammonium phosphate, sulfate, and potash. Fertilizers containing less than 60 percent AN are not covered by this code. Fertilizer materials that contain AN are commonly described, not by their chemical composition, but by their plant nutrient (N-P-K) values. For example, agricultural-grade AN will appear in the market place with a guaranteed nitrogen content of 34-0-0. This means there is a guaranteed analysis of 34 percent total nitrogen, with 0 percent phosphate and 0 percent potassium. The theoretical maximum nitrogen content of pure or 100 percent AN is 35 percent by weight. The typical nitrogen content of AN fertilizers offered in the market-place is usually between 28 and 34 percent. Other nutrients such as sulfates or phosphates, added hardening agents, coating agents, and residual water make up the balance.

If the total available nitrogen in an AN-based fertilizer comes from AN, the percentage of AN can be determined through the use of the following formula:

[E.1]

% ammonium nitrate = 
$$\frac{\text{(\% total nitrogen listed in the fertilizer)}}{0.35}$$

For example, if a fertilizer is indicated as being 30-0-0, then it contains (30/0.35) = 85.7% AN.

However, when some, but not all, of the nitrogen could come from other nitrogen compounds in the mixture, the percentage of nitrogen for each component containing nitrogen in the fertilizer mixture must first be determined. For example, a fertilizer product described as 28-0-0-5(S) has a guaranteed analysis of 28 percent total nitrogen, 0 percent phosphate, 0 percent potassium, and 5 percent sulfur. Whether the nitrogen is derived from AN or another nitrogen fertilizer source, it must be disclosed by the manufacturer to determine the hazard classification of the material. This type of information is usually found on the SDS provided by the manufacturer where the names of the material included in the mixture along with the concentration of each material is expressed. It is not unusual for a range of concentrations to be given on an SDS, and users are cautioned to assume the AN concentration to be at the top of the range.

By use of Equation E.1, AN fertilizers with a nitrogen content of less than 21 percent by weight derived from AN (60 percent AN) are not regulated by Chapter II (e.g., (21/0.35) = 60% AN).

For interstate shipments, the U.S. DOT classifies AN with not more than 0.2 percent total combustible material, including any organic substance, calculated as carbon to the exclusion of any other added substance, as an oxidizer Division 5.1. AN with more than 0.2 percent combustible substances, including any organic substance calculated as carbon to the exclusion of any other added substance, as a Division 1.1D material. AN-based fertilizers can be classified as an oxidizer Division 5.1, or in some cases as a Division 9 material (miscellaneous hazardous material). (See U.S. DOT Transportation Regulations 49 CFR 172.101, "Purpose and Use of Hazardous Materials Table.")

The requirements for classification of AN as a Division 5.1 oxidizer by the DOT are described in the United Nations publication, *Recommendations on the Transport of Dangerous Goods, Model Regulations.* Such oxidizing materials can yield oxygen upon decomposition under fire conditions and will, therefore, under proper conditions of mixing, vigorously support combustion if involved in a fire with combustible materials.

AN in higher concentrations is capable of undergoing detonation with about half the blast effect of explosives, if heated under confinement that permits high-pressure buildup, or if subjected to strong shocks, such as those from an explosive. The sensitivity of AN to detonation increases at elevated temperatures. Additional information on the explosive nature of AN, including the degree of confinement along with the effect of certain inert diluents, such as chalk, limestone, dolomite, and so forth, can be found in U.S. Bureau of Mines Report of Investigations 4994, *Investigations on the Explosibility of Ammonium Nitrate*.

Industrial use of AN extends to use as an ingredient in blasting agents. When a carbonaceous or organic substance such as fuel (or diesel) oil, nut hulls, or carbon black is added and mixed in with AN, the mixture could become a blasting agent. A blasting agent as defined by NFPA 495 is a material or mixture that meets the requirements of the DOT *Hazardous Material Regulations*, as set forth in 49 CFR 173.56, "New Explosives — Definition and Procedures for Classification and Approval," 49 CFR 173.57, "Acceptance Criteria for New Explosives," and 49 CFR 173.58, "Assignment of Class and Division for New Explosives," Explosive 1.5D.

Test data on AN are included in the U.S. Bureau of Mines Report of Investigations 6746, Sympathetic Detonation of Ammonium Nitrate and Ammonium Nitrate Fuel Oil; Report of Investigations 6903, Further Studies on Sympathetic Detonation; and Report of Investigations 6773, Explosion Hazards of Ammonium Nitrate Under Fire Exposure. On the basis of these reports, a table of recommended separation distances of AN and blasting agents from explosives or blasting agents has been developed [see Table 9.4.2.2(b) of NFPA 495]. However, the table is only valid for AN and AN-based materials that are NOT DOT Hazard Class 1 sensitive. The table is only applicable to materials that show positive results in the UN Test Series 1 sensitivity and thermal stability tests and negative results in the UN Test Series 2 gap tests. Products that show positive results when tested in the UN Test Series 1 and 2 tests could potentially be classified as having a mass explosion hazard. NFPA 495 requires that Hazard Class 1 materials be stored in accordance with the requirements for high explosives (Division 1.1) under the quantitydistance requirements of SLP 2, "American Table of Distances (ATD)," developed by the Institute of Makers of Explosives (IME) and published in NFPA 495.

The maximum quantities of material indicated by the ATD are limited to quantities less than what might be found on sites where large amounts of AN or AN mixtures might be found. The Department of Defense Explosives Safety Board

(DODESB) currently uses software called SAFER along with tables of distance methods to assess DOD potential explosives sites. The IME, in collaboration with the DODESB, APT Research, and Canadian and U.S. regulatory agencies, has developed a software called IMESAFR. The software incorporates risk-based methodology to address the impact of siting for explosives and explosive operations. Provisions for AN are included using an approach and distances based on TNT equivalency.

While blasting agents should not be confused with fertilizer products, extreme care should be taken to ensure that stored AN does not become sensitized by intimate mixing with carbonaceous, organic, or combustible material.

**E.2 Suggested Fire-Fighting Procedure.** Pre-incident planning by the fire department and/or emergency management officials should be developed for every AN storage facility and include when to evacuate. The pre-incident planning and emergency response should account for toxic AN gaseous products of decomposition, fire effluents, and potential for explosions. Pre-incident plans should account for emission of toxic gases from fires involving AN and plume travel depending on wind direction.

Only incipient fires in an area where AN is stored or in vehicles transporting AN should be attacked using manual fire-extinguishing methods (fire extinguishers, hose streams, etc.) that require a human operator. Fire fighters, emergency responders, and/or facility personnel should withdraw to a safe distance and allow a structure or vehicle to burn to completion if a fire in an area where AN is stored or in vehicles transporting AN progresses beyond the incipient stage or should a fire break out in an area where AN is stored, or in a vehicle transporting AN. When evacuation is deemed necessary, fire-fighting personnel should immediately evacuate the area within 1 mile (1609 m) (or as determined by the Emergency Action Plan) in all directions.

Water is the only satisfactory extinguishing material for fires involving AN. It is important that the mass be kept cool and the burning be promptly extinguished. Large volumes of water should be applied as quickly as possible. This is best accomplished by automatic fire-extinguishing systems and not the use of manual suppression means (fire hoses, master streams, etc.) that require fire fighter actions. Normally, ventilation and the application of water, including automatic sprinklers, can quickly desensitize and stabilize the hot AN material. Firewater should be contained and prevented from leaving the site and entering streams, lakes, and rivers.

After extinguishment of the fire, the loose and contaminated unsalvageable AN should be disposed of according to federal, state, and local environmental agencies' acceptable practices or regulations. Any residue that cannot be removed by sweeping should be washed away; contaminated water from flushing must be disposed of. Flushing and scrubbing of all areas should be very thorough to ensure the dissolving of all residue. Wet empty bags should be removed, and disposed of in accordance with federal, state, and local regulations.

Remediation of a site involving AN should be conducted by someone trained on the hazards of AN and a HAZMAT technician–level responder or qualified third-party responder. Any contaminated material should be properly disposed of by dilution. Any wood exposed to AN should be properly disposed. Any porous material should be treated with special care

because of the potential to re-ignite after the material has dried. Metal surfaces if in contact with the residues of AN should be thoroughly cleaned with water to prevent corrosion.

**\Delta F.1 General.** The assignment of the organic peroxide formulation classifications shown in the tables in this annex are based on the container sizes shown. A change in the container size could affect the classification. The information in this annex was collected from the Organic Peroxides Producers (Plastics Industry Association — Organic Peroxide Producers Safety Division). The most current version of the information can be found at plasticsindustry.org/oppsd.

For an alphabetical listing of typical organic peroxide formulations, see Table F.1.

### F.2 Class I Formulations.

- F.2.1 Fire Hazard Characteristics. Class I formulations present a deflagration hazard through easily initiated, rapid explosive decomposition. Large-scale burn rates greater than or equal to 661 lb/min(300 kg/min) can be expected. Class I includes some formulations that are relatively safe only under closely controlled temperatures. Both excessively high and excessively low temperatures can increase the potential for severe explosive decomposition and/or rapid burning.
- **F.2.2 Fire-Fighting Information.** The immediate area should be evacuated and the fire should be fought from a remote location. Some damage to structures from overpressure can be expected should a deflagration occur.
- **Δ F.2.3 Typical Class I Formulations.** See Table F.2.3.

### F.5 Class III Formulations.

**F.5.1 Fire** Hazard Characteristics. Class III formulations present a fire hazard similar to Class IIB combustible liquids. They are characterized by rapid burning and high heat liberation due to decomposition. Large-scale burn rates of less than 132 lb/min (60 kg/min) but greater than or equal to 22 lb/min (10 kg/min) for Type D, or small-scale burning rates for Type D, Type E, and Type F of less than 0.184 lb/min(ft²) [0.9 kg/min(m²)], are expected for these organic peroxide formulations. These organic peroxides are typically less reactive or contain much higher levels of diluent than the Class I, Class IIA, and Class IIB formulations.

**F.5.2 Fire-Fighting Information.** Caution should be observed due to possible unexpected increases in fire intensity.

**Δ F.5.3 Typical Class III Formulations.** See Table F.5.3.

### F.6 Class IV Formulations.

**F.6.1 Fire Hazard Characteristics.** Class IV formulations present fire hazards that are easily controlled. Reactivity has little effect on fire intensity. Large-scale burn rates of these organic peroxide formulations are less than 22 lb/min (10 kg/min).

**F.6.2 Fire-Fighting Information.** Normal fire-fighting procedures can be used.

### Annex G Oxidizers

This annex is not a part of the requirements of this NFPA document but is included for informational purposes only.

### G.1 General.

**\Delta** G.1.1 Solid Oxidizers. Oxidizers can have both physical and health hazards. The tests and criteria described in G.1.2 through G.1.5 are based on burning rate only and do not address other physical hazards of oxidizers, such as thermal instability and chemical reactivity, or health hazards of gaseous products generated during combustion or decomposition. If confined, gaseous products generated from oxidizer decomposition can result in overpressure events and explosions. Cumulative research test data indicate the burning rate of solid oxidizers is principally a function of the chemical composition of the oxidizer and its concentration, and to a lesser degree, its physical form (e.g., powder, granular, or tablets). Inclusive in the influence of the oxidizer composition are the amount and type of additives (if any) as well as the moisture content of the oxidizer or hydrated salt additives. The tests and criteria apply to oxidizers or formulations containing oxidizers that are found in commerce, use, and storage and do not apply to the evaluation of oxidizer-containing explosive mixtures, and pyrotechnic mixtures. The tests and criteria assign an oxidizer to an NFPA Class for storage and are not applicable to and should not be confused with Department of Transportation (DOT) and United Nations (UN) Packing Group (III, II, I) assignments and vice versa. The UN and DOT Division 5.1 solid oxidizer packing groups are different from, and not synonymous with, the NFPA Class (1, 2, 3, 4) assignments for storage, handling and use. The NFPA Classes for solid oxidizers are also different from the hazard categories (Categories 3, 2, 1) for oxidizing solids defined by the Global Harmonization System (GHS) adopted by the revised OSHA Hazard Communication Standard in March, 2012.

The oxidizer classification method consists of two reaction-to-fire tests: (1) a bench-scale test with 30 g mixtures of oxidizer and dried cellulose exposed to a glowing wire and (2) an intermediate-scale test with 10.9 kg of oxidizer in combustible test packaging exposed to a constant external fire source. The key physical indicators of burning rate measured in the intermediate-scale test are peak convective heat release rate and the burning time calculated from the radiant heat flux profile. The key physical indicators of burning rate measured in the bench-scale test are mass loss rate and burning time calculated from the mass data. Either of these tests can be used to classify a solid oxidizer. If both of these tests are conducted and the results differ, then the results from the intermediate-scale fire exposure test data should be used as the basis for the classification.

**G.1.2 Tests and Criteria.** Oxidizers and formulated products containing an oxidizer are assigned to Oxidizer Class 1, Class 2, Class 3, or Class 4 according to the tests and criteria specified in Table G.1.2(a) and Table G.1.2(b).

#### **G.1.3 Definitions.**

- **G.1.3.1 Active Burning Time.** Duration of burning with flaming combustion, or decomposition with minor flaming combustion, calculated from test data. From the bench-scale test data, the active burning time is calculated as the time from first measurable mass loss to the time at which 80 percent of the total mass loss has occurred. From the intermediate-scale radiant heat flux test data, the active burning time is the width of the curve at one-half the peak radiant heat flux.
- **G.1.3.2 Burning Behavior.** The complete characterization of a material or mixture's reaction to fire including both visual descriptors and test data.
- **G.1.3.3 Burning Rate.** The principal physical hazard of oxidizer fires described by the intensity or quantity of energy release, in the form of heat and light or accelerated fire, and time duration over which the energy is released.
- △ G.1.3.4 Fire-test-response Characteristic. A response characteristic of a material, product, or assembly to a prescribed source of heat or flame, under controlled fire conditions; such response characteristics may include, but are not limited to, ease of ignition, flame spread, heat release, mass loss, smoke generation, fire resistance, and toxic potency of smoke. [ASTM E176, Standard Terminology of Fire Standards]
  - **G.1.3.5 Formulated Product.** A product that contains a solid or liquid oxidizer as one of its constituents, including admixtures. Some oxidizers are not sold in pure form (e.g., lithium hypochlorite, calcium hypochlorite). Formulations include chemical by-products and unreacted raw materials inevitably present in the product and intentionally added diluents and exotherm control agents, such as hydrated salt crystals coarsely blended with the manufactured oxidizer.
- △ G.1.3.6 Heat Release Rate (HRR). The thermal energy released per unit time by an item during combustion under specified conditions. [ASTM E176, Standard Terminology of Fire Standards]

G.1.3.8 Mass Loss. The change in mass of a solid material to gaseous products during combustion or decomposition expressed per unit quantity of material (g/g, %).

G.1.3.9 Test Packaging. Packaging for solid (granular, tablet, or powder) oxidizers during the intermediate-scale fire exposure test consisting of six, high-density polyethylene (HDPE) containers in a double-wall corrugated board carton.

G.1.3.10 Visual Burning Duration. Duration (s, min) of visible flaming combustion, as measured with a stopwatch.

**G.1.4 Bench-Scale Test.** The solid oxidizer (granular, powder, crystalline) is evaluated in the particle size and distribution intended for storage, handling, and use. For tablets, the pretablet or raw material is tested. Thirty gram (30 g) mixtures (1:1, 4:1, and 9:1 by mass) of the oxidizer or formulated product and dry cellulose powder are exposed to a glowing wire energized to 150 W on a data logging laboratory balance in a laboratory hood. The mass loss rate of each mixture is calculated from test data. The mixture with the highest or maximum mass loss rate is compared to the mass loss rate and burning rate duration criteria in Table G.1.2(a) and Table G.1.2(b). The bench-scale test is capable of distinguishing weak oxidizers (Class 1), strong oxidizers (Class 3), and oxidizers that principally decompose.

**G.1.4.1** Test Materials. Cellulose Powder. Dried fibrous cellulose with a fiber length between 50 µm and 250 µm and a mean diameter of 25 µm is used as the combustible material. The cellulose powder is spread in a pan so the depth of powder is less than or equal to 0.25 in. and dried in a laboratory oven at 221°F (105°C) for 4 hours. After drying, the powder is transferred to a desiccator cabinet with desiccant. When cool, the moisture content is measured using an analytical moisture analyzer or by gravimetric analysis. The moisture content must be below 0.5 percent w/w when measured at 105°F. Suitable cellulose is currently available as Technocel 75 from CFF GmbH & Co. KG, Arnstaedter Strasse 2, 98708 Gehren, Germany, www.dff.de, and was previously available as CF-11 from Whatman.

Oxidizer. A solid (granular, crystalline, powder, prill, or tablet) containing an oxidizer functional group requiring evaluation for assignment to Class 1, Class 2, Class 3, or Class 4. The oxidizer should be documented as-received to include: CAS number of the oxidizer(s), chemical composition if a mixture or formulation, form, and, if granular, the particle size and distribution measured with certified sieves and recorded as mass percent of each particle size fraction.

 $\Delta$  G.1.4.2 Instrumentation and Test Set-Up. Balance. A laboratory balance is positioned and leveled inside a clean laboratory hood. The hood air stream velocity should be 0.5 m/s (1.6 ft/s) or less measured at the face of the hood and capable of capturing all gaseous products generated. An apparatus such as a metal frame, constructed of welded steel and having two pins at the diagonal of the weighing surface, is used to center scale protection materials. The pins do not contact the laboratory balance but function to center protection materials. The laboratory balance programmable response-time settings are optimized to establish the data output interval. Data collection at 0.2-, 0.5-, or 1-second intervals is typical. Data-logging parameters are similarly set at the computer interface and software to collect and record time-stamped mass data. Auto-calibration functions of the balance, if any, are disabled during tests.

Protection Materials. The laboratory balance weighing pan is protected with three or more layers of high-temperature ceramic fiberboard. For example, a balance weighing surface with dimensions  $0.15 \text{ m} \times 0.15 \text{ m}$  (6 in.  $\times$  6 in.) would be protected with a bottom or base layer of Kaowool HT board with dimensions  $0.30 \text{ m} \times 0.30 \text{ m} \times 0.013 \text{ m}$  (12 in.  $\times$  12 in.  $\times \frac{1}{2}$ in.). The base layer extends beyond the balance to capture material ejected from the test platform. Two openings in the

base layer correspond to the location of the centering pins of the apparatus. The middle layer is Kaowool HT board with dimensions 0.178 m  $\times$  0.178 m  $\times$  0.013 m (7 in.  $\times$  7 in.  $\times$   $\frac{1}{2}$  in.), and the top layer, or test platform, is Kaowool PM board with dimensions 0.114 m  $\times$  0.114 m  $\times$  0.006 m ( $\frac{4}{2}$  in.  $\times$   $\frac{4}{2}$  in.  $\times$   $\frac{1}{4}$  in.). The base layer of protection remains on the balance after each trial.

Due to heat retained from the glowing wire and/or test mixtures, the two top layers of ceramic board on the base layer are removed after each test. The middle and top layers of HT board can be reused after cleaning and cooling to room temperature.


A suitable barrier is constructed around the laboratory balance and protection materials to prevent air currents from the operating hood from influencing balance stability. For example, a barrier might consist of up to three 0.0127 m ( $\frac{1}{2}$  in.) thick fiber boards — one on each side of the balance extending from the back of the hood to the front of the hood and one in the back — and clear plastic in the front secured to the sides with tape. The hood air velocity should not interfere with balance stability.

Thermocouples (Optional). Three K-type air thermocouples (TC) are secured to a ring stand to one side of the protected lab balance. The tips of the thermocouples are centered above the test platform. The distances from the surface of the test platform recommended to capture the range in plume temperatures are 7.6 cm (3 in.), 15.2 cm (6 in.), and 22.8 cm (9 in.). A fourth K-type thermocouple monitors the ambient temperature. The TCs are attached to the data acquisition system programmed to record the plume temperatures over the same time interval as the lab balance (e.g., 0.2-, 0.5-, and 1-second intervals). The fixed-height thermocouples are also used to estimate peak flame height during a test.

Ignition source. A wire (for example, Nichrome) is formed as specified in Figure G.1.4.2. The length of the wire is 30±1 cm (11.8 in.); the wire diameter is <1 mm (<0.039 in.). A variable laboratory power supply is used to regulate the voltage and current to the wire to achieve 150±7 W when energized. It is very important that the power connection to the heating wire is flexible enough to avoid any influence on the proper operation of the balance. For example, conductors from the power supply output can be secured to one or more ceramic terminal blocks. The first terminal block, secured with a clamp at the rear of the lab balance, has conductors to a second ceramic terminal block near the test platform, and the looped wire is inserted in the second terminal block to complete the circuit. The looped portion of the wire is centered over the test platform.

**G.1.4.3 Test Methodology.** Test Mixtures. Three concentrations of oxidizer-cellulose powder mixtures evaluated are (1) 1:1 by mass mixtures containing 15 g oxidizer and 15 g dried cellulose powder; (2) 4:1 by mass mixtures containing 24 g oxidizer and 6 g dried cellulose powder; and (3) 9:1 by mass mixtures containing 27 g oxidizer and 3 g dried cellulose powder. Five trials of each concentration are tested. Each mixture should be prepared individually and not taken from a pre-mixed batch.

Single Test Procedure. Each mixture of oxidizer and dried cellulose powder is prepared immediately prior to each trial in a test series. A second laboratory balance is used to weigh the required amounts of cellulose powder and oxidizer to the nearest 0.1 g. The materials are transferred to and combined in a clean, labeled container (500 mL) with a screw-top lid. Mixing of the contents is done by inverting (not shaking) the container no less than 25 times. After mixing, the contents of the container are transferred into a funnel (70 mm diameter, 102 mL volume, 60 degree angle) with a sealed stem. The funnel with the mixture is tamped lightly. The funnel with material is inverted so that the conical pile of material is centered over the looped ignition wire. This can be done by putting the wire and test platform over the funnel and then inverting the entire assemblage. Alternatively, using cardstock paper, the funnel with the mixture is inverted over the looped wire ignition source on the test platform. When the cardstock is removed, gently twisting the funnel over the wire allows for uniform settling of the mixture around the ignition wire on the test platform. The funnel is removed, leaving the conical pile of material centered on the wire.

The balance is tared to zero. The sash of the hood is lowered and the hood blower is energized. The laboratory temperature and relative humidity are recorded. If necessary, the balance is re-tared to zero. Once balance stability is confirmed, data acquisition is initiated, and baseline data is collected for at least 10 seconds before the wire is energized at the power supply. A stopwatch is activated when the wire is energized. Mass loss and the temperature data are collected until spreading discoloration and/or visible flaming combustion cease. In the event of little or no flaming combustion, mass and temperature data are collected for 5 min.

After each trial, whether the wire is open or continuous, the electrical power to the wire is shut off, the wire is disconnected, and the top two layers of balance protection materials with the test residue are removed.

A new wire should be used for each test.

**G.1.4.4 Test Sequence.** The oxidizer:cellulose powder mixtures are tested in the following sequence: 1:1 (5 trials), 4:1 (5 trials), then 9:1 (5 trials). If either the 1:1 or 4:1 mixture results in vigorous burning with stopwatch burning durations less than 6 sec and/or the calculated peak mass loss rate is greater than 3 g/sec, the 9:1 mixture does not need to be tested

**G.1.4.5 Test Data.** *Visual.* Photographs and/or video recordings are used to document, at a minimum, one representative trial in a test series. Visual observations should be recorded and might include: the peak flame height above the test platform; whether the pile ignited readily or was slow to ignite; whether flames readily spread over the pile or were slow to spread; the flame color; the relative volume and color of gaseous products generated; material displaced from the test platform, if any; unusual burning behavior such as swelling or "boiling"; observable or clear dependence of burning rate on the duration of the energized wire; irregular or intermittent burning; and presence of unburned or uninvolved material remaining at the end of a test.

Calculated. The profile of each burning test is examined by plotting the mass loss data as a function of time. The percent material consumed is calculated from the final measured mass loss (m<sub>f</sub>) over the initial mass (m<sub>i</sub> or 30.0 g) of the mixture times 100 percent. The mass loss rate is then calculated from the time at 20 percent and 80 percent the final measured mass loss. For example, the balance with a 30.0 g mixture is tared to and starts with a reading of 0.0 g and, at the completion of combustion, ends with a reading of -20.0 g. The percent material consumed is  $20.0/30.0 \text{ g} \times 100 \text{ or } 67 \text{ percent}$ . The mass loss rate is calculated from the time at  $0.20 \times 20.0$  g or 4.0 g to the time at  $0.80 \times 20.0$  g or 16.0 g. The mass loss rate is preferably calculated by performing a least squares linear fit of the mass loss data between 0.20 m<sub>f</sub> and 0.80 m<sub>f</sub>. The coefficient of correlation (R2) of the mass curve from each trial should be at least 0.90 between 20 percent and 80 percent mass loss. The active burning time is the time from first measurable mass loss to the time at 0.80 m<sub>f</sub>. First measurable mass loss is defined as, upon energizing the wire, the first time-stamped mass data that leads a continuous series of decreasing mass at the pile as ignition, combustion, or decomposition occurs.

Mass loss rate and active burning time data are calculated for each trial within a series and are then used to calculate an average and sample standard deviation for the series of trials (e.g., 5 trials for 1:1 mixture). If the burning behavior is found to depend on the duration of wire continuity, the highest mass loss rate is used instead of the average; or a sufficient number of trials are conducted to obtain trials where the wire break occurs after the main reaction time.

**G.1.4.6 Test Criteria.** The bench-scale test criteria, based on the maximum mass loss rate from the averages and the active burning time, are shown in Table G.1.2(a) and Table G.1.2(b). The average active burning time and mass loss rate data for an

oxidizer in 1:1, 4:1, and, if necessary, 9:1 oxidizer:cellulose powder mixtures are compared after completing the series of trials. The mixture with the greater mass loss rate is identified; the maximum mass loss rate within that mixture is compared with the test criteria. For example, a 1:1 oxidizer:cellulose powder mixture has average mass loss rate and active burning time  $2.1 \pm 0.2$  g/sec and  $10.7 \pm 1.3$  s, respectively. The 4:1 mixture of the same oxidizer with cellulose powder result in average mass loss rate and active burning time  $11.3 \pm 1.2$  g/sec and  $2.0 \pm 0.4$ s, respectively. The 4:1 mixture has the greater mass loss rate with a maximum mass loss rate 11.3 g/sec + 1.2 g/sec or 12.5 g/sec. Using the maximum mass loss rate, active burning time, and criteria in Table G.1.2(a), the oxidizer is assigned to Class 3.

G.1.5 Intermediate-Scale Fire Exposure Test. If the benchscale test results in borderline Class assignment (e.g., borderline Class 1/Class 2 or borderline Class 2/Class 3), the intermediate-scale test should be performed. The intermediatescale test can be performed instead of the bench-scale test. Otherwise, the intermediate-scale test is optional. Twenty-four pounds (10.9 kg) of the solid oxidizer (in the form and concentration intended for storage, handling, and use are transferred to the combustible test packaging is centered on a drywall-lined table and inside the opening of a U-shaped propane-fueled burner, and ignited under a calibrated 2 MW hood instrumented in accordance with ASTM E2067. The peak convective heat release rate, less the burner contribution, is calculated from gas temperature rise calorimetry equations. The duration of active burning is calculated from radiant heat flux transducers, less the burner contribution, at a fixed distance from the packaged test material. The peak convective heat release rate of the oxidizer in test packaging is compared to the peak convective heat release rate active and burning time criteria in Table G.1.2(a) or Table G.1.2(b).

**G.1.5.1 Test Materials.** Oxidizer. The chemical composition and physical properties of the oxidizer or formulated product containing an oxidizer being evaluated are recorded. The oxidizer or formulated physical form is characterized as granular, crystalline, powder, prill, or tablet. The test material is not ground or subject to any mechanical attrition or sieving to reduce the particle size. The original packaging of the oxidizer is recorded.

Combustible Test Packaging. High-density polyethylene (HDPE) wide-mouth containers with screw-top lids in corrugated board cartons are used as combustible test packaging. The HDPE containers should not contain additives that would reduce the burn rate. The HDPE container specifications are summarized in Table G.1.5.1(a). Suitable containers are currently supplied by Consolidated Plastics Inc. (Twinsburg, OH).

The corrugated board carton should be double-wall construction and not contain additives that would reduce the burn rate. The carton specifications are summarized in Table G.1.5.1(b). Suitable cartons are made by JM Packaging-Detroit Tape and Label (Warren, MI).

Although oxidizers and formulations containing oxidizers can be sold in other packaging, the standard test method utilizes combustible packaging consisting of six, HDPE containers (60 oz or 85 oz) with lids in a corrugated board carton. The 1,774 cm³ (60 oz) HDPE containers accommodate most oxidizer solids based on density; the 2,514 cm³ (85 oz) containers can be used for low-density (i.e., powder form) oxidizers. Four pounds (1.8 kg) of oxidizer are transferred to each HDPE

container. The HDPE containers are then arranged in the corrugated board carton with doubled-wall construction. The dimensions of the carton that enclose six, 1,774 cm $^3$  (60 oz) HDPE containers are 40.6 cm  $\times$  25.4 cm  $\times$  20.3 cm 16 in.  $\times$  10 in.  $\times$  8 in.); the dimensions of the carton that enclose six 2,514 cm $^3$  (85 oz) HDPE containers are 40.6 cm  $\times$  20.3 cm $\times$  20.3 cm (16 in. 10 in. $\times$  10 in.).

**G.1.5.2 Instrumentation and Test Set-Up.** *Laboratory Balance.* A laboratory balance is used to measure the oxidizer from the as-received packaging for transfer into the test packaging. The mass of oxidizer in each container and/or bag is measured and recorded.

Hood. A minimum 2 MW capacity hood designed and equipped with instrumentation described in ASTM E2067, Standard Practice for Full-Scale Oxygen Consumption Calorimetry Fire Tests, is required to capture and measure the temperature of the gaseous products of combustion or decomposition. The skirt of the hood should be no more than 6 ft from the floor. For consistency between burns, the hood flow rate should be the same for the calorimetric calibration, the baseline burner, and the test materials. Because oxidizers can evolve oxygen during combustion, gas temperature rise and not oxygen consumption calorimetry is used to calculate the heat release rate.

Burn Table. A noncombustible table, with a removable top and tray, is centered and leveled under the hood. The bottom of the tray is lined with  $\geq 6.35$  mm (0.25 in.) thick drywall 0.91 m  $\times$  0.91 m (3 ft  $\times$  3 ft). Four short 7.6 cm to 10.1 cm (3 in. to 4 in.) walls made of non-combustible material are attached to the edges of the tray to contain and prevent the flow of material from the tray during a test. The table height is such that the bottom of the test package is 1.1 m (3 ft 8 in.) from the floor

Ignition Source. A U-shaped burner is constructed from threaded black gas pipe (1 in. NPS) and cast iron threaded fittings. The distance between the two legs of the U-shaped burner is 43.8 cm ( $17\frac{1}{4}$  in.); the length of each leg is 50.8 cm ( $20\frac{1}{4}$  in.). Each leg of the burner has 38 uniformly spaced openings oriented toward the interior each with a diameter 3.4 mm (0.13 in.); the pipe joining the two legs has 26 drilled openings. The carton is centered between the parallel burner legs and 4 in. from joining the section opposite the open side of the U. The burner does not contact the protected load cell, table, or

tray. Propane gas is supplied to the burner from a cylinder. The flow rate to the burner is adjusted using a regulator at the cylinder outlet. The flow rate to the burner is adjusted using the regulator so that the output of the burner is 38 kW (convective heat release rate). Note: Using the effective heat of combustion of propane (46.4 kJ/g), for a 38 kW fire, the mass flow rate of propane gas to the burner is will probably be approximately  $0.8~\mathrm{g/sec}$ .

Radiant Heat Flux Transducers. Two calibrated, water-cooled, Schmidt-Boelter or Gardon Gage incident radiant heat flux  $(0\text{-}50 \text{ kW/m}^2)$  transducers are affixed to a rigid stand and positioned next to the table with the sensors center with the carton between the legs of the U-shaped burner. The distance from the floor to the lower target is 1.2 m (4 ft 2 in.); the distance between the lower and upper target is 0.45 m (18 in.). The distance from the heat flux sensors to the center of the table where the carton is positioned is 0.95 m (3 ft 2 in.). With respect to the test packaging, the lower heat flux transducer is located at the height of the top section of the carton (or pail). The second heat flux transducer is located at 0.4 m (16 in.) above the top of the carton.

Digital Clock. A digital clock that will be visible and readable in the video recording of the test can be used.

Ambient Air Thermocouple (Required). The ambient air temperature is measured continuously during the test at the same data acquisition rate as the exhaust gas temperature. The ambient air thermocouple should be placed outside of the hood, far enough away to prevent interference from the burn test, but close enough to represent the ambient air in the room. The thermocouple should be protected from radiant heat from the burn test.

Thermocouples (Optional). Four, K-type fiberglass insulated thermocouples (TC) are attached to the carton. One TC is taped to the exterior bottom center of the carton; a second TC is taped to the exterior top center of the carton. A hole is punched through one side of the carton, through which two TCs are inserted. A hole is drilled through the lid of one HDPE container and a TC is inserted into the material inside. The hole in the lid is sealed with tape. The second TC is secured to the side exterior center of one HDPE container with the bead positioned between the container and the carton wall. The bead of the TC is exposed (e.g., not taped). Temperature data is recorded using a data acquisition system.

Data should be collected at least every second for the calibration, baseline, and test burns.

G.1.5.3 Test Methodology. Before each test, the temperature and relative humidity inside the burn facility are recorded. At the start of a test, the hood is turned on and a 2-minute baseline of data is collected. The data should be collected at a frequency rate of at least 1 second; 5 second intervals is typical. The gas burner is ignited at 2 minutes and a timer is activated. The gaseous products of combustion and/or decomposition from the packaged oxidizer are entrained in the hood and exhaust collection duct. The burner remains on for the duration of a test and for sufficient time after enhanced burning of the packaged test material to return to burner baseline values. For example, for inert materials and weaker oxidizers, the burner remains on for up to 20 minutes. For stronger oxidizers, the burner remains on for 10 minutes. At the conclusion of a test, the regulator at the propane cylinder supplying fuel to the burner is closed. The test material is observed for residual
